#### **ENTRODUCT ION**

The information included in this selected bibliography will introduce the user to some of the literature and other resources presently available in the broad areas of gerontology, clothing, disabilities, handicaps and rehabilitation philosophy. The bibliography has been developed as part of the research project "Identification of Clothing Needs of Men and Women Age 65 or Over." This project, initiated in September 1973, was supported by the Oklahoma State University Research Foundation and The Division of Home Economics at Oklahoma State University.

This bibliography is comprehensive but not exhaustive. Selected references believed to be representative of the literature dealing with the clothing needs of the handicapped and the elderly have been included. An attempt has been made to identify and systematize books, journal and magazine articles, pamphlets and bulletins generally available in large public and/or university libraries for use by interested persons. Due to the interdisciplinary nature of the subject matter included in this bibliography, a number of references are listed in more than one section. Some theses and dissertations which are available on interlibrary loan or on microfilm from University Microfilms, Ann Arbor, Michigan are listed. Recognizing that there are many similarities and commonalities in the clothing problems and needs of the young and the old, some of the theses and dissertations as well as other

bibliographical entries are concerned directly with the clothing problems of children. The user of the bibliography will be required to use discretion as to the value of such bibliographical entries for individual purposes.

The names and addresses for sources of clothing and aids for the physically handicapped have been included as a part of this bibliography. A section listing periodicals that publish articles dealing with the handicapped and/or the elderly has also been provided.

It is hoped that the information included in this selected bibliography will be useful for researchers, teachers in the classroom, and to others who work with or who are interested in making life more satisfying and rewarding for those who may be handicapped and who are elderly.

The financial assistance of the Oklahoma State University Research Foundation and the Division of Home Economics in support of this project is gratefully acknowledged. Special thanks are extended to Dr. Marguerite Scruggs, Associate Dean, Division of Home Economics for her encouragement and suggestions concerning the total project and to Miss Clarice Stine, Graduate Research Assistant, Department of Clothing, Textiles and Merchandising for her assistance in the early stages of the development of this bibliography.
