Adoption Another Choice

Dear Dimensions,

I'm writing in reference to the article "So, you want to have a baby..." in the May 1994 issue of Dimensions. I think any discussion about alternative fertilization should include the idea of whether people have a right know their biological roots.

I am adopted. Many of my friends are too. We have spent many years searching for our birth parents. We've worked to change adoption laws so future adoptees won't be denied the opportunity to know about their biological mothers, fathers and siblings. Many adoptees feel the need to search for their biological roots, despite having wonderful adoptive parents. Many of us have known since we were very young that we were different from our adoptive families. It is apparent to us that many important parts of who we are, come from our "donors."

People who are conceived by semen that is purchased from a sperm bank will never have the opportunity to learn about about half of their biological heritage. If they attempt to search as adults, they will find that the sperm bank, the doctors and their mothers conspired to make sure they would never know anything about their paternal roots. Some of these people will be very angry and hurt.

I'd also like to address the issue of medical information. Most sperm donors are college or medical students. These young men, in their late teens or early 20's have not yet experienced the medical problems that they are passing to their children. The medical information from these young donors is almost useless unless some way opens up for donors to update health information as they get older.


I hope that lesbians considering parenthood will think about these issues before choosing unknown donors, or deciding to "...pick several donors and mix the sperm together so that the identity of the father is uncertain."

Women interested in reading more about adoption and unknown donor issues from a feminist perspective are encouraged to check out the excellent newsletter, Chain of Life, P.O. Box 8081, Berkeley, CA 94707. Many lesbians participate in the dialogue.

My ex-lover and I chose to become parents through adoption. Our daughter is now 8 years old. We never forget that she has a mother and father, and a brother and sister who are an important part of who she is. It doesn't diminish our position in her life one bit.

CONGRESSIONAL. HEARING FOCUSES ON CAMP SISTER SPIRIT

JACKSON, MISS. - A U.S. House of Representative subcommittee held an oversight hearing in Jackson, Mississippi on July 6th focusing on the events surrounding the conflict in Ovett, Mississippi, the location of the feminist retreat Camp Sister Spirit, run by the lesbian couple Brenda and Wanda Henson. The Subcommittee on Civil and Constitutional Rights of the House Judiciary Committee heard testimony from the Hensons, leaders of the Mississippi for Family Values (who oppose the creation of Camp Sister Spirit), several local officials, representatives of the U.S. Department of Justice and experts in the area of hate crimes.

The hearing was chaired by Rep. Barney Frank (D-Mass.) and also led by Rep. Jerrold Nadler (D-NY). Robin Kane, Public Information Manager at the National Gay and Lesbian Task Force (NGLTF), attended the hearing and submitted a written statement to the

subcommittee.

In their testimony, Brenda and Wanda Henson summarized the harassment. threats and violent incidents that have been committed against them since November 1993, including death threats by mail and phone, a dead dog hung on their mailbox, gunshot fire along the property line, gunshots aimed at a woman from a moving vehicle, and a high speed vehicle chase involving Brenda Henson and an unknown perpetrator. These incidents have followed a highly publicized campaign against Camp Sister Spirit headed by James

Hendry and his group, Mississippi for Family Values. Hendry has organized two town meetings and two rallies targeting the Hensons and Camp Sister Spirit.

The Hensons testimony also featured several instances in which they say Mississippi officials did not respond to requests for assistance or intervention or were directly antagonistic toward the Hensons. Those officials included the Jones County Sheriff Maurice Hooks Deputy Sheriff Myron Holifield, Jones County Clerk of Courts Cynthia Clayton, Commissioner of the Mississippi Department of Public Safety James Ingram, Mississippi governor Kirk Fordice, and U.S. Representative Mike Parker (D-Miss.) The Hensons implored federal officials to protect them and ensure their basic civil rights.

"We do not seek tolerance and acceptance," said Wanda Henson. "We seek equality under the law and freedom from oppression, intimidation and harassment. We seek justice and a legal system that is capable and willing to

defend our rights."

Both James Hendry and Rev. John Allen stated during their testimony that the harassment and incidents against the Hensons are unsubstantiated and they implied or overtly stated that the Hensons created the campaign against them for publicity. Contrary to previous statements, both Hendry and Allen said they do not want the Hensons to leave Ovett. Instead, they said they merely oppose the "commercial" aspect of Camp Sister Spirit.

Hendry went on to list the incidents of harassing mail and phone calls he has received since January. Hendry played a tape of several graphic phone calls. Allen also referred to harassment targeting him as spokesperson for Mississippi for Family Values and asked the congressmen to "reject [the Hensons'] claims and desires." While Allen's testimony focused on his moral opposition to the Hensons' lesbianism and the "gay and lesbian agenda," he did not outline any specific goals except that the Hensons' "experience the life-changing redemption found in a genuine faith surrender to Jesus Christ."

Sheriff Maurice Hooks and Deputy Sheriff Myron Holifield (who stated in a newspaper article that "It is a known fact that all your violent crimes comes from homosexuals") had agreed to appear at the hearing but did not attend due to a funeral.

Robin Kane's written statement to the subcommittee said, in part — "The situation in Ovett has demonstrated how the lack of federal protection based on sexual orientation actually hinders the federal government from intervening on behalf of its own citizens. Without specific inclusion in legislation, gay, lesbian and bisexual people across the country lack basic civil rights that are taken for granted by most citizens. NGLTF wants to ensure that case-bycase advocacy is not necessary for the federal government to protect its gay lesbian and bisexual citizens."

KENNEDY ISSUES LETTER TO GAY COMMUNITY

The following is an open letter to the lesbian/gay community by Senator Edward M. Kennedy. Senator Kennedy is a principle co-sponsor, with 30 other Senators and 110 Members of the House of Representatives of the Employment Non-Discrimination Act of 1994, a bill outlawing employment discrimination based on sexual orientation.

THE TIME IS NOW

At all critical stages in the history of a

free people, forces of oppression must be confronted in order for the frontiers of justice to be extended. For America, the time has come again. For gay men and lesbians, the time is now.

Just recently, a million Americans gathered to commemorate the 25th anniversary of Stonewall, the first milestone in this long journey on freedoms road. The civil rights movement is on the march again, moving closer to the American ideal of liberty and justice for all.

We have refused to be intimidated by hate. Once again, it is time to challenge our country to live up to its founding ideals.

A great deal of progress has been made in the past quarter century. Although many miles have been traveled, there are many promises yet to keep. They are promises to a cook in Georgia fired for being a lesbian; to a postal worker in Michigan beaten unconscious by coworkers for being gay; and to a truck driver in New Hampshire, a stock broker in Maryland, a social worker in Mississippi, and countless other Americans — all fired because of prejudice despite their productivity and performance. Such flagrant discrimination is wrong, and it is time to fight back.

That is why, along with thirty of my Senate colleagues and 115 House members. I have sponsored the Employment Non-Discrimination Act of 1994. Our bipartisan legislation will extend existing federal protections against job discrimination to gay men and lesbians, and give relief to those living in fear of losing their livelihoods. Our bill will send a strong message to employers and all Americans that homophobia will not be tolerated as employment policy anywhere in the nation.

This is not about granting special rights
— it is about righting senseless wrongs.
Our case is strong — our cause is just — and we intend to prevail.

Polls show that the vast majority of Americans agree with us that lesbians and gay men should not have to face discrimination in the workplace. Many Fortune 500 corporations have already included sexual orientation in their non-discrimination policies. Eight states and more than 100 municipalities have acted to ban discrimination against gay men and lesbians.

But the fact remains that in 42 states, qualified lesbians and gay men with excellent records can be fired — with no warning — just for being gay. It happens every day and it is up to us to

stop it.

Let's be clear — the radical right will leave no stone unturned to block the enactment of this essential legislation. Our own commitment must be even stronger. To ensure success, we need your active support and assistance.

Being right is good, but it is not enough. We need to mount a major effort in order to prevail. We must inspire the complacent and convert the skeptical. To make this bill a reality, we need you to take the following steps:

1) If you have been discriminated against

in employment or know someone who has — make sure we know the facts. Send all the information to: Committee on Labor and Human Resources, SD 428, DC 20510.

2) Write and call your Senators and Representatives at (202) 224-3121 and tell them to con-sponsor the Employment Non-Discrimination Act of 1994 (S.2238 and HR 4636).

 Urge your friends, family and coworkers to make their voices heard in

favor of freedom and justice.

For those imprisoned by prejudice and those liberated by pride, let this be a call to action. Gay and Lesbian Americans—the time has come—and together we march toward a new dawn.



COMING OF AGE: STONEWALL 25

emembering how it was...

I was just fifteen when the now famous riot at the Stonewall Inn made it to the pages of the New York Times. I read the story from microfilm at the county library, constantly vigilant lest a librarian catch on to my quest for

information. It was a restless time, filled with civil rights, war, rebellion, and in my heart I knew that my people, too, would rise someday. Only first, I had to find my people. But where?

Try New York on June 26th, 1994 at a parade that stretched from the United Nations to Central Park. My people were there, And so was I. And it was

...organized, festive, fun, peaceful and ... dare I say it... normal. The way I see it, in the twenty-five years since Stonewall, the Lesbian & Gay rights movement has come of age. And so have I. I celebrated my 40th birthday during gay pride week. And the events

oday, I don't get called to make TV appearances. There are paid lobbyists who do that. Instead, I go about the business of being a middle-aged career woman with a dog, some good friends, and a girlfriend I take to all my company functions. I've become

I became one of those activist types who wrote to newspapers, canvassed candidates, took every opportunity to stand before a camera or a microphone and say, "I am a Lesbian, and it's OK."

of that week...the dances, the parties, the Gay Games, the cruise, and of course, the parade...made me realize how much I owe the movement. And, it made me reflect on how both my life and the movement have truly matured.

nce I escaped the confines of my hometown, back in the early 70's, I set out to join the Gay Liberation Front. Except there wasn't one at my Midwestern college. So I helped start one, and soon became one of those activist types who wrote to newspapers, canvassed candidates, took every opportunity to stand before a camera or a microphone and say, "I am a Lesbian, and it's OK." It was risky and there were repercussions. But I did it because there were other brave people, mentors who affirmed what I knew to be true: that my heart and my dignity were worth fighting for, and that I was tu t alone.

a retired revolutionary, who contributes to the bureaucracy that has evolved from the Stonewall Riots, and Unity Week, Pride Week, Gay Games Week ... the whole great celebration, is an incredible testimony to just how much life for gays and Lesbians has changed. We are recognized, courted for votes, capitalized on, marketed to, and have just about made the mainstream, Imagine...

Of course it was grand to watch the parade take four hours to pass, to see subways, theatre lines, airport terminals, restaurants all filled with Gay and Lesbian folk. The moment of silence, when New York City was hushed in memory of the wonderful people we've lost to AIDS, brings a tear to my eye even as I write. But, for me, the real significance came in a most unexpected package.

I stood next to a woman at the parade who had a very active three-year-old.

He was just a kid at a parade like you'd see anywhere, running onto the street for a better look, marching along for a few yards when he liked the music or the costumes, bugging his mama to pick him up ... just like any kid at a parade ... except he was waving a rainbow flag. It was fascinating to see how moved the people marching in the parade were by this happy little kid. Some just broke into big grins; some lifted him up and twirled with him; one drag queen who made Glinda the Good Witch look underdressed even stopped to take HIS picture.

Which tells me that the work we activ-

ists started so many years ago has truly come of age. Our children, and our friend's and family's children, are waving the banner for us now, and there will be more... people who are raised knowing that Mama, or Aunt Amy or Uncle Steve are homosexuals... young Gays and Lesbians who don't have to hide in the stacks at the library or in public restrooms to discover their sexuality. We have, in my lifetime, gone from deviants to radicals to respectable folks. That, my friend, is what I saw on my 40th birthday in New York City.

And yes...I am proud.



The first book we'll look at this month is Up, Up and Away by Catherine Ennis (author of Clearwater and Chautaugua).

Sarah Bodman has two professions— Certified Video Specialist and hot air balloon pilot.

Sarah is called to videotape a deposition in a Louisiana prison. Two federal lawyers will be questioning a man in the witness protection program. The man is testifying against the notorious mobster, Vinnie Scalio.

While taking the deposition, Sarah finds herself very attracted to Margaret Paige, the federal lawyer from Boston. The morning after the deposition, Sarah takes Margaret up for a ride in her balloon and they witness the murder of the witness and the other federal lawyer. Sarah cuts the tethers on the balloon when the murderers turn and fireat the two women. They crash-land in Louisiana's Manchac swamp.

Scalio is determined to eradicate every trace of evidence against him and sends out his goons to track down Margaret and Sarah, and the film of the deposition. The women must escape the swamp while avoiding Scalio's planes and guns.

In the midst of this danger, the two women find themselves falling in love. But, Margaret is keeping a secret that may destroy their budding relationship—if Sarah's ex-lover doesn't destroy it first.

Catherine Ennis' books are always entertaining. The characters are believable even though they are frequently in unbelievable situations. The setting is intriguing and gives alot of local flavor that Louisianians and Eastern Gulf Coast Texans will particularly enjoy. Up, Up and Away is escapism, pure and simple — a great book for the beach or for a long car trip.


Next, we'll take a look at Personal Ads by Robbi Sommers. This collection of short stories all begin with a classified ad and then proceed to tell the story behind the ad. The stories are mostly erotic in nature, with a little ghost-type fantasy thrown in for good measure.

An erotic fiction writer looks for someone to help bring the characters in her stories to life. A three-way sexual encounter begins with the purchase of red, rhinestone, high-heeled pumps. An uptight executive seeks sexual release in a company elevator. A woman finds a lost diary and discovers some very erotic writing, as well as some surprising news about her ex-lover.

Ms. Sommers' books usually concentrate on the purely sexual, and her erotic writings have improved greatly since her first book (Pleasures). However, it is this reviewer's opinion that her true talent lies in the writing of fantasy (Uncertain Companions). Included in Personal Ads is the story of a artist who agrees to house sit for a month in a remote cottage. The ghostly direction this story takes is frightening

and sensual all at the same time — making it the best story in the book.

willingly into the flame.




