

A cheerful note from the Connecticut State Medical Journal: one out of eight doctors dying between 1940 and 1953 were in debt at the time of death . . . The statement is based on a survey of 144 probate cases conducted by the Hartford County Medical Society . . . One out of three left less than \$10,000 and one out of two left less than \$25,000 . . . Of those who did leave sizeable estate (\$25,000 or more,) virtually all had their peak production between 1920 and 1933, years of small income taxes . . . It makes an interesting commentary on the popular public belief that all doctors are rich . . . Another interesting finding: one doctor out of three died without leaving a will . . . Our thanks to the ladies of the Auxiliary and the Medical Assistants Society for staffing the Tulsa County Medical Society booths at the Tulsa State Fair last month . . . Visitors to the Fair carried away nearly 10,000 pieces of useful literature distributed at the Society booth . . . The Bulletin winds out twenty years of publication next month . . . The first issue had eight pages, one of which was blank, and was edited by Dr. David V. Hudson . . . Special features of the first issue were an editorial by Dr. Russell C. Pigford, then President of the Society, and a biography of the Society's first President in 1907, Dr. W. Albert Cook . . . Druggist Orville L. Prather and his Medical Arts Prescription Shop advertised in the first issue, and be it said that in twenty years he has not missed advertising in a single issue . . . A folder from the Royal Sabina Airlines of Belgium announces a Medical Tour of South Africa, limited to 35 doctors, and leaving New York on December 31st . . . Group will visit South African medical centers, see the sights, and even do some big game hunting . . . Just \$4,600 per person plus laundry, entertainment, and fare to and from New York . . . Medco Products' Mark DeGroff of Tulsa is organizing a nationwide association of doctors who fly . . . The group will have its first meeting in Florida next month.

FOUNDERS DAY CLINIC ON NOVEMBER

Four Visiting Distinguished Guest Speakers Set for One-Day Postgraduate Study Event. Seven Papers To Be Featured. Heavy Attendance Expected.

Several hundred area doctors are expected to attend the Tulsa County Medical Society's Second Annual Founders Day Clinic to be held Thursday, November 18, 1954, at the Blue Cross-Blue Shield Building, 1215 South Boulder, Tulsa.

Headlining the one-day postgraduate study course are four visiting distinguished guest speakers who will present seven formal papers. They are:

George E. Burch, M.D., Chairman of the Department of Medicine, Tulane University Medical School, New Orleans, Louisiana.

Sergei Feitelberg, M.D., Director of the Department of Physics, Mount Sinai Hospital, and Associate Professor of Radiology, Columbia University College of Physicians and Surgeons, New York, N. Y.

Richard H. Freyberg, M.D., Associate Professor of Medicine, Cornell University School of Medicine, New York, N.Y.

Elmer Hess, M.D., President-Elect of the American Medical Association, and nationally known urologist of Erie, Pennsylvania.

There will be no registration fee and all medical doctors are invited to attend. Luncheon will be \$2.50. Advance reservations are requested, and tickets may be purchased from the Executive Offices of the Tulsa County Medical Society, or from Dr. Wilkie D. Hoover, Dr. Earl I. Mulmed, Dr. Marshall O. Dr. Burch's morning lecture will be designated the Dr. W. Albert Cook Lecture, honoring the first President of the Tulsa County Medical Society in 1907. Dr. Cook will be an honor guest. This annual recognition of his contributions to the Society was created last year by action of the Board of Trustees.

"This is a very fine program featuring some of the most distinguished of American doctors," Dr. Earl I. Mulmed, Chairman of the Postgraduate Study Committee, said last month, "and it is our hope that the event will be attended by every member of the Society and by as many area doctors as possible."

Dr. George E. Burch is a graduate of Tulane University School of Medicine, Class of 1933. He interned at Charity Hospital, New Orleans, and was subsequently a fellow in cardiovascular research at the Hospital of the Rockefeller Institute for Medical Research. He has been a member of the staff of Tulane since 1934, excluding the time spent at the Rockefeller Institute, and in 1947 was named as Henderson Professor and Chairman of the Department of Medicine. He is an editor of the American Journal of Medical Sciences, and a member of the editorial board of the A.M.A. Archives of Internal Medicine, Circulation, and G. P. He is author or co-author of seven textbooks in the field of cardiology and

has published 140 other scientific articles and essays. Dr. Burch is a member of the Board of Directors of the American Heart Association, President of the Southern Society for Clinical Research, Vice-President of the American Society for Clinical Investigation, fellow of the American College of Physicians, diplomate of the American Board of Internal Medicine, and member of seventeen other medical organizations including several in South America. Now a consultant in cardiovascular diseases to the Ochsner Clinic, he is one of America's best known cardiologists.

Dr. Sergei Feitelberg has been described as "one of the world's best informed scientists on atomic medicine." an appellation he justly deserves. He is a graduate of the University of Lausanne Medical School in Switzerland, Class of 1938. In 1939 he joined the staff of Mount Sinai Hospital, New York, N. Y., to do research on pharmacology of the central nervous system. Since 1947 he has been in charge of radioisotope therapy and research, and since 1951 has been Director of the Department of Physics at Mount Sinai. Dr. Feitelberg is now Associate Professor of Radiology at Columbia University College of Physicians and Surgeons, and a member of numerous medical organizations. His research in the field of radioactive isotopes in medicine has won him international recognition.

Dr. Richard H. Freyberg is a former President of the American Rheumatism Foundation and widely known for his studies in the field of rheumatology. A graduate of the University of Michigan Medical School, Class of 1930, he also interned at the University of Michigan Hospital and in 1932 joined the faculty of his alma mater as an instructor in Medicine. From 1934 to 1944 he served as Director of the Rackham Arthritis Research Unit at the University of Michigan School of Medicine. In 1944 he was appointed to his present post as Associate Professor of Medicine at Cornell University Medical School, New York, N. Y. He is now Director of the Department of Internal Medicine and Director of Arth-

From time to time there have been rumors of a third major hospital to be constructed in Tulsa. While not all Tulsa doctors share my view, I believe this would be desirable and beneficial to the community. At the same time, I feel that a third hospital would not affect the progress or success of either Hillcrest Medical Center or St. John's Hospital. Both of these institutions, following completion of their present expansion programs, will have reached a size which is probably a point of greatest economic and efficient administration. Further expansions may pose so many new administrative problems as to impair the quality of patient care and possibly increase its cost to the patient. The pattern of progress for these two hospitals should not be towards mere size. A more important goal is that of a maximum efficiency in economical and complete hospital care.

It has been estimated that Tulsa now lacks 425 beds of reaching a desirable level of hospital bed facilities. A third hospital would create a new margin of community safety. At the same time it would permit further growth of Tulsa as a medical center by accommodating hundreds of additional area patients referred to our qualified specialists. Such a hospital could conceivably provide the needed facilities for our indigent patients and for colored patients under the care of both white and colored physicians. A third hospital would, I believe, provide a means of alleviating some of the problems which are now besetting our professional staffs and leading to friction within the Tulsa profession. It would provide new opportunities to many qualified doctors and would accommodate the annual influx of new physicians. I feel the Tulsa County Medical Society would do well to give active support to any reliable organization seeking to build a third hospital in Tulsa. Such hospital growth should be part and parcel of our traditional pattern of progress in Tulsa.



PHILADELPHIA SURGEON TO SPEAK HERE NOVEMBER 8TH

Dr. Robert P. Glover, Chief of Thoracic and Cardiac Surgery at Episcopal, Presbyterian and St. Christopher's Hospital for Children, Philadelphia, Pennsylvania, will be guest speaker for the Tulsa County Medical Society on Monday, November 8, 1954. His subject will be "The Present Status of Surgery for Stenotic Valvular Heart Disease."

A special call meeting of the Society has also been scheduled for Monday, November 29, 1954, at 8:00 P.M., for a program devoted to the medical organization of Civil Defense. Captain Carroll P. Hungate of Olathe, Kansas, Chairman of the Medical Division of the Missouri State Civil Defense Agency, will discuss "The Medical Aspects of Civil Defense." Dr. Hungate is one of the best known authorities on Civil Defense in the United States and has participated in many national meetings of Civil Defense authorities. He will be introduced by Dr. Gifford H. Henry, Chairman of the Medical Division of Tulsa Civil Defense.

Both meetings will be held in the auditorium of the new Blue Cross-Blue Shield Building at 1215 South Boulder. By formal action taken at the October meeting, the Society voted to hold all meetings at the Blue Cross-Blue Shield Building until further notice. Doctors may use the two parking lots on both the North and South sides of the Building, including the spaces marked as reserved, and telephone service is available by calling 5-9149.

One of the best known of American cardiac surgeons, Dr. Robert P. Glover is presently Clinical Professor of Surgery at Hahnemann Medical College and Hospital, Philadelphia. He is a graduate of the University of Pennsylvania School of Medicine, Class of 1939, and interned at Germantown Hospital of Philadelphia for two years. Subsequently he served a five year surgical residency at the Mayo Clinic and did special postgraduate work for one year at the University of Minnesota School of Medicine. He entered private practice at Philadelphia in 1947 and limited himself to Thoracic and Cardiac Surgery. Dr. Glover is a diplomate of the American Board of Surgery and of the American Board of Thoracic Surgery, a member of the American Association for Thoracic Surgery, American College of Chest Physicians, and numerous other medical organizations.

Dr. Glover's scientific research has included studies of retrograde lymphatic spread of carcinoma of the rectosigmoid region, experimentation in the development of the surgery of septal defects, investigation of a modified rock procedure for infundibular pulmonary stenosis, and original investigations on the use of streptomycin, particularly in association with resection for tuberculosis. He is the author of numerous medical articles published in leading journals. His more recent publications have been in the field of stenotic valvular surgery, a field which he pioneered with his partner, Dr. Thomas J. E. O'Neill.

The final meeting of the vear will be held on Monday, December 13, 1954, with the program devoted to the election of officers and other business matters.



SCOPE OF ENDOCRINOLOGY TEXTBOOKS BEING BROADENED

Almost all books on endocrinology have been written with the internist in mind, but in very recent years the objectives have been enlarged to include specialists in other fields. The Library of the Tulsa County Medical Society has on its shelves two titles which illustrate this broadened scope.

One of these is Hormonal and Neurogenic Cardiovascular Disorders; Endocrine and Neuroendocrine Factors in Pathogenesis and Treatment, by Wilhelm Raab, M.D., Professor of Experimental Medicine and Head of the Cardiovascular Research Unit, University of Vermont School of Medicine. The author states at the beginning that the purpose of two separate fields of Medicine, namely of Endocrinology and Cardio-Angiology." He has arranged the subject matter in three main sections:

- Experimental cardiovascular effects of hormones and neurophormones.
 Cardiovascular features in endocrine and neuroendocrine syndromes.
 Endocrine and neuroendocrine factors in cardiovascular syndromes.

On Page 524 he states that "regardless of the problematic character of many of the factual details and interpretations presented in this book, there emerge a few basic principles which can be assumed to constitute the essence of neuroendocrine and endocrine participation in the origin of cardiovascular pathology of various types." And on Page 525: "Some timehonored but out-dated factors are no longer tenable-telelogical auxiliary hypotheses are becoming increasingly superflous and should be discarded."

There are many cross references and an unusually lengthy bibliography. The volume contains 722 pages with 88 illustrations and is published by the Williams and Wilkins Company, Baltimore, Maryland, 1953.

A second volume that shows this trend is a short monograph, Surgery and the Endocrine System, by James D. Hardy, M.D., Assistant Professor of Surgery, University of Ten-nessee Medical College, and which carries the sub title "Physiologic Response to Surgical Trauma-Operative Management of Endocrine Dysfunction.'

This little volume extends the study of endocrinology into the field of surgery as well as into the field of internal medicine. It was published by W. B. Saunders Company, Philadelphia, in 1952.

An excellent review of this book was written by Dr. Richard E. McDowell and was published in the Journal of the Oklahoma State Medical Association, 45:335 (September) 1952. In closing he says that "The practical nature and the importance to the patient of the material presented in the text, plus the clarity with which it is presented, make Dr. Hardy's book required reading for every surgeon and every internist-in fact, for every physician.'


Policyholders will now pay their pre-

ST. JOHN'S HOSPITAL PLANS NEW PARKING STRUCTURE

Plans for the construction of a huge two deck parking facility to accommodate 225 cars were announced last month by St. John's Hospital of Tulsa. The structure will be located east and south of the Hospital in the area now utilized for a garden and recreational yard.

With construction scheduled to begin about November 1st, the parking unit will provide approximately 72,000 square feet of parking space. The ground floor will accommodate 100 automobiles and the top floor 125. The entrance and exit will be on 21st street directly across from Utica Square. The new unit is designed for the use of visitors to the Hospital and will relieve a critical parking situation which now exists at virtually all times.

The bottom floor will contain a small office, restrooms, and quarters for the guard. The second floor will be equipped with floodlights and a steel railing. Leon Senter is the architect for the new facility.

The cost of the project was not an-



nounced, but it is part of a new \$3,500,000 expansion program at the Hospital, which will include a new wing and special laundry and kitchen construction. The laundry expansion will add 1,770 square feet to the present building. Three more large tubs, an extractor, and a new mangle will be installed to augment the present equipment.

LONG BEFORE HOT FLUSHES APPEAR ...

Patients presenting such classic menopausal symptoms as hot flushes cause little diagnostic difficulty. However, throughout the period of declining ovarian function which may begin long before hot flushes appear, many women complain of distressing symptoms which though less clearly defined are actually due to estrogen deficiency. For example, insomnia, headache, easy fatigability, and symptoms affecting the bones, joints, and the skin may not be readily identified as due to estrogen deficiency because they may occur years before, or even years after cessation of menstruation.

Investigators^{1,2} have found that as the body attempts to adjust itself to declining estrogen production, a number of symptoms may appear which call for the prompt institution of estrogen replacement therapy. These symptoms may be nervous, circulatory, arthralgic, or dermatologic in character because the loss of ovarian hormone "withdraws one of the most important regulators of the organism"³ and affects many body functions. The Tulsa County Red Cross Blood Center will begin its Second Annual Class of Donor Room Nurses on November 2nd with an anticipated enrollment of twelve. The class is trained in methods of blood taking as a reserve auxiliary donor room staff in times of emergency. Last year's class was composed of thirteen registered nurses.

After two splendid replacement records in July and August, most Tulsa hospitals declined sharply in September. Hillcrest Medical Center, after an amazing 101.7% in August, fell to 30.6% in September. St. John's Hospital, largest user of blood, fell from 76.8% in August to 60.1% in September. Further declines were noticed in October. Dr. Felix R. Park, Chairman of the Red Cross Blood Center Committee, last month urged physicians not to slacken efforts to have blood given to their patients replaced.

A contributor to a public forum column of a Tulsa newspaper last month asserted irresponsibly that blood secured from the Tulsa County Red Cross Blood Center must be paid for if not replaced. Doctors' should note that there is no charge for blood, regardless of whether or not it is replaced, and there are no replacement requirements such as twofor-one, etc. Blood should be replaced insofar as possible, but no charge is ever made. A charge of \$10.00 for laboratory procedures is made. The blood itself is free. Any evidence of a charge being made for blood should be called to the attention of the Blood Center.

Dr. Freyberg is a member of the Board of Directors and Executive Committee of the Arthritis and Rheumatism Foundation of America, fellow of the American College of Physicians, diplomate of the American Board of Internal Medicine, and member of numerous medical organizations. His studies in rheumatology have been widely published in leading scientific journals.

Dr. Elmer Hess is a graduate of the University of Pennsylvania School of Medicine, Class of 1911. After a distinguished career in World War I which saw him decorated with the Croix de Guerre and other honors, he did postgraduate study in Urology at Johns Hopkins University, and since 1922 has practiced at Erie, Pennsylvania. He is a pastpresident of the American Urology Association, member of the American College of Surgeons, diplomate of the American Board of Urology, fellow of the International College of Surgeons, and member of numerous professional organizations. A leader in medical circles in Pennsylvania, he rose through various posts to the Board of Trustees of the American Medical Association, and since 1937 has been a devoted leader in A.M.A. activities. 
