The State Board of Education was called to order at 2:45 P. M. Tuesday afternoon, July 25th, by President R. H. Wilson. Those present were Mr. Wilson, Mr. Glen, Mr. Brandenburg, and Mr. Scott.

On motion by Mr. Brandenburg, seconded by Mr. Scott, President Kurdaugh was authorized to find a suitable man for the work in Manual Training at the Southeastern State Normal School at Durant.

All voted aye.

On motion by Mr. Glen, seconded by Mr. Brandenburg, President Kurdaugh's recommendation of Miss Ruth Voorhees Atkinson, as Instructor in Physiology and Director of Physical Training for Girls in the Southeastern State Normal School at a salary of \$900.00 per annum, was accepted and Miss Atkinson was elected.

On motion by Mr. Brandenburg, seconded by Mr. Glen, President Kurdaugh was authorized by the Board of Education to proceed according to the regular form in the matter of expenditure for equipment for the Southeastern State Normal School as laid down in his recommendation for such and filed with the State Board of Education on the 25th day of July, 1911.


All voted aye.
