On motion by Mr. Ralls seconded by Mr. Campbell, the Secretary was instructed to write to Mr. Gardner that in advertisements and letter-heads of the State Home that no pictures purporting to be inmates of the institution should be used unless the originals of such pictures are actually children committed to the Home. All voted aye.

Recommendations were presented from Pres. G. W. Austin of the Oklahoma College for Women as follows:

First, that Julia Brekke be elected Assistant in the Domestic Science Department at a salary of \$800.00 per annum;

Second, that the salary of Okla Wood, Assistant in Science, be raised from \$900. to \$1000. per annum.

On motion by Dr. Fite seconded by Mr. Ralls, Pres. Austin's recommendations were approved. All voted aye.

On motion by Dr. Fite seconded by Mr. Shepler, Supt. O. W. Stewart of the School for the Blind was authorized to attend the meeting of the Association of Instructors of the Blind at Halifax, Nova Scotia, in July, Supt. Stewart's expenses to be paid by the state.

(2) That the Superintendent of the School be given time to locate a suitable person to teach Sewing and Handicraft to the girls;

(3) That the employing of such help as Cook, Janitor, Nightwatchman, and dining room maids be left to the Superintendent, the maids to receive from \$4.00 to \$5.00 a week for services, with Cook and Janitor and Nightwatchman to receive from \$12.00 to \$15.00 per week each.

On motion by Mr. Ralls seconded by Dr. Fite, Supt. Stewart's recommendations were approved. All voted aye.

Recommendations of Pres. G. W. Gable of the Northeastern State Normal were presented as follows:

(1) That the President of the Northeastern State Normal be authorized to employ two substitutes for the instructors assigned from the Oklahoma College for Women, such substitutes to serve until the arrival of these instructors and to receive a salary of not to exceed \$25.00 per week each.

(2) That leaves of absence be granted to Wright A. Gardner, Instructor in Biological Sciences, and A. K. Gosson, Instructor in Physics, for study on full pay for the summer term of 1916, and that I. H. Needham be elected as substitute for Mr. Gardner and Hogan Markam be elected as substitute for Mr. Gosson at a salary of \$25.00 per week each.

On motion by Mr. Ralls seconded by Mr. Sandlin, Pres. Eskridge's nominations were approved, except as to Rolla G. Sears, and the Secretary was instructed to notify Pres. Eskridge that Mr. Sears had been elected to and accepted his present position in the East Central State Normal School at Ada. All voted aye.

Communication was presented from Pres. G. W. Gable requesting permission to attend the N. E. A. Meeting in New York City on July the 1st to 8th, and that he be allowed railroad expenses for such trip. On motion by Mr. Ralls seconded by Mr. Campbell, the request was dis-approved and the Secretary was instructed to notify Pres. Gable that it is the sense of the State Board of Education that the summer term is the most important period of the school year and the presence of the President of the institution is deemed essential at that time.

Pres. Stratton D. Brooks of the University of Oklahoma appeared before the Board and presented the following:

1 - (299) I recommend that the title of Lucien Quitman Campbell be changed from that of Assistant in English, and Debating Coach, to that of Instructor in English and Public Speaking.

2 - (300) I recommend that the action taken April 29th, fixing the salary of E. Marie Anderson, for the school year beginning September 1, 1916 at \$500.00 and fees, be rescinded and instead thereof the salary be fixed at \$600.00 per year and all fees collected for private lessons.

This recommendation is made on account of assigning additional classes to Miss Anderson.

3 - (301) I recommend that the salary of Miss Addie Maloy be fixed for the months of July and August, 1916, at the rate of \$133.33 per month.

4 - (302) Subject to your approval I have appointed Miss Lottie Bohrer Instructor in the summer school for the months of July and August at a salary of \$60.00 per month.

5 - (303) Subject to your approval I have appointed Miss Agnes Berrigan, Special Instructor in the Summer School at a salary of \$100.00 per month for the months of July and August.

Upon the recommendation of Pres. Grant B. Grumbine, leave of absence for the purpose of study was granted to Blanche V. Bussey, Critic Teacher at the Northwestern State Normal, for the summer term on full pay, on motion by Mr. Sandlin seconded by Mr. Ralls. All voted aye.

Communication was presented from Pres. Grumbine of the North-western State Normal concerning the lack of funds to pay Miss Cora Farrell, Penmanship Teacher assigned to that institution by the Board. On motion by Mr. Ralls seconded by Mr. Campbell, Miss Farrell was transferred to the McAlester Branch of the Southeastern State Normal School as Instructor in Penmanship.

Whereas, it has been established that certain boys hereinafter named, now confined in the State Training School, have reformed to such an extent that their release will not be incompatible with the welfare of society nor detrimental to their own good, and they will not violate the law,

Be it therefore resolved by the State Board of Education that there be discharged from the State Training School the following named boys:

On motion by Mr. Ralls seconded by Dr. Fite, the resolution was adopted. All voting aye.

On motion by Mr. Ralls seconded by Dr. Fite, the salary of J. G. March as teacher in the State Training School at Pauls Valley was fixed at \$1200. per annum to begin July 1, 1916, and the salary of Mrs. J. G. March, Assistant teacher in the same institution was fixed at \$600.00 per annum beginning July 1st. All voted aye.

On motion by Mr. Ralls seconded by Mr. Sandlin, the Superintendent of the Training School at Pauls Valley was instructed to re-establish the separate dining room for officers, employees and the nurse at that institution, and to arrange for the presence of two officers at each meal in the boys' dining room, which duty is to be alternated among the officers. All voted aye.

On motion by Mr. Ralls seconded by Mr. Sandlin, it was the sense of the State Board of Education that greater care should be taken at the State Training School with reference to the general appearance of the inmates thereof, and the Superintendent was instructed, first, that the inmates' hair be cut at least once a month; second, that the boys be required to take regular baths on Saturday and Wednesday; third, that the boys be required to be clean and have their clothes in good condition on the days they attend school; fourth, that attention be paid to the condition of their shoes and stockings and that the shoes be furnished with shoe strings and polished occasionally; fifth, that clean towels be provided; and sixth, that a feeling of self-respect be instilled in the boys through the improvement of their personal appearance.

All voted aye.

Communication was presented from Pres. J. M. Marquess transmitting a check for \$42.37 covering rebate on insurance policy. On motion the check was ordered deposited with the State Treasurer to the credit of the C. A. and N. University.

On motion by Mr. Ralls seconded by Mr. Sandlin, the Supreme Court of Oklahoma was requested to appoint a committee of competent lawyers to assist in conducting an examination of the candidates for graduation from the Law School of the University of Oklahoma in order that such candidates may not be required to take the regular bar examination but may be admitted upon motion.

Motion carried.

Communication from E. S. Blackburn, Mayor of Edmond; and J. F. Baldwin, City Clerk, was read. The Secretary was instructed to write to Mr. Blackburn that he should make out a bill for the damages done in the City Hall of Edmond by the students of the Central State Normal School and present the same to Pres. Evans for adjustment.

Moved by Mr. Ralls seconded by Mr. Hill, that the Secretary of the Board write to Edgar Rippey of the University Preparatory School and ask him if he carried a pistol to the school, as has been reported to the Board.

Motion carried.

On motion by Mr. Sandlin seconded by Mr. Wilson, Claude Reeds was re-elected Director of Athletics and Physical Education at the Southwestern State Normal School at Weatherford at a salary of \$1200.00 per annum, beginning September 1st.

On motion by Mr. Sandlin seconded by Mr. Shepler, F. Park Geyer was elected Director of Athletics and Physical Education at the Northwestern State Normal School at Alva, at a salary of \$1200.00 per annum.

All voted aye.

On motion by Mr. Ralls seconded by Mr. Shepler, that all colleges organized and operating under the laws of Oklahoma desiring the State Board of Education to approve their courses of study in order that the graduates of such colleges may be granted state life certificates, under Chapter 66 of the Session Laws of 1915, shall submit their course of study with a statement showing the number, names and qualifications of their faculty; the salary paid each; the number of pupils in each class, the complete enrollment of the institution by collegiate years, a complete description of the character and value of the equipment, buildings, library, etc. Motion carried.

On motion by Mr. Sandlin seconded by Mr. Hill, the faculty of the Central State Normal School was elected for the year beginning September 1, 1916 as follows:

Pres. J. M. Marquess of the C. A. and N. University appeared before the Board and spoke concerning the election of the faculty of the C. A. and N. University for the next scholastic year.

On motion by Mr. Ralls seconded by Dr. Fite, the positions of all instructors and employees in the C. A. and N. University were declared vacant to take effect September 1, 1916.




