The minutes of the meeting of the State Board of Education on Merch 28th and 29th were presented and approved.

Pres. G. W. Austin of the Oklahoma College for Women appeared before the Board and presented his recommendations for the year 1917-18. President Austin also spoke concerning the progress of the institution and the policies which he desired adopted for the coming year.

On motion by Mr. Hill, seconded by Mr. Ralls, leave of absence, without pay, beginning September the first, 1917, was granted to Maxie Woodring, Instructor in Language in the Oklahoma College for Women.

The Board then proceeded to consider Pres. Austin's recommendations for the faculty of the Oklahoma College for Women for 1917-18.

MINUTES OF THE MEETING OF THE STATE BOARD OF EDUCATION
Monday Afternoon, April 23, 1917.

The following resolutions were presented by Mr. Wilson:

- WHEREAS, there is no appropriation for the continuance of the Oklahoma School of Mines and Metallurgy at Wilburton, during the next biennial period, and
- WHEREAS, an appropriation has been made for carrying on extension work with the miners, and
- WHEREAS, it is the desire of the State Board of Education that the extension work among the miners shell in no wise deteriorate on account of the discontinuance of the Oklahoma School of Mines, but that the work shall be conducted in a manner which shall make it most highly valuable to the geological and mining interests of the State;

THEREFORE, BE IT RESOLVED, that the State Board of Education request the University of Oklahoma, through its Department of Geology to take charge of said extension work, and all services in connection therewith to be performed without additional compensation to anyone or additional expense to the State; and pursuant to this plan that we invite President Stratton D. Brooks and Professor M.G.Mehl, Head of the Geological Department of the State University, to be present at the next regular meeting of the State Board of Education and present plans for the continuation of this extension work.

- WHEREAS, there is no appropriation for the maintenance of the University Preparatory School at Tonkawa during the next biennial period, and
- WHEREAS, the buildings, equipment and other property belonging to the State will necessarily need care and attention in order to keep them in a good state of preservation, and
- WHEREAS, the City of Tonkawa has no high school building for the maintenance of the high school in that community, and the time for the erecting of such building is not sufficient to raise money and erect buildings necessary to equip a high school, and
- WHEREAS, it is the desire of the State Board of Education to cooperate to the fullest extent possible in assisting the people of Tonkawa in maintaining a high school, and
- WHEREAS, the Tonkawa City Board of Education has expressed a desire to be allowed the use of such buildings and equipment for the purpose of maintaining a high school at Tonkawa;
- THEREFORE, BE IT RESOLVED that the State Board of Education grant to the City of Tonkawa for the consideration of \$1.00 per annum, for the biennial period beginning July 1, 1917, the full use and benefit of the grounds, buildings and equipment heretofore used for the conducting of the University Preparatory School, and that the City of Tonkawa through the offices of its Board of Education keep said premises, buildings and equipment insured against loss by fire and tornado, and to keep them in good repair, thus saving the state the expense of upkeep and necessary insurance that may be occasioned because of such property standing vacant.

BE IT FURTHER RESOLVED that the President and Secretary of the State Board of Education are hereby authorized to take such steps as may be necessary on the part of the State Board of Education in granting said lease to the City Board of Education of Tonkawa.

- WHEREAS, there is no appropriation for the maintenance of the Eastern University Preparatory School during the next biennial period, and
- WHEREAS, the buildings, equipment and other property belonging to the State will necessarily need care and attention in order to keep them in a good state of preservation, and
- WHEREAS, the City of Claremore has no high school building for maintenance of the high school in that community, and the time for the erecting of such building is not sufficient to raise money and erect buildings necessary to equip a high school, and
- WHEREAS, the Claremore City Board of Education has expressed a desire to be allowed the use of such buildings and equipment for the purpose of maintaining a high school at Claremore;
- THEREFORE, BE IT RESOLVED that the State Board of Education grant to the City of Claremore for the consideration of \$1.00 per annum, for the biennial period beginning July 1, 1917, the full use and benefit of the grounds, buildings and equipment heretofore used for the conducting of the Eastern University Preparatory School, and that the City of Claremore through the office of its Board of Education keep said premises, buildings and equipment insured against loss by fire and tornado, and to keep them in good repair, thus saving the state the expense of up-keep and necessary insurance that may be occasioned because of such property standing vacant.
- BE IT FURTHER RESOLVED that the President and Secretary of the State Board of Education are hereby authorized to take such steps as may be necessary on the part of the State Board of Education in granting said lease to the City Board of Education of Claremore.

On motion by Mr. Ralls, seconded by Dr. Fite, a requisition for repairing the Water tank at the School of Mines, at a cost not to exceed \$20.00, was approved.

Motion carried, Mr. Wilson voting no.

President Austin again appeared before the Board and presented the following recommendations:

1. That the request made on March 26th, in a communication to Mr. G. W. Austin, President of the Oklahoma College for Women, by Miss Anne Wade O'Neill, head teacher of the History Department of the Oklahoma College for Women, be granted and that the regulations governing the question of Sabbatical Absence now in force in the University of Oklahoma apply in this case.

On motion by Mr. Ralls, seconded by Mr. Sandlin, Anne Wade O'Neill was re-elected head of the History Department at the Oklahoma College for Women and Miss O'Neill's request made on March 26th in a communication to Pres. G.W. Austin asking for a leave of absence beginning September 1st, 1917, on half pay under the regulations governing the sabbatical leave now in force in the University of Oklahoma for the purpose of completing the course of some standard college in order that the Oklahoma College for Women may meet the standards of the North Central Association of Colleges was granted.

. Motion carried.

2. That all teachers who are re-elected to positions on the faculty of the Oklahoma College for Women for 1917-18 at a salary of \$900.00 or more, who have not A.M. degrees be required to spend at least ten weeks during this coming summer in study in some leading University or institution and that they be required to take the usual number of hours work that is done by the average student in said institution, and that each teacher be required to file in the office of the President of the Oklahoma College for Women not later than September 1st, 1917, a report made out by the Registrar of the institution in which the teacher may study, giving a complete record of all work done. In the event any teacher fails to comply with these recommendations, such teacher agrees to forfeit the salary for two months.

Approved on motion by Mr. Sandlin, seconded by Dr. Fite, Mr. Ralls voting no.

3. That the following table of expenses be approved as a conservative estimate of essential expenses during the year 1917-18:

Room and board, payable monthly in advance, approximately \$18.00 per month First month's room and board - - - - - - - - 21.25

Free transportation on the street car to and from church each Sunday morning is given to each girl in the boarding department during the first semester, and a ticket given each girl that will entitle her to admission to all lyceum courses during the entire year.

Laundry, approximately - - - - - - - - - - - - - - \$18.00 per year Books and stationery, approximately - - - - - - - - - 155000 " "

A fee of fifty cents per hour is charged those who use the college piano for practice purposes.

A fee of \$2.50 per semester is charged in all Home Economics courses and must be paid in advance.

A monthly fee of fifty cents is charged those who use the college typewriters for practice purposes.

A library charge of fifty cents will be made against every student who enrolls in order to have a fund to replace losses.

No deduction in board will be made for absence of less than two weeks and then only when absence is necessary. The board must be paid monthly in advance.

The service and comforts of the Nellie Sparks Hall and first class. Because of the uncertain conditions of the market of all food supplies, the State Board of Education reserves the right to increase the board at any time circumstances demand it.

Tuition is free. According to Section 12, of the law by which the College was established, all white female citizens of Oklahoma between the ages of twelve and thirty-five, who are known to possess a good moral character, may be admitted to all the privileges of the institution.

Non-resident students of the State of Oklahoma will be charged the tuition fee of \$20.00 per year. The same rate is charged for each special.

One dollar will be added to each fee that is not paid during the two weeks after the beginning of each semester.

Communication was presented from Supt. A. K. Gossam concerning the number of immates that could be cared for at the State Training School.

That the State Normal Schools of Oklahoma, their Presidents, faculties, and employees confine their activities, looking toward the procuring of students and increasing of attendance of said schools, to the following territory:

Northeastern State Normal School, located at Tahlequah, the following counties: Adair, Cherokee, Craig, Delaware, Haakell, Mayes, Muskogee, Nowata, Ottawa, Sequoyah, Tulsa, Washington, Wagoner, Rogers, Osage.

Southeastern State Normal School, located at Durant, the following counties: Atoka, Bryan, Choctaw, Love, Latimer, LeFipre, Marshall, McCurtain, Pittsburg, Pushmataha, McIntosh, Carter.

Hast Central State Normal School, located at Ada, the following counties: Coal, Garvin, Hughes, Johnston, McClain, Murray, Pontotoc, Pottawatomie, Okruskee, Okmulgee. Seminole.

Northwestern State Normal School, located at Alva, the following counties: Alfalfa, Beaver, Blaine, Cimarron, Ellis, Gerfield, Grant, Harper, Texas, Woods, Woodward. Major.

Southwestern State Normal School, located at Weatherford, the following counties: Beckham, Caddo, Comanche, Cotton, Custer, Dewey, Greer, Harmon, Jackson, Kiowa, Roger Mills, Tillman, Washita.

Central State Normal School, located at Edmond, the following counties: Canadian, Cleveland, Creek, Grady, Jefferson, Kay, Kingfisher, Lincoln, Logan, Noble, Oklahoma, Payne, Pawnee, Stephens,

## BE IT FURTHER RULED BY THE STATE BOARD OF EDUCATION:

That no normal school shall be permitted to advertise or distribute its literature, advertisement or school publications outside of the counties above designated as being tributary to said school except upon request of those desiring information regarding such normal school.

That no Normal School President, or member of his faculty, shall accept invitations to deliver educational addresses or otherwise visit educational gatherings outside of the counties included within his respective district, except after having advised the President of the Normal School of such other district of his proposed visit and its purpose.

No Normal School President shall nominate as a special instructor in the summer school faculty, any teacher from another normal school district or territory, until he shall have advised the President of the Normal School of the district from which he proposes to nominate such faculty member, and in said nomination shall state fully his reasons.

The purpose of this rule being to the end that each of the six State Normal Schools may work together without friction and to promote the general welfare of education and the training of

teachers in this State, provided, however, that any Normal School may send literature, school publications, etc., to former students and graduates outside territory set forth above.

On motion by Mr. Ralls, seconded by Dr. Fite, the resolution was adopted. The Board recessed until Tuesday morning at 9 o'clock.

MINUTES OF THE MEETING OF THE STATE BOARD OF EDUCATION
Tuesday Morning, April 24th, 1917.

President Stratton D. Brooks of the University of Oklahoma appeared before the Board and presented recommendations as follows:

1. (381) That the following salary schedule be adopted for application to the University of Oklahoma:

Assistants, \$700.00 to \$900.00, as fixed in each individual case;

Instructors, \$1000.00 first year, annual increase \$100.00 to a maximum of \$1300.00;

Vice-President and Deans, \$300.00 in addition to their schedule salary as professor;

the above schedule not to apply to the teachers in the Medical School at Oklahoma City, the Dean of the Law School, and to the teachers in the School of Fine Arts.

- 10. (390) I desire to report that the Legislature has appropriated \$700.00 for the purpose of continuing the investigation work of Mr. Joseph B. Thoburn, until June 30, 1917. This money has been placed to the credit of the University by the State Auditor.

I have, therefore, subject to your approval, appointed Joseph B. Thoburn, as special investigator in archaeology and local history, at a salary of \$125.00 per month, from April 1, 1917, to July 1, 1917.

I recommend that \$325.00 of this appropriation be apportioned for the purpose of paying for traveling, labor, and other necessary expenses involved in said investigation.
