MINUTES OF THE MEETING OF THE STATE BOARD OF EDUCATION.

Morning Session, June 27 and 28, 1917.

Members present: Messrs. Wilson, Brewer, Fite, Hill, Ralls, Sandlin and Shepler.

Minutes of the meeting of the State Board of Education on April 24th and 25th and May 15th; 16th and 17th were presented and considered.

Minutes of May 15th, 16th and 17th were approved as corrected.

Supt. A. K. Gossam of the State Training School appeared and presented the following matters relating to his Institution:

- 1. He recommended that Harry Blanford be granted a parole under the statutes providing for the issuance of paroles to the immates of the State Training School.
- 2. He recommended that the salary of the night watches at the State Training School be raised from \$25.00 to \$35.00 per month.

On motion by Mr. Sandlin, seconded by Mr. Brewer, recommendation was approved. All voted aye.

3. He requested that the Board establish a policy for the granting of vacations to the employees of the State Training School.

On motion by Mr. Sandlin, seconded by Dr. Fite, the Board authorized the President of the Board of Education and the Superintendent of the Training School to grant leaves of absence to employees of the State Training School for a period of not to exceed ten days on full pay at such times as the Superintendent of the Institution shall fix, provided that all such employees receiving vacations shall have served one year as an employee of the Training School.

Motion carried.

4. That he was not ready to nominate teachers for the Training School at this time.

On motion by Mr. Ralls, seconded by Dr. Fite, the Superintendent of the Training School was authorized to employ three teachers, a principal at not to exceed \$75.00 per month and two teachers whose total monthly salary for both shall not exceed \$100.00.

Motion carried.

On motion by Mr. Ralls, seconded by Mr. Brewer, the Superintendent of the Training School was instructed to investigate and report to the Board a feasible plan for planting an orchard and vineyard at the Training School.

Motion carried.

Judge Crook, Parole Officer, appeared and spoke concerning the matter of paroling and discharging immates from the State Training School. He stated that the Board of Education had full authority to parole or discharge immates of the training school under the statute of the state.

On motion by Mr. Brewer, seconded by Mr. Ralls, Harry Blanford was paroled and required to report to the Superintendent of the State Training School weekly. Motion carried, Mr. Shepler voting no.

Pres. Stratton D. Brooks appeared and presented the following recommendations

Lindsay, Financial Clerk of the University, was presented, and on motion the Secretary was instructed to notify this Company that it was not the policy of the State of Oklahoma to cancel surety bonds but that the State Examiner and Inspector would be requested to audit the accounts of Mr. Lindsay and a report of such audit would be furnished to the Company.

Attorney Kirby Fitspatrick appeared before the Board and spoke concerning the establishment of military training courses at the State Educational Institutions.

MINUTES OF THE MEETING OF THE STATE BOARD OF EDUCATION.

Afternoon Session, June 27th, 1917.

Members present: Messrs. Wilson, Brewer, Fite, Hill, Ralls, Sandlin and Shepler.

The Board proceeded to consider the application of the Oklahoma City University for authority to grant degrees under Senate Bill No. 381 passed by the last session of the Legislature. Committee of the faculty and the

students of this Institution appeared before the Board and the following spoke concerning the work of the Institution; courses offered, methods of instruction, class of students, the desirability of such a school, salaries paid, etc; W. R. Raylor, President; Chas. West, Robt. Burns, E. E. Gish, John F. Martin, W. L. T. Hartman, Messrs. Shields, Norris, and others, after which the committee retired.

Pres. G. W. Austin of the Oklahoma College for Women appeared and presented the following recommendations:

1. That all students who live in Chickasha and all students who board in the City be required to pay \$2.00 per year to the Student Activity Fund.

Approved on motion by Mr. Ralls, seconded by Mr. Shepler.

2. That any student who takes a degree from the Oklahoma College for Women and who completes the required 24 hours in Education be granted a life high school certificate.

Approved on motion by Dr. Fite, seconded by Mr. Brewer.

3. That Frances D. Davis, teacher of Expression, be given a leave of absence for one year without pay.

Approved on motion by Mr. Ralls, seconded by Dr. Fite.

4. That the resignation of Annie Smith, Teacher of Art in the Oklahoma College for Women, be accepted and that Nellie Shepard be elected as head of the Department of Art at a salary of \$1400.00 per annum.

Approved on motion by Mr. Ralls, seconded by Mr. Brewer.

5. That the resignation of Laura Finch, teacher of Domestic Art, be accepted.

Approved on motion by Mr. Ralls, seconded by Dr. Fite.

On motion by Mr. Sandlin, seconded by Mr. Hill, Caroline Laird was elected head of the Department of English in the Oklahoma College for Women at \$1400.00 per annum.

On motion by Mr. Sandlin, seconded by Mr. Hill, the salary of Edgar Cowan, Head of the Department of Science and Dean of the Oklahoma College for Women, was fixed at \$1800.00, Mr. Wilson voting no.

On motion by Mr. Sandlin, seconded by Mr. Hill, Jane H. Miller was elected head of Modern Languages in the Oklahoma College for Women at \$1400.00 per annum.

On motion by Mr. Sandlin, seconded by Mr. Hill, I. E. Mott was elected head of the Department of Education in the Oklahoma College for Women at \$1400.00.

On motion by Mr. Ralls, seconded by Dr. Fite, the salary of Zoe Norman, Head of the Domestic Science Department of the Oklahoma College for Women, was fixed at \$1500.00, Mr. Sandlin voting no.

On motion by Mr. Sandlin, seconded by Mr. Shepler, Pres. Austin was authorized to employ a Domestic Art teacher at a salary of less than \$1000.00 per annum.

Be it resolved by the State Board of Education that

WHEREAS the state owes a duty to every man of military age to give him at least the rudiments of a military education, and

WHEREAS the common schools in the state is the best agency for reaching all the people,

THEREFORE, the position of Commandant is hereby created for the purpose of giving such instruction in the first principles of military training to the common school teachers attending the summer schools in the year 1917, as will best fit them to train their pupils and also the young men of the surrounding community not in attendance at school;

That such Commandant operate in such summer ashool as in his judgment will afford the best field of service, taking into consideration the co-operation of the faculty and the student body and the number of teachers in attendance;

That such Commendant shall be a military man of good moral character and shall be paid as salary and expenses for the remainder of the summer term the sum of \$25.00 per week.

On motion by Mr. Ralls, seconded by Mr. Brewer, the resolution was adopted.

Recommendations of Pres. Gordon were presented as follows:

- 1. That Marian Kenny be elected Director of Physical Training and Adviser of Women in the East Central State Normal at a salary of \$1000.00 per annum.
- 2. That Iole Burks be elected Secretary of the East Central State
 Normal at \$1000.00 per annum.

On motion by Mr. Sandlin, seconded by Mr. Brewer, the recommendations were approved.

Presi Gordon's requisition for additional campus help at not to exceed \$50.00 per month for the months of July and August was presented.

On motion by Mr. Ralls, seconded by Mr. Sandlin, the requisition was allowed for \$25.00 for the months of July and August.

Claims for traveling expenses for the East Central State Normal were presented showing the rejection of the Auditor assigning for his reason that the claims were improper charges against the funds of the state.

On motion by Mr. Ralls, seconded by Mr. Shepler, the claims were referred to the Attorney General for his opinion as to whether they are legal charges.

Motion carried.

On motion by Mr. Ralls, seconded by Mr. Sandlin, the Secretary was instructed to notify the Waynoka Music Company of the next meeting of the Board at which time a hearing will be granted.

Recommendations for teachers and employees of the Institute for the Deaf, Blind and Colored Orphans at Taft were presented.

Upon motion by Mr. Ralls, seconded by Mr. Sandlin, action was deferred on the recommendations until the next meeting of the State Board of Education.

On motion by Mr. Ralls, seconded by Mr. Brewer, the recommendation was approved.

2. That Nelson Jones be elected as successor to Benj. P. Crampton as a mechanist at the C. A. & N. University at a salary of \$900.00 per year.

On motion by Mr. Ralls, seconded by Mr. Shelper, Nelson Jones was elected at \$70.00 per month.

3. That J. Wilson Pettus be elected head of the Normal Department at a salary of \$1200.00 per annum.

Approved on motion by Mr. Ralls, seconded by Mr. Shepler.

4. That Octavia C. Long be elected teacher of Languages.

On motion by Mr. Ralls, seconded by Mr. Shepler, Octavia C. Long was elected at \$1000.00 per annum.

5. That John Lampton be elected assistant in Pedagogy at a salary of \$900.00 per annum.

Approved on motion by Mr. Ralls, seconded by Mr. Shepler.

Report of the School of Mines was read and ordered filed.

Claim of Pres. Lynn Glover for \$12.50 for expenses incurred on a trip to Oklahoma City May 14-18, 1917, was, on motion, approved.

On motion by Mr. Sandlin, seconded by Mr. Hill, the following requisitions for the School of Mines were approved:

- 1. 500 reports and recommendations to the State Board of Education \$32.00
- 2. 10# red coloring, building paper, etc. - - - 5.05
- 3. Tamber - - 19.39

Applications for positions in the Extension Department of the School of Mines were presented.

Moved by Mr. Ralls that the Governor be notified that, in dealing with the extension work for the School of Mines, as it appears in Senate Bill No. 223, found on page 67 of the Session Laws of 1917, a provision after the itemized statement of the various sums, the following: Provided that said sum herein appropriated nor any part thereof shall be available until satisfactory evidence of title in the State of Oklahoma shall be presented to the Governor and by him approved and such approval filed in the office of the Secretary of State; and that the Board desires information as to whether or not this has been complied with and if not an opinion from the Attorney General is desired as to the legality of the Board's making provision for using the appropriations for the extension work without a compliance with the provise of the statute.

Motion seconded by Mr. Shepler. Carried.

Mr. Ralls introduced the following resolution; seconded by Dr. Fite:

WHEREAS, it has been the custom of the State Board of Education to employ teachers and employees for the State Schools for a period of one year commencing September 1st of each year and payable in twelve equal monthly payments and to employ the Presidents upon indefinite tenure, and

WHEREAS, these teachers and employees have already rendered to the state a full school year's service, and

WHEREAS, there are no appropriations for the State Schools at Tonkawa, Claremore, and Wilburton for the fiscal years 1917 and 1918,

BE IT THEREFORE RESOLVED, by the State Board of Education that the positions of all Presidents, teachers and employees for the said State Schools at Tonkawa, Claremore and Wilburton be declared vacant on the 30th day of June, 1917.

On roll call, the vote was as follows: Mr. Shepler, no; Mr. Whil, no; Mr. Ralls, aye; Mr. Brewer, aye; Dr. Fite, aye; Mr. Sandlin, no; Mr. Wilson, no.

The motion was declared lost.

The Board then proceeded to consider the plans of the auditoriums to be built at the University of Oklahoma and the Northeastern State Normal.

On motion by Mr. Ralls, seconded by Dr. Fite, the plans for the two buildings were approved.

All voted ave.

On motion by Mr. Ralls, seconded by Dr. Fite, the Board reconsidered the vote upon which the resolution concerning the payment of salaries for the instructors at the University Preparatory School at Tonkawa was lost.

All voted age.

Moved by Mr. Sandlin, seconded by Mr. Shepler, that the resolution as offered for the payment of salaries be adopted.

All voted ays.

Moved by Mr. Hill, seconded by Mr. Ralls, that the Board reconsider the vote by which the resolution declaring all places vacated at the University Preparatory School, the Eastern University Preparatory School and the School of Mines on July 1st was lost.

All voted aye.

Moved by Mr. Ralls, seconded by Mr. Sandlin, that the resolution declaring such places vacant be adopted.

All voted aye.

On motion by Mr. Brewer, seconded by Mr. Ralls, the Board adjourned to meet at the call of the President.
