MINUTES OF THE MEETING OF THE STATE BOARD OF EDUCATION

Morning session, Merch 19, 1918.

Members present: Messrs. Wilson, Hill, Rells and Brewer.

Minutes of the meeting of the State Board of Education on February 6th and 7th were presented and approved.

Hon. W. D. Matthews, Commissioner of Charities and Corrections, appeared before the Board and spoke concerning his trip of inspection to the School for the Deaf at Sulphur. Mr. Matthews stated that it was his opinion that the complaints made against the conditions existing at the institution were much exaggerated.

The Board discussed with Mr. Matthews the matter of water supply at Sulphur, after which he retired.

The Board then convened as a Text Book Commission and the bids of the several companies offering books for adoption were presented and considered. On motion by Mr. Hill, seconded by Mr. Brewer, it was decided to grant public hearings to the agents of the publishers, allowing each fifteen minutes to present his books and five minutes in which to close his argument after all agents had been heard.

The Board then proceeded to discuss methods of securing greater efficiency in the reading circle work; after which it recessed as a Text Book Commission.

President S. D. Brooks of the University of Oklahoma appeared before the Board and presented the plans for the Library building at the University. On motion by Mr. Ralls, seconded by Mr. Erewer, the plans as presented were approved. All voted aye.

The Board recessed until 2 P. M.

Afternoon session, March 19, 1918.

Members present: Messrs. Wilson, Hill, Brewer, Ralls.

President Brooks of the University of Oklahoma appeared before the Board and presented the following recommendations:

- That the salary of Z. V. Austin, Janitor, be fixed at the rate of \$65.00 per month, to date from February 22nd to July 1st, 1918. (529) Approved.
- Subject to your arroval I have appointed the following named persons at the ranks and salaries indicated: Miss Alice Wolverton, Assistant in Business, to date from February

18th to September 1st, 1918, at the rate of \$100.00 per month, said

salary to include services during the summer school;

Mrs. Alice B. Alexander, Assistant in Latin, to date from February 1st to June 1st, 1918, at the rate of \$62.50 per month: John P. Torry, Acting Professor of Anatomy, to date from March 1st. 1918, at the rate of \$150.00 per month, said salary to include services during the summer of 1918. (530) Approved.

- That indefinite leave of absence, without pay, be granted to Dr. R. M. Hargrove, Professor of Anatomy, for military service, said leave of absence to date from May 20th, 1918. (531)
- Subject to your approval I have appointed Mary Burks to the position of stenographer in the office of the Director of Extension Lectures, to date from February 18th, to June 1st, 1918, at the rate of \$55.00 per month. (532)Approved.
- (533) I recommend that the regulations governing janitor service in the 5. University of Oklahoma be amended by the inclusion of the following: Amendment to Rule No. 21: Any janitor desiring to resign from his position before the exciration of his term of employment shall give at least thirty days notice in writing to the President of the University to that effect. Approved.
- (534) I recommend the passage of the following joint resolution: RESOLVED, That in accordance with Section 3, Chapter 60, Session Laws of Oklahoma, 1917, transfer of moneys from "Salaries" account No. 1-18 to "Support and Maintenance" account, No. 2-18, in the sum of Seven Thousand Dollars (\$7000.00) be and is hereby authorized. Approved.
- 7. (535) I recommend that the President of the University be authorized to arrange for a special course of lectures and demonstrations in the Summer Session, 1918, at a total cost of not to exceed Nine Hundred and Fifty Dollars (\$950.00)

Superintendent A. K. Gossom of the State Training School appeared before the Board and spoke concerning the releasing of certain inmates of the Training School to responsible parties, to work under indenture contract. Mr. Gossom recommended that the following boys be let out under such conditions:

James Eskey, Homer Harvey, Willie Hendrix, Otis Darby, Albert Anderson, Claud Williams, Eddie DuPree, Charles Bradley, Herman Brank, Orville Robinson, Eddie Burkett, Johnnie Knisley, Milos Eslinger, Matthew Burns, Fritz Carroll, Pete Carroll, Ralph Turner.

On motion by Mr. Ralls, seconded by Mr. Hill, Superintendent Gossom's recommendation was approved.

Superintendent Gossom also spoke concerning his vacation.

On motion by Mr. Ralls, seconded by Mr. Hill, Superintendent Gossom was allowed a vacation of thirty days and granted authority to employ additional help to take care of the institution during his absence. All voted aye.

A communication was read from the National Security League concerning the loyalty of the officers, professors and instructors under the direction of the State Board of Education.

A communication was presented from President T. D. Brooks, of the Scutheastern State Normal, recommending the employment of Jane Markle as instructor in commercial work at the Southeastern State Normal, salary \$1200. per annum.

On motion by Mr. Ralls, seconded by Mr. Brewer, the recommendation was approved.

A communication was also presented from President T. D. Brooks, requesting permission to publish the Southeastern State Normal School Bulletin monthly, except for June and July, instead of quarterly, as it is now appearing.

On motion by Mr. Brewer, seconded by Mr. Ralls, the request of President Brooks was approved.

The bond of Lucy J. Hampton, on sabbatical leave from the Central State Normal, was presented and on motion by Mr. Ralls, seconded by Dr. Brewer, was approved.

Communications were presented from President A. S. Faulkner of the Northwestern State Normal, as follows:

- 1. That the Board take action in the matter of transferring the balance in the salary fund in order that such balance may be used in the construction of the President's home. Also that the Board authorize repairs to be made in the third floor of the Administration Building at the Northwestern State Normal, in order that that floor may be used for class room purposes.

  On motion by Mr. Ralls, seconded by Mr. Brewer, President Faulkner's communication was referred to Mr. Hill to work out with the State Board of Public Affairs.
- 2. That leaves of absence, on full salary, be granted Minnie Shockley, for three months, and Blanche V. Bussey for six months.

  On motion by Mr. Ralls, seconded by Mr. Hill, leaves of absence were granted Minnie Shockley and Blanche V. Bussey for the months of June, July and August, on full pay. All voted aye.
- 3. The resignation of C. A. Jenner, with communication from President Faulkner, was read.

  On motion by Mr. Ralls, seconded by Mr. Brewer, the Secretary was instructed to write President Faulkner and ask for an explanation concerning the resignation and request for reinstatement of Mr. Jenner, and for copies of all correspondence. All voted aye.
- 4. Recommending that the resignation of Nettie Hardy, Secretary, be accepted and that Olive Stricklen, Assistant Secretary and Bookkeeper, be appointed as Miss Hardy's successor, at \$100.00 per month.

  On motion by Mr. Ralls, seconded by Mr. Brewer, the recommendation was approved. All voted age.

5. That student assistants be appointed in the office and library of the Northwestern State Normal.

On motion by Mr. Ralls, seconded by Mr. Brewer, the recommendation for an office assistant as approved at \$25.00 per month, provided that President Faulkner does not employ a member of his family.

On motion the recommendation for a library assistant was rejected.

Recommendations of President G. W. Gable of the Northeastern State Normal School were presented as follows:

1. That his action in memoving Earnest McCurry, janitor, and the appointment of Andrew Kaufman as McCurry's successor, at a salary of \$60.00 per month be approved.

On motion, President Gable's action was endorsed and the Secretary instructed to notify him that in the employment and removal of janitors the endorsement of the Board was not necessary, as he had been granted full authority to make such employments or discharges.

- 2. That the resignation of Roy C. Hinds, Registrar and Head of the Department of Public Speaking, be accepted.

  Approved.
- 3. That Flora Allison, Librarian, be appointed as Registrar and Head Librarian, at a salary of \$1200.00 per year.

  Approved on motion by Mr. Hill, seconded by Mr. Ralls.
- 4. That Lizzie Bird be appointed Assistant Librarian at a salary of \$50.00 per month.

  Approved on motion by Mr. Ralls, seconded by Mr. Brewer.
- 5. That the Board authorize the payment of summer teachers at the Northeastern State Normal in accordance with the following:

"All summer teachers to be employed and paid for a term of ten weeks as has been formerly the case, it being understood that approximately two weeks of this time be made up by teaching on Saturday. By this plan school will close July 19th, but the teachers will draw their salary until August 2nd. "

On motion by Mr. Halls, seconded by Mr. Hill, the plan for the payment of the salaries for the summer school teachers was approved for all six State Normals.

A communication was presented from Superintendent W. W. Pierce of the West Orlahoma Home for White Children, concerning the incorrigible boy from Cheyenne, Oklahoma, committed to his institution.

On motion by Mr. Ralls, seconded by Mr. Hill, Superintendent Pierce was instructed to return the boy to the county from which he had been committed.

- 1. That the Board elect the list of additional instructors for the summer school submitted, at a salary of \$100.00 per month.
- 2. That the Board elect Josephine Junius for the summer school work with the understanding that she take charge of the voluntary Sunday School classes in the afternoon and on Sundays, the balance of her time to be given to the literary work of the institution; one month of her salary, at \$100.00 to be paid by the International Sunday School Association.

3. That the Board authorize an expenditure for farm work of \$150.00 per month for the remaining months in the fiscal year.

On motion by Mr. Hill, seconded by Mr. Balls, President Marquess's recommendations were approved, except as to the election of the summer school instructors, action on which recommendation was deferred until the regular meeting for the election of such employees, on April 17th, 1918.

A communication was read from C. W. Rasure, complaining against the actions of the agent selling "Public School Methods" in Caddo County. On motion the Secretary was instructed to notify the Company publishing "Public School Methods" of the action of their representative, and inform them that the Board would immediately cancel its approval of their books should such action continue.

The Board recessed until Wednesday morning, Merch 20th.

Morning Session, Merch 20th, 1918.

Members present: Messrs. Wilson, Ralls, Hill and Brewer.

On motion by Mr. Ralls, seconded by Mr. Hill, the heads of the History Departments of the University of Oklahoma, the A. & M. College and the six Normal Schools were appointed as a committee to investigate all adopted text books for the purpose of ascertaining if such books contained Pro-German references or any matter of Pro-German character, that would indicate a German propaganda; the committee to report to the State Board of Education at its next meeting.

The motion carried.

A copy of a communication from James P. Munroe, Vice-Chairman of the Federal Board for Vocational Education, notifying Mr. Barrett that the Federal Board could not accept the school at Wilburton for War Education and Training was read.

On motion by Mr. Ralls, seconded by Mr. Hill, the communication was ordered filed.

The report of Mr. Barrett on the extension work was read and approved on motion by Mr. Hill, seconded by Mr. Ralls.

Claims against the Lead and Zinc Extension Plan at the School of Mines at Miami were presented.

On motion by Mr. Brewer, seconded by Mr. Ralls, the approval of all such claims as the Board of Affairs find correct was authorized. The

The Board recessed.

Afternoon session, March 20th, 1918.

Members present: Messrs. Wilson, Hill, Ralls and Brewer.

The Board instructed the Secretary to call the other members of the Board, Dr. Fite, Mr. Shepler and Mr. Sandlin and find out whether they might not be present the next day, in order to proceed with the adoption of Spelling Book, Registers and Reading Circle Books. The Secretary reported that Dr. Fite and Mr. Shepler would be present and the Board recessed until Thursday morning, March 21st, at nine A. M.

Morning Session, March 21st, 1918.

Members present: Messrs. Wilson, Shepler, Ralls, Hill, Brewer and Fite.

The Board went into session as a Text Book Commission. The bids of the following Companies were presented and opened:

McBrien's "America First", published by the American Book Company, was approved for supplementary use in connection with history classes in the seventh and eighth grades, with the recommendation that this book be placed in immediate use in the public schools.

Afternoon Session, March 22nd, 1918.

Members present: Messrs. Wilson, Ralls, Hill, Shepler.

President J. W. Graves, of the Central State Normal, appeared before the Board and spoke concerning military training in the schools.

Mr. Ralls offered the following motion:

"BE IT RESOLVED BY THE STATE BOARD OF FDUCATION, that all schools under the jurisdiction of this Board shall give military training, using Lieutenant Kirby Fitzpatrick's Military Primer, approved by the State Board of Education on the 27th day of September, 1917.

All teachers of public schools including all Rural Schools, all High Schools, all State Normal Schools, The State University, State Training School, and Oklahoma State Homes for dependent or crphan children, shall require all students, over eight years of age, to take military training at least one period each day."

On motion by Mr. Ralls, seconded by Mr. Brewer, the resolution was adopted, all voting aye.

On motion by Mr. Hill, seconded by Mr. Ralls, the question of credits for military work in lieu of physical culture in the Normal Schools was referred to the Normal School Presidents' Council for report to the Board at its next meeting. The motion carried.

On motion by Mr. Ralls, seconded by Mr. Hill, the president of the University of Oklahoma, and the presidents of the six normal schools were appointed as a committee to work out a plan for the establishment of the

Teachers' Reading Circle work in order that credit for such work may be given in the State Schools. All voted aye.

On motion by Mr. Ralls, seconded by Mr. Brewer, the adoption of reading circle books was postponed until the next meeting, in order that the Board might consider the plan as outlined by the committee.

The contracts and bonds with the Webb Publishing Company and the MacMillan Company were presented.

On motion by Mr. Ralls, seconded by Mr. Hill, the contracts were approved and ordered signed on behalf of the State by the Governor. All voted aye.

On motion by Mr. Ralls, seconded by Mr. Brewer, the Secretary was instructed to notify the State Treasurer to return the deposits of the unsuccessful bidders and also those of the Webb Publishing Company and the MacMillan Company, as soon as the bonds were approved and contracts signed by the Governor.

On motion, the Board adjourned to meet April 17th, 1918.
