MINUTES OF THE MEETING OF THE STATE BOARD OF EDUCATION 3 May 13-14, 1918.

Morning Session, May 13, 1918.

Members present: Messrs. Wilson, Shepler, Hill and Sandlin.

The minutes of the meeting of the State Board of Education on April 17-18, 1918, were presented and approved.

A copy of the testimony given at a meeting of the Weatherford Council of Defense in investigating charges against C. H. Simpson, teacher in the Southwestern Normal School, was presented and read.

On motion by Mr. Sandlin, seconded by Mr. Shepler, the following resolution was adopted:

"WHEREAS, it has been made to appear to the State Board of Education upon investigation made by the Weatherford Council of Defense, under date of May 9, 1918, that C. H. Simpson, Professor of Agriculture in the Southwestern State Normal, has made remarks to the effect that young men of the white race would be killed off in this war to such an extent that the young women will have to marry negroes to build up the race; that the German Government is a better government than that of the United States of America; that the American citizen has no right on the high seas that should be respected by Germany; that soldiers from the front making Liberty Loan and Y. M. C. A. speeches are impostors; that the American soldier should have no assistance or help from war relief societies other than his regular pay, the same as a mail carrier; and

WHEREAS, the said C. H. Simpson discourages the pursuit of agriculture in his classes, especially the growing of wheat,--

THEREFORE BE IT RESOLVED BY THE STATE BOARD OF EDUCATION that the said C. H. Simpson be dismissed on this date from the faculty of the said State Normal School, and that the written statement taken by the Weatherford Council of Defense be filed by the Secretary of the Board in the permanent files of the State Board of Education as a part of the record of the Board justifying its action in this case."

All voted aye.

Communications were read from Superintendent J. W. Blattner of the School for the Deaf and C. G. White, Chairman of the Murray County Liberty Loan Committee, concerning the refusal of John A. Graham, an employee of the School for the Deaf, to sign a loyalty pledge card and his circulation of the book "The Hidden Mystery".

On motion by Mr. Sandlin, seconded by Mr. Shepler, the following resolution was passed:

"WHEREAS, it appears from the report of the Chairman of the Liberty Loan Committee of Murray County and the Superintendent of the Oklahoma School for the Deaf that John A. Graham, an employee of the School for the Deaf, has refused to sign a loyalty pledge card and has circulated "The Hidden Mystery", the said John A. Graham is discharged from the services of the School for the Deaf as of May 1st, 1918."

All voted aye.

The Board then proceeded to consider the revision of the "Story of the Old World" offered by the World Book Company. After careful consideration of the copy submitted for the revised edition, the following motion was adopted:

"That the Story of the Old World as revised be approved, provided that the rictures found on Pages 94, 96, 98 and 117 be stricken out and that all copies of the old book be withdrawn from sale, and all pupils having copies of said book that they desire to exchange be given the revised book in even exchange."

Voting aye: Mr. Hill, Mr. Shepler, Mr. Sandlin, Mr. Wilson.

The answer of Superintendent Neil B. Gardner of the Oklahoma State Home to the charges filed against him by Mrs. Florence Pigg, former teacher in the State Home, was read. On motion by Mr. Sandlin, seconded by Mr. Hill, the charges against Superintendent Gardner were dismissed. All voted aye.

Moved by Mr. Sandlin, seconded by Mr. Hill, that it be the rule of the State Board of Education and the State Home at Pryor that immates of the said State Home be not permitted to work in close proximity to dangerous machinery such as sorghum mills, silage cutters, etc., and that adult employees be placed in charge of the work about such machinery in order that they may at all times keep the children from getting near enough to such dangerous work that injury may result.

All voted aye.

The Board recessed to 1:30.

Afternoon Session, May 13, 1918.

Members present: Messrs. Wilson, Hill, Shepler, Sandlin:

President J. B. Eskridge of the Southwestern State Normal appeared before the Board and presented the following recommendations:

1. That the salary of J. R. Campbell, Assistant in Education, be placed at \$1650.00 per annum, to take effect September 1, 1918.

- Approved on motion by Mr. Sandlin, seconded by Mr. Shepler. All voted age.
- 2. That I be allowed to expend not to exceed \$50.00 for commencement speakers etc.

On motion by Mr. Sandlin, seconded by Mr. Shepler, the request was granted and the expenditure of not to exceed \$50.00 for commencement expenses authorized in all the state normal schools. All voted aye.

President Stratton D. Brooks appeared and presented the following:

1. (539) I recommend that the salary of Julien C. Monnet, Dean of the School of Law, be fixed at \$4200.00 for the school year beginning September 1, 1918, and be regularly advanced at the rate of \$100.00 per year to a maximum of \$4500.00.

Approved.

2. (555) I recommend that indefinite leave of absence, without pay, be granted to Leon Forest Wood, Instructor in Electrical Engineering, for military service, said leave of absence to date from August 10, 1918.

Approved.

3. (556) Professor William Peter Haseman was granted sabbatical leave of absence from September 1, 1916, to September 1, 1917, and is now completing the school year, extending from September 1, 1918. He has been granted indefinite leave of absence from September 1, 1918. He informs me that it is very doubtful that he will return to the University.

During the sabbatical leave of absence he was paid Eleven Hundred Dollars (\$1100.00), and filed a bond to return that sum unless he taught three consecutive years after the expiration of his sabbatical leave. Under the terms of his bond he would owe the State two-thirds of this \$1100.00, or \$733.33, in case he did not complete the three years of teaching.

I recommend that he be requested to return this amount to the State.

Approved.

4. (557) I recommend that all students required to take military drill be required to make a deposit of \$25.00 with which to purchase the necessary uniform, the surplus, if any, to be refunded to the student.

Approved.

5. (558) Subject to your approval I have appointed the following named persons for the time and at the salary specified:

Bennie Schultz, June 1 to Sept. 15, 1918.....\$150.00 per mo. William A. Kitchen, June 1 to Sept. 15, 1918....\$100.00 per mo. Approved.

- 6. (559) I recommend that the action taken at the last meeting of the Board, appointing J. B. Jones, General Assistant, at a salary of \$900.00 per year, be rescinded, and that he be reappointed for such portion of the year from July 1, 1918, to July 1, 1919, as his services may be necessary and satisfactory, at the rate of \$1000.00 per year.

 Approved.
- 7. (560) I recommend that leave of absence, without pay, be granted to Philip G. Phelps, Extension Field Agent, from May 1 to June 1, 1918.

Approved.

- 8. (561) I recommend that the previous action appointing Miss Edna Holland Superintendent of Murses, at a salary of \$960.00 per year be rescinded and that she be appointed beginning July 1, 1918, for such portion of the school year as her services may be necessary and satisfactory, at the rate of \$1200.00 per year. Approved.
- 9. (562) I recommend that Wann M. Langston, Associate Professor of Clinical Pathology and Microscopy, be granted indefinite leave of absence without pay, for military service, to date from July 1, 1918.

Approved.

10. (563) Subject to your approval I have appointed Felix Gastineau, Instructor in Clinical Pathology and Microscopy, in the School of Medicine, to date from July 1, 1918 to July 1, 1919. Owing to the fact that this position covers eleven months' service during the year, I recommend that his salary be fixed at \$200.00 in addition to the regular salary for his rank, namely at \$1400.00 per year.

Approved.

11. (564) On the suggestion of the Dean of the Medical School I recommend that the State Board of Education offer to the United States Government the use of its hospitals for any service that may be necessary in connection with the war.

Approved.

12. (565) I recommend that indefinite leave of absence, without pay, be granted to John P. McClure, Instructor in English, for military service, said leave of absence to date from July 20, 1918.

Approved.

- 13. (566) I recommend that leave of absence, without pay, be granted to L. W. W. Morrow, Professor of Electrical Engineering, for military service, said leave of absence to date from July 20, 1918. Approved.
- 14. (567) I desire to report that the following high schools have complied with all the conditions necessary to become fully accredited schools with the University of Oklahoma, and are therefore entitled to operate as independent school districts:

On motion by Mr. Shepler, seconded by Mr. Sandlin, the salary of Neil B. Gardner, Superintendent of the Oklahoma State Home, was fixed at \$2200.00 per a num beginning September 1, 1918.

Mr. Sandlin introduced the following resolution:

RESOLVED BY THE STATE BOARD OF EDUCATION that each employee of the institutions under the jurisdiction of said Board and each and every teacher in the city and rural schools of the state shall, before entering upon his or her duties for the next school year, take and subscribe an oath of office to the effect that such employee or teacher will support and defend the Constitution of the United States, the State of Oklahoma, and support the Red Cross, Liberty Loans, War Stamp Sales, Food and Fuel Administrations, and all war relief societies and organizations and societies, and especially to cooperate with the County and School District Councils of Defense in the matter of reporting disloyal statements and stamping out disloyalty and to teach patriotism.

That the Secretary and Chairman of this Board prepare forms in accordance with this resolution to be used by this Board and its employees and county superintendents and school coards.

Adopted on motion by Mr. Sandlin, seconded by Mr. Hill. All voted aye.

The recommendations of Superintendent J. R. Johnson of the State Institute for Colored Deaf, Blind and Orphans were presented.

On motion by Mr. Sandlin, seconded by Mr. Shepler, the recommendations of Superintendent Johnson were approved and an increase of \$5.00 per month granted to each of the employees recommended except Mrs. Dora H. Johnson; the following being a list of the employees, with salaries:
