

## THE BOARD OF REGENTS OF THE UNIVERSITY OF OKLAHOMA

The meeting of the Board of Regents of the University of Oklahoma was held at 2:00 P. M., June 10th, 1919, in the office of the President of the University, in Norman, on call by Regent Samuel W. Hayes, President of the Board.

Present: Regents Muldrow, Rogers, Bowman, Roberts and Diamond.

In the absence of Regent Hayes, Regent Rogers was nominated acting president of the Board.

The minutes of the meeting on April 30 were approved as read.

The following appointments certified by the President of the University as being in accordance with the rules and regulations, to take effect on the dates stated, were presented and on motion approved:

The President of the University recommended that the title of Frederick F. Blachly, now Associate Professor of Government be changed to that of Associate Professor of Government, and Director of the Bureau of Municipal Research, to date from September 1, 1919.

ACTION: Approved.

The President of the University reported that, by action of the county court, the name of Nathan Altshiller had been changed to that of Nathan Altshiller Court. Mr. Court holds the position of Assistant Professor of Mathematics in the University.

The President of the University recommended that the title of Andrew Clarkson Parsons, now Professor of Secondary Education and High School Inspector, be changed to that of Professor of Educational Administration and Director of High School Extension, to date from September 1, 1919.

The President of the University recommended that the previous action, changing the title of Emory N. Ferris to Associate Professor of Education and Supervisor of Practice, be rescinded, and that his title, beginning September 1, 1919, be made that of Associate Professor of Education.

**ACTION:** Approved.

The President of the University recommended that leave of absence, without pay, be granted the following named individuals to date from September 1, 1919 to September 1, 1920:

Emory N. Ferriss, Associate Professor of Education.

John Ray Cable, Assistant Professor of Economics.

**ACTION:** Approved.

The President of the University recommended that Doctor J. T. Martin, now Assistant Professor of Medicine, be made Associate Professor of Medicine to date from September 1, 1919.

**ACTION:** Approved.

The President of the University reported that Errett R. Newby, Secretary-Registrar, on leave of absence for Government service, had returned to his position in the University on June 1, 1919.

The President of the University recommended that the previous action fixing the salaries of the following named individuals, be rescinded and that their salaries be fixed as indicated in each case:

**ACTION:** Approved.

It was voted that the President of the Board of Regents be authorized, in behalf of the Board of Regents, to sign such bond or bonds as may be necessary for the requisitioning and returning of Government property assigned to the University of Oklahoma for use in the Reserve Officers' Training Corps.

The meeting adjourned to meet subject to the call of the President of the Board of Regents.
