

## THE BOARD OF REGENTS OF THE UNIVERSITY OF OKLAHOMA

The meeting of the Board of Regents of the University of Oklahoma was held at 10:00 A. M., Tuesday, December 16, 1919, in the office of S. W. Hayes, President of the Board of Regents, 810 Colcord Building, Oklahoma City, Oklahoma.

Present: Regents Hayes, Rogers, Diamond, Muldrow, and Bowman.

The following amendments to the by-laws of the Board of Regents were approved:

Article 3—Section 3. The Secretary of the Board shall be the custodian of the corporate seal.

Article 4—Section 1. (To read as follows:) The Board of Regents will hold an annual meeting on the second Monday of March each year, and quarterly meetings on the second Tuesday of June, and the second Monday of September and December of each year. The June quarterly meeting will be held at the University; all other meetings will be held at such places as the President of the Board may direct.

The President of the University requested that the following communications with reference to the authority of the Board of Regents in regard to traveling expenses be incorporated in the minutes:

Sir:

By the opinion of the former Attorney General, the State Board of Education, (and therefore its successors, the Board of Regents of the University) has authority to order the expenditure of funds appropriated by the Legislature for support and main-

tenance of the University, for whatever in the opinion of the Board is necessary for the proper conduct and management of the University. The Board of Regents has decided that the proper conduct of the University business will necessitate some traveling, and on April 29, 1919, adopted the following regulations in regard thereto:

1. That the President of the University be authorized to do such traveling as the interests of the University demand.

2. That each dean be authorized to attend one educational or scientific meeting outside of the State annually.

3. That each director of the school be authorized to attend one educational or scientific meeting outside of the State annually, said trip to be approved by the President of the University.

4. That persons employed in extension work may do such traveling as is necessary, provided that trips outside of the State shall be limited to Directors and be subject in each case to the approval of the President of the University.

5. That the high school inspector be authorized to attend the annual meeting of the High School Inspectors and the annual meeting of the North Central Association of Schools and Colleges, and that the department be authorized to make such trips within the State as may be necessary.

6. That the financial clerk and other employees be authorized to do such traveling within the State as the business of the University may demand, such traveling to be subject to the approval of the President of the University.

7. That the President of the University, with the approval of the President of the Board of Regents, be authorized to delegate other representatives of the University to attend academic and scientific meetings as official representatives of the University, the expense of said attendance to be paid by the University.

I am writing to inquire whether the determination of what constitutes the proper business of the University lies within the legal authority of the Board of Regents, and whether traveling expenses of the employees of the University when incurred in the business of the University and in accordance with the regulations above specified, is a legal charge against the appropriation of the University. I desire also to know whether there is any distinction in the statutes between traveling on University business within the State and outside of the State.

May I say in explanation of these items involving attendance upon educational or scientific meetings, that a considerable share of the business of the University with reference to its relations

to educational institutions in other states, is conducted at conferences of the deans and directors held in connection with such scientific and educational conventions, and that it would be practically impossible to conduct this business satisfactorily by correspondence without personal conference.

Dear Sir:

The Attorney General is in receipt of your letter of the 25th ult., in which you set out certain regulations for the government of the University, adopted by the Board of Regents April 28th, 1919, authorizing the President, the deans and others to attend certain meetings or conferences to be held without the state, and in which you request to be advised whether such persons are entitled to be reimbursed from funds appropriated for the support and maintenance of the University other than for salaries, on account of expenses actually and necessarily incurred in attending the meetings specified in the regulations.

By Rev. Laws, 1910, it is provided:

"Sec. 7955. The government of the University shall vest in a Board of Regents," etc.

"Sec. 7956. The Board of Regents and their successors in office shall constitute a body corporate by the name of 'The Regents of the University of Oklahoma' and shall possess all powers necessary or convenient to accomplish the objects and perform the duties as prescribed by law," etc.

"Sec. 7958. The Board of Regents shall enact laws for the government of the University in all its branches, etc."

By virtue of these statutes, it would appear that the Regents were empowered to adopt the regulations set forth in your letter (which have the effect and force of law), and to thereby impose upon the President of the University and others named therein, the duty of attending the meetings mentioned.

The rule prevailing in this jurisdiction is that where a public

officer necessarily incurs expense in the discharge of his duties, he is entitled to be reimbursed on account thereof from the public treasury.

The law does not distinguish between expenses for travel in the discharge of official duties, within or without the state.

The Attorney General is of the opinion that any necessary expense incurred under authority of the regulations of the Board of Regents above referred to is properly payable out of the appropriation for support and maintenance of the University, other than salaries.

President Brooks reported that John B. Taylor, Assistant Professor of English, had retired permanently from the University on December 1, 1919, on account of ill health.

**Professors Who Are Heads of Departments:** First two years \$3000.00; second two years \$3200.00; third two years \$3400.00; fourth two years \$3600.00; fifth two years \$3800.00; eleventh and subsequent years \$4000.00.

Provided that advances to the next higher salary in any rank shall be made on the first of September of the first odd numbered year following the date of appointment to that rank, and regularly every two years thereafter.
