THE BOARD OF REGENTS OF THE UNIVERSITY OF OKLAHOMA

The postponed meeting of the Board of Regents of the University of Oklahoma was held at 3:00 p. m., Monday, December 20, 1920, in the office of the State Board of Public Affairs, Capitol Building, Oklahoma City.

The President reported that a committee of the faculty, interested in the establishment of a faculty club, desires to know whether the Board of Regents would approve the location by the club of a suitable club house on ground now owned by the University.

It was voted that no action be taken in the matter until more definite plans by the faculty club had been made. The President of the University was requested to inform the members of the faculty club that the Board of Regents look with favor upon the proposition.

The President of the University submitted the following items with reference to appropriations for the University.

- 2. Details with reference to request for emergency appropriations.
- 3. Details with reference to supplementary appropriations for the University Hospital and Medical School.

- 5. Budget of the University containing requests for the biennium beginning July 1, 1921 and ending June 30, 1923.
- 6 Budget of the University Hospital containing requests for the biennium beginning July 1, 1921 and ending June 30, 1923.

The following resolution was adopted:

"Whereas, the need for dormitories at the University of Oklahoma, at Norman, is very great, and:

"Whereas, it is probable that no money will be available from taxation and appropriation that may be used for the construction of dormitories;

now therefore,

Be it Resolved by the Regents of the University of Oklahoma:

Section 1. That a bill providing for the issuance of bonds in the amount of Five Hundred Thousand (\$500,000) Dollars, to be secured by a portion of the University campus and the buildings so constructed, be introduced in the Legislature.

Section 2. That the Regents Muldrow, Bowman, and Roberts be appointed as a Building Committee to work in cooperation with the President of the University in the preparation of a bill to be introduced in the Legislature, and in making other necessary arrangements in connection therewith.

At this point the members of the State Board of Public Affairs were invited for consultation with reference to the building program of the University and the items as presented by the President of the University were unanimously approved.
