Ordered Filed.

It was voted that the enforcement of the regulation with reference to the maintenance of automobiles by the students of the University, passed by the Board of Regents on May 23, 1921, be effective on and after June 8, 1921, beginning at eight o'clock on the first day of class work at the opening of the school year.

It was voted that a committee be appointed to consult the architects—Schmitt and Wellman, and the contractors—Dunning Construction Company for construction and the B. Z. Hutchinson Company for heating and plumbing—of the girls' dormitory, with reference to expenditures to date in connection with the dormitory. The matter was referred to Chairman Muldrow and President Brooks with the suggestion that they take up the question of legal proceedings and liability, and the possibility of securing a deficiency certificate covering said expenditures.

It was voted that the President of the University formulate some plan of supervising the auditing of accounts of student publications.

It was voted that the President of the University take such steps as may be necessary in order to supply students text-books at net cost, to begin at the opening of the second semester, January 28, and to report progress at the next meeting of the Board.

The President of the University presented the question of pavement adjacent to or on the University campus. After a discussion of the matter it was voted to pave the "oval."
