

THE BOARD OF REGENTS OF THE UNIVERSITY OF OKLAHOMA

A special meeting of the Board of Regents of the University of Oklahoma was held in the office of Regent I. Frank Roach in Oklahoma City at 1:00 p. m., on Thursday, April 20, 1922.

H. L. Muldrow, Chairman of the Board, presiding; others present: Regents Diamond, Craig, Roach, Fogg.

The President of the University reported that in accordance with the instructions of the Board at its meeting held March 20, 1922, he had requested the resignation of Samuel S. Catell, Assistant Professor of Economics; that Mr. Catell had declined to tender his resignation and desired a hearing before the Board. The hearing was granted. Professor Catell submitted in writing various letters of recommendation and petitions by the students all of which were read. These were supplemented by oral statements by Mr. Catell.

After reconsideration it was moved and passed that the services of Professor Catell be discontinued on June 6, 1922.

The following resolution was unanimously adopted:

Owing to the controversy that exists throughout the state in connection with the Ku Klux Klan and the Anti-Ku Klux Klan, and the dependency of the University upon retaining the good will of all parties, we believe it unwise for members of the faculty or employes of the University of Oklahoma to place themselves in a position where they will need to take active part in such controversy.

The following recommendations by the President of the University were presented:

That the previous action of the Board fixing the salary of Horace Taylor, Assistant in Economics at \$1200.00 for nine months service, be rescinded and that he be appointed at the salary of \$1400.00 for nine months service, and that the President of the University be authorized to make the necessary adjustments in accordance with the schedule for ten and eleven months service.

Approved.

That John Jacobs be appointed Special Assistant in Physical Education at the rate of \$177.77 per month, from April 15, to June 1, 1922.

Approved.

That the salary of the following teachers in the University be fixed at the rates specified for the months indicated in each case:

Joseph M. Thuringer, \$326.66 for April, May and June.

A. B. Adams, \$341.48 for April, May and June.

Maurice J. Neuberg, \$311.74 for April, and \$317.26 for May.

Edward Crabb, \$263.06 for April, \$172.00 for May and June.

John Wallis, \$150.00 per month from June 1 to September 15, 1922.

Approved.

That the following named persons be appointed to the position specified in each case, for the fiscal year beginning July 1, 1922 to July 1, 1923, and that the salary paid in each case be determined on the following basis, with the provision that the President of the University be authorized to establish monthly salaries in accordance with the schedule, and to make such adjustments therein from time to time as will make the entire compensation paid to net the individual the total amount as specified:

That Eva Marie Anderson be appointed Assistant Professor of Dramatic Art to date from September 1, 1922. It was further recommended that allowance be made for previous service in the University and that she be placed on the salary schedule for Assistant Professors at an initial salary of \$2400.00 for nine months service and be regularly advanced in accordance with the salary schedule.

Approved.

That Maurice J. Neuberg, Assistant Professor of Education, be

granted leave of absence without pay to date from September 1, 1922, to September 1, 1923.

Approved.

That the following teachers in the University be granted leave of absence under the regulations governing sabbatical leaves to date from September 1, 1922, to September 1, 1923:

Royal Edgar Jeffs, Assistant Professor of Botany.

James Wellings Sturgis, Professor of Latin.

Patricio Gimeno, Professor of Spanish.

Approved.

The President of the University reported that he had accepted the resignation of Belle J. Vickery, Assistant Professor of Voice, effective September 1, 1922.

Ordered Filed.

It was reported that J. K. Kellog, previously appointed for service in the summer school, had declined to accept.
