

THE BOARD OF REGENTS OF THE UNIVERSITY OF OKLAHOMA

The meeting of the Board of Regents of the University of Oklahoma was held in the office of the President of the University at Norman, Oklahoma, at 10:00 a. m., Monday, March 12, 1923.

H. L. Muldrow, President of the Board presiding; other present: Regents Craig, Bowman, Miller, Fogg, Schwoerke. (Mrs. J. N. Schwoerke, of Oklahoma City, was appointed by Governor J. C. Walton, to fill the vacancy caused by the resignation of Dr. I. Frank Roach.)

The minutes of the meeting on November 13, 1922 were approved as printed.

Turley, Assistant Dean of the Medical School and Professor of Pathology, be fixed at the rate of \$5,000.00 per annum, until otherwise ordered, of which \$4,500.00 shall be paid from the University appropriations, covering services from September 1 to June 1 in each year, and that \$500.00 be paid from the Hospital appropriation covering services for the thirty day period following commencement of each year;

recommended further, that in addition to his regular duties, Professor Turley be required to serve as Consulting Pathologist in the University Hospital one day in each week from September 1 until June 1, and that he shall have full charge of the laboratory in the Hospital for the thirty day period following commencement in each year;

recommended further that the President of the University be authorized to adjust the monthly salary for the present year on the above basis.

That the President of the University be authorized to notify Vera I. Moore of the intention to appoint a director for the Department of Home Economics and to discontinue that part of her services as Acting-Director of the department; and that action with regard to her position as Assistant Professor be deferred until the June meeting of the Board.

Approved.

That the President of the University be authorized to notify J. W. Shepherd, Associate Professor of Education, of the intention of the Board to modify or possibly discontinue the position which he now holds, but that final action will be deferred until the June meeting of the Board.

Approved.

That the President of the University be authorized to request the Legislature to pass a bill approximately as follows:

"Be it enacted by the people of the State of Oklahoma:

The Board of Regents of the University of Oklahoma is hereby authorized to lease to the Board of Governors of the Oklahoma Student Union not to exceed two acres of the campus of the University at Norman, Oklahoma, for the purpose of erecting and maintaining thereon a building to be erected without cost to the State and to be for the use of the students of the University. The duration of said lease shall not exceed ninety-nine years and may be renewed by agreement of both parties.

In consideration of the service rendered by the Board of Governors of the Oklahoma Student Union in caring for the needs of the students of the University the Board of Regents is authorized to supply heat, light, power, and

water for said building and to establish an annual rental not to exceed \$1.00.

The Board of Regents is further authorized to incorporate in said lease such regulations with reference to the management and control of the building and the conduct of the students while therein as they may deem desirable for the welfare of the University."

Approved.

The President reported the resignation of Stella Ostenberg, Assistant in English, effective February 1, 1923.

Ordered Filed.

The question as to whether the Life Insurance Salesmanship course should be repeated during the coming summer was presented by the President of the University. It was voted to repeat the course, and the President of the University was instructed to confer with directors of the Oklahoma Fraternal Insurance Association and invite their co-operation in conducting the course.

On motion adjourned.
