BOARD OF REGENTS OF THE UNIVERSITY OF OKLAHOMA

A meeting of the Board of Regents was held on Friday, September 23, 1926, at 10:00 a.m., in the office of the President of the University at Norman.

There were present the following members of the Board of Regents:

Chairman A. A. McDonald, presiding; Buttram, Schwoerke, Bowman, Rogers, Carlock and Busby.

The minutes of the meeting of June 8, 1926, were approved as printed.

President Bizzell presented a comparative statement of enrolment in the University for 1925-26 and 1926-27, which showed that there was an increase of 344 students at the close of enrolment this year over last year.

President Bizzell brought up the question of widening the streets in the University section. The Gity Commission had voted to make these improvements previously. It was the sense of the Board that such improvements might be desirable but that no funds were available with which the University could pay its portion of the assessment.

President Bizzell made a report on the new Residence Halls concerning the administration and number of girls admitted.

President Bizzell made a report with reference to the University Hospital Survey, which was conducted by Dr. Wm. H. Walsh, Executive Secretary of the American Hospital Association. The President was requested to supply each member of the Board with a copy of Dr. Walsh's report.

The question of a bond for the Financial Clerk and assistants in the Financial Clerk's Office, the Manager of the Book Exchange and assistants in the Book Exchange, was discussed. President Bizzell was instructed to arrange for bonds in a sufficient amount to provide reasonable security for such employees as may seem advisable.

The University budget requests to be presented to the legislature were discussed. President Bizzell explained in detail the items covering salaries and maintenance, extension program and the building program. The Board concurred in these recommendations and it was voted to appoint a committee to go with the President before the Budget Officer for a hearing. The following were appointed to serve on the committee: Regents Carlock, Buttram and Rogers.
