The Board of Regents met pursuant to adjournment at 10 o'clock A.M. at the office of the President, in Guthrie, Oklahoma. Present, H. E. Asp, President, W. M. Grimes, Acting Governor, D. L. Larsh, Secretary. Absent, C. O. Blake, G. W. Sutton, R. E. Wood.

This being the date advertised for the opening of Bids for the contract for the construction of the proposed new University Building, the matter was considered, and it appearing that the Hon. T. B. Ferguson, the recently appointed Governor for Oklahoma, was absent from the Territory, and the Regents being desirous of his counsel, advice and assistance in the awarding of the said contract, it was unanimously ordered that the date for opening said Bids be postponed until Friday, December 20, 1901, and that prospective bidders be notified of such postponement, and the Secretary was further directed to give notice of such postponement in the following papers published in the Territory, to-wit: Norman Transcript, Guthrie State Capital, Times-Journal, Oklahoma City, and El Reno American, El Reno, and that sealed Bids would be received at the office of Architect A. J. Williams, until December 19,"1901, and including said date.

Upon motion of Acting Governor Grimes, a warrant for \$1875.00 was ordered drawn upon the University Building fund, in favor of Arthur J. Williams, being amount due under his contract for preparing plans, specifications and Superintendence of new Buildings for the University.
