#### BOARD OF REGENTS OF THE UNIVERSITY OF OKLAHOMA

The September, 1942, meeting of the Board of Regents of the University of Oklahoma was held on Tuesday, September 15, 1942, in the office of the President of the University. Preceding the meeting, the Board assembled for dinner in the Union Building at 6:30 p.m., following which the meeting was called at 7:30 p.m. in the President's Office.

The following members were present: Regent Harrington Wimberly, President, presiding; Regents McBride, Hopper, Craig, Chambers, and Erl Deacon. (Erl E. Deacon presented credentials showing appointment to membership on the Board of Regents as of August 17, 1942.)

President Brandt introduced the Reverend Joseph S. Ewing, Vicar of St. John's Episcopal Church, Norman, stating that he felt it appropriate to open the session of the Board meeting on the first day of the beginning of the second fifty-year period of the University with a prayer. Following the prayer, Mr. Ewing retired from the meeting.

The minutes of the meeting on June 24, 1942, were approved, each member having been furnished a copy previously.

President Brandt reported on the enrolment, giving a comparative statement with the school year of 1941-42 as follows:

Attention was called to the new desk in the President's Office. President Brandt stated it had been made by the NYA at a total cost to the University of \$50.00.

President Brandt told the members of the Board about the ceremony that was held on the oval at 10:00 a.m. (September 15)

celebrating the beginning of the second fifty-year period of the University, the following being introduced:

Mr. Edwin DeBarr, one of the four men on the original faculty, who came here as Professor of Physics and Chemistry and was for many years Vice President of the University.

President Emeritus William Bennett Bizzell, President of the University from 1925 to 1942.

Professor J. W. Sturgis, senior professor of the University, who came to the University in 1900 as Professor of Classical Languages.

Mrs. Grace King Maguire, the first Director of the School of Music. She served from 1898 to 1901.

Judge C. Ross Hume, of Anadarko, who in 1898 was one of the first two men to receive a Bachelor of Arts degree from the University and who two years later was the first person to receive a Master's degree.

Mrs. Fantine Samuels Paxton, Class of 1901, who was the first woman to receive a degree from the University.

Members of the faculty and employees who have served the University for twenty-five years or more were also introduced.

Dean Roy Gittinger presented to the President of the University the first copy of his new book "THE UNIVERSITY OF OKLAHOMA: A History of Fifty Years, 1892-1942."

All University classes were dismissed during the hour.

President Brandt reported that in response to the request of the Board, by resolution at the meeting held on June 24, the Governor had allocated \$39,236.00 from his Contingency and Emergency Fund for the purpose of completing the construction and purchase of the necessary furniture and equipment for the dormitory originally under an NYA project. He stated work was progressing on the building and equipment ordered, and that it was hoped it would be ready for occupancy by the opening of the second semester. He suggested that the Board of Regent express its appreciation to the Governor for his action in this case. President Brandt was directed to write such a letter to the Governor on behalf of the Board.

President Brandt reported that Franklin House (formerly the Masonic Dormitory) had been completely redecorated and that it had been necessary to make repairs to plumbing, electrical wiring, interior woodwork, and furniture but that the expense had been held to a minimum. The total cost, according to a statement prepared by Bennie Shultz, Acting

Superintendent of University Utilities, is \$4,371.45. President Brandt stated the rooms are all filled and that there is a waiting list.

There was a discussion concerning the lease on the building, which instead of being with the Masons, is with R. T. Stuart of the Mid-Continent Life Insurance Company, who holds a mortgage on the property and an agreement as to lease contracts. Following is a copy of the lease:

## SUB-LEASE AGREEMENT

#### No. 2843

THIS LEASE made this the 30th day of July, 1942, by and between Mid-Continent Life Insurance Company, a corporation, party of the first part, and the State Board of Public Affairs and the Regents of the University of Oklahoma, acting for the use and benefit and on behalf of the University of Oklahoma, party of the second part,

#### WITNESSETH:

That said first party for and in consideration of the payment of the annual rental hereinafter specified and the keeping of the promises, covenants and agreements hereinafter set forth, does by these presents demise, lease, and let unto second party the following described property, situation in the County of Cleveland, City of Norman, State of Oklahoma, to-wit:

The west 95 feet of Lots 27, 28, and 29 of Lot 30, Block 1, and the South 40 feet of the West 95 feet of Lot 30, Block 1, Larsh's University Addition to Norman, Oklahoma, as per the recorded plat thereof, including the building located thereon commonly known as the "Masonic Dormitory".

TO HAVE AND TO HOLD the same to the party of the second part from the first day of September, 1942, until the last day of August, 1943.

In consideration of the premises herein set forth, party of the second part agrees to pay to party of the first part as rental for the above described premises the sum of \$2,600.00 per annum, payable in twelve equal monthly installments, commencing on or before September 1, 1942 and continuing each month thereafter until said twelve monthly rental installments are paid in advance.

It is further understood and agreed by and between the parties that the property is leased for the use of the University of Oklahoma and that the party of the second part will, in addition to the aforementioned rental, pay all premiums on fire, tornado, lightning, and boiler insurance up to, but not exceeding, the sum of \$200.00 per annum.

It is further understood and agreed by and between the parties that all additions, alterations, or re-decorations made upon or to the building, or any part thereof, are to be paid for by party of the second part.

It is further understood and agreed by and between the parties that the party of the second part shall pay all bills for utilities furnished or supplied to the premises.

This lease shall terminate on August 31, 1943, without notice, unless renewed by mutual consent in writing.

It is further agreed and understood by and between the parties that should the party of the first part sell or otherwise dispose of the said premises, during the term of this lease agreement, then and in that event this lease agreement shall be binding upon its grantee or assigns.

It is further agreed and understood by and between the parties that the party of the first part shall yield possession of the premises to the party of the second part on or before August 1, 1942.

It is further agreed and understood by and between the parties hereto, that at the end of this lease, or any extension thereof, the party of the second part shall give peaceable possession of the premises to the party of the first part in as good condition as they are now, the usual wear and tear and damage by the elements alone excepted.

IN WITNESS WHEREOF the parties hereto have executed or caused this instrument to be executed the day and date first above written.

On motion by Regent Hopper, it was voted to approve the lease; and the President of the Board of Regents and the President of the University

were authorized to sign the lease which had already been signed by Mr. W. M. Bell, Chairman of the State Board of Public Affairs.

President Brandt recommended the establishment of a School of Camouflage as a short course. This matter was called to the attention of the Board through correspondence during the summer and several members indicated approval.

It was voted to approve the recommendation.

President Brandt recommended that a Scholarship in Art be established to be awarded annually to the most talented high school senior boy or girl who submits the best portfolio and scholastic standing to the National Scholastic Art Awards Scholarship Jury, Carnegie Museum of Fine Arts, Pittsburgh, Pennsylvania. The winner would be selected from those exhibiting at the National Exhibit in May, 1943. If a nonresident student were selected, the scholarship would provide for the waiving of the nonresident fee plus the fees in art. If a resident of Oklahoma were selected, it would provide for the waiving of the art fees. The recommendation has the approval of the Faculty of the School of Art with the provision that the scholarship be awarded on an annual basis with the understanding that it may be renewed upon the recommendation of the Faculty of the School of Art.

It was voted to approve the scholarship under the conditions outlined.

President Brandt recommended that Mrs. Josephine Williams be given a scholarship in English 167 and that the \$25.00 fee be waived. This recommendation has the approval of Professor W. S. Campbell and is in accordance with the policy of the Board which authorizes not to exceed five scholarships in one year in this course.

Approved.

President Brandt reported the death of Sardis Roy Hadsell, Professor of English, on August 22, 1942. Mr. Hadsell came to the University as a student in the Fall of 1900 and served in various capacities, including Secretary to David R. Boyd, the first President of the University; as Registrar of the University; and as a teacher in the English Department since 1904. He was one of the most valued members of the faculty and served on various University committees. The University has suffered a great loss in his death.

President Brandt was directed to write a letter on behalf of the Board of Regents expressing to Mrs. Hadsell; her daughter, Mrs. James M. McMillan; and her son, John Dell Hadsell, its appreciation for the fine service Mr. Hadsell rendered the University and its sympathy in their bereavement. President Brandt recommended that the regulation of the Board concerning resignations (Meeting on Friday, May 26, 1939) which states that resignations will not be accepted after August 1 of any year be amended to read as follows:

Professors and Associate Professors shall be required to give not less than six months' notice prior to the end of the scholastic year if they intend to discontinue their connection with the University.

Assistant Professors and Instructors shall be required to give not less than ninety days prior to the end of the scholastic year.

The regulation concerning leaves of absence shall remain as in effect at the present time with the understanding that leaves will be granted only if satisfactory substitutes are available at no additional cost to the University.

Mr. Brandt recommended that they be reinstated in their positions pending future call to service.

President Brandt discussed with the members of the Board the need for assistance in the President's Office. He recommended that Royden J. Dangerfield, Professor of Government and formerly Assistant Dean of the Graduate College, be appointed to the position of Dean of the Faculty on a twelve months' basis at an annual salary of \$4,860.00, effective September 1, 1942. His duties would be those formerly exercised by Morris L. Wardell under the title of Assistant to the President and, in general, he would be a faculty coordinator resolving problems that arise between departments, colleges, and faculty personnel matters. President Brandt stated further "this appointment is vitally necessary as I have been attempting to continue both jobs in the past year, and find that it is physically impossible, particularly in view of the many complexities which the war has brought. If you confirm Mr. Dangerfield's appointment, Mr Kraettli, Mr Dangerfield, and I will work out routines which will give the University greater efficiency of service."

Following a discussion of the matter, Mr. Dangerfield was invited to appear before the Board. After introductions and a brief conference, Mr. Dangerfield retired from the meeting. The motion was made, seconded, and carried that Mr. Dangerfield's appointment as recommended be approved.

President Brandt recommended that George L. Cross, who was appointed Assistant Dean of the Graduate College on June 24, be appointed Acting Dean of the Graduate College in place of Dean Homer L. Dodge who is on leave of absence.

Approved.

President Brandt submitted a list of teachers in the College of Arts and Sciences, recommending adjustments in salaries and in some cases promotions. He stated that he had made no commitments, but that he felt the salary increases were justified due to the increased cost of living and the qualifications of those recommended for increases. There was a discussion concerning the financial situation and questions as to whether the budget would permit additional expenditures. Imquiry was also made by members of the Board concerning those who had been recommended for increases and approved at the meeting on June 24 when the budget was adopted. It was the sense of the Board that action on these increases be postponed until further study has been made and that the President furnish each member of the Board prior to the next meeting with a complete list of those recommended showing their salaries during the school year of 1941-42, salaries approved at the meeting on June 24, and the amounts recommended at this time.

On motion by Regent McBride, seconded by Regent Chambers, it was voted to hold this matter over for further discussion until the next meeting.

President Brandt reported the following changes in the Oklahoma Geological Survey and recommended confirmation by the Board:

- Stuart L. Schoff, who was employed on a cooperative basis in the Oklahoma Geological Survey and the U. S. Geological Survey, has accepted a commission as First Lieutenant in the Engineers Corps, effective July 1, 1942.
- Edwin W. Reed, Junior Hydraulic Engineer on the U. S. Geological Survey staff, who has been working with Mr. Schoff will continue with the project, though somewhat revised.
- C. L. Jacobsen, Junior Geologist, will be assigned to assist Mr. Reed about October 1, 1942.
- Joseph Moxie, U. S. Bureau of Mines, has been invited to take charge of the research project on "Coke and By-Products and Other Minerals" for which funds were made available by the recent legislature. Mr. Moxie is now employed by the U. S. Bureau of Mines and the project is being conducted on a cooperative basis.

President Brandt, in referring to Franklin House, recommended that Professor Kester Svendsen be named Master of Franklin House at a salary of \$50.00 a month in lieu of the absence of dining quarters. He stated that Mr. and Mrs. Svendsen will receive a furnished apartment. Mr. Svendsen has had previous training in dormitory management at the University of North Carolina and since August 1, the date he assumed his duties, he has been doing "a magnificent job in the management of Franklin House."

The recommendation was approved.

#### SCHOOL OF MEDICINE

There was a discussion concerning the appointment of the Dean of the School of Medicine; and President Brandt reported on his trip to Chicago for a conference with Dr. Fred C. Zapffe, Secretary of the American Association of Medical College, and Dr. H. G. Weiskotten, Secretary of the Council of Medical Education and Hospitals of the American Medical Association. Dr. Zapffe stated a number of medical schools are operating with deans who are practicing and giving part time service in administering the medical schools. Dr. Weiskotten was rather firm in his belief that it was unwise to have a dean on a part time basis.

President Brandt discussed the matter also with Dean Bachmeyer of the University of Chicago Medical School. He felt that first emphasis should be placed on medical education rather than on ability to manage a hospital.

The three men under consideration for the position were Dr. Franklin C. McLean who established the Department of Medicine in the University of Chicago Medical School. He is one of the foremost writers on medicine in the United States. He has had varied teaching and administrative experience. He is a director of the Rosenwald Fund and might be of assistance in securing funds for the Medical School "if we were to make public health the principal matter of research." Dr. McLean is engaged in war research and would not be available for the duration of the war.

President Brandt talked also to Dr. Emmet Bay, who has been Associate Dean of Rush Medical College, and Dr. Victor Johnson, Dean of Men in the Biological Sciences Division and Adviser to Medical Students in the University of Chicago. Dr. Bay is engaged in war research and would not be available at this time.

President Brandt reported that Dr. Johnson is interested.

"He is a man of about forty-three years of age, tall, pleasant, a scholar with definite administrative ability; however, he has had no hospital management. In talking with President Hutchins, he pointed out the difficulty we might experience in finding a full time dean in view of the fact that many professors on the Chicago Medical School Faculty have an income of \$18,000 a year."

President Brandt reported on a conference with Dean Patterson in which the Dean had asked for a decision as to whether he should continue to serve as Dean or whether the Board would accept his resignation which was submitted earlier. For personal reasons, it is important to Dean Patterson that this matter be determined at an early date.

Following a discussion, action on the matter was postponed until the next meeting of the Board.

Dean Patterson that it would be impossible to maintain the University
and Crippled Children's Hospitals on the funds provided by the Eighteenth
Legislature, due to the increased cost of items such as "Food and Clothing,"

#### RESOLUTION

WHEREAS, the appropriations for the University Hospital and the Crippled Children's Hospital made by the Eighteenth Legislature for "Food and Clothing", "Milk and Dairy", and "Maintenance" for the 1st 6-mo. period of the fiscal year beginning July 1, 1942, and ending Jan. 1, 1943, were far below the expenditures for the preceding fiscal year and:

WHEREAS, the prices for food and clothing, milk and dairy products and maintenance items have increased very materially since the appropriations were made, and under existing conditions will increase still further or become unavailable and;

WHEREAS, the Superintendent of these hospitals has presented estimates showing that these funds will not be sufficient to operate efficiently until Jan. 1, 1943, and;

WHEREAS, these State Hospitals are filled with patients and a waiting list exists of more than 2000 adult citizens needing treatment and hospital care, and;

WHEREAS, nurses, technicians and other skilled medical personnel are accepting positions with the United States Government at larger salaries, thereby creating a scarcity of such trained personnel who cannot be obtained unless better salaries may be tendered;

NOW THEREFORE BE IT RESOLVED, by the Board of Regents of the University of Oklahoma, in special meeting on this fifteenth day of September, 1942, that we request the Honorable Governor to issue deficiency certificates for the purposes, and in the amounts indicated below, namely:
