BOARD OF REGENTS OF THE UNIVERSITY OF OKLAHOMA

The Board of Regents of the University of Oklahoma met in regular session in the office of the President of the University at 10:00 a.m., on Wednesday, April 11, 1945. Present were: Regents Hopper, President of the Board, presiding: Regents Wallace, Deacon, Emery, McBride; Regents Wimberly and Noble arrived at 2:00 p.m. for the afternoon session.

The minutes of the meeting held on March 14, 1945, were approved, each member having been sent a copy previously.

The Chair presented an official copy of the appointment of Harrington Wimberly as a member of the Board of Regents of the University of Oklahoma, to succeed Dr. Claude S. Chambers, for a term beginning March 30, 1945, and ending March 29, 1952, signed by Governor Robert S. Kerr, dated March 27, 1945, and certified by the Secretary of State indicating confirmation by the State Senate on March 29, 1945.

Regent Deacon, moved and it was voted, that the copy of the appointment of Harrington Wimberly be received and the credentials accepted.

Regent Wallace, Chairman of the Committee on the Masonic Dormitory asked that the committee report be passed over until the afternoon session when Regent Noble, a member of the committee, would be present.

Regent Emery, Chairman of the Committee appointed at the last meeting to draft a resolution concerning Dr. Claude Chambers, read the following resolution and moved its adoption.

RESOLUTION, "WHEREAS the term of Dr. Claude S. Chambers as a Regent of the University of Oklahoma expired March 29, 1945, and

WHEREAS Dr. Chambers has completed a year of effective leadership as President of the Board of Regents, and

WHEREAS such leadership has always been exercised with a sympathetic respect and solicitude for the views and view-points of each of the Regents,

NOW THEREFORE, BE IT RESOLVED that the Regents express their deep regret by reason of retirement of Dr. Chambers as Regent of the University, that they declare their profound appreciation for his leadership, for the sympathetic understanding and solicitude that has always characterized his guidance of the affairs of the Board, and for his constant interest in the welfare of the University.

The above resolution was unanimously adopted.

At the August, 1944, meeting President Cross discussed the relation of the Oklahoma School of Religion with the University. President Cross was asked to supply further information of the work of the School of Religion for consideration at a later date. In response to the above, President Cross supplied each member with material furnished by Dean Comfort. Following a discussion Regent Wallace moved, and it was voted, to receive the report and it was ordered filed.

President Cross reported on the Legislative program. He stated there are no new developments and that the final outcome seems to depend upon whether or not the Legislature approves tax measures now under consideration.

President Cross inquired if the Board of Regents would sponsor a dinner for members of the faculty who have had twenty-five years of service in the University. It was the sense of the Board that this is a worthy project, and on motion by Regent Wallace, it was voted "that the Board of Regents sponsor such a dinner".

At the meeting of the Board on March 14, President Cross discussed the question of employing legal counsel in connection with the issuance of Dormitory Bonds. He stated this matter had been considered and that he felt it would be helpful to employ local attorneys, and suggested T. R. Benedum. He stated Mr. Benedum would use George Fagin, of Oklahoma City, a bond attorney, He stated no contract had been entered into but that in the discussion a maximum fee of \$1,500.00 regardless of the size of the bond issue had been mentioned; it is contemplated to issue \$1,000,000.00 of bonds.

Regent Wallace expressed the opinion that it is not necessary to employ legal counsel since companies dealing in bonds have their own legal departments, and that the Attorney General would give such assistance as may be necessary.

Following a discussion Regent McBride moved, and it was voted, "if it becomes necessary to have the services of an outside attorney, the matter with regard to the choice of counsel and the fee, be left to the discretion of the President of the University".

President Cross reported concerning Dr. Willard Z. Park, formerly Professor of Anthropology, who has requested an extension of his leave of absence, which was terminated on September 1, 1944.

Dr. Park, has been notified that he will be given a hearing by the Board, or that he may file a document, in connection with matters that concern Dr. Park.

President Cross called attention to the copy of the letter in the material sent to each member of the Board, written to Neil Johnson, President of the Board of Governors of the Oklahoma Memorial Union. He stated a report on the matter would be made later.

The President asked that the Board discuss the question of "Academic Freedom and Academic Tenure" and called attention to the statement on pages four (4) and four-A (4-A) of the Agenda, including his recommendation as a policy for the University.

Regent Emery, moved, and it was voted, "that the statement on Academic Freedom and Academic Tenure, on pages four(4) and four-A (4-A), as interpreted by the President in his recommendation as shown on page four-A (4-A), as limited by the Constitution and the laws of the State of Oklahoma, be adopted as the policy of this board". The recommendation follows:

ACADEMIC TENURE

(1) The time that a person with the rank of instructor may serve on the faculty shall be limited to five years, and that therefore, a person with the rank of instructor shall hot be able to achieve continuous tenure.

- (2) Every assistant professor and associate professor not on tenure, shall be considered for continuous tenure in the spring of his third year of service, but he shall be granted tenure only by specific action of the University. The person concerned shall be informed of the University's decision before May 1, of that year.
- (3) A full professor shall be considered for continuous tenure in the spring of his second year of service but he shall be granted tenure only by specific action of the University. The person concerned shall be informed of the University's decision before May 1, of that year.
- (4) In accordance with rule of practice two (2) above, even if an assistant professor, associate professor, or professor is not granted tenure at the end of his period of probation, and if his period of probation is not extended, he may retain his position on the faculty until the end of the following academic year.

President Cross discussed the desirability of offering work leading toward the degree of Bachelor of Science in Medical Technology, submitting the following statement:

CURRICULUM FOR THE BACHELOR OF SCIENCE IN MEDICAL TECHNOLOGY

The practice of modern medicine requires the aid of the laboratory. Approved hospitals are required by the American Medical Association to have adequate laboratories which must be in charge of a full time Medical Technologist. Such Technologists must have passed successfully an examination given by the American Society of Clinical Pathologists, and have spent twelve calendar months in special training in an approved hospital laboratory.

The Medical Technologist is a person whose education and training have fitted him or her for the performance under the direction of a physician of the innumerable chemical, bacteriological, histological, aerological and other tests used in the diagnosis and treatment of disease.

Prior to 1928 persons who did such work proved so inadequate that a Registry of Medical Technologists was set up for the purpose of promulgating standards and recognizing qualifications of laboratory workers, and establishing standards for training schools for Medical Technologists.

For the certificate only, the present requirements for Medical Technologists are two years of college work with emphasis on chemistry and biology and in addition twelve calendar months spent in an approved hospital laboratory. However the war with its increased demands on medicine has so changed the situation that future requirements will be much higher. There is a real demand on the part of students for a bachelor's degree in medical technology. Our own Medical School faculty urges that students take three years of work in the College of Arts and Sciences and that a degree of B. S. in Medical Technology be conferred at the end of the laboratory year. By setting up a new degree as suggested in the plan outlined, students will be able to obtain the degree and at the same time meet the rigid requirements which the American Society of Clinical Pathologists has imposed.

Electives up to 94 hours and 141 grade points during three years. Fourth year consists of 12 months of instruction and special laboratory work in the hospitals of the University of Oklahoma Medical School.

President Cross recommended approval of this curriculum, and the granting of the degree of Bachelor of Science in Medical Technology upon the completion of the required courses.

The revision of the Articles of Incorporation of the Athletic Council, a copy of which had been sent to each member of the Board by Regent Emery, was discussed. On motion by Regent Deacon, seconded by Regent Noble, this document was approved.

Regent Wallace, Chairman of the Committee to consider the question of the purchase of the Masonic Dormitory reported for the committee as follows:

"We recommend that the University purchase the property at \$65,000.00, without the nuisance value, the actual value to be \$65,000.00."

Following a discussion Regent Emery made the following motion: "I move that the report of the Committee be accepted, the value of the building as recommended by the Committee (\$65,000.00) to constitute the relative measure as to its nuisance value".

The motion was adopted.

Regent McBride suggested that Mr. Stuart be invited to meet with the Board at the meeting on May 9; Regent Wallace concurred in the suggestion, and it was the sense of other members that Regent Wallace confer with Mr. Stuart and extend the invitation.
