BOARD OF REGENTS OF THE UNIVERSITY OF OKLAHOMA

The Board of Regents of the University of Oklahoma met in regular session in the office of the President of the University at 10:00 a.m. on Thursday, June 14, 1945. Present were: Regent. Hopper, President of the Board, presiding; Regents Wallace, Deacon, Wimberly, McBride, Noble, Emery.

The minutes of the meeting held on May 9, 1945, were approved, each member having been sent a copy by mail.

The Chair announced the appointments on the following committees of the Board, the first named, on each committee, to be chairman:

MEDICAL SCHOOL, UNIVERSITY AND CRIPPLED CHILDREN'S HOSPITALS:

President Cross reported the death of Dr. Arthur Weaver White, Professor Emeritus of Clinical Medicine, Medical School, on June 11, 1945.

The Chair asked that President Cross express the sympathy of the Board to the family of Dr. White.

President Cross reported that a fee of \$ 24.75 had been determined for the students enrolled in the pre-radar course, this fee to include the incidental fee regularly paid by university students, and recommended approval of the above amount.

On motion by Regent Emery, the fee of \$ 24.75 was approved for pre-radar students.

President Cross submitted the report of Mr. Kraft on Logan Apartments as requested at the last meeting of the ^Board, and recommended that the proposal (see letters to Roscoe Cate under dates of April 20 and May 1, 1945 signed by Leonard Logan, Secretary-Treasurer of the University Scholarship Corporation) to transfer the title to what is known as Logan Apartments, to the University of Oklahoma.

Following a discussion of the report Regent Emery made the following motion:

"I move that the President of the University be authorized to proceed in the acquisition of the Logan Apartments, and to do what may be necessary, according to law".

The motion was duly seconded, and unanimously carried.

**** President Cross discussed plans for the Bizzell Memorial Library to be undertaken through the University of Oklahoma Foundation, and outlined some of the work that has been done by Mr. Cate.

It was the sense of the Board that the President proceed according to the statement.

Attention was called by President Cross to the regulation of the Board of Regents concerning outside employment on the part of persons employed on a full-time basis, adopted May 21, 1931 and recommended that this regulation be rescinded; that this matter be studied further.

On motion by Regent McBride it was voted to rescind the regulation as recommended by the President, and that the matter be brought up again at a later date and a policy adopted.

President Cross stated that under the present plan of operation the Director of the University of Oklahoma Research Institute (Dean of the Graduate College) is paid \$ 50.00 a month from Institute funds. He recommended that effective July 1, 1945, the University pay the total salary of the Director of the Research Institute thus leaving the present monthly payment available for the purchase of needed supplies and equipment.

On motion by Regent Wallace it was voted to approve the President's recommendation that the University pay the salary of the Director of the University of Oklahoma Research Institute, subject to the filing with the Secretary of the Board of Regents, a certified copy of a companion resolution by the Directors of the Research Institute.

President Cross explained the plans to coordinate all instructional work in Radio; at the present time the School of Drama, and the Departments of Journalism and Speech, are offering overlapping courses. He stated it was his desire to find someone who knows about radio, and to coordinate all work in order to strengthen the curriculum and avoid duplication.

The Board expressed approval of the plan.

**** On August 4, 1948, the minutes of this meeting were corrected to show that the library was designated on this date as the William Bennett Bizzell Memorial Library (See 2807) Attention was called to the file on Willard Z. Park sent to each member of the Board. President Cross recommended that Dr. Park's leave of absence be reinstated as of September, 1944 to August 31, 1945, but that the leave not be extended beyond that date, and that he not be permitted to return to this position until Dr. Park shall have appeared before the Board of Regents in connection with the charges that have been made.

On motion by Regent Wallace the above recommendation was unanimously approved.

President Cross reported on the allocation of funds by the State Regents for Higher Education for the biennium beginning July 1, 1945 and ending June 30, 1947. He stated the allocations to the University had been made in the ratio agreed upon.

Recommendations by President Cross:

DAVID ROSS BOYD PROFESSORSHIPS

1. Canons for Selection.

To qualify for a David Ross Boyd Professorship a faculty member must have demonstrated over a period of years his, or her, vigorous performance and leadership in the teaching, counseling and guidance of students.

2. Selection Procedure.

(a) The dean of each degree-granting college and the Dean of the University College shall consider the qualifications of each full professor in that college each year, and make a selection of those professors who, in his opinion, meet the Canons of Selection, The Deans shall then consult with the departments (or schools) in which these selected professors occupy chairs, and also with committee B of the faculty of the college, concerning the merits of each of these professors. After the Deans have collected all pertinent information concerning the professors they have selected, they may nominate any whom they deem worthy for David Ross Boyd Professorships. The nominations shall be passed to the University Committee on Promotions, Salaries and Tenure.

(b) The University Committee on Promotions, Salaries and Tenure shall survey the records of all full professors in the University that year. After this Committee has made thorough investigations and collected all pertinent information concerning the merits of the different professors, it may nominate to the President any whom it deems worthy for David Ross Boyd professorships. All nominations shall be presented to the University Committee on Promotions, Salaries and Tenure, and shall lie before this committee for at least thirty days, whereupon they shall be discussed by the Committee. Each nominee receiving a favorable vote of a majority of the members of the Committee shall be recommended to the President of the University for a David Ross Boyd Professorship. All pertinent information concerning this professor, including the dissenting opinions, if any shall accompany this recommendation to the President. If the President approves, he shall present the nomination to the Board of Regents for approval.

3. Tenure, Teaching-Load and Salary,

Each David Ross Boyd Professor shall retain membership on the staff of his department (or school) and his salary shall be part of the budget of that department (or school). His appointment shall be for five years - subject to reappointment upon recommendation of the President to the Board of Regents.

The stipend of a David Ross Boyd Professor shall be not less than \$5,000.00 per year for ten months of service.

RESOLUTION OF THE BOARD OF REGENTS OF THE UNIVERSITY OF OKLAHOMA CONCERNING THE REORGANIZATION OF THE UNIVERSITY OF OKLAHOMA PRESS.

The Regents of the University of Oklahoma at a meeting duly called and now in session regularly assembled as a board on this 14th day of June, 1945, hereby resolve that the University of Oklahoma Press be reorganized in the following form and manner: 1. That the University of Oklahoma Press shall continue as a division of the University of Oklahoma and shall continue to be administered by a Director appointed by the President of the University of Oklahoma and approved by the Board of Regents.

2. That in its reorganized form the University of Oklahoma Fress shall consist of three divisions, namely:

- (1) The Publishing Division.
- (2) The Sales Division, and
- (3) The Printing Division.

3. That the Publishing Division shall remain under the direct supervision of the Director of the University of Oklahoma Fress, and shall be budgeted from the University appropriations from year to year according to its needs.

4. That the functions of the Publishing Division shall be to receive manuscripts and certify those acceptable for publication by the University of Oklahoma Press; to edit, design, and generally prepare such acceptable manuscripts for manufacture into book, brochure, or pamphlet form; to meet the costs of composition, printing, and folding of sheets for works of scholarly research, in an amount not to exceed the sum of its budgeted appropriations, for such initial stages of manufacture, to wit, composition, printing, and folding; to maintain all necessary relations between the University of Oklahoma Press and such writers and authors of scholarly manuscripts who may be resident on the University of Oklahoma campus or elsewhere; to promote and publicize scholarly undertakings, particularly those which promise to become or do become published works under the imprint of the University of Oklahoma Press; to serve as a co-ordinating agency and the publishing instrumentality for all works, official bulletins, magazines, periodicals, and other printed matter intended to represent the University of Oklahoma to the State, the Nation, and abroad; to act as the custodian of the University Seal in all its uses in printed form; to assist in the development of such informational services as may be decided upon by the University; and to receive moneys, credits, and funds from foundations, institutions corporations, proprivate individuals, by bequest, gift, or in any other way whatsoever, for the purposes of specific scholarly publications or for general purposes, or for the behefit of the employees of the University of Oklahoma Press, such gifts, bequests, or grants to be deposited with the Comptroller of the University of Oklahoma as restricted funds, or with the University of Uklahoma Foundation, in accordance with instructions of the donor or donors and the regulations of the Board of Regents of the University of Oklahoma, and to be disbursed on order of the Director of the University of Oklahoma Press.

5. That all existing and prior auxiliary enterprises which are performing or have performed functions of the University of Oklahoma

Press be hereby dissolved and that in lieu thereof the Sales Division shall be created and set up as an auxiliary enterprise, and all moneys, credits, and funds of such existing and prior auxiliary enterprises shall be transferred to the credit account of the Sales Division.

6. That the Sales Division shall receive no budgeted appropriation, but instead shall function as a self-supporting auxiliary enterprise, and shall be supervised by an official bearing the title of "Service Manager of the Sales Division," to be appointed by the President of the University of Oklahoma upon nomination and recommendation by the Director, and to be approved by the Board of Regents.

7. That the Sales Division shall be self-sustaining at all times: and that it shall receive all moneys, credits, and funds derived from the marketing and sales of all books, pamphlets, magazines, periodicals, and other works and services authorized by the Director, and its authority, powers, and functions shall be to arrange for, supervise, contract for, and bear the expense of all binding, billing, shipping, copyrighting, advertising, selling, storing, paying of commissions and royalties, and all other matters relating to the marketing and distributing of all publications published, handled or marketed by the university of Oklahoma Press, together with the meeting of all costs of production and manufacturing except those borne by the Publishing Division in the performance of its functions. By the force of this resolution all future contracts for publication of manuscripts entered into with writers, authors, or producers shall be executed by the Director of the University of ^Oklahoma Press and countersigned by the Service Manager of the Sales Division.

8. That the Printing Division shall be supervised by a Superintendent of the Printing Division to be appointed by the President of the University upon nomination and recommendation by the Director, and to be approved by the Board of Regents.

9. That the Printing Division shall continue to serve as the manufacturing agency for the production of all works published by the University of Oklahoma Press and for other printing requirements of the University, and for the addressing and distribution of bulk mailings of printed materials. As incidental to these prime functions, it shall manufacture and furnish such printing or printed matter required upon the properly authorized order of any division, department, school, college, auxiliary enterprise, organized activity, or other instrumentality of the University, insure conformance of all ordering departments to the requirements of postal permits as may be issued to the ^University, and buy, stock, and supply under appropriate state regulations such paper, metals, matrices, engravings, machinery, and other supplies, materials, and capital equipment as may be necessary, under authorized appropriations, to fulfill the functions herein provided for.

10. That the Printing Division shall operate as a service unit, charging for its services on a cost of production basis to the end that its income be sufficient to pay all of its operating costs, 11. That the Comptroller of the University of Oklahoma shall receive and account for the disbursement of all funds, moneys, and credits received by all divisions of the University of Oklahoma Press,

12. That the reorganization of the University of Oklahoma Press is hereby authorized and directed to take effect and be put into operation as of the 1st day of July, 1945, and the University of Oklahoma Press shall continue to so operate and function until further order of the Board of Regents of the University of Oklahoma.

The resolution was approved.

ATTORNEY, UNIVERSITY PRESS

Dr. Floyd Wright, Professor of Law, has for a number of years done the legal work for the University Press Publishing Division, which has fallen into several categories, namely:

1. Drafting of resolutions, publication contracts, trust agreements, and other documents.

2. Adjusting and contesting the rights and interests in unpublished and uncopyrighted manu-scripts.

3. The reading and checking of manuscripts about to be published by the Press to avoid libelous matter creeping in.

4. Contesting infringements upon copyrighted materials by other authors and publishers.

5. Protecting the Press and our authors against unfounded charges of copyright infringements by other authors and publishers.

6. Handling of the collection cases of the Press.

Mr. Lottinville recommends that Mr. Wright be named "Attorney for the University of Oklahoma Press", and I concur in this recommendation.

Regent McBride, moved and it was voted to rescind the order requiring reports on overtime of University Utility Employees.

On recommendation of Dean Lowry the following changes in the personnel of the Oklahoma School of Medicine is herewith submitted.

Dr. Raymond Lester Murdoch, on leave of absence with the armed forces since September 18, 1942, has resumed his duties as Professor of Clinical Surgery on the faculty of the School of Medicine and the staff of the University Hospital, effective May 15, 1945.

Dr. Walter W. Wells, Professor of Obstetrics and Chairman of the Department of ^Obstetrics, has reached the retirement age of 65, and has submitted his resignation from the faculty of the School of ^Medicine.

I recommend that Dr. Wells' resignation from active duties be accepted, and that he be appointed Professor Emeritus of Obstetrics, effective June 1, 1945. Dr. Wells has been on the staff of the School of Medicine since 1916 and has rendered faithful service. He will be presented with a certificate in recognition of this service.

I recommend that Dr. Edward Pennington Allen, Professor of Clinical Obstetrics be appointed Professor of Obstetrics and Chairman of the Department effective June 1, 1945.

I recommend that Dr. Robert Howe Akin, Associate in Urology be promoted to the rank of Assistant Professor of Urology, effective July 1, 1945.

Dr. Rufus Quitman Goodwin, Associate Professor of Clinical Medicine, promoted to the rank of Professor of Clinical Medicine, effective May 1, 1945.

Dr. Thomas Craig Points, appointed to the rank of Assistant in Obstetrics, affective June 1, 1945, on the clinical staff of the School of Medicine.

<u>R E S O L U T I O N</u>

A RESOLUTION SETTING ASIDE PORTIONS OF THE CAMPUS OF THE UNIVERSITY OF OKLAHOMA FOR THE CONSTRUCTION AND ERECTION THEREON OF APARTMENT DORMITORY BUILDINGS FOR THE USE OF STUDENTS ATTENDING THE UNIVERSITY, AUTHORIZING THE ISSUANCE OF REVENUE BONDS FOR THE PURPOSE OF OBTAINING MONEY FOR COM-STRUCTING, EQUIPPING AND FURNISHING THE SAID BUILDINGS IN THE AGGREGATE AMOUNT OF TWO HUNDRED SEVENTY FIVE THOUSAND (\$275,000.00) DOLLARS, PROVID-ING FOR THE PRINCIPAL AND INTEREST ON THE BONDS AND THE AMOUNT OF THE BONDS TO MATURE EACH YEAR, PROVIDING FOR THE PAYMENT THEREOF AND FIXING OTHER DETAILS OF THE ISSUE.

WHEREAS, Senate Bill No. 41 of the 20th Okkahoma Legislature, approved March 2, 1945, and which act became effective on said date, authorizes the Board of Regents of the University of Oklahoma, for and in behalf of the University of Oklahoma, to set aside such portions of the campus of said University as may be necessary and suitable for the construction, furnishing and equipping thereon of dormitories, kitchens, dining rooms, auditoriums, student union buildings, field houses, stadiums and other self liquidating projects, and other revenue producing buildings including additions to existing buildings used for such purposes, and authorizes said Board of Regents to borrow money on the Credit of the income and revenues to be derived from the operation of the buildings, and in anticipation of the collection of such income and revenues to issue negotiable bonds in such amount as may be in the opinion of said Board necessary for such purposes, and

WHEREAS, said act provides that said bonds may be issued in one or more series, may bear such date or dates, may mature at such time or times not exceeding twenty-five (25) years from their date, may be in such denomination or denominations, may be in such forms, either coupon or registered, may carry such registration and conversion privileges, may be excuted in such manner, may be payable in such medium of payment at such place or places, maybesubject to such terms of redemption with or without premium, and may bear such rate or rates of interest, not exceeding five (5%) per cent per annum, as may be provided by resolution or resolutions to be adopted by the Board; that such bonds may be sold in such manner, and at such price or prices, not less than par plus accrued interest to date of delivery, as may be considered by the Board to be advisable, but interest cost to maturity shall hot exceed five (5%) per cent per annum computed on the basis of average maturity, according to standard tables of bond values; that such bonds shall have all of the qualities and incidents of negotiable paper; that

such bonds shall not be subject to taxation by the State of Oklahoma or by any county, municipality or political subdivision therein; that the Board may in its discretion authorize one issue of bonds for the construction, furnishing and equipping of more than one building and may make the bonds payable from the combined revenues of all buildings acquired in whole or in part with the proceeds thereof, and

WHEREAS, said Act by appropriate provision therefore provides that the Board shall fix rentals, fees and charges to be paid for the use of the dormitory buildings by students in an amount sufficient to pay the maintenance and operation cost of said buildings, and for paying the interest and the principal on said bonds as they mature, and for the creation of a fund in the State Treasury to be pledged for the payment of said bonds and other appropriate provision, and

WHEREAS, the said Board of Regents under and by virtue of the foregoing authority deems it advisable and has determined that it should issue bonds in the aggregate amount of Two Hundred Seventy Five Thousand (\$275,000.00) Dollars for the purpose of constructing, furnishing and equipping apartment dormitories for use of the students attending the University of Oklahoma, and that said apartment dormitories will consist of a number of buildings and that all of the buildings constructed, equipped and furnished from moneys derived from the issuance of the bonds hereunder shall be considered as one unit and the revenues derived from the use of all of said buildings shall be used for the payment of the interest and principal of the bonds issued hereunder.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF REGENTS OF THE UNIVERSITY OF OKLAHOMA, ACTING FOR AND IN BEHALF OF THE UNIVERSITY OF OKLAHOMA.

1. That the following described portions of the campus of the University of Oklahoma be, and the same are hereby set aside for the construction and erection thereon of apartment dormitories in conformity with the provisions of Senate Bill No. 41 of the 20th Oklahoma Legislature, to-wit:

Beginning at a point 33 feet West and 1029 feet South of the Northeast Corner of the Northeast Quarter of Section Six, Township Eight North Range Two West (NE2 6-8N-2W), Indian Meridian, in Cleveland County, Oklahoma; thence West 797 feet, thence South 600 feet, thence East 797 feet, thence North 600 feet to the point of beginning, containing 11 acres more or less.

2. Be it further resolved that the Board of Regents of the University of Oklahoma, for and in behalf of the University of Oklahoma, is authorized and directed to issue its revenue bonds in the aggregate amount of Two Hundred Seventy Five Thousand (\$275,000.00) Dollars for the purpose of constructing, furnishing, building and equipping apartment dormitories which will be sufficient or ample for approximately ninety-six (96) living units on the portion of the campus of the University of Oklahoma above described for the use of students attending said University.

3. That said bonds shall be regular coupon bonds, shall be signed by the President of the Board of Regents of the University of Oklahoma and attested by the Secretary, and shall be issued in the total sum of Two Hundred Seventy Five Thousand (\$275,000.00) Dollars, said bonds to be designated "University of Oklahoma Apartment Dormitory Bonds" and shall be two hundred seventy-five (275) in number, numbered from 1 to 275, inclusive, of the denomination of One Thousand (\$1,000.00) Dollars each, shall be dated the 1st day of July, 1945, and become due and payable as follows:

Said bonds shall bear interest from their date until paid in accordance, with the lowest interest rate bid at an advertised sale of the bonds not to exceed five (5%) per cent per annum on the principal amount of the bonds, said interest to be payable semiannually on the 1st day of January and July of each year, beginning on the 1st day of July, 1946, which installments of interest to date of maturity of principal shall be evidenced by appropriate coupons attached to each of said bonds, and both principal and interest shall by payable at the Fiscal Agency of the State of Oklahoma in New York City or in the event of the discontinuance of such Agency, then at the Manufacturers Trust Company in said City and State of New York.

4. That each of said bonds with coupons attached thereto and the endorsements and certificates thereon shall be in the following form:

It is hereby certified and recited that this bond is not and shall not become an obligation of the State of Oklahoma; and it is further certified and recited that all acts, conditions and things required to be done precedent to and in the issuance of this bond have been properly done, happened and performed in regular and due form as required by law.

It is further certified and recited that this bond is payable from the rentals, revenues and income to be paid by the students attending the University of Oklahoma who avail themselves of the use of the apartment dormitories which are constructed with the moneys received from the sale of the bonds issued for said purpose, and of which this bond is one of a total issue of bonds aggregating the principal sum of Two Hundred Seventy Five Thousand (\$275,000.00) Dollars, all as provided for by Resolution of the Board of Regents of the University of Oklahoma authorizing the issuance of said bonds and passed and approved on the 14th day of June, 1945. The moneys received from the rentals, revenues and income are hereby pledged to the payment of the interest and principal of said bonds and for the operation, maintenance and repair of said apartment dormitories.

It is further certified and recited that the Resolution of the Board of Regents of the University of Oklahoma providing for the issuance of said bonds, covenants and guarantees (a) that rentals, charges and fees for use of the apartment dormitories be established and maintained in amounts sufficient to pay in the following order of priority; first, costs of operation, maintenance and repair of the said apartment dormitories; second, interest and bond maturities when due; and third, to create and maintain a \$35,000.00 reserve; (b) that no revenues from the said apartment dormitofies will ever be pledged to payment of any other bonded indebtedness so long as any bonds of this issue are outstanding; (e) that rules and regulations governing the living arrangements of students be established to insure maximum occupancy of the apartment dormitories; (d) that fire, tornado, explosion, and use and occupancy insurance be carried on the buildings; (3) that annual financial statements on operation of the apartment dormitories and condition of the sinking fund be supplied, on request, to any bondholder.

7. Immediately upon the construction and completion of the apartment dormitories herein provided for, the Board of Regents of the University of

Oklahoma shall prescribe such rules and regulations for the conduct, management and care of the apartment dormitories constructed as provided herein. and shall provide for such necessary rentals. charges and fees to be paid by the students attending the University of Oklahoma who will avail themselves of the use of the dormitories as will be necessary and sufficient to pay in the following order of priority: first, costs of operation, maintenance and repairs of the dormitories; second, interest and principal of the bonds as they become due; and third, to create and maintain a reserve in the amount of \$35,000.00, the said reserve to be created by transferring to the sinking fund before July 1 each year, in addition to the current interest and principal requirements, sufficient funds to establish a reserve of at least 20% of said amount by July 1, 1946; at least 40% of said amount by July 1, 1947; at least 60% of said amount by July 1, 1948; at least 80% of said amount by July 1, 1949; and the full sum of \$35,000.00 by July 1, 1950, to be thereafter maintained in that amount as long as any of the bonds are outstanding.

8. All income and revenues derived from the operation of said apartment dormitorias, which are built and constructed from the proceeds of the sale of the bonds issued hereunder, shall be collected and deposited in a fund in the State Treasury to be designated as "University of Oklahoma Apartment Dormitory Fund" to be applied solely to the payment of the cost of operation, maintenance. and repair of said dormitories, and the payment of the principal and interest of the bonds issued hereunder. No revenues from the said apartment dormitories shall ever be pledged to the payment of any other bonded indebtedness so long as any bonds of this issue are outstanding. There shall also be created in the State Treasury a special fund to be designated as "University of Oklahoma Apartment Dormitory Sinking Fund" and there shall be transferred thereto from the "University of Oklahoma Apartment Dormitory Fund" each year at least thirty (30) days prior to the maturity of the first maturing interest coupon on the bonds. and thirty (30) days prior to the first day of July of each year thereafter, a sum sufficient to pay the accruing interest coupons falling due for the ensuing year and the maturing principal of the bonds together with the amount of money collected for the purpose of accumulating a reserve as provided for in Section 7 hereof.

Said Sinking Fund shall be used only for said payment of the interest and principal of the bonds and the same is hereby irrevocably pledged to the payment of said interest and principal of said bonds. As the principal and interest become due and payable from time to time upon the bonds issued hereunder, the State Treasurer shall not less than fifteen (15) days prior to the payment date transmit to the paying agent of the bonds money from said Sinking Fund in an amount sufficient to pay the interest and principal so falling due.

The State Auditor is hereby directed and authorized to issue warrants upon the State Treasury against the "University of Oklahoma Apartment Dormitory Fund" upon itemized claims for expense of the operation, maintenance and repair of said apartment dormitories so constructed and built under the provisions hereunder, which claims bear the approval of the President of the University of Oklahoma and of the Board of Regents of the University of Oklahoma.

9. Said Board of Regents covenants and agrees that in addition to the provisions hereinabove provided for that it will: (a) construct the apartment dormitories as nearly as possible in exact conformity with the approved preliminary plans and specifications; (b) pass such rules and regulations governing the conduct and living arrangements of the students attending the University of Oklahoma as will, so long as any of the bonds remain outstanding, assure maximum occupancy of said dormitories; (c) carry on said apartment dormitories erected under the provisions of this Resolution, fire, tornado and explosion insurance, and in case of damage to said buildings or loss thereof said insurance is to be used to repair said buildings so damaged or to rebuild the same in case of total loss thereof; (d) carry on said apartment dormitories use and occupancy insurance and in case said dormitories are injured or destroyed the proceeds collected on account of such policy of insurance shall be placed in the Sinking Fund, as hereinabove created, to pay and retire the bonds herein issued, the cost of all of such insurance to be considered a part of the expense of operating said dormitories and the premiums therefor paid from said "University of Oklahoma Apartment Dormitory Fund"; and (e) supply to any Bondholder, on request, annual financial statements on operation of the apartment dormitory project and condition of the sinking fund.

The chair declared the motion adopted.

Mr. Cate discussed the resolution, drawn by the Attorney General authorizing the sale of bonds and notice of sale by publication.

Thereupon Regent Wallace introduced a resolution which was read in full by the Secretary and upon motion by Regent Wallace, seconded by Regent Wimberly, was adopted by the following vote:

Aye: Hopper, Wallace, Deacon, Emery, McBride, Wimberly.

Nay: Noble.

RESOLUTION

A RESOLUTION AUTHORIZING AND DIRECTING THE SALE OF "UNIVERSITY OF OKLAHOMA APARTMENT DORMITORY BONDS," PROVIDING FOR THE GIVING OF NOTICE OF SALE OF SAID BONDS, AND PRESCRIBING THE FORM OF THE NOTICE OF SALE AND PUBLICATION THEREOF.

WHEREAS, the issuance of Two Hundred Seventy Five Thousand (\$275,000.00) Dollars of "University of Oklahoma Apartment Dormitory Bonds" by the Board of Regents of the University of Oklahoma, for and in behalf of the University of Oklahoma, has been duly authorized at a regular meeting, of said Board on the 14th day of June, 1945, pursuant to authority granted by Senate Bill No. 41 of the 20th Oklahoma Legislature, and

WHEREAS, the Board of Regents is of the opinion that said bonds should be sold at an advertised sale to the bidder who shall agree to pay par and accrued interest and stipulate in his bid the lowest rate of interest which said bonds shall bear.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF REGENTS OF THE UNIVERSITY OF OKLAHOMA:

Section 1. That the Two Hundred Seventy Five Thousand (\$275,000.00) Dollars of "University of Oklahoma Apartment Dormitory Bonds" authorized by the Resolution of the Board of Regents passed and adopted on the 14th day of June, 1945, shall be offered for sale at the office of the President of the University of Oklahoma, located in the Administration Building, in the City of Norman, County of Cleveland, State of Oklahoma, on the 26th day of June, 1945, at 10:00 p'clock, A.M.

Section 2. That the notice of sale of said bonds shall be on a form of notice as follows:

notice is hereby given that the Board of Regents of the University of Oklahoma will receive bids on the 26th day of June, 1945, at 10:00 o'clock, A.M., at the office of the President of the University of Oklahoma, located in the Administration Building on the campus of the University of Oklahoma at Norman, Oklahoma, for the sale of Two Hundred Seventy Five Thousand (\$275,000.00) Pollars of revenue bonds of the University of Oklahoma, which bonds are designated as "University of Oklahoma Apartment Dormitory Bonds," which bonds will mature:

> \$ 8,000.00 on July 1, 1947 to 1949, inclusive 10,000.00 on July 1, 1950 to 1952, inclusive 14,000.00 on July 1, 1953 to 1956, inclusive 15,000.00 on July 1, 1957 to 1959, inclusive 20,000.00 on July 1, 1960 to 1965, inclusive.

Said bonds shall be sold to the bidder bidding the lowest rate of interest the bonds shall bear and agreeing to pay par and accrued interest for the bonds. Each bidder shall submit with his bid a sum in cash, or its equivalent, equal to two (2%) per cent of the amount of his bid. The bonds will be offered for sale subject to the approval of the same by the Attorney General, and the approval of said bonds by Chapman and Cutler, bond attorneys, Chicago, Illinois, or other recognized bond attorney, or attorneys, who may be selected by the purchaser, the expense thereof to be paid for by the purchaser. The Board of Regents of the University of Oklahoma reserves the right to reject any and all bids.

Regent Wallace moved the adoption of the resolution.

On the vote on the motion for adoption all members voted "aye" except Regent Noble, who voted "no", with the statement: "for the reason it carries no call privilege."

The chair declared the motion adopted.

Regent Wallace made a motion "that the Secretary of the Board of Regents be authorized to accept the bids, but not to be opened until the next meeting of the Board of Regents.

The motion was adopted.

The Chair presented a Release of Mortgage in connection with a loan made to B. G. Brown and Nelle Brown from the Will Rogers Memorial Scholarship Fund, the loan having been paid off.

Regent Noble moved that the President of the Board be authorized to sign the Release of Mortgage, on behalf of the Board of Regents, University of Oklahoma Trustee for the Will Rogers Memorial Scholarship Fund.

The motion was unanimously approved.

President Cross stated Dean Lowry had asked that Dr. Fred C. Zapffe, Secretary, Association of American Medical Colleges, represent the School of Medicine of the University of Oklahoma at the hearing for approval of schools of medicine before the Approving

Authority for Colleges and Medical Schools, the Commonwealth of Massachusetts.

On motion by Regent Wallace, and voted, that Dr. Zapffe, represent the University Medical School, and that the President of the Board be authorized to sign the necessary forms.

President Cross reported that Savoie Lottinville had again raised the question of improved facilities both as to quarters and equipment for the University Press, and that unless assurance is given that this will be provided at the earliest opportunity he would accept another position which has been tendered him.

On motion by Regent Emery, it was voted that the President be authorized to tell Mr. Lottinville that the facilities of the Press will be improved just as soon as possible.

President Cross stated that Dean Cheadle, Administrative Assistant, had asked that he return to his work in the Law School and give up the work in the President's office. He discussed Mr. Dangerfield and recommended that the Board authorize a salary of \$7,500.00 for Mr. Dangerfield for this position.

It was the sense of the Board that Mr. Dangerfield would be an ideal man for this work, and on motion by Regent Noble, it was unanimously voted to authorize the President to make this offer to Mr. Dangerfield.

President Cross presented his nominations for directors of schools, and chairmen of departments as follows: showing the term for each. He stated the chairman for the department of Modern Languages had not been selected.
