#### BOARD OF REGENTS OF THE UNIVERSITY OF OKLAHOMA

(Wednesday, May 8, 1946.)

The Board of Regents of the University of Oklahoma met in regular session on Wednesday, May 8, in the office of the President of the University at 10:30 a.m.

Present were: Regent Wallace, president of the Board, presiding; Emery, Shepler, Dr. White, Noble, McBride, Deacon. Absent: None.

The minutes of the regular meeting held on April 10 were approved.

The minutes of the special meeting held on April 24 were approved.

The minutes of the special meeting held on April 29 were approved.

Regent Wallace read the following communication from Lippert Brothers, General Contractors, on the Veterans' Apartment project:

"May 6, 1946

Board of Regents University of Oklahoma

Gentlemen:

In compliance with your request made through the architects, Sorey, Hill, and Sorey, we are designating below the deductions which will be allowed from the actual charges and work that is going to be absorbed by the University Utilities Department.

# 1. Water Mains

For eliminating the material and labor on the water mains from the property line to a point where the four two-inch water meters are to be set including the fire hydrant and fittings, also the four two-inch valve connections, you may deduct the sum of \$1.000.00

Note: At the point where the meters are to be set and including the meter boxes will be constructed and furnished by us.

### 2. Sewer Mains

For eliminating the material and labor for the installation of the necessary sewer mains from the property line to and

including manhole Nos. 1, 2, 3 and 4. From these four manhole sewer services will be run and connections made to the several sewer outlets from the building at points five feet outside the building. For the elimination of this work you may deduct the sum of \$2.351.00.

# 3. Electrical Service

For the elimination of material and labor covering all overhead feeder lines including the installation of poles 2 to 5 and including the primary conductors between poles 1 to 5 inclusive; also including the transformers. For the elimination of this work you may deduct the sum of \$1,050.00. Note: We will make service connections from the transformers to the building.

## 4. Gas Service

For the elimination of material and labor covering all the gas distribution system from the property line to a point five feet outside of the buildings you may deduct the sum of \$1,632.00.

We trust these deductions are in conformity to your request for the work which you desire to perform yourselves; the above amounts to be deducted from the base bid of our contract.

President Cross reported that work is progressing on the above project, concrete foundations having been poured and that considerable material is on the ground.

President Cross discussed the report of the survey and recommendations concerning the Law School prepared by Dean Merrill, a copy of which was sent to each member of the Board. He stated Dean Merrill had suggested it be sent to members of the state bar.

Regent Emery moved, and it was voted "that the Board authorize and direct the President of the University to have such additional studies made, as reflected in Table A and others (salary comparisons, student-instructor ratios, and other subjects) as will bring such comparative studies up-to-date, and re-submit same to the Board for approval before submission to the bar."

President Cross stated Mr. Cate had sent information concerning the proposed bond issue for the 500-units pre-fabricated houses to various bond purchasers, and that several representatives were on hand to make proposals. The following appeared before the Board:

John H. Edwards was the only representative making a definite proposal, copies being supplied to the Regents. The other representatives stated they desired further information and they were directed to Mr. Cate. Action on the matter was deferred until later in the meeting.

Recess for lunch at 12:30. Guests: Dean A. B. Adams, and the following chairmen of departments in the College of Business Administration:

W. K. Newton, Accounting: I.J. Sollenberger, Finance; Floyd Vaughn, Marketing; E. E. Hatfield, Secretarial Science; Lee E. Thompson, Business Management; J. C. Powell, Business Law.

The Board met again in the President's Office at 1:45 p.m.

President Cross discussed a proposed cooperative program between the University of Oklahoma and Langston University to conduct summer workshops in Oklahoma City for negro teachers, and Extension teaching as a later possibility. The letter from Dr. F. A. Balyeat, Director of the Department of Adult Education, to President G. L. Harrison, Langston University, was read.

Following a discussion, Regent Emery moved, and it was voted "that upon the recommendation of President Cross, he be authorized to present the matter to the State Regents for Higher Education.

President Cross recommended approval of the following fee schedule for the summer of 1946:

The above fees are in addition to course and laboratory fees.

On motion by Regent McBride, it was voted to approve the recommended fee schedule.

President Cross reported the director of athletics recommends that a compulsory athletic ticket be required of all students, at a cost of \$10.00 for all athletic events during the school year. He explained there are approximately 39 events as follows: 4 football games; 15 basketball games; 12 baseball games; 4 track meets; 4 tennis, 3 golf and 2 swimming matches; the average cost per event would be approximately \$0.30. He recommended that the \$10.00 athletic ticket be approved, effective with the beginning of the fall term in September, 1946.

Regent Emery moved, and it was voted to approve President Cross's recommendation.

President Cross informed the Regents that Mr. Charles W. Hull, Special Representative of the General Housing Company, of Dallas, manufacturers of the pre-fabricated housing units, was available if the Board desired to discuss the matter with him. Mr. Hull was invited and he statedhis company was going forward with the work on the 500 units and that the first houses would be ready for delivery early next week, and that the ten units would be erected each day.

There was a discussion concerning the bond issue and it was explained to Mr. Hull that there would be some delay in meeting legal requirements. Following a telephone call to the president of his company in Dallas, Mr. Hull stated they would carry the account without interest for 60 days after starting with the work. He stated further, if circumstances are such that payment cannot be made at that time, the Regents would be expected to pay interest, at not to exceed 4 per cent for the time it is necessary to carry the account beyond the 60-day period; also that interest will be figured only on that part that has been expended for labor and materials.

The following amendment to the contract was proposed; it was signed by Mr. Hull for the General Housing Company, and by Regent Wallace for the Board of Regents:

#### "AMENDMENT TO CONTRACT

It is hereby agreed by the undersigned parties to two purchase orders dated April 19, 1946, covering the purchase of 300 16 x 16 Homettes and 200 16 x 32 Homettes which purchase orders incorporated the provisions of a proposal letter dated April 18, 1946, that the contract be amended to provide as follows:

Terms of Payment. It is agreed that the purchaser may defer without penalty the periodical monthly payments which become due as the work progresses until the date of receipt of proceeds of the bond issue sold to finance this project, provided further that if this deferment exceeds a period of 60 days after the beginning of work on the project at the site, then the University

of Oklahoma shall reimburse the General Housing Company for its actual carrying charges in bank interest which are incurred after the 60-day no-penalty period; but in no event shall such reimbursement exceed interest at the rate of 4 per cent per annum on the amount deferred beyond 60 days. It is further understood and agreed that the work done in any 30-day period after the 60 days shall have expired shall bear interest, if not paid when due, after such 30-day period not to exceed said four per cent. This amendment is not intended to replace the provisions of the original contract except temporarily for a period in which proceeds from the bonds issued for this project are not available to the University. The terms of payment described herein shall apply to the purchase order contract covering utility extensions and site improvements and executed by the same parties under date of May 9, 1946.

President Cross read the following letter from Mr. Kraft:

"April 25, 1946

President George L. Cross Faculty Exchange

Dear Dr. Cross:

With reference to the correspondence with the State Highway Commission regarding the easement for right-of-way requested by the State Highway Department across the grounds of the Southern Oklahoma Hospital at Ardmore, Oklahoma, I wish to advise that I have discussed this matter with Mr. L. T. Dyche, Engineer of Right-of-Way for the State Highway Department, and with Mr. Peyton Smith, Engineer, State Board of Public Affairs.

Mr. Dyche showed me the record of payments made or proposed for right-of-way both North and South of the property of the Southern Oklahoma Hospital. For the right-of-way just worth of the hospital property, they are paying \$3000 for a distance about 100' shorter than that across the hospital grounds. However, included in their price is the right to take a considerable amount of dirt from the property for the purpose of making a fill. For the property on the South they are paying about

\$2600 for approximately an equal amount of right-of-way plus an additional amount for the removal of a structure. Under the circumstances, I would recommend that \$2500 be the price for the right-of-way across the property of the Southern Oklahoma Hospital as requested by the State Highway Department.

President Cross recommended that the State Board of Public Affairs be notified that the Regents will agree to a payment of \$2500.00 for the right-of-way easement at the Southern Oklahoma Hospital, from the State Highway Department.

On motion by Regent Emery it was voted to approve the recommendation.

President Cross read the following letter which had been sent to him by Mr. Robert H. Dott, Director of the Oklahoma Geological Survey:

Dear Bob:

Now that the location of the insulation plant at Ada seems assured I want to express to you the appreciation of Mr. Banister and myself as well as the Frisco of the splendid work performed by you and your staff which was largely responsible for the plant locating in the section. We are not unmindful of the fact that this important plant location might lead to the location of other kindred plants.

I know this accomplishment on the part of your organization is the source of personal pride and satisfaction to you because of your undying faith in the importance of the mineral resources of that part of the State.

The Regents expressed pleasure in this report, and directed the President to express appreciation to Mr. Dott on behalf of the Board for the excellent work and extraordinary endeavors of the Oklahoma Geological Survey.

President Cross recommended the granting of 12 scholarships for freshmen in the College of Fine Arts under conditions as outlined by Dean Salter.

Regent Emery moved, and it was voted to approve the 12 scholarships as recommended, to be administered by the Dean of the College of Fine Arts and the President of the University.

President Cross requested that the Board reconsider its action prohibiting the employment of relatives within the third degree. He explained the difficulties in securing competent teachers and other employees, the critical housing situation, and other factors. He recommended that for the duration of the emergency the rule be revised to state that no one related within the third degree be appointed to any position in which tenure is contemplated; that during the emergency there be made temporary appointments, and that when housing is available such appointments be terminated.

Regent Noble moved, and it was unanimously voted, that the rule on non-employment of relatives be rescinded for one year in accordance with the President's recommendation.

President Cross stated estimates had been received for the remodeling of the Masonic Dormitory, and emphasized the importance of beginning the work immediately. The delay in completing the bond issue and therefore failure to secure possession of the building, will prevent completion of the work by the opening of the fall term.

It was unanimously voted to authorize the President of the University and the President of the Board of Regents to enter into a contract for the remodeling and redecoration of the Masonic Dormitory building.

It was unanimously voted that the President of the University be authorized to request a temporary loan in the amount of \$75,000.00 from the State Regents for Higher Education for the above purpose.

Regent Wallace stated he would endeavor to secure the permission of Mr. Stuart to begin work immediately.

The representatives of bond houses were again invited to appear before the Board to make their proposals for the purchase of the \$1,300,000.00 bond issue following their conferences with Mr. Cate who supplied the additional information requested.



None of the representatives made either written or oral proposals, except Mr. John Edwards, whose proposal was as follows:

"May 8, 1946

Honorable Board of Regents University of Oklahoma Norman, Oklahoma

## Gentlemen:

For your proposed \$1,300,000.00 Dormitory Revenue Bonds, to be designated "Single Unit Dormitory Bonds" or some other similar designation, bearing an average rate of interest equivalent to 2 per cent per annum for the life of the bonds, we will pay you par and accrued interest, subject to the following provisions:

1. Provided that the bonds mature as follows:

- The Board of Regents agrees to adopt a rent schedule sufficient both to operate and maintain the buildings and to equal one and one quarter (12) times the average annual requirement for payment of principal and interest. Excess revenue over the amount required for operation, maintenance and debt service shall be paid into the sinking fund of this bond issue and used to call outstanding bonds of this issue prior to maturity in the following manner: 1946 bonds callable at par any interest date on or after December 1, 1948; 1955 bonds callable at par any interest date on or after December 1, 1950; 1954 bonds callable at par any interest date on or after December 1, 1953; the order of call within any one maturity to be determined by lot; provided further that a cash reserve of \$125,000 shall be created to insure prompt payment of the principal and interest, at the rate of not less than \$31,250.00 each year for four years. This reserve shall be maintained so long as any of the bonds of this issue remain outstanding and not matured.
- 3. The Board of Regents agrees to carry all necessary insurance to fully protect the value of the buildings and furnishings, and also to carry use and occupancy insurance on the rental value of the property.

- 4. The Board of Regents agrees to adopt suitable regulations to insure full occupancy of the buildings.
- 5. It is further agreed that in the event the rental revenue becomes insufficient to service these bonds as herein provided, the Board of Regents shall charge a general fee payable by all students attending the University of Oklahoma in a sufficient amount to make up any such deficiency. It is also agreed that if the Board of Regents is unable to issue these bonds with a legal pledge of a general student fee as a contingent guarantee on the bonds, then we shall pay par and accrued interest for the bonds subject to all of the other foregoing provisions except that the rate of interest shall average 3 per cent per annum over the life of the bonds with a maturity schedule as follows:

WHEREAS, the term of E. C. Hopper who served as President of the Board of Regents of the University of Oklahoma last year expired on March 29, 1946; and

WHEREAS, E. C. Hopper was a football letterman and a graduate of the great state University of our neighbor to the South - Texas - and like all Texans layal to their heritages and traditions, nevertheless when we met his Alma Mater in any field of competition there has been no member of the Board or of our alumni more enthusiastic in their support of the University than this Sooner-by-adoption; and

WHEREAS, during his entire term as a Regent he gave unsparingly of his time, efforts, and thoughts in the interests of the University of Oklahoma;

NOW THEREFORE, BE IT RESOLVED that the Regents express their deep regret by reason of retirement of E. C. Hopper as Regent of the University; that they declare their sincere appreciation for his leadership, his sincerity of purpose, his faithfulness, and his constant interest in the welfare of the University.
