BOARD OF REGENTS Regular Meeting, August 14, 1946

The Board of Regents of the University of Oklahoma met in regular session in the office of the President of the University, at Norman, on August 14, 1946, at 10:00 a.m. There were present W. R. Wallace, President, and the following members: Lloyd Noble, Erl Deacon, Joe McBride, Ned Shepler, Dr. Oscar White. Absent: Don Emery.

The minutes of the regular meeting held on July 10, were approved.

President Cross reported that the Federal Public Housing Authority had requested that some additions be made to equipment in the Eederal Dormitories for which the University would receive reimbursement. He proposed the following resolution:

RESOLUTION

RESOLVED, that the President of the University of Oklahoma-George L. Cross-be, and he is hereby authorized to sign on behalf of the Board of Regents, the Agreement between the University of Oklahoma and the Government for various Dormitory and Cafeteria repairs on Project Okla - 34071, more specifically described as follows:

Item 1. Additional high limit controls duplicating existing units. This is to be done in accordance with established procedures, wherein relief vents are not provided and the alternate method of dual high limit controls is to be used.

Item 2. Asbestos wall board between ceiling and existing duct structures where insufficient clearance has been provided.

This agreement provides that the Government shall pay to the University of Oklahoma the actual cost and/or expense under this contract not to exceed Six Hundred Fifty (\$650.00) Dollars.

On motion by Deacon, the resolution was unanimously adopted.

President Cross submitted a revised fee schedule stating the revisions had been presented as necessary to meet changes in courses, increased costs of supplies and apparatus, and changing from "deposits" to fixed course and laboratory fees to meet accounting procedures of the Veterans' Administration in connection with Veterans' enrolments. He called special attention to the breakdown for the athletic fee

authorized at the July 10 meeting on which he would make a separate recommendation, and the Sooner Yearbook fee on which a separate recommendation would be made. He called attention also to the \$90.00 per semester fee for Flight Instruction.

Following a discussion of the fee schedule, a copy of which is shown below, Regent McBride moved, and it was unanimously voted to approve the recommendation as submitted by President Cross.

President Cross discussed the various items and emphasized the statement is the best estimate that can be made at this time.

On motion by Snepler, the statement was approved and ordered filed.

President Cross stated it is desirable that additional cafeteria space be provided at the Woodrow Wilson Center to accommodate the large number of students who will be taking their meals in this facility. Following a discussion a resolution was proposed by President Cross:

RESOLUTION

RESOLVED, that the Service Unit of the Physical Plant Department of the University, under the supervision of Walter W. Kraft, Superintendent of the Physical Plant of the University, is hereby authorized to construct and equip an addition to the Wilson Center dining room at a total cost not to exceed twenty five thousand dollars (\$25,000.00); and the Service Unit shall be re-imbursed for actual cost of labor and materials used in this project, within the limit specified, from the proceeds of the \$1,500,000.00 dormitory bond issue of 1946 issued by the Regents to construct, add to, furnish and equip dormitories, including Wilson Center.

Motion by McBride, seconded by Deacon, and unanimously voted to adopt the resolution.

President Cross read a letter from Howard Dickey, Chief Clerk in the University Hospital concerning the Blue Cross Hospital Service, asking that the Board of Regents approve the application of the Hospital to become a member hospital in the Blue Cross Hospital Service, and explaining the advantages to the Hospital of such membership.

Moved by Dr. White, and unanimously voted, to authorize the President of the Board of Regents to sign the application on behalf of the Board of Regents.

President Cross asked that the Board authorize an additional temporary loan in connection with the pre-fabricated housing program. He stated the bonds had been signed but would not be ready for delivery to purchasers before approximately September 5, and that additional payments would need to be made to the contractors to cover materials on hand and work completed. He stated an additional loan in the amount of \$300,000.00, above the \$500,000.00 authorized at the meeting on July 10, would be required.

The following resolution was proposed:

RESOLUTION

BE IT RESOLVED by the Board of Regents of the University of Oklahoma that the officers of said Board are severally authorized to borrow from the First National Bank and Trust Company of Oklahoma City additional sums of money not to exceed \$300,000.00 (a loan in the amount of \$500,000.00 was authorized at the meeting on July 10) making a total loan in the amount of \$800,000.00, said indebtedness to bear interest at a rate not to exceed 3% per amnum and to become due and payable on or before December 31, 1946, and to use said funds in the construction of dormitories heretofore authorized; to execute and deliver appropriate note evidencing said indebtedness; and for the purpose of securing the payment of said indebtedness to pledge and assign the proceeds of sales of dormitory bonds and such other funds as may lawfully be used to pay said indebtedness.

Provided that the note or notes computed to evidence said indebtedness shall not be a personal obligation of any member of the Board of Regents of the University of Oklahoma; and that said note or notes shall never be sold, transferred, or assigned until after the maturity or maturities thereof; and that the First National Bank and Trust Company of Oklahoma City, upon the delivery of said note or notes shall contemporaneously deliver to the Board of Regents of the University of Oklahoma a written declaration signed by said Bank and Trust Company evidencing the above stated provisos.

Regent McBride moved, seconded by Deacon, that the resolution be adopted. On the vote on the motion all members voted "AYE", and it was declared adopted.

President Cross stated he had been unable to find a replacement for Dr. Battenfield as Director of the University Infirmary, and that several doctors whom he had interviewed and considered qualified for the position would not accept the salary paid Dr. Battenfield—namely, \$6000.00 on a twelve months basis. He asked authority to employ a Director of the Student Health Service (University Infirmary) at a salary of \$10,000.00 or \$12,000.00 if necessary to secure a competent Director.

Dr. White moved, and it was unanimously voted, to authorize the President to pay the salary indicated.

President Cross brought up the question of the Articles of Incorporation of the Athletic Council, this matter having been discussed a year ago without reaching a final solution to several problems. He suggested a meeting of the Board with the members of the Athletic Council.

Following a discussion during which it was suggested that copies of all material concerning this question be re-submitted to refresh the memory of each member.

Regent Noble moved, and it was voted, that President Cross arrange for the meeting as suggested.

It was suggested also that President Cross prepare plans for expansion of the field house, intramural, physical training, and other athletic facilities.

In discussing the housing situation, President Cross urged that "we proceed on the Women's Dormitory program". He stated there are no additional rooms for girls, the only housing being in the sorority houses and the Women's Residence Halls; that due to FPHA restrictions the Masonic Dormitory could not be used for girls since 80% veteran occupancy is required.

The Board expressed itself as in favor of proceeding with the Women's Dormitories.

President Cross stated further that the plans for developing the veterans' college at the South Base would have to be postponed due to lack of housing for faculty. He called attention to the communication from Messrs. Rambo and Crew, a copy of which was sent to each member of the Board.

The matter was referred to "the President and his assistants" and that he prepare a breakdown of the whole plan, the total cost, plan of liquidation, overhead expense, etc. The President was asked to bring in a report at a later date.

President Cross reported that the Fisheries Laboratories, of the Oklahoma State Fish and Game Commission would be located on the North Base instead of on the south end of the drill field as previously planned, that a building is available for temporary use, and more space for test ponds. If and when a title to the base is acquired the Department will construct its own permanent building.

Regent Noble suggested the importance of contracts in the state through this project, and assistance to the public in solving problems with reference to ponds, soil erosion, etc. He suggested that qualified persons be added to the staff of the Oklahoma Biological Survey.

President Cross made the following reports and recommendations, and the action in each case was as indicated:

"I regret to inform you that James Huston Felgar, Dean Emeritus of the College of Engineering, died on July 19, 1946, following a brief illness. I recommend that a suitable resolution be adopted and that a copy be sent to Mrs. Felgar."

The Board expressed sincere regrets in the death of Dean Felgar, and asked that President Cross convey this message to Mrs. Felgar with an appropriate resolution.

Recommended that the previous action concerning the School of Religion (severance of relations May 29, 1946—page 2082) be rescinded.

Approved on motion by Regent Deacon.

President Cross called attention to the action of the Board of Regents at the meeting held on July 10, providing for a compulsory athletic fee in the amount of \$10.00 for each student effective with the fall term, 1946. He asked that the previous action be amended to provide for a breakdown of the fee which would provide for a payment of \$6.00 for the fall, or first semester, and a payment of \$4.00 for the second or spring semester.

On motion by Deacon, it was unanimously voted to approve the President's recommendation, and that the fee schedule be changed accordingly.

President Cross called attention to the discussion concerning the compulsory yearbook fee at the meeting on July 10, no action having been taken at that meeting. He stated he had had further conferences on the matter and that he desired to recommend that a compulsory fee of \$6.00 for the yearbook (Sooner) be established effective with the fall enrolment in September, 1946.

On motion by Dr. White it was unanimously voted to approve the President's recommendation, and that the fee be included on the fee schedule for the fall smester of 1946.

Recommended that effective on this date (August 11, 1946) the Department of Music, in the School of Music of the College of Fine Arts, be known as the Department of Applied Music and Theory.

Approved.

Lytle Powell, Associate Professor of Music (Piano), who was granted a leave of absence under the regulations governing Sabbatical leaves, has asked that this action be rescinded. Recommended approval.

Approved.

Recommended naming of various University Housing projects as follows:

- (1) That the house formerly known as the Graduate House be named "Terry House". The house was purchased from Mr. Terry through the University of Oklahoma Housing Authority.
- (2) That the Masonic Dormitory be named "Whitehand House" in the memory of Robert Whitehand, the only University Faculty member who lost his life in the war.
- (3) That the prefabricated project be named "Sooner City".
- (4) That the four apartment dormitories be known as the "Nieman Apartments" in memory of Hal Nieman, a former student for whom the memorial which stands adjacent to the apartment dormitories was built. That the four separate buildings be named "Chickasaw", "Seminole", "Cherokee", and Choctaw" after the five civilized tribes.

President Cross reported with reference to the material on the drama which Mrs. Mort L. Bixler has collected over many years, and which would be very valuable to the School of Drama for research and instruction. He stated Mrs. Bixler had asked \$7,500 for this material, but another proposal, that she be employed for the remainder of her life (she is now 77) would appeal to her more than an outright purchase. President Cross suggested the possibility of an offer of \$5,000 or \$6,000 and one year of services, a total not to exceed \$7,500 for the material and one year salary.

Regent McBride moved, and it was voted, to authorize President Cross to work the problem out on the best basis possible.

Regent Noble suggested that President Cross make an attempt to get someone to give the collection to the University.

President Cross discussed the chairmanships in the Medical School, Oklahoma City. He recommended "that the appointments of departmental chairmen and other administrative officials in the School of Medicine and the University Hospitals be on a one-year basis to July 1, 1947 and that time appointments, or reappointments shall be made in line with the policy on the Norman campus.

On motion by Dr. White, the recommendation was approved.

Recommended that the Departments of Physiology and Pharmacology be combined under one chairman, effective at the beginning of the fall semester, 1946. President Cross explained that Physiology and Pharmacology are closely related subjects, and it is the opinion of the Dean that such a combination is feasible and that the efficiency of both departments can thereby be enhanced economically.

On motion by Dr. White, the recommendation was approved.

President Cross reported on several conferences he had had with the Dean of the School of Medicine, and others on the staff, concerning Dr. T. M. McDonald, Associate Professor of Pathology. Dr. H. C. Hopps, Chairman of the Department of Pathology recommends that the appointment of Dr. McDonald be terminated, the reason being that his services as an instructor have not been satisfactory. This situation has been under discussion for a number of years and it was the hope of the staff that this matter would be remedied during Dr. McDonald's leave of absence. Dean Langston concurs in Dr. Hopps' recommendation.

President Cross stated he had discussed the matter with Dr. McDonald and that he has agreed to submit his resignation to become effective at the close of the school year 1946-47 on conditions that he receive his full salary \$3,840.00 during the year. This conforms to the policy of the AAUP and the North Central Association.

President Cross recommended that Dr. McDonald be placed on the status of a leave of absence, with Full salary, during the school year 1946-47; also that he be relieved of the obligation to return to the University the amount paid him while he was on sabbatical leave of absence, on condition that he submit his resignation at this time to become effective at the close of the year, June 30, 1947.

On motion by Regent Noble, the recommendation was unanimously approved.

President Cross reported that the Alumnae Association of the School of Medicine is establishing the Oklahoma Medical Research Foundation. This foundation is collecting funds to build a research

institute and a cancer hospital. The Park Board of Oklahoma City has advised the Oklahoma Research Foundation that Block 11, 2nd State Capitol Addition of Oklahoma City, formerly belonging to Oklahoma City, now belongs to the State of Oklahoma. In order to satisfy donors it is necessary that the foundation secure the deed to the land on which its proposed buildings will be built. The Foundation has approached the University and asked me to take steps to secure for the Oklahoma Medical Research Foundation title to the land described above.

Following the discussion of the matter, it was the sense of the Board that this matter be referred to the Attorney General for a decision on the question of the Oklahoma Medical Research Foundation securing title to the land. Regent Wallace explained with reference to conferences he had had with its most active members in the Foundation. He stated that articles of incorporation had been prepared and that the Foundation was contemplating the employment of a man in September to raise funds for the Foundation. Regent Noble asked that each member of the Board be furnished a copy of the by-laws and the articles of incorporation.

There being no further business, the meeting was adjourned at 12:30 noon.
