MINUTES OF THE MEETING OF THE BOARD OF REGENTS UNIVERSITY OF OKLAHOMA Wednesday, January 8, 1947 10:00 a.m.

The regular monthly meeting of the Board of Regents was held on Wednesday, January 8, 1947, at 10:00 a.m. in the office of the President of the University.

The following were present: W. R. Wallace, President, presiding; Noble, Emery, White, Shepler, McBride. Absent: Deacon.

Regent Emery asked that the minutes record his concurrence in the observations and reflections of Regent McBride on the vote on the Student Union resolution which was adopted at the meeting held on Wednesday, December 18, 1946. (Noted in minutes, December 18, 1946.)

The minutes of the meeting held on Wednesday, December 18, 1946, were approved.

President Cross asked permission to bring up the question of the football coaching staff on account of developments since the agenda was mailed. By unanimous consent the President's request was granted.

President Cross stated that Coach Tatum is considering a transfer to the University of Maryland at a considerable increase in salary and that newspaper reports indicated Mr. Wilkenson was being considered for a position at Drake University, Des Moines, Iowa. He stated that he had discussed the situation with Jap Haskell and Mr. Tatum, and that he had also conferred with the Athletic Council.

Following a full discussion of the entire situation, President Cross recommended that he be authorized to negotiate with Mr. Tatum at a salary of \$12,000.00 a year for the two remaining years of his present contract with the clause in the present contract providing for a bonus of \$3,000.00 stricken. Also that he be authorized to adjust the salaries of assistant coaches to provide a maximum increase of \$1,000.00 each.

Regent White moved, and it was unanimously voted, to approve the recommendation.

President Cross reported that arrangements had been made to establish a help-yourself laundry for use by residents in the pre-fab area and Woodrow Wilson Center.

January 8, 1947.

Regent Wallace reported that the officials of the Sun Ray Oil Corporation and the Phillips Petroleum Company, holders of leases on land on the University Hospital and Medical School Campus, had agreed to change the Extension of Oil and Gas Lease to provide that no well shall be drilled on said property without the written consent of the lessor in accordance with the action of the Board at the meeting on December 18 and that a copy of the resolution adopted on that date had been forwarded to the Commissioners of the Land Office.

The Board recessed for lunch in the Oklahoma Memorial Union. The following members of the Law School faculty were guests of the Board at the luncheon: W. Page Keeton; Maurice Merrill; John B. Cheadle; Victor H. Kulp; William B. Swinford; Olin L. Browder, Jr.; Elbridge D. Phelps; Earl Sneed, Jr.; John Wesley Reed; and A. H. Huggins.

President Cross called attention to the certificate of authority authorizing the expenditure of funds from the Governor's Contingency Fund issued by Governor Kerr under date of September 12, 1946, in the amount of \$138,444.31 to the University Hospitals for supplementary operational expenses for the period beginning July 1, 1946, and ending December 31, 1946. He stated a like amount would be required for the last six months of the fiscal year, or close a part of the hospital. He explained that the State Regents for Higher Education during the Twentieth Legislature had recommended less in appropriations than the amount requested and in addition, the costs of supplies, food, and other items had increased greatly and that it had been necessary to raise salaries in order to maintain the hospital staff.

Regent White stated that the number of student nurses was far below normal and that two of the large wards are nearly vacant because of the impossibility of securing an adequate staff; that he understood funds are available for graduate nurses if they could be found, but that there have been insufficient applications for student nurses. He gave the figures on Government allowances under the Cadet Nursing Program, none of which are available under our present plan.

Regent Wallace stated, "There is no question but that the hospital must be operated at full capacity."

President Cross recommended that a deficiency appropriation be requested to cover the last six months of the fiscal year and that the Board of Regents adopt a resolution. The following resolution was presented by President Cross:

RESOLUTION

WHEREAS, the allocations for the University Hospitals by the State Regents for Higher Education for the fiscal year beginning July 1, 1946 were insufficient for operation expenses for the first six months of the said fiscal year; and,

WHEREAS, Governor Robert S. Kerr issued "Certificate of Authority No. 32" authorizing the expenditure of funds from the Governor's Contingency Fund in the sum of One Hundred Thirty-eight Thousand Four Hundred Forty-four Dollars and Thirty-one Cents (\$138,444.31) to be allocated in turn by the State Regents for Higher Education to the University Hospitals for supplemental operation expenses during the first six months of the said fiscal year;, and

WHEREAS, an emergency exists and a like amount will be required for the last six months of the fiscal year due to the additional expense incurred for the operation of the enlarged wards for negro patients, the additional expense incurred in the maintenance and operation of the Southern Oklahoma Hospital, the additional expense incurred due to the increased cost of food, clothing, hospital supplies, drugs, salaries, and the loss of anticipated revenue, upon which the original budget was to be financed, due to withdrawal of Federal funds on the cessation of hostilities;

NOW, THEREFORE, BE IT RESOLVED that the Board of Regents of the University of Oklahoma request that the State Regents for Higher Education ask the Twenty-first Legislature for a deficiency appropriation in the amount of One Hundred Thirty-eight Thousand Four Hundred Forty-four Dollars and Thirtyone Cents (\$138,444.31) and that the said State Regents for Higher Education allocate the said sum to the University Hospitals.

The resolution was unanimously adopted by the Board on motion by Regent White.

President Cross stated that a special meeting of the Board of Governors of the Oklahoma Memorial Union had been called for 6:00 p.m. on Friday, January 10 to discuss the resolution of the Board of Regents adopted at the meeting on December 18, 1946, copies of which had been sent to each member of the Board of Governors. Regent Emery moved and it was unanimously voted to adjourn until 10:00 a.m. on Friday, January 17, and at that time take up the Oklahoma Memorial Union matter.

The meeting was adjourned at 3:40 p.m.
