MINUTES OF THE MEETING OF THE REGENTS OF THE UNIVERSITY Wednesday, March 10, 1948 1:00 p.m.

The Regents met in regular session on Wednesday, March 10, 1948. Present were Regents Noble, presiding; Deacon, Emery, Benedum; Absent: Shepler, McBride, White.

President Cross called attention to the ceremonies on April 27, at which time the Distinguished Service Citation awards will be made, at a banquet which will be held in the evening. He urged that the Regents attend this banquet, and asked that a member of the Board be designated as presiding officer.

Motion by Regent Deacon, and unanimously voted, that Lloyd Noble be designated master of ceremonies at the dinner.

President Cross reported the following were selected to receive the Distinguished Service Citation Awards by the committee on selection:

Alumni:

Everett L. DeGolyer, 1000 Continental Building, Dallas, of the class of 1911, petroleum geologist and one of America's most distinguished pure scientists.

The Honorable A. S. "Mike" Monroney, congressman from the Fifth District of Oklahoma, an alumnus of the University, class of 1924, whose record in the field of statesmanship has been recognized through the \$10,000 Collier's Award.

Mr. Lynn Riggs, poet and playwright, alumnus of the University, ex-23, who is perhaps best known for Green Grow the Lilacs and Oklahoma!, the musical play, which was based upon that production.

Non-Alumni:

Lt. General Raymond S. McLain, Oklahoma City, who achieved higher rank than any Oklahoman before him has done, and whose record of service in World War II is one of the most remarkable of any that we know.

Major General William S. Key, Oklahoma City, who is also a distinguished soldier and was one of Oklahoma's highest ranking officers during World War II.

President Cross stated the Committee on Selection had suggested some changes in the charter, after holding several meetings, more particularly with reference to the term of service on the committee; and, the distribution of awards as between alumni and non-alumni.

Following a discussion, and on recommendation by President Cross, Regent Benedum moved, and it was unanimously voted, that the following amendments to the charter be submitted to the Alumni Board for consideration.

- l. The awards shall be made to distinguished Oklahomans, or to alumni of the University of Oklahoma wherever located. The number of alumni to be selected to be left to the discretion of the committee.
- 2. That the number of recipients for the Distinguished Service Citation in any one year be limited to a maximum of three.

President Cross recommended that the salary of Dr. Royden Dangerfield, Executive Vice-President, be fixed at the annual rate of \$8,400 effective July 1, 1948.

President Cross recommended that he be authorized to adjust the salary of Dr. Arnold Joyal, Dean of the College of Education. to \$8500 effective July 1, 1948, if necessary.

Regent Emery moved, and it was unanimously voted, that the salary recommendations of Dr. Dangerfield and Dean Joyal, as made by President Cross, be approved.

President Cross recommended that Dr. Dangerfield be granted a leave of absence, without pay, from September 1 to December 31, 1948, in order that he may accept the invitation of Vice Admiral Harry Hill, Commandant of the National War College, to join the staff of the National War College as civilian instructor for the first semester of 1948-49.

Regent Benedum moved, and it was unanimously voted, to approve the President's recommendation that Dr. Dangerfield be granted a leave of absence from September 1 to December 31, 1948, to participate in the War College.

President Cross reported that he and the Financial Vice-President, Mr. Cate, had negotiated for an offer for the proposed Power and Heating Plant bonds as authorized by the Regents at the meeting held January 14, 1948.

He reported further that the University had been notified by Lee Higginson Corporation, R. J. Edwards, Inc., and associates that a firm order had been received from the Mutual Life Insurance Company of New York for \$1,800,000 Regents of the University of Oklahoma Power and Heating Plant Bonds, to be dated approximately April 1, 1948, and to mature serially in 24 installments from July 1, 1949, to July 1, 1972, and to bear interest at the rate of three and one-quarter per centum $(3\frac{1}{4})$ per annum, payable semiannually on and after January 1, 1949, subject to the following terms and conditions:

1. That the maturity schedule shall be such as will produce relatively level annual debt service requirements.

- 2. That the Board of Regents will continue to levy upon and collect, beginning the summer term of 1948, from all students in attendance at the University of Oklahoma at Norman, both in regular and summer sessions, a general student fee in an amount (A) necessary to produce and to deposit into the bond fund 133 1/3% of the average annual debt service requirements of the loan in each year and (B) an amount sufficient when taken in conjunction with the operating revenues of the power and heating plant to provide for and to pay all expenses of operation and maintenance, insurance, replacements, renewals and necessary improvements.
 - 3. That a reserve fund of \$200,000 will be established.
- 4. That all bonds called with the proceeds of surplus revenues in the bond fund shall be callable at par in inverse order or maturity and by lot within the maturity on any interest payment date on or after July 1, 1950.
- 5. That a capital improvement fund would be created with whatever surplus revenues may accrue either from the operation of the system or from other sources, which funds shall have the privilege at the direction of the Board of Regents of calling bonds prior to maturity in inverse order of maturity and by lot within the maturity on any interest payment date on or after July 1, 1950, at 100 plus a premium of 3%, the call premium to be reduced 1/4 of 1% in each succeeding two-year period so that the call premium in 1971 shall be only 1/4 of 1%.
- 6. That the terms and conditions of the bond resolution shall be mutually agreeable and satisfactory and shall contain the usual restrictive provisions for the benefit of both the bondholders and the Board of Regents.
- 7. That the bonds will be issued subject to the unqualified approving opinion as to legality of issuance by the Attorney General of the State of Oklahoma and by Messrs. Chapman and Cutler, Attorneys of Chicago.
- 8. That we are to absorb the expenses incurred in connection with the preparation of the resolution, the printing of the bonds and the legal opinion of Messrs. Chapman and Cutler, of Chicago, but that you are to absorb any expenses incurred in having the bonds validated by the Supreme Court of the State of Oklahoma.
- 9. That in return for our services we are to receive a fee equal to 25% of the par value of the bonds, which fee is to be paid to us either in cash at the time of delivery or by extra coupons to be retained by us in like amount at the time of delivery of the bonds.
- 10. That a mutually acceptable trustee will be appointed to have and to hold in a special trust account for the benefit of the bondholders all funds required for the debt service under the terms of the bond resolution.

President Cross recommended that the offer for the bonds be accepted in accordance with the general terms agreed upon in the

negotiations, as stated above, but subject to later approval by the Regents of a resolution stating in full detail all the terms of the bond issue.

After discussion, Regent Deacon moved that, contingent upon inability to make better arrangements, the offer for the \$1,800,000 Power and Heating Plant bonds made by the Mutual Life Insurance Company of New York, on the general terms reported by President Cross, be accepted by the Board of Regents subject to later approval by the Board of a resolution stating in full detail all terms of the bond issue.

The motion was seconded by Regent Emery and was passed by the following vote: Aye: Deacon, Emery, Benedum, Noble. No: None.

President Cross recommended that the Regents authorize the release to the Board of Governors of \$15,000 of impounded funds collected through the Union fee for the purpose of working on plans for the Union Building expansion program.

Moved by Regent Emery and unanimously voted, to approve the recommendation.

Dean Everett reported on bids received covering X-ray equipment for the University Hospital Addition, listing the items and bids on individual items, the total from various companies being as indicated:

Merkel X-Ray Company, Oklahoma City, \$20,000.00

Pengelly X-Ray Company, Minneapolis, \$30,700.00

Midwest X-Ray Supply Company, Tulsa, Oklahoma, \$35,028.00

R. P. Kincheloe Company, Oklahoma City, \$30,651.26

General Electric X-Ray Corporation, Milwaukee, Wisconsin, \$24,575.00

The low bid is from the Merkel X-Ray Company, Oklahoma City, in the amount of \$20,000.00 complete as specified, covering installation and guarantee.

President Cross recommended that the low bid of Merkel X-Ray Company be accepted.

Moved by Benedum and unanimously voted that the President's recommendation be approved.

President Cross reported on his conferences with Dean Arthur B.

Adams, concerning his retirement as Dean of the College of Business Administration. He stated Dean Adams had expressed a preference for a Regents

Professorship upon retirement as Dean, and recommended that he be given that title when he retires. (Title of Dean Emeritus approved by Regents in the January 14, 1948 meeting)

Moved by Regent Emery and seconded by Regent Benedum, and unanimously voted, that the recommendation be approved.

President Cross called attention to his recommendation at the meeting on February 14, that Walter Driskill be appointed Assistant Football Coach, but that he had withdrawn the recommendation at that time. He again made the recommendation that Walter Driskill be appointed Assistant Football Coach, Associate Professor of Physical Education, and Coordinator of Intramural and Intercollegiate Athletics, at an annual salary of \$7,500.00 effective March 1, 1948.

On motion by Regent Benedum, it was unanimously voted to approve the appointment of Walter Driskill as recommended.

Recommended also, that Major Louis Hemerda be appointed as part-time football coach for the six-weeks spring practice period at a salary of \$30 a week.

Unanimously approved on motion by Regent Benedum.

President Cross recommended that the Board of Regents authorize the officers of the Board to execute a contract with Hudgins-Thompson-Ball and Associates, Architect-Engineers, Oklahoma City, providing for architect-engineer services in preparation of plans and specifications for construction of a radio transmitter house and associated construction work, on the terms suggested in the following memorandum from Mr. Kraft and Mr. Cate:

After making a study of the needs of WNAD in the construction of a new transmitter house Northwest of Norman, the installation of underground and overhead wires, construction of a sewage plant, the drilling of a water well, and the construction of roads, drives and landscaping, we recommend that the Board of Regents be requested to authorize employment of a firm of architect-engineers to prepare detailed plans and specifications for this work.

If the Board of Regents desires a suggestion as to a choice of architect-engineers, we recommend that the firm Hudgins-Thompson-Ball and Associates, be employed for this project. This particular firm has recently worked on plans and specifications for construction of two radio stations in Oklahoma City and has employed temporarily on its staff a radio-engineer specialist. The firm also has recently employed as a permanent member of its staff, an electrical engineer with considerable experience in connection with transmission lines. Most of the problems involved in this particular project will be engineering rather than architectural in nature.

We suggest that a contract be authorized providing for fees as follows: (1) a flat fee of \$550 for engineering services in connection with furnishing of boundary survey, setting corner monuments, preparation of topographic map with contour interval and scale as directed, staking of site for grading and terracing, and cross sectioning of site after work is completed to determine pay quantities; and (2) eight per cent (8%) of the construction cost for preparation of plans and specifications covering grading and terracing site, access road and drainage structure, water well, pump and complete water system, power lines from OGE encREA to transmitter building, and construction of transmitter building.

Because of the large proportion of engineering work as compared to architectural work in this project, plus the fact that it is a small job, it is believed that an 8% fee would be reasonable. The standard scale of engineering fees for each item under \$10,000 is 10%, according to the published schedule of the Oklahoma Society of Professional Engineers.

Moved by Regent Emery, and unanimously voted, to authorize the contract with Hudgins-Thompson-Ball and Associates, for services in connection with the radio transmitter house as recommended by President Cross.

President Cross recommended approval of the following items:

That Robert H. Rucker be employed as Consulting Landscape Architect on a part-time basis at \$225.00 a month, effective February 1, 1948. Mr. Rucker has been working much more than onehalf time since submitting his resignation, and will continue to do so. The appointment will be effective until July 1, 1948.

Approved.

That James A. Graves be named as recipient of the scholar-ship sponsored by the Oklahoma City Women's Aeronautical Association. This scholarship is for two academic semesters, beginning with the second semester of 1947-48 and is in the sum of \$250. This recommodation is based upon the scholarship record of Mr. Graves and the recommendation of Dean Carson.

That Herbert C. Oakes be named the recipient of a scholarship awarded by the Pumice Aggregate Sales Corporation. This scholarship is for an undergraduate student in the College of Engineering and the recipient thereof is to receive \$40 per month

for an academic year. The appointment will be effective February 1 and will run for the second semester of 1947-48 and the first semester of 1948-49.

Approved.

That authorization be granted to purchase a Miehle No. 29 Automatic Cylinder Press for installation in therman Press Building, at a cost of \$12,750. Authorization to purchase this press was approved at the November, 1947 meeting but the manufacturers would not accept an order except on the basis of "price prevailing at the time of shipment." The manufacturer has now promised delivery in April, but in the meantime the price has advanced.

Recommendation approved on motion by Regent Benedum.

President Cross recommended approval of a reallocation of plant funds as shown in the fourth column of the following statement. At the beginning of the 1947-49 biennium, the State Regents for Higher Education allocated \$800,235.00 in plant funds to the University. The revised allotment provides for \$425,000.00 for one unit of a Geology or Mineral Resources Center.

He recommended that a request be made to the Oklahoma State Regents for Higher Education for the revised reallocation of funds.

On motion by Regent Benedum it was unanimously voted to approve the recommendations.

Attention was called to the previous action designating Walter T. Vahlberg, Oklahoma City, as architect for the new Geology Building, but a contract for such services has not been executed for the reason that funds have not been specifically allocated for this purpose.

President Cross recommended that the officers of the Board be authorized to execute a standard architectural contract with Mr. Vahlberg upon receipt of notification from State Regents that the allocation for the Geology Building has been approved.

On motion by Regent Deacon, it was unanimously voted to approve the recommendation.

Recommended that the Regents authorize a change order increasing the amount of the construction contract on the Petroleum Engineering Building in the amount of \$13,865.00 to cover installation of a concrete slab, trenches and machine bases for the Plant Area of the Petroleum Engineering Building as explained in the following letter from the contractor to Walter W. Kraft. Funds for this purpose are available in the supplemental appropriation for construction of this project.

We have completed our estimate in connection with the concrete slab, trenches and machine bases for the Plant Area of the Petrožeum Engineering Building.

Our price for this work, based on performing the work in accordance with the plans as prepared by Bailey and Bozalis, Architects, would be \$13,865.00.

The above price, of course, is based upon the condition that we could start to work immediately while our supervising employees etc. are working on our original contract.

For your further information, the actual grating is not included in the above price, however, the angle guards to receive the same are included. The steel people advise us that this grating would cost approximately \$2,500.00.

Should this work be done after our original contract is completed we estimate that you should allow, over and above the prices given you above, approximately \$2,500.00 to cover supervision, general overhead, etc.

A communication, together with a resolution providing for a consolidation of the School of Medicine and University Hospitals with other schools and colleges of the University, were discussed.

Regent Emery suggested several changes both in the letter and the resolution which were acceptable to the other Regents and President Cross.

Regent Emery moved, and it was unanimously voted, to approve the resolution as modified, and that the letter be changed to correspond to the resolution.

The letter and resolution as modified follow:

March 3, 1948

To the Board of Regents:

The School of Medicine of the University of Oklahoma and the University Hospitals now operate with allotments of funds made separately from allotments made for the Norman campus of the University.

Dr. John B. Cheadle reports that it is clear that the State Regents for Higher Education, if they so desire, may consolidate the allotments.

During the last session of the Legislature, the State Regents for Higher Education made it very clear that the Board desires to deal with the President of the University rather than with the Dean of the School of Medicine in considering the problems of the School of Medicine and Hospitals. Some of the members of the University Board of Regents also have made it clear that they believe the affairs of the School of Medicine and Hospitals should be administered in much the same way as other Schools and Colleges of the University.

The Dean of the School of Medicine and the President of the University have agreed that, in order to administer the affairs of the School of Medicine and Hospitals in approximately the same way as other Schools and Colleges of the University, it is essential that the School of Medicine and Hospitals be made an integral part of the University for all purposes.

The President of the University has been handicapped in administering the affairs of the School of Medicine and Hospitals by reason of the fact that the Oklahoma City campus has operated as an independent financial unit.

Records of budget detail, contracts, purchases of supplies and equipment, accounting, auditing and other basic functions have been kept at Oklahoma City except for annual or especially requested reports. So long as funds are allotted directly to the Oklahoma City campus, and are disbursed there, this is the only way the financial operations can be handled.

It therefore has been difficult for the President to utilize the services of his administrative staff at Norman in policy determination for the School of Medicine and Hospitals. Because of the separate handling of funds, the financial operations of the Oklahoma City campus have not been subject to the policy controls that operate on the Norman campus through the offices of the Comptroller, the Chief Accountant, the Auditor, the Purchasing Office, the Physical Plant Office, the Financial Vice-President and the Executive Vice-President.

Deans of Schools and Colleges on the Norman campus devote very little time to business affairs and therefore have most of their time free to devote to academic affairs. Under the present form of administration of the School of Medicine and Hospitals, all business detail goes across the desk of the Dean. It has been demonstrated by experience that under such circumstances the Dean's desk becomes a bottleneck for business affairs, leaving him little time to devote to academic problems. The members of the administrative staff at Norman have no regular channels for assisting the Dean, because all of the official contacts of the two separate institutions are between the Dean and the President.

It is my opinion that, regardless of the ability and good intentions of whoever is serving as Dean of the School of Medicine and regardless of the ability of the business administrator of the Hospitals, the financial affairs of the School of Medicine and Hospitals will continue to be in a confused state until the administrative procedures are integrated with administrative procedures of the Norman campus, to the end that the President will have available at all times a clear and comprehensive picture of the financial operations as a basis for policy decisions.

The consolidation of the two institutions would help to lessen the unfortunate appearance of competition between the Norman campus and the Oklahoma City campus for funds from the State Regents. Moreover, a single allotment of funds for both the Norman campus and the Oklahoma City campus would create a much more flexible budget situation from the viewpoint of the School of Medicine and Hospitals. The University Board of Regents would be in a position to make adjustments in the budget of the School of Medicine and Hospitals after the beginning of a biennium instead of having to make the best of a rigid budget allotment to the Oklahoma City campus which cannot be adjusted regardless of circumstances that arise during a biennium.

It is therefore recommended that the University Board of Regents adopt the attached resolution requesting the State Regents

for Higher Education to consolidate, for all purposes, the School of Medicine and Hospitals and the Norman campus of the University.

RESOLUTION

WHEREAS, by virtue of Title 70, section 1981, Oklahoma Statutes 1941, the University of Oklahoma is one institution and the School of Medicine of the University of Oklahoma together with the University Hospital and the Crippled Children's Hospital may constitute a separate institution, (for the purpose of,) allotment of funds from Legislative appropriations made in consolidated form by the State Legislature of the State of Oklahoma to the Oklahoma State Regents for Higher Education; and

WHEREAS, the School of Medicine of the University of Oklahoma, the University Hospital, the Crippled Children's Hospital, and other teaching hospitals thereof and the University of Oklahoma are under the control of the Regents of the University of Oklahoma, and it is desirable and necessary for the efficient administration of each of said institutions and for the purchasing of supplies and the control and expenditure of their funds that they be operated, for all purposes, as a unit; and

WHEREAS, the Oklahoma State Regents are authorized by law to designate educational units which shall receive allotments as separate institutions and to change such designations under the provisions of Paragraph 8 of said Section 1981 of Title 70, Oklahoma Statutes of 1941,

EE IT THEREFORE RESOLVED:

That the Oklahoma State Regents for Higher Education be and it is hereby requested to consolidate, for all purposes, the School of Medicine and Hospitals with other schools and colleges of the University of Oklahoma as divisions of the University of Oklahoma, and to designate the University of Oklahoma as the institution entitled to receive allotments for said University and all its schools and departments including the School of Medicine of the University of Oklahoma, the University Hospital, the Crippled Children's Hospital and other teaching hospitals of said School of Medicine out of appropriations made to said Board for educational purposes by the Legislature of Oklahoma.

Moved by Emery and unanimously voted that the resolution as modified be approved.

President Cross recommended approval of a revision of use of plant funds allocated to the School of Medicine and Hospitals for the Mennium of 1947-49. Dean Everett reports these changes are necessary to make the program conform to the contract prices of the various projects. The proposed revisions are shown on the following statement:
