REGENTS OF THE UNIVERSITY Wednesday, November 10, 1948 10:00 a.m.

The Regents of the University met in regular session in the Office of the President of the University, Norman, on Wednesday, November 10, 1948, at 10:00 a.m. Present were Regents Deacon, President, presiding; McBride, Benedum, and White. Absent: Noble, Shepler, Emery.

The minutes of the regular meeting held on October 1, the minutes of the adjourned meeting held on October 2, and the minutes of the adjourned meeting held on October 6, and the minutes of the meeting held on October 10 were approved.

Regent McBride requested that his vote on the Emery motion, meeting of October 10, 1948, with reference to the admission of G. W. McLaurin, page 2896, be changed from NO to AYE. The secretary was instructed to correct the minutes accordingly (P. 2898)

President Cross brought up the question of the Associate Deanships in the School of Medicine, this matter having been discussed at previous meetings. Following the discussion, President Cross recommended that the position of Associate Dean of the Faculty be discontinued at the end of the present semester and that the position of associate dean of students and Associate Dean of Graduate Studies be continued throughout the year in accordance with the recommendation of Dean Everett.

Regent White moved, and it was unanimously voted, to approve the President's recommendation.

President Cross discussed with the Regents the sale of tickets to students to the Texas game at reduced rates. He stated that approximately 6,500 tickets were sold to students and that more than 1,000 non-students were stopped at the gates and that probably 1,000 other non-students went through the gates on student tickets without being detected. He stated further that the sale of tickets at reduced rates encourages student attendance and that actually the hazards in connection with the trip to Dallas and return are very great. Fortunately, there were no deaths, but there were some accidents this year. Furthermore, there is a loss of \$2.30 to the institution for every ticket sold on the present plan. He stated that some plan should be worked out to see that legitimate holders of the tickets use them. He had no recommendation at this time and stated that he wanted the Athletic Council to study the situation further.

President Cross reported that the proposal to play a football game in the Health Bowl had been declined. This matter was discussed at the October 1 meeting.

There was a discussion concerning the enlargement of the stadium and the President reported that tentative plans were being drawn to complete the north end of the stadium and also to build a second tier on the west side. Calculations are being made to determine costs.

REGENTS OF THE UNIVERSITY Wednesday, November 10, 1948 10:00 a.m.

Regent McBride requested that his vote on the Emery motion, meeting of October 10, 1948, with reference to the admission of G. W. McLaurin, page 2896, be changed from NO to AYE. The secretary was instructed to correct the minutes accordingly (P. 2898)

President Cross brought up the question of the Associate Deanships in the School of Medicine, this matter having been discussed at previous meetings. Following the discussion, President Cross recommended that the position of Associate Dean of the Faculty be discontinued at the end of the present semester and that the position of associate dean of students and Associate Dean of Graduate Studies be continued throughout the year in accordance with the recommendation of Dean Everett.

Regent White moved, and it was unanimously voted, to approve the President's recommendation.

President Cross discussed with the Regents the sale of tickets to students to the Texas game at reduced rates. There was a discussion concerning the enlargement of the stadium and the President reported that tentative plans were being drawn to complete the north end of the stadium and also to build a second tier on the west side. Calculations are being made to determine costs.

President Cross reported on an investigation concerning the portrait of President Brandt and one of himself and stated that the cost would be approximately \$1,000 for each. President Cross was instructed to proceed with the necessary arrangements.

On the second question with reference to the recovery of lead from the shooting ranges, Dean Cheadle stated: "The suggested license to recover lead from the shooting ranges on the North Base and to use the proceeds for University purposes presents a different problem. No extensive mining operations are involved, but merely the license to enter and search.

"One question would be whether the United States might assert a right to this lead after it is recovered. Exception was made in the deed by which the University acquired this land of, "all uranium and other materials pursuant to Section 5 (b) (1) of the Atomic Energy Act of 1946 (60 Stat. L. 761) to be peculiarly essential to the production of fissionable material, contained, in whatever concentration in deposits in the lands—are hereby reserved for the use of the United States, together with the right of the United States—at any time to enter upon the land and prospect, mine, and remove the same, making just compensation for any damage or injury occasioned thereby. However, such lands may be used, and any right otherwise acquired by this disposition may be exercised as if no such reservation of materials had been made."

"It is questionable whether the above provision, or any other reservation in the deed of August 31, 1948, above, could be construed as a continuing claim of the United States to demand this lead recovered from the land."

In view of Dean Cheadle's opinion with reference to oil and gas leases, no action was taken on the matter.

On the question of recovery of lead, the President was instructed to make further inquiry as to the manner of recovery and whether or not it would be damaging to the property or intefere with normal operations of the range. The Regents were of the opinion that the digging might do more damage than the University's part in the recovery would justify.

President Cross discussed the question of outside employment for full time members of the faculty, administrative staff, and other employees and submitted the following resolution recommending its approval:

RESOLUTION

WHEREAS, it is recognized as a fundamental principle that the full-time members of the faculty and administrative staff of the University of Oklahoma are employed to serve the interests of the State;

AND WHEREAS, the President of the University and the Board of Regents should be apprised of the extent and nature of the professional services rendered by the full-time faculty and administrative staff, other than that covered by the salary paid by the University.

NOW BE IT RESOLVED, that the President of the University be empowered to grant permission to the full-time members of the University staff to engage in outside employment as defined below whenever in the President's opinion such outside employment is of a professional nature, and does not interfere substantially with their regular University duties, or contravene the obligation of the University to furnish expert knowledge and counsel to the people of Oklahoma without charge. No fulltime members of the University staff may engage in such outside employment without prior approval by the President.

Outside employment includes (a) work of a continuing nature, such as supervising, consulting or advisory services or other regular continuing employment for which compensation, regular or occasional, is received, and (b) specific work, usually of limited duration, for which compensation is received. It does not include honoraria for lectures or for literary articles, private income from real estate or investments, and royalties from books or patents. Payments for services performed by a member of the staff in any period during which the staff member is not on the University payroll are excluded.

The resolution was unanimously adopted.

President Cross recommended authorization to make purchases as shown below for items costing in excess of \$5,000. It was unanimously voted to approve purchases of laboratory equipment for Civil Engineering at a cost of approximately \$11,000.

It was also voted to approve purchase of laboratory furnishings and equipment for the new school of Petroleum Engineering laboratories in the recently completed addition to the Engineering Building at a total cost of approximately \$22,000.

Voted to approve purchase of laboratory equipment and furnishings for Mechanical Engineering laboratories at a cost of approximately \$5100.00.

Action on the purchase of a combination excavating and material handling machine at the approximate cost of \$18,668.46, was deferred pending a conference with Mr. Kraft. The tabulation of bids on this equipment was included in the agenda.

President Cross recommended that space for taxicab parking be provided on Boyd Street west of Asp Avenue by setting back seven feet from the curb in accordance with plans prepared by Mr. Kraft and Mr. Rucker. This will not interfere with any of the trees along the parkway and the width is sufficient to clear the curb line. The parking space is to be financed entirely by the taxicab companies and is to be constructed under plans and supervision of the Physical Plant Department.

On motion by Regent McBride it was voted to approve the recommendation.

President Cross recommended that the University institute the necessary measures to set up within the administrative framework of the University a department of insurance, or something comparable thereto; and that the University explore the possibilities of and if necessary, initiate and support the necessary legislation to provide a means for the University to make substantial contributions toward payments of premiums of individuals who may be members of any of the several possible group health units.

The recommendation was approved on motion by Regent McBride.

Attention was called to the action of the Regents on September 8 amending the regulation concerning the holding of political meetings on the campus approved May 5, 1944 (P 1598). The amendment limited such meetings to parties legally recognized in Oklahoma." Dr. Joseph C. Pray, faculty representative for political meetings on the campus appointed by President Cross, requested a clarification of the amended resolution stating, "The net effect is to require parties legally recognized in Oklahoma to check through me when they schedule meetings; whereas any party not legally recognized does not have to check through me or be subject to the conditions that follow. Paragraph (f) of the resolution makes the resolution stand on its own feet, and when it does it subjects the legally recognized parties to regulation, and the others to no regulation, and no ban."

Following a discussion, Regent Benedum moved and it was unanimously voted that the amendment of September 8 be stricken and that the first paragraph of the resolution shall then read as follows: "RESOLVED: That the President of the University be authorized to designate a member of the faculty to supervise the holding of political meetings on the University campus and to cooperate with the heads of the various political parties in permitting the use of any auditorium of the University upon proper authenticiation and upon the following conditions:..."

The effect of this action was to reaffirm the resolution in its original form as approved on May 5, 1944.

President Cross presented the following resolution:

RESOLUTION

BE IT RESOLVED by the Board of Regents of the University of Oklahoma that the Oklahoma State Regents for Higher Education be requested to authorize State supported institutions of higher education to waive the collection of regular student fees in any case where a full-time employee of an institution enrolls in not to exceed four credit hours of class work, provided:

- 1) That the subject matter of the course is such that the successful completion of the course by the employee would benefit the employer:
- 2) That the taking of the course will not interfere with the employee's regular duties; and
- 3) That the institution may, as an alternative plan, collect the regular fees for such enrollment with the understanding that the fees will be refunded if the employee satisfactorily completes the course.

On motion by Regent McBride the Resolution was unanimously adopted.

President Cross presented the following resolution and recommended approval:

RESOLUTION

WHEREAS the Board of Regents of the University of Oklahoma on October 1, 1948, adopted a resolution accepting the offer from the First National Bank and Trust Company of Oklahoma City, Trustee Under the Will of William Noble, deceased, to deliver to it the trust estate of the approximate value of \$22,500.00 created by the Will of William Noble, to be used to acquire and equip a clinical investigation laboratory, to be known as the William Noble Laboratory, in the Crippled Children's Hospital; and providing further that the Dean of the University of Oklahoma School of Medicine be authorized to select and acquire the equipment for said laboratory and to supervise its establishment and operation for and on behalf of the Board of Regents;

BE IT RESOLVED that the available cash in the hands of the Trustee in the approximate sum of \$1,877.60 be delivered by the Trustee to Dean Mark R. Everett in his capacity as superintendent of University Hospitals, to be administered according to terms of the trust; and that the securities coming into the control of the Board be held in and disposed of through the Office of the Comptroller of the University of Oklahoma; and to that end it is directed that all bonds and stock and other securities held in the said William Noble trust be delivered to J. L. Lindsey, the Comptroller of the University of Oklahoma, as the duly authorized agent or official of the Regents of the University of Oklahoma for such purpose, to be disposed of by said Comptroller in such a way as to make available funds necessary for the completion of the William Noble Laboratory in the Crippled Children's Hospital.

On motion by Regent White the resolution was unanimously adopted.

President Cross recommended that Dr. John Rohrer who was granted a leave of absence without pay September 1, 1948 to June 1, 1949 in order to accept a post-doctoral fellowship at Yale University be placed on the status of sabbatical leave at 1/4 salary, effective November 1, 1948 to June 1, 1949 instead of the normal Sabbatical rate of half salary. This recommendation is presented in view of the fact

that Dr. Rohrer is not yet entitled to a Sabbatical Leave of Absence, having come to the University in June of 1945. The awarding of this fellowship to Dr. Rohrer was a compliment both to Professor Rohrer and to the University. Under the plan recommended he would be paid 1/4 of his regular salary (\$130.55 per month) with the stipulation that he sign a bond agreeing to return to the University for a three year period following the expiration of the leave.

On motion by Regent McBride the leave of absence under the conditions specified was approved.

President Cross recommended approval of the following resolution authorizing the State Treasurer to use the surplus funds in the dormitory bonds of 1946 Principal and Interest Fund to purchase as many bonds as possible from the 1957 maturity of this bond issue.

RESOLUTION

WHEREAS the resolution of the Board of Regents of the University of Oklahoma authorizing the issuance of the Dormitory Bonds of 1946 provides in part:

"The money remaining in the Bond Fund in each twelve months period after current principal and interest requirements have been met and after any required payments into the reserve shall have been made, shall be used to retire bonds prior to maturity. either through the purchase thereof on the open market at not more than the price at which the bonds are currently redeemable. or, as to such bonds as may then be redeemable under the option herein above reserved, through the calling of bonds for redemption, except that if the Board of Regents shall at any time consider it advisable to use part or all of such surplus then existing for construction of additions or improvements to the system, it may provide that the surplus then existing be used for such purpose rather than the retirement of bonds in advance of maturity. It is the intention hereof that the Bond Fund shall be so handled that on December 2 of each year there shall remain in the Bond Fund only the amount required to be held in the reserve, and such amount not greater than \$2,000.00 as it shall have been impossible to use in the purchase or redemption of bonds as herein provided"; and

WHEREAS the above stated option of the Regents to use surplus funds for improvements to the system was eliminated by a provision in Section 8 of the resolution of the Board of Regents authorizing the issuance of the \$2,400,000 Dormitory Bonds of 1948, as follows:

"Section 8. That subject only to the payment of the cost of operating and maintaining the system as hereinafter provided, and except that until the bonds which are now outstanding of an issue of \$1,500,000 Dormitory Bonds dated July 1, 1946, and payable from the revenues of the aforesaid Wilson Center and Sooner City Dormitory System shall have been retired, no part of the revenues of said Wilson Center and Sooner City Dormitory System shall be considered to be pledged or applicable to the payment of the bonds herein authorized. The gross revenues to be derived from the operation of the system are hereby irrevocably

pledged to the payment of principal of and interest on the bonds herein authorized. It is hereby agreed that as long as any bonds of the aforesaid issue of \$1,500,000 Dormitory Bonds dated July 1, 1946, are outstanding all surplus revenues derived from the operation of said Wilson Center and Sooner City Dormitory System will be used solely for the retirement of said outstanding bonds"; and

WHEREAS a statement of the University Auditor's Office shows that prior to December 1, 1948, the Sooner City and Wilson Center project will have a cash surplus estimated at approximately \$110,000 to \$120,000 above the interest and principal and reserve requirements due December 1, 1948; and

WHEREAS the 1957 maturities of the Dormitory Bonds of 1946, totaling \$170,000, become optional for payment December 1, 1948; and

WHEREAS the Lee Higginson Corporation has agreed to sell to the Regents of the University of Oklahoma prior to December 1, 1948, from \$110,000 to \$120,000 of the 1957 maturities at a price of 99 7/8 plus accrued interest to date of delivery; and

WHEREAS the Attorney General of the State of Oklahoma on October 16, 1948, gave the Honorable John D.Conner, Treasurer of the State of Oklahoma, an opinion advising that "any money remaining in the 'Dormitory Bonds of 1946 Principal and Interest Fund' as of December 1, 1948, after current principal and interest requirements have been met, and 'after any required payments into the reserve shall have been made', may be used to retire bonds prior to maturity, either (a) by purchase thereof on the open market at not more than the price at which said bonds are currently redeemable, or (b) by calling bonds for redemption as provided in the resolution and in the bonds";

BE IT RESOLVED by the Board of Regents of the University of Oklahoma that Honorable John D. Conner, Treasurer of the State of Oklahoma, is hereby authorized and directed to:

First, set aside a sufficient amount in the "Dormitory Bonds of 1946 Principal and Interest Fund" to meet the December 1 principal, interest, and reserve requirements; and

Second, use all of the remaining cashin the said "Dormitory Bonds of 1946 Principal and Interest Fund" to purchase from the Lee Higginson Corporati as may of the 1957 maturities of the Dormitory Bonds of 1946 as can be purchased with the said remaining amount, at a price of 99 7/8 plus accrued interest to the date of delivery, the purchase of the bonds to be completed as soon as possible after the date of this resolution.

On motion by Regent White it was unanimously voted to adopt the resolution.

President Cross presented specifications for furnishings in the Women's Dormitories as prepared by Architects Sorey-Hill-Sorey and recommended approval of these specifications. He recommended further that bids for these furnishings shown in the specifications are to be addressed to the Regents of the University, Office of the President of the University, Norman, Oklahoma,

and opened at 10:00 a.m. on December 1, 1948, inaccordance with Instructions to Bidders as prepared by the architects. Specifications and instructions to bidders were approved after examination by Walter Kraft, Superintendent of the Physical Plant, D. R. Kimrey, Director of Purchasing, Garner Collums, Director of Housing, and Roscoe Cate, Financial Vice President. On motion by Regent Benedum the President's recommendation was approved.

Regent White discussed the question of insurance, the premiums to be paid from University funds, for members of the clinical staff of the School of Medicine to cover suits for malpractice. He stated that several doctors on the staff had brought up the question in view of the fact that they are serving practically without pay in the University Hospitals.

No action was taken on this matter.

President Cross reported on the conferences with the State Regents for Higher Education concerning the budget requests of the University and the Oklahoma Geological Survey on the Norman Campus and the School of Medicine and University Hospitals on the Oklahoma City campus. He presented charts showing enrolment trends, precentage of degrees granted, fund allocations, and comparisons on the above with A and M College and other institutions in Oklahoma. He stated that he presented these charts at the hearing before the State Regents and explained that the percentages of fund allocations are not in keeping with the services performed by the respective institutions and that he had protested the proposed allocations to the University. The Regents were unanimous in their approval of the President's presentation to the State Regents and it was the concensus that everything possible should be done to have the University placed in its proper position so far as fund allocations are concerned.

In the absence of Mr. Kraft, Superintendent of the Physical Plant, Mr. Bennie Shultz, Assistant Superintendent, appeared before the Board concerning the purchase of the combination excavating and material handling machine. Mr. Shultz explained in detail the reasons for recommending the Koering Model 205 machine and made comparisons with other machines on which bids had been submitted. Following this discussion Mr. Shultz retired from the meeting and it was unanimously voted on motion by Regent Benedum that the recommendation to purchase a Koering machine be approved. The delivered price is\$18,668.46.

There being no further business the meeting was adjourned.
