BOARD OF REGENTS Annual Meeting March 9, 1949 10:00 a.m.

The Board of Regents of the University of Oklahoma met for the annual meeting on March 9, 1949, at 10:00 a.m. in the office of the President, Norman. All members were present.

The minutes of the special meeting held on February 23, 1949, were approved.

The Chair announced the next order of business would be the election of officers (President, Vice President, and Secretary) for the ensuing year. Regent White nominated Regent Fmery for the office of President. Regent Benedum moved that nominations cease and that Mr. Emery be elected by acclamation. He was unanimously elected President and he was ushered to the chair by the retiring President, Mr. Deacon.

Nominations were called for the office of Vice President and Mr. Deacon nominated Joe McBride. Regent White moved that nominations cease and that Mr. McBride be elected by acclamation. He was unanimously elected.

Nominations were called for the office of Secretary and Mr. Benedum nominated Emil R. Kraettli. There being no other nominations, Mr. Kraettli was unanimously elected.

President Cross presented the plans and specifications as prepared by Owen, Mansur, and Steele of Tulsa, Oklahoma, consulting engineers, covering the construction of the athletic track and field which is to be located on the present golf course. He recommended that these plans and specifications be approved and that a contract be entered into with Owen, Mansur, and Steels, Consulting Engineers.

President Cross stated further that Mr. Kraft had recommended that bids for the construction of the Track be requested from the Harmon Construction Company; J. J. Bollinger Construction Company; and the Chas. M. Dunning Construction Company, all of Oklahoma City, and that these concerns be asked to submit their proposals before Monday morning, March 14, at 10:00 a.m. The State highschool track meet occurs on May 6 and 7 and it is important that the work on the track be completed by that time. He recommended that the Regents authorize the President of the Board to enter into a contract with the lowest bidder.

Regent Benedum moved and it was unanimously voted to enter into a contract with Owen, Mansur and Steele, Consulting Engineers, for the plans and specifications and that the plans and specifications as submitted be approved.

Regent Benedum moved and it was unanimously voted that bids be requested from Harmon Construction Company, J. J. Bollinger Construction Company, and Chas. M. DunningConstruction Company of Oklahoma City for the construction of the athletic track and field; that the form of contract contained in the specifications be approved; and that a contract for the construction be entered into by the President of the Board of Regents.

President Cross called attention to the Achievement Day Dinner which will be held on Tuesday evening, April 12, to honor five alumni or Oklahomans, at which time the distinguished service certificates are to be awarded. Under the plans of procedure the Regents should designate a member of the Board to make the address of welcome. A member of the Alumni Association, normally the president, will preside under the plan of rotating the presiding officer with the Regents and the Alumni Association.

Regent McBride moved and it was unanimously voted that the President of the Board, Don Emery, give the address of welcome.

President Cross asked that the Regents consider the naming of an architect in connection with the construction of a central refrigeration plant which will supply chilled water for the air conditioning system for the student union building. It has been decided to locate the central refrigeration plant very close to the power plant, the control board to be located on the power plant floor, and the same staff will operate both plants. Coston and Frankfurt, Oklahoma City, is the architectural and engineering firm for the new power plant now under construction. In addition to Coston and Frankfurt, Mr. Kraft had mentioned Sorey, Hill & Sorey and Collins and Gould. In view of the fact that Coston and Frankfurt are doing the work on the power plant and the refrigeration plant will be tied in very closely with the power plant, Mr. Kraft recommended this firm to be employed. President Cross recommended that Coston and Frankfurt be named.

Regent Deacon moved, seconded by Regent White that a contract be entered into with Coston and Frankfurt for architectural and engineering services on the central refrigeration plant and that the President of the Regents be authorized to sign such a contract on behalf of the Board. The motion was unanimously carried.

President Cross discussed a proposal made by Mr. E. G. Johnson of Norman concerning a new golf course on South Campus. The proposal was that a group of Norman citizens contribute funds to supplement University funds toward the cost of this project and that it be managed cooperatively.

The belief was expressed that the Regents could not legally bind their successors to a joint operation of the golf course. While no action was taken, it was the consensus that the utilization of the course by persons other than University students and faculty be considered later.

President Cross stated that Perry Maxwell, who has laid out some of the finest golf courses in the country, was invited to Norman for consultation and that he is working on the project at this time. 2.

President Cross reported briefly on the conference at a luncheon with the State Regents on Monday, February 28, which was held at the University Hospital. Regents Benedum, McBride, and White were present. Regent McBride discussed the conference at some length and Regents Benedum and White added to the remarks by Regent McBride.

The question of coordination by the State Regents was mentioned by President Cross, stating that a bill has been introduced in the Legislature by Representative Boatman which would abolish the State Regents for Higher Education, and that Representative Boatman has informed the State Regents he will push this bill unless something is done on coordination. At the conference, Chancellor Nash had suggested that the University give some consideration to this matter.

Regent McBride moved, and it was voted, that the Board of Regents authorize and direct the President of the University to do anything he regards as necessary and that he make a recommendation to the Board of Regents as to what representations to make to the State Regents on the proposal of coordination.

President Cross stated that at the last meeting when he recommended salary increases for the deans he had inadvertently omitted Dr. Fellows, Dean of Admissions and Records and Professor of Education. He recommended that his annual salary rate for the current year be increased by \$400 and that the increase become effective on February 1.

There being no objections to this increase, the Chair declared the recommendation approved.

President Cross recommended that the Regents authorize a lease to the Oklahoma National Guard covering a tract of land approximately 300' by 200', just south of Building 90l on the North Campus, as a site for a motor vehicle storage building for the Medical Battalion of the Oklahoma National Guard which is now occupying Building 90l, the lease to run for 25 years. The execution of such a lease is subject to authorization from the State Legislature and approval of the Civil Aeronautics Administration.

Approved on motion by Regent Benedum.

Recommended approval of authorization to purchase 1418 reams of paper stock for the Printing Division of the University Press at a total cost estimated at \$11,695.00.

Approved on motion by Regent Deacon.

There was a discussion concerning the proposal to change the name of the University Guidance Service to the Psychological Service Center of the University of Oklahoma. It was agreed to defer action and that President Cross make further investigation and report later.

President Cross recommended approval of the summer school budget. The budget shows the name, rank, and monthly salary of each individual who will be employed during the months of June, July, and August. The salaries have been fixed at 90% of the salary during the regular school year. The grand total allowed for is \$242,817.20. Any changes from this budget as they occur by the opening of the summer school will be reported for action by the Regents.

Approved.

President Cross made a report concerning the investigation by the Legislature on communistic activities. He was complimented on his handling of the matter before the Legislative Committee. He stated that the deans and chairmen of departments, schools and colleges are being asked to report on members of their respective faculties.

Regent Emery made inquiry concerning the applications from fourteen negroes for admission to the University as reported in the newspapers. President Cross stated that application blanks had been requested, but to date had not been filed. It was the sense of the Board

that we should have a record in each case to show that the State Regents for Higher Education have been notified of any applications from negroes and an inquiry of what disposition is to be made. President Cross was authorized and directed to so notify the State Regents.

Recess for luncheon at 12:15 p.m. with the faculty of the School of Journalism. Mr. Jenkin Lloyd Jones of the Thisa World attended the luncheon as a guest of the Journalism faculty.

The meeting reconvened at 1:15 p.m.

The newly elected President of the Board of Regents, Don Emery, requested the adoption of the following resolution, which he understands to be the existing practice:

RESOLUTION

RESOLVED, That any statement made on behalf of the Board to the public through the press or through any other agency be made only by the President of the Board upon authorization by the Board, and the statement to be made be only the statement duly authorized by the Board:

provided the President may make any public explanation of prior action by the Board;

and provided further that this resolution shall not be construed to abridge the right and privilege of any member of the Board to state publicly his personal opinion on any matter.

Regent Benedum moved adoption of the resolution and it was unanimously adopted.

Regent McBride moved that the Board of Regents express appreciation to its member Erl Deacon for his sincere and able leadership and attention to his office as President of the Board during the year 1948-49. The motion was unanimously adopted.

Regent Deacon expressed, "Appreciation for the cooperation of the Board, Dr. Cross, and Emil. I have had much satisfaction in the unity and work on the Board during the entire time I have been a member. I shall long remember and cherish my associations. Thanks to all."

President Cross reported with reference to his negotiations with former President Brandt concerning a portrait for the University. He stated that Mr. Brandt had selected an artist who had completed the portrait and that Mr. Brandt had caused the portrait to be sent to the University. He had expressed to President Cross his complete satisfaction with the finished portrait and, thereupon, President Cross submitted the portrait for inspection by the Board. Since it appeared that it satisfied former President Brandt in all respects, it was ordered hung with portraitsof other former presidents.

There being no further business, the meeting was adjourned at 3:30 p.m.
