# MINUTES OF THE RECENTS OF THE UNIVERSITY OF OKLAHOMA WEDNESDAY, NOVEMBER 9, 1949 10:00 a.m.

The Regents met in regular session on Wednesday, November 9, 1949, at 10:00 a.m. in the office of the President of the University, Norman. 5329

There were present the following: Joe McBride, vice-president, presiding in the absence of the president; Shepler, Benedum, Morgan, White, Shartel.

Absent: Don Emery, president of the Board.

The minutes of the meeting held on October 12, were approved.

President Cross reported in accordance with instructions at the meeting on November 10, 1948, he had arranged to have his portrait painted but that the cost would exceed the \$1,000 authorized by \$200, the total cost being \$1,200. The portrait has been completed by Dr. Joseph Sigall of Tulsa.

It was moved by Regent Shepler, and unanimously voted, to authorize a payment of \$1,200 for the portrait of President Cross.

President Cross stated he had received letters of appreciation from Mrs. Lois Bird and Don Gould, expressing appreciation for the naming of the Geology Building as a memorial to their father, Dr. Charles N. Gould, deceased.

Dean Everett recommended approval of renewal of the agreement on ARTICLES OF AFFILIATION with Mercy Hospital, St. Anthony Hospital, Wesley Hospital, and Veterans Administration Hospital, all of Oklahoma City with the University of Oklahoma School of Medicine and University Hospitals. The original agreement was authorized by the Regents on September 8, 1948.

President Cross recommended approval by the Regents, and that the president of the Regents be authorized to sign on behalf of the Regents, and the Dean of the School of Medicine on behalf of the institution. A copy of the renewal agreement follows:

President Cross recommended that the President of the University be authorized to execute on behalf of the Board of Regents, leases or rental agreements covering use of facilities on the North Campus or the South Campus by any branch or agency of the State or the United States. Such authorization for leases or rentals have been granted with the National Guard.

The following resolution was presented:

### RESOLUTION

WHEREAS, it is the general policy of the University to co-operate whenever possible with other public agencies, and

WHEREAS, various facilities at the North Campus and the South Campus are available from time to time for rent or lease to such agencies,

BE IT RESOLVED, by the Board of Regents of the University of Oklahoma that the President of the University is authorized to execute on behalf of the Board of Regents, leases or rental agreements covering use of facilities on the North Campus or the South Campus by any branch or agency of the State or United States.

Approved on motion by Regent Shartel.

The Chair announced that representatives of several fraternities had requested a hearing on the purchase of the Wentz property (formerly School of Religion lots immediately west of the campus). At the Regents' meeting on October 14, the President of the University was authorized to negotiate for the purchase of the lots and report to the Regents at this meeting.

At 11:30 the Regents recessed to make a tour of the campus, including an inspection of the Wentz property. Luncheon at 12:15 in the Union Building.

The meeting reconvened at 1:00 in the President's office.

The following representatives of the fraternities appeared before the Board:

Mr. Hyde spoke first stating that the three fraternities are interested in acquiring sites for new houses, and that the Delta Tau fraternity desires to purchase 100 feet adjoining its present property.

Joe Curtis, representing the Sigma Nu fraternity, stated it was their plan to build on the corner where the School of Religion building now stands, this being the old home of the four Reeds brothers, all members of the fraternity, the house to be a memorial to these men.

Dave Price spoke on behalf of the Phi Delta Theta fraternity.

Each speaker expressed appreciation for the opportunity to appear before the Regents and pledged full cooperation in the development of the University; also appreciation for the fine work being done by President Cross.

President Cross expressed appreciation for the fine support he had received, and especially for the kind things said about the Administration of the University. He outlined his plans for the future of the University. He stated the University is interested in the property as locations for two buildings - The Graduate School of Education and the School of Home Economics. He stated there is very little space left on the south oval after the complete development of the proposed geology building now under construction, and unless we utilize this space, near the axis of the campus, it will be necessary to go to locations south of the new dormitories, which would be extremely undesirable for classroom purposes. The land east, between the golf course and the campus, is built up with private residences and he predicted that the University would some day need to acquire this property.

The discussion ended and the representatives of the fraternities retired from the meeting.

President Cross suggested the appointment of a committee of the Board of Regents to study the long range plans of the University, and that no action be taken until after such a study has been made.

Regent Shartel moved, and it was voted, that a committee be appointed to make an investigation to see if the University can, without detriment to the future plans, avoid the purchase of the Wentz property; and that pending such an investigation suspend action on the authority granted the president to negotiate for the property.

The Chair was authorized to appoint the committee and the following were named: Regents Shartel, Morgan, Emery.

The items on the agenda were presented by President Cross and he recommended approval.

That the policy with reference to naming buildings, as approved by the Regents on March 8, 1920, be rescinded and that the following policy be adopted:

"No building on the campus shall be given a specific name except by vote of the Board of Regents, other than that which designates the type of work done therein; and no building shall be named after any living person."

That the policy with reference to the employment of relatives be amended and recommended the following:

(1) The employment of one or more additional members of any family, related within the third degree to someone already employed, shall be recommended by the President only in a case where no unrelated person with the necessary qualifications for the position to be filled is available, and shall be considered temporary employment only.

(2) Only one of the members of any family shall be eligible for tenure.

Approved.

That the following policy with respect to assignment of faculty housing be adopted:

(1) That no University faculty members be assigned to student family dwelling units so long as there are unaccepted application for such units from married students.

(2) That the Logan Apartments be reserved for married faculty members except for those apartments set aside as scholarship apartments for married students.

(3) That anyone teaching as much as nine credit hours be classified as a faculty member unless he is a candidate for a degree and is teaching only in order to remain in school long enough to receive the degree.

Recommended adoption of the following resolution on retirement of University of Oklahoma Dormitory Bonds of 1946:

### RESOLUTION

WHEREAS, prior to December 1, 1949, there will be in the Principal and Interest Fund of the Regents of the University of Oklahoma Dormitory Bonds of 1946 an amount sufficient to meet all interest, principal and reserve fund payments due on that date, plus a surplus of \$50,000 which can be used to redeem bonds prior to maturity; and

WHEREAS, Bonds No. 1391 to 1430, inclusive, and 1491 to 1500, inclusive, of the 1957 maturities, are the bonds outstanding and unpaid with the highest serial numbers and are eligible for redemption at par and accrued interest on December 1, 1949; and

WHEREAS, the Fidelity-Philadelphia Trust Company of Philadelphia, Pennsylvania, is owner of the said bonds and has by telegram dated November 1, 1949, waived requirement for publication of notice of call.

BE IT RESOLVED by the Board of Regents of the University of Oklahoma that Bonds No. 1391 to 1430, inclusive, and 1491 to 1500, inclusive, 1957 maturities of the Regents of the University of Oklahoma Dormitory Bonds of 1946 be called for redemption on December 1, 1949, and that Mr. John D. Conner, State Treasurer, be directed to transfer from the Principal and Interest Fund of this bond issue in the State Treasury, the necessary amount of money to the paying agent, the Fidelity-Philadelphia Trust Company of Philadelphia, Pennsylvania, for the purpose of calling the said bonds on December 1, 1949; and provided further that upon receipt of the said bonds called for redemption the State Treasurer shall cancel the said bonds and give the Comptroller of the University evidence of such cancellation.

Approved.

Recommended that the February resolution with reference to investment of money on deposit in bond reserve funds be amended to read as follows:

#### RESOLUTION

Be it Resolved by the Board of Regents of the University of Oklahoma that the President of the University is authorized to act for the Board of Regents in requesting and directing the State Treasurer or the bank serving as trustee, whichever is holder of a particular bond issue principal and interest reserve fund, to invest money on deposit in such reserve fund in obligations of the United States, provided that the investment be made in United States Savings Bonds Series F or Series G.

Approved.

Recommended that the Regents authorize the following steps to provide for preparation of preliminary plans for the Graduate Education Building, which is next in the University's building program after completion of the Geology-Mineral Industries Building: (1) That \$5,250 of Section 13 and New College Funds (1% of the estimated cost of construction) be set aside in a special account to be expended as hereinafter provided for to cover the cost of preparation of preliminary plans in form ready for preparation of working drawings and specifications.

(2) That Richard N. Kuhlman, Associate Professor of Architecture and University Architect, be appointed as Architect to prepare the preliminary plans for the Graduate Education Building, on the following terms:

a) All necessary expenses for supplies, materials, drafting assistance and other incidentals in connection with preparation of the preliminary plans to be paid on requisition approved by the Financial Vice-President of the University from the special \$5,250 fund;

b) The Architect to be paid, as a professional fee for preparation of the plans, the sum remaining in the \$5,250 fund after payment of necessary expenses as provided for in "a" above; such payment to be made upon completion of the preliminary plans and acceptance by the Board of Regents;

c) Working drawings and specifications to be prepared by a firm of practicing architects to be designated later by the Board of Regents as "Associate Architect" for the project.

Approved.

Recommended approval of the following policy with respect to basketball broadcasting rights, in accordance with a recommendation made to me by the Athletic Council:

1. If an originating station agrees to broadcast all basketball games played at Norman by the University of Oklahoma during a particular season, the fee shall be \$200.

2. If an originating station agrees to broadcast all basketball games played at home and abroad by the University of Oklahoma during a particular season, the fee for all games played at Norman shall be \$150.

3. If an originating station wishes to broadcast less than a full season of basketball games, the fee payable for the home games shall be:

4. Where an originating station permits one or more additional stations to carry its basketball broadcasts, such originating station shall pay \$5.00 for each such additional station for each game.

5. The above charges shall apply whether the broadcasts be on AM or FM or both. Further, the above fees shall apply for wire-recreated or recorded broadcasts, provided, however, that if a station broadcasts a game at the time of playing, the station may later broadcast a recording without paying additional fees to the Athletic Council.

6. All bidders for the right to broadcast the basketball games of the University of Oklahoma must agree to the following provisions:

(a) To pay the fee due for each home game by check payable to the Athletic Council of the University of Oklahoma, which check shall be delivered to the Treasurer of the Athletic Council at least twenty-four hours before the time of the game for which the fee is tendered. Bidders wishing to broadcast the entire schedule of home games or more than one home game, may, if they desire, pay the fees for all games they will broadcast before the opening home game.

(b) If an originating station is going to permit one or more other stations to carry its basketball broadcasts, the fees for such additional stations shall likewise be paid by check to the Athletic Council by the originating station at least twenty-four hours before time of the game for which the fee is tendered, together with a list of stations to be furnished the broadcast of that game by the originating station.

(c) To broadcast, record, or send by wire an on-the-spot, play-byplay description of the basketball games played either in Norman or away from Norman.

(d) To pay all fees for broadcasting which may be required by schools on whose courts the basketball games may be played.

(e) To pay for the installation and maintenance of all wire connections, telephone lines, and other expenses pertinent to the several broadcasts of the basketball games.

(f) To furnish a competent sportscaster who shall exercise all diligence in presenting a fair and impartial coverage of any and all games to be broadcast.

(g) To pay for all the expenses of personnel engaged in broadcasting the basketball games.

(h) To insure good quality of broadcasts by using only regular telephone lines with a frequency response of at least 5,000 cycles.

(i) To submit to the Athletic Council for approval the name and business of any and all sponsors of the originating station and of all stations fed by the originating station at least three days before the first game to be broadcast by the station. The Athletic Council reserves the right to reject any sponsor.

(j) To grant WNAD and KUVY - the University stations - the right and privilege to pick up from the control room of the bidder all games without cost and to exclude from the broadcasts any and all commercials, the University stations to pay the cost of lines from said control rooms, if lines are used.

(k) To limit commercial announcements according to the following schedule: one commercial announcement not to exceed 60 seconds in length before the game starts, two during the half, and one at the close of the game. No other commercials except during an official time out, and these commercials not to exceed 30 seconds.

7. The Athletic Council of the University of Oklahoma reserves the right to reject any bids for the broadcast of basketball games at Norman.

President Cross made the following statement with reference to student organizations which have been approved to operate on the University campus through which the administration must accept some responsibility for the way in which the organizations handle financial operations.

The University should assume some responsibility for educating officers of student organizations with respect to the following responsibilities: (1) To keep proper records of receipts and disbursements of organization funds; (2) To accept responsibility for disbursing funds only for proper purposes in accordance with functions of the organization; and (3) To make adequate and proper reports on disbursements of funds.

He recommended that the Board of Regents establish policies for supervision of the financial operations of approved student organizations as follows:

(1) That every approved student organization be required to deposit all of its cash income in an agency account in the Comptroller's Office, in order that the University may make sure that proper records of financial transactions of such organizations will be kept.

(2) That the President of the University appoint a University faculty member or full-time staff member as the sponsor for each approved student organization.

(3) That the Comptroller's Office write an official depository check for disbursement of funds from a student organization account only upon presentation of a disbursement order signed by the treasurer of the organization and counter-signed by the sponsor appointed by the President of the University.

(4) That a student organization be permitted to spend its funds for any purpose not in violation of good taste or inconsistent with the general purposes of the University.
