

MEETING OF THE REGENTS
UNIVERSITY OF OKLAHOMA
WEDNESDAY, MARCH 8, 1950
10:00 a.m.

The Regents of the University of Oklahoma met in regular session on Wednesday, March 8, 1950, at 10:00 a.m. in the office of the President of the University. The following were present: President Emery, presiding; McBride, Shepler, White, Benedum, Morgan. Absent: Regent Shartel.

The minutes of the meeting held on Wednesday, February 8, were approved.

Regent Emery requested that the following statement be made a part of the minutes, and that a copy be given to the press:

STATEMENT OF DON EMERY UPON HIS RETIREMENT FROM THE BOARD OF REGENTS

"I know you will accord me the privilege of saying a few words at this meeting which, but for a few days, terminates my service as a regent of the University and marks the end of my tenure as President of the Board.

"My service has been completely enjoyable and entirely beneficial to me. I have been doing the things I have enjoyed doing in association with enjoyable persons--with persons who have appreciated that the vigorous expression of dissenting views indicates the essential nature of our political culture and gives to unanimity its essential virtue.

"I leave your deliberations with the hope that all the people of this state will someday, somehow learn soon that in every comparative sense they are not now providing through taxation and by appropriation sufficient funds to pay just salaries to teachers and to insure adequate facilities so necessary if their children and their children's children are to have the opportunity to acquire the education they deserve."

The Chair announced the next order of business at this the Annual Meeting to be the election of the following officers for the ensuing year -- to wit: President, Vice-President, Secretary.

Nominations for the office of President were called for.

Regent Benedum nominated Joe McBride. No other nominations being made, upon motion duly made, seconded, and carried, Regent McBride was elected President of the Board and was declared duly elected to the said office.

Nominations for the office of Vice-President were called for.

Regent White nominated Ned Shepler. No other nominations being made, and upon motion duly made, seconded, and carried, Regent Shepler was elected Vice-President of the Board and was declared duly elected to the said office.

Nominations for the office of Secretary were called for.

Regent Shepler nominated Emil R. Kraettli. No other nominations being made, upon motion duly made, seconded, and carried, Emil R. Kraettli was elected Secretary of the Board and was declared duly elected to the said office.

President Cross read the following statements from Joe N. Hamilton concerning the location of the Cerebral Palsy Institute.

(Excerpt from a letter by Lawrence J. Linck, executive director of the National Society for Crippled Children, to State Secretaries) 2-24-50

"In looking ahead, the Executive Committee of the National Society has taken the position that it is the expressed policy of the National Society to recommend and to emphasize that where units for the diagnosis and treatment of cerebral palsy are established, they be made integral parts of medical schools and teaching hospitals, to supplement the advancement of diagnosis and treatment by an active educational program for the undergraduate type of student, hospital entrants and residents, and the practitioner in general."

"To: Board of Regents, University of Oklahoma

"The 1949 Oklahoma Legislature enacted new legislation pertaining to the care and treatment of crippled children. The act now provides for the establishment of a Professional Advisory Committee of six. Three of these are selected from a list of nine names submitted to the Commission for Crippled Children by the Oklahoma State Medical Association.

"The present composition of the Professional Advisory Committee is as follows:

- "Dr. D. H. O'Donoghue, Oklahoma City, Chairman -- physician
- H. D. Helland, Tulsa -- State director of the Blue Cross and Blue Shield Plans
- Miss Celeste Kemler, R. H., Ada -- hospital administrator
- Dr. Thurman Shuller, McAlester -- physician
- Dr. Wayne A. Starkey, Altus -- physician
- Dr. A. W. Wallace, Chickasha -- dentist

"At the last meeting of the Professional Advisory Committee, held February 26, 1950, the following motion was made by Dr. Starkey, seconded by Dr. Shuller, and carried unanimously:

" 'That the Professional Advisory Committee recommend to the University Board of Regents that the proposed building for the treatment of cerebral palsied patients be made an integral part of the Oklahoma Medical School and its teaching hospitals; that it be located on the Medical School campus; and that the building be constructed and used as a treatment and not as a custodial institution. '

Professional Advisory Committee."

Following a discussion of the matter the Secretary was authorized and directed to advise Mr. Hamilton of the action of the Regents at the February 8 meeting with the further information that one of the factors in the decision to locate the institute on the Norman campus was that the Spastic Commission stated ten acres of ground would be required and this would not be available on the Medical School campus.

In accordance with authorization by the Regents at the February 8 meeting President Cross submitted a report on negotiations for a definite proposal to refinance existing dormitory indebtedness and obtain new funds to construct a dormitory system to house 848 men in buildings similar to those of the Women's Quadrangle. The terms of the proposal were shown in the agenda, together with a letter under date of February 28, 1950 from LEE HIGGINSON CORPORATION, 40 Wall Street, New York 5, New York, and the amortization schedule for a bond issue in the amount of \$5,525,000.

President Cross reported that he had received a few communications from individuals, and the Interfraternity Council in opposition to the plan to require all freshmen men to live in University operated dormitories. The Interfraternity Council, through its president, Walter Gray, requested a hearing on the matter.

Following a discussion, and at the suggestion of Regent McBride, it was agreed that President Cross gather further information, including the number of freshmen men enrolled, total male enrolment, occupancy of present facilities, and any other data available; also that before final action is taken the Interfraternity Council be granted a hearing.

President Cross was authorized to answer the letters on behalf of the Regents.

President Cross recommended that Sorey, Hill and Sorey, the Architects on the Women's Quadrangle buildings, be named Architects on the Men's Dormitory project using the same basic structural system, for a fee of 3% of the construction cost.

Approved on motion by Regent McBride.

President Cross reported that the Fluor Corporation, Los Angeles, California, who were awarded the contract for the construction of the Cooling Tower had completed the project and submitted the following resolution and recommended its adoption:

"Whereas, the Director of the Physical Plant of the University of Oklahoma reports that the contract of the Fluor Corporation, Los Angeles, California, for the construction of the induced draft cooling tower for the new Power Plant of the University of Oklahoma, dated April 14, 1948 (and processed for expenditure purposes by University of Oklahoma Purchase Order No. 11044-49), has been completed in compliance with the plans and specifications,

Be it Resolved by the Board of Regents of the University of Oklahoma that the cooling tower is accepted as complete and the contract is hereby terminated."

Regent Benedum moved, and it was unanimously voted to adopt the resolution.

President Cross discussed with the Regents the use of funds allocated to the University of Oklahoma from the \$36,000,000 bond issue. Following is his statement on the building program:

"The University should have about a million and three quarters more than is available at this time to meet most urgent needs at the University. The first three buildings in our program are: completion of the geology building, Graduate Education Building, and the Home Economics Building. We hope to get these underway soon.

"We have more than 2300 students enrolled in Geology and that is more than the total enrolment in the University not many years past.

"It is imperative that the University provide facilities for the College of Education, presently housed in the old Carnegie Library; the University's most important contacts in the state are through the schools.

"There is not a high school in the state, located in a city with a population of 10,000, that does not have better facilities for Home Economics than the University has. There is a great need for training in home management and every girl in the University should have the opportunity to enrol in such courses.

"There is a desperate need for additional space for Chemistry. The Chemistry Department has only recently been conditionally accredited after the temporary building was moved to the campus. Due to the use of chemicals, explosives, and Bunsen burners the building is a great fire hazard. Even with this building there is a great lack of laboratory space.

"I would not be fair if I did not state the need for Chemistry is much greater than for either law or journalism. Guy James and Dial Currin, both members of the State Regents' Board visited the campus recently and they were impressed with the need for additional facilities in Chemistry. At the meeting of the State Regents John Rogers brought up the matter. Being a lawyer he is interested in the School of Law,

but he indicated the need in Chemistry is great. He stated he is not familiar with Journalism but he was convinced the need is not as great as for Chemistry. All members of the State Regents expressed the same opinion.

"I would suggest no action be taken at this time except on the three buildings listed; that we ponder the problem as to what should be done with the balance available to the University. We can provide a great deal of space for several departments in the new wing of the stadium.

"It is my responsibility to the institution and to the State to recommend to this board that if sufficient funds are not available to meet the needs in Chemistry and some of the other needs, after careful consideration, I would want to recommend to this board that the Chemistry Department be taken care of before Journalism and Law, unless the Oklahoma Press Association comes through with its amount, and that the balance of the money be used for Chemistry. In view of the needs in Chemistry I would recommend that Journalism and Law be moved below Chemistry in the building program."

President Cross made a financial report on the Sugar Bowl game, showing receipts and disbursements. He stated he would have all of the details shortly and that a complete statement would be sent to each Regent.

He discussed also the business management of the Athletic Department and the relationship of the department to the University Administration. He submitted the following recommendations for improvement of the business administration of the intercollegiate athletic program:

- (1) That intercollegiate athletic activities be designated as an auxiliary enterprise of the University of Oklahoma, under the title "Athletic Department."
- (2) That all income from intercollegiate athletics be deposited in the Comptroller's Office in appropriate accounts, in accordance with the University's general policies for handling the funds of auxiliary enterprises.
- (3) That the Comptroller of the University be responsible for determining procedures to be used in the Athletic Department for accounting, control of cash, disbursements, and control of and accounting for all tickets to intercollegiate events.
- (4) That all business activities of the Athletic Department, including ticket sales, bookkeeping, budget preparations, handling of cash receipts, requisitioning of supplies, and so on, be consolidated in an office identified as the Athletic Business Office, under the management of an Athletic Business Manager who also serves as Athletic Ticket Manager.

- (5) That the position of Athletic Council Treasurer be abolished, and that all cash receipts of the Athletic Office be deposited daily in the Comptroller's Office, the cash receipts in the Athletic Business Office to be handled by a cashier responsible to the Athletic Business Manager for general duties but responsible to the Comptroller for all procedures in handling of cash.
- (6) That the Athletic Business Office staff include a book-keeper responsible to the Athletic Business Manager for general office duties but responsible to the Comptroller's Office for accounting procedures.
- (7) That the Athletic Business Manager be responsible to the Athletic Director for general duties in planning and executing the business aspects of the Intercollegiate Athletics program, and be authorized to act for the Athletic Director on business matters requiring action during absence of the Athletic Director.
- (8) That the Athletic Director be responsible to the President of the University for all phases of Intercollegiate Athletics, including business management, the line of responsibility for business management to be through the Financial Vice-President of the University.

Regent McBride moved, and it was unanimously voted to approve the President's recommendations.

Recess at 12:00 to attend the BMOC luncheon, in the Union Building and met again in the President's office at 2:00 p.m.

President Cross reported that Carl Mason Franklin has been offered a Sterling Fellowship in the Yale University Law School during the academic year of 1950-51 to do graduate work in international law, and that Mr. Franklin had requested a leave of absence, without pay, in order to accept this fellowship; he expects to complete the residence requirements for the J.S.D. degree, plus a portion of the doctoral dissertation by July, 1951. He recommended that the leave of absence be granted from October 1, 1950 to July 1, 1951.

Approved.

The preliminary plans for the Aeronautical Engineering Building as prepared by William S. Burgett were presented by President Cross. He recommended that the officers of the Board execute a contract for preparation of working drawings and specifications and that the contract be given Reynolds and Morrison, Architects, of Oklahoma City. This firm does not have any other University work and one member (Morrison) is an OU man.

President Cross submitted the detailed plans and specifications covering the construction of the addition to the School of Nursing Building. These plans have incorporated the needs of the School of Nursing and have been approved by the United States Public Health Service and the State Department of Health. President Cross recommended approval of the plans and specifications as submitted by Dean Everett, and that bids be requested on March 28, 1950.

On motion by Regent White the recommendation was approved.

President Cross stated that Bruce Goff had been requested to do some work on preliminary plans for the University Chapel with the understanding that he would be paid something for his work. Vice President Franklin and Vice President Cate, in conference with Mr. Goff agreed on a payment of \$800, most of which was for materials and amounts paid out by Mr. Goff for student help employed on the project. They recommend payment of \$800 even though it appears likely that the University will not be able to make use of the plans and the elaborate model he prepared.

President Cross recommended a payment of \$800 to Mr. Goff as settlement for his work on the plans and model of the University Chapel, with the understanding that the plans and model will remain the property of Professor Goff; that if the University ever decides to proceed with the project it will be necessary to enter into a new agreement with him for architectural services.

On motion by Regent McBride the recommendation was approved.

President Cross called attention to his letter under date of February 10 requesting opinions from the Regents on a proposed football game with the University of Pittsburg on October 4, 1952 in Norman, with a return game at Pittsburg in 1953 or 1954. Each member replied in the affirmative and he asked that the minutes record the vote of each Regent.

President Cross reported the following deaths of members of the faculty in the School of Medicine:

Dr. Harvey O. Randel, Assistant Professor of Ophthalmology. Dr. Randel was a graduate of the Chicago College of Medicine and Surgery and began service on the faculty of the School of Medicine in 1939. He

is survived by his wife and one son. They reside at 524 Northwest Thirty-Ninth, Oklahoma City. He died on February 17, 1950.

Dr. Walter W. Wells, Professor Emeritus of Obstetrics. Dr. Wells graduated from Epworth College of Medicine in 1910, and began service on the faculty of the School of Medicine in 1916. He was given the title of Professor Emeritus upon his retirement from active service in 1945. He is survived by his wife, Dr. Eva Wells who resides at 730 Northeast Nineteenth Street, Oklahoma City. He died on February 14, 1950.

President Cross was asked to write letters on behalf of the Regents extending sympathy to members of the respective families.

President Cross reported that the faculties of the School of Medicine, the School of Nursing and the College of Arts and Sciences have worked out a curriculum which will lead to the degree of Bachelor of Science in Nursing. This provides that the student will complete two years on the Norman Campus with a minimum of 72 hours of credits, and a total of 111 weeks (exclusive of vacation periods) in Oklahoma City for a minimum of 68 credit hours. This will require the addition of only one new course which will have to be added anyway to service the new program of the School of Public Health. This does not eliminate the regular three-year nurses' training course as it is now offered. The curriculum is aimed particularly to raise substantially the qualifications of its nursing instructors and for supervisory positions in nursing. The new curriculum has been approved by the Council on Instruction.

President Cross recommended approval by the Regents and that the President of the University be authorized to submit the proposal to the State Regents for Higher Education.

On motion by Regent White it was unanimously voted to approve the recommendation.

President Cross exhibited tentative plans for utilization of space under the stadium by providing classrooms, laboratories, and other facilities. He stated considerable thought had been given to such a project and he recommended that Wright and Selby, the Architects on the Stadium, be employed to work up detailed plans and specifications, and that the President of the Regents be authorized to execute a contract on behalf of the Regents.

On motion by Regent Benedum the recommendation was approved.

Regent Shepler suggested that Mr. Emery draft an appropriate letter or resolution on behalf of the Regents to the members of the family of Lloyd Noble. It was the sense of the Regents that this be done.

Regent Benedum offered the following motion:

March 8, 1950

"I move that the Board make of record its appreciation and thanks to Don Emery for the outstanding and farsighted leadership which he has rendered as President of the Board of Regents during the year just ended, and for the immense amount of personal time and energy which he has devoted to the office, all of which has inured to the benefit of the University of Oklahoma and the State of Oklahoma."

The motion was unanimously adopted.

At this point Regent Emery escorted Regent McBride to the Chair as the new President of the Board.

President Cross called attention to the Third Annual Achievement Day on April 19, the chief feature of which will be the awarding of the Distinguished Service Citations to five outstanding state citizens. This project is jointly sponsored by the Board of Regents and the Alumni Association. On alternate years each one supplies the toastmaster; this is the year for the Regents. It was agreed that Joe McBride represent the Regents as toastmaster.

At the Regents' meeting on February 8, a committee composed of Regents White, Morgan and Benedum was appointed to make a study with reference to records of students in the School of Medicine. A tabulation of grade reports for each student was supplied each member of the committee by Dr. Homer Marsh, Associate Dean of Students and Chairman of the Admissions Committee. The tabulation showed a comparison of grades for students in the School of Medicine who had done their pre-medical work in the University of Oklahoma with those who had been accepted from other institutions in the State. Regent White reported on a study of the tabulation he had made. It was understood that Dr. Marsh will submit a complete list of admissions for the entering class in September of 1950 when it is completed - about the second week in April. No action was taken by the Regents.

There being no further business the meeting was adjourned at 3:45 p.m.
