# MINUTES OF A REGULAR MEETING BOARD OF REGENTS OF THE UNIVERSITY OF OKLAHOMA THURSDAY, SEPTEMBER 14, 1967

A regular meeting of the Board of Regents of the University of Oklahoma was held in the office of the President of the University, Norman, on Thursday, September 14, 1967, beginning at 10:00 a.m.

The following were present: Regent James G. Davidson, President, presiding; Regents Little, Houchin, Sparks, Calvert, Davies, and Huffman.

The following were also present: Dr. G. L. Cross, President of the University; Dr. J. Herbert Hollomon, President-Designate; Vice Presidents Brown, Kennedy, and Dennis; Mr. David Swank, Associate Professor of Law; Mr. David A. Burr, Assistant to the President; Mrs. Barbara H. James, Assistant Secretary of the Regents; Dr. Jodie C. Smith, Desn of Student Services; Dr. Thurman J. White, Dean of the Extension Division; Mr. Gordon A. Christenson, Assistant to the President-Designate; Mr. Raymond D. Crews, Business Administrator of the Medical Center; and Mr. James E. Swain, Director of Public Information.

The minutes of the meeting held on July 27, 1967, were approved.

A report of the various achievements and accomplishments by the students, faculty, alumni, Research Institute, and the University as a whole was included in the agenda for this meeting.

President Cross stated that an important item was inadvertently omitted from the agends at the time it was prepared. Because of press releases and announcements being made elsewhere he said the proposed sale of certain University-owned land south of Norman should be added to the agenda and acted upon immediately.

On motion by Regent Davies it was unanimously agreed to add this item to the agenda for this meeting.

President Cross said the University has received the following offer to purchase a portion of the Noble Auxiliary Flying Field from the University:

"September 13, 1967

"Regents of the University of Oklahoma University of Oklahoma Norman, Oklahoma

> Re: Partof Sections 9 and 10, Township 8 North, Range 2 West, Cleveland County, State of Oklahoma

#### "Gentlemen:

"The Board of Regents of the University of Oklahoma, a body corporate, is the owner of part of Sections 9 and 10, Township 8 North, Range 2 West lying South of New State Highway 9 and East of U. S. Highway No. 77 situated in Cleveland County, Oklahoma. As Trustee for my client, which will be identified herein as 'Buyer', I wish to purchase the surface of that land and make to you herewith in behalf of the Buyer the following offer:

- "1. Buyer offers to purchase for the sum of \$1500 per acre and a proportionate part thereof for less than an acre the surface of the lands above referred to, the acreage therein to be determined by a licensed land surveyor hired by the Buyer at the Buyer's expense; provided, that from said acreage there shall be deducted the number of acres contained in the West 800 feet of Section 3, Township 8 North, Range 2 West, Cleveland County, Oklahoma, the acquisition of which has been required by the Federal Aviation Administration upon which to relocate the airfield now located on your land.
- "2. Buyer has under purchase option, the surface of the West 800 feet of Section 3, Township 8 North, Range 2 West and upon the acceptance of this offer by you agrees to exercise that option and to convey said land to you.
- "3. Buyer agrees to pay the cost of constructing a barbed wire fence along the East side of the West 800 feet of the said Section 3 to prohibit livestock from crossing onto the relocated sirfield.
- "4. Buyer agrees to pay the cost of moving the building and septic tank located on that portion of Section 9, Township 8 North, Range 2 West under lease to Norman Aviation Corporation, Inc. to an acceptable site on the West 800 feet of said Section 3 and to reimburse Norman Aviation Corporation, Inc. for the cost of the water well drilled by it on that portion of Section 9 under lease to it.

"Upon your acceptance of the foregoing offer, the following provisions shall apply:

"(a) Title shall close and deed shall be delivered at the office of Charles P. Ames, 219 Couch Drive, Oklahoma City, Oklahoma at 10:00 o'clock a.m. on a day specified by the Buyer by notice to you. The date of closing shall not be more than ninety (90) days from the date of your acceptance unless at such time there be a title defect, in which case the ninety day period shall be extended for a reasonable time in which to meet the defect. The purchase price shall be paid on closing of title by good, certified check to your order. In the event of any title defect, then you will at your expense seek to cure the same within the ninety day period (or the extended period) failing which Buyer, at its option may, (1) waive the defect and take title subject to the defect, or (2) cancel the agreement or (3) cure any such defect, charging the expense against the purchase price and deducting such expense on closing title.

"At the time of closing title, you shall deliver to the Buyer a good and sufficient full special warranty deed, in form for recording, conveying to the Buyer a good and marketable title to the surface of the premises, with all Federal, State and local stamps or taxes imposed on the transfer to be paid by you. You will convey the premises free and clear of all liens and encumbrances, restrictions, and easements except oil and gas leases of record and pipe line easements and rights-of-way, if any.

"The following shall be adjusted and apportioned as of the date of closing title: Real estate taxes, water and sewer rents or charges, if any. All special assessments against the premises, whether levied before or after delivery of the deed, for improvements made prior to delivery of the deed shall be promptly paid by you, and this provision shall survive delivery of the deed.

"The sale of the premises shall include, and the deed shall convey, all of your right, title and interest, if any, in and to all ponds, waterways, easements and roads in front of, adjoining or running through the premises.

"If all or part of the premises are taken by condemnation, prior to delivery of the deed, at the Buyer's option, the Buyer may terminate this agreement. If the Buyer elects to proceed with this contract after condemnation, then any condemnation award shall be credited against the purchase price and on closing you shall assign to the Buyer all rights to receive the award that may be payable.

"At the time of closing, you shall deliver possession of the premises free of all occupants except that you shall have a reasonable time to harvest any crops thereon and to arrange for the removal of Norman Aviation Corporation, Inc. to the new site.

- "(b) Prior to closing of title, the Buyer of his agents and contractors may enter the premises to make reasonable examinations, surveys, and inspections of the same and to make such soil tests and borings on the property as the Buyer deems necessary. The Buyer agrees to repair any damages to the premises which it may cause.
- "(c) Any notice to be given by either party to the other shall be in writing and shall be mailed by United States Registered or Certified Mail. The notice shall be deemed served on the day on which it is mailed. Any notice to you shall be addressed to you at your address first above written. Any notice to the Buyer shall be addressed to the Buyer at my address.
- "(d) The provisions hereof shall constitute the entire agreement between us and that agreement may not be modified except by instrument in writing signed by each of us. The agreement shall bind and inure to the benefit of each of us and our respective representatives, successors and assigns.

"If the offer and the provisions thereof are acceptable to you and meet with your approval, it would be appreciated if you would pass a Resolution and accept the same at the meeting of the Board of Regents of the University of Oklahoma on September 14, 1967.

President Cross said that if the offer to purchase is accepted by the Regents, we would be disposing of approximately 344 acres of the Noble Flying Field out of a tract of 441 acres. Of this, approximately 97 acres would be traded on an acre for acre basis for land immediately north and east of the present Noble Field site. This land to be acquired would be located in Section 3, Township 8 North, Range 2 West, immediately north of Highway 9. The remaining 247 acres to be disposed of would be sold at a total price of \$370,500. This would leave the University owning 72 acres north of Highway 9 of the original Noble Field tract. A few years ago approximately 25 acres were conveyed to the State of Oklahoma for highway purposes when the new Highway 9 interchange was built.

Professor Swank stated that Mr. Perry Ames, attorney for the buyer, International Business Machines, would like to appear before the Regents and that he had several IBM officials with him. Mr. Ames, Mr. Ted Simmons, Director of Planning for IBM, Mr. Robert A. Morris, Information Manager of the Midwest Region, Mr. Robert B. Morris, Real Estate and Construction Division, and Mr. Richard Holliday of the IBM Legal Department, were invited to the meeting.

A discussion of the proposed sale followed. It was pointed out that three independent appraisals had been obtained on this property and that the price offered is well in line with all of the appraisals.

On motion by Regent Calvert, the following Resolution accepting the offer was unanimously adopted and the Regents authorized the appropriate officials to execute the necessary contracts:

## RESOLUTION

BE IT RESOLVED that the Regents of the University of Oklahoma having this day been made an offer by International Business Machines for the purchase from the Regents of a portion of the Noble Flying Field, do hereby accept that offer subject to the following conditions:

1. That in accordance with the terms of a letter of intent from the Federal Aviation Administration the sale must be finally approved by the Federal Aviation Administration.

- 2. That the Regents shall at time of closing deliver a special warranty deed warranting the title only from the date of acquisition from the United States Government and that no warranty of title is to be made prior to the time of that acquisition.
- 3. That the purchaser shall relocate the building of the present tenant upon the new tract in as good condition as the building now exists.

Mr. Ames and the gentlemen from IBM retired from the meeting.

President Cross reported he had asked Dr. Thurman J. White, Dean of the Extension Division, to attend the meeting and report to the Regents on a current project of the Extension Division.

Dean White explained that a hacienda, El Cobano located in Colima, Mexico, has been leased to the University of Oklahoma Foundation by Senor Lic. Carlos Septien rent-free for 10 years. In order to use the hacienda it will be necessary to make some repairs and modernize the building. Dean White stated he has recommended to President Cross that the University borrow the money from the Foundation to make the necessary repairs, that the hacienda be assigned to the Extension Division for educational purposes and that the Extension Division be responsible for repayment of the loan.

The University Architectural Committee estimates that the cost of modernization and repairs will be \$16,000. The Governor of the State of Colima has offered to pay 20% of these costs. Dean White said the Extension Division would like to borrow \$20,000 from the Foundation with the balance remaining after repairing the building to be used for the purchase of furniture. The agreement between Senor Septien and the Foundation provides for an option to renew the lease or to purchase the property at the end of the 10-year period.

With the proposed renovation, the building will house approximately 29 individuals. The Extension Division anticipates that if 25 people use the hacienda for 40 nights per year at \$6.00 per night the cost of the repairs can be amortized in 10 years. However, they expect the building will be used approximately 200 nights per year.

Dean White said they have discussed possible uses for this building with members of the faculty and interest has been expressed by Botany, Zoology, Geology, Anthropology, Modern Languages, Fine Arts, and others. First priority for use of the building would be members of the faculty for educational purposes. The facility could also be used in training Peace Corps volunteers and it could be made available to the Southwest Alliance for Latin America and to other educational institutions in the United States.

President Cross stated he had requested Dean White to make this report so that the Regents would have an opportunity to express any objections they might have to the Extension Division entering into this type of agreement with the Foundation and with Mexico.

The Regents all expressed agreement with the proposal as presented with the understanding expenses will not be in excess of those reported.

Dean White retired from the meeting.

President Cross called attention to his letter of August 15 to the Regents pertaining to the request of the College of Law to have separate budget status. He suggested that a committee of the Regents might be appointed to look into this matter rather carefully. After a discussion it was agreed that the Board should act as a committee of the whole in studying the Law request for a separate budget allocation. The Regents also requested that Dean Kuntz be invited to present information at the luncheon or an afternoon session following the October Regents' meeting.

President Cross reported that Dr. J. Herbert Hollomon, President-Designate, had been on the campus since September 1 and he invited Dr. Hollomon to report on his activities.

Dr. Hollomon stated during the first few days on the campus he has been trying to meet as many people as possible, particularly the students. He also has been making arrangements for additional members of his staff as authorized by the Regents. Dr. Gordon A. Christenson, appointed as Associate Professor of Law and Assistant to the President-Designate, was approved by the Regents at the July meeting. Dr. Hollomon said that Mr. James Howard, who was a graduate student last year and quite familiar with the students and the campus, and Dr. Robert A. Shapiro, Associate Professor of Industrial Engineering, have also been added to his staff. On a part-time basis Professor Mildred Andrews from the School of Music and Dr. Robert A. Bird from the School of Medicine will be members of his staff.

Dr. Hollomon reported on his speaking engagements in the State, his plans for visiting other educational institutions in Oklahoma and outside the State, and the studies he will undertake this year pertaining to the future development of the University.

There was a brief discussion of plans for Dr. Hollomon's inauguration. It was agreed that the most appropriate time would be in October 1968 after the fall semester is well under way. Mr. Davidson stated he would appoint a special committee from the faculty, student body, alumni, and the general public to make plans for this inauguration.

Mr. Houchin, Chairman of the Regents' committee appointed to study the plans for the proposed golf house, presented a report. Regents Sparks and Calvert were also members of the committee. Mr. Houchin said the committee went into this matter at considerable length and some revisions have been made in the plans which they think are beneficial and money saving. A meeting was held this morning and the committee has now agreed that the plans as revised by the architectural committee on September 13, 1967 are very satisfactory. Accordingly the committee recommended to the Board that the plans be approved and that financing for this facility be by way of revenue bonds. Mr. Houchin said the committee agreed the revenue bonds could be sold separately or in conjunction with those sold to construct the proposed new fieldhouse, whichever is most feasible.

President Cross circulated a letter from Mr. Kenneth E. Farris, Associate Athletic Director and Business Manager, pertaining to financing for the proposed golf facility. Mr. Farris said in his opinion it would not be wise at this time to finance the golf house from surplus revenue of the Athletic Department, which now totals \$401,407.19, since the primary function of the surplus account is to cover a departmental loss in a given fiscal year, if there is one, and/or to provide funds for the purpose of meeting contractual obligations in the event of an extremely bad season or disastrous gate sales. He suggested revenue bonds as the only immediate means of financing the project at this time.

It was agreed that the President's staff will investigate the possibility of issuing revenue bonds for the golf facility alone or in conjunction with the new fieldhouse and present a report to the Regents at the October meeting.

Mr. Houchin moved adoption of the committee recommendation that the golf house plans be approved as revised, that authorization be given to advertise for bids at the appropriate time, and that the facility be financed from revenue bonds if possible.

Approved.

Vice President Brown reported there is now \$7,645 cash in the Murray Case Sells Foundation. Money in this fund is usually used for matching the NDEA loan funds but this amount will not be needed until the fall of 1968. Dr. Brown recommended that a 180-day Certificate of Deposit be purchased.

He reported also that \$3,565 cash is available in the Murray Case Sells Building Fund. J. & W. Seligman & Co. has recommended that up to 45 shares of Allegheny Ludlum Steel \$3 convertible preferred stock be purchased. Dr. Brown concurred in this recommendation.

On motion by Regent Little, the investment recommendations were approved.

A report on activities at the Medical Center since the last meeting was included in the agenda.

The Medical Center has been the recipient of certain endowments, most of which have been designated for the benefit of Children's Memorial Hospital. Occasionally, this income becomes available at times when the Medical Center is not prepared to use the income for its intended purposes. They have recommended that they be authorized to invest this expendable income in Certificates of Deposit or short-term Treasury Notes, pending the need of the money for expenditure. Mr. Swank has indicated that there is nothing improper about this procedure.

President Cross recommended that appropriate officials of the Medical Center be authorized to invest such expendable endowment income in Certificates of Deposit or Treasury Notes so as to realize the greatest possible income for such temporary periods that such expendable income is not needed for immediate expenditure.

Approved on motion by Regent Houchin.

President Cross reported that under the trust of the Charles B. Taylor Lectureship Fund one-fourth of the investment income each year should be added to capital and invested. The income for the year ended June 30, 1967, was \$553.12. This would make available for transfer to principal cash \$138.28, leaving a balance of \$660.07 from earnings from this and previous years for use by the School of Medicine for a lecture.

On June 30, 1967, were was a balance of \$86.10 in principal cash which is also available for investment.

The investment portfolio of this fund contains the following securities:

It was the intention of the donors to continue investing in shares of these three funds.

President Cross recommended that \$138.28 of income cash be transferred to the capital fund and that the total amount available, \$224.38, be invested to the fullest possible extent in the George Putnam Fund.

Approved on motion by Regent Houchin.

In 1965, Helen Taggart died in Muskogee, Oklahoma. In her will she named the Crippled Children's Hospital as a residuary legatee. Prior to her death, she had sold a tract of land to Loyd Hayes and Josephine Hayes. The contract for sale of this land provided for installment payments to be made. When the estate was probated, this contract and the payments to be made under it were all that was left as a residue of the estate. The payments under this contract have now been made to the University and the purchasers have requested the Regents to execute a Quit Claim Deed on the property covered by the contract of sale.

President Cross recommended that the Regents authorize the President of the Board to execute a Quit Claim Deed to Loyd Hayes and Josephine Hayes.

Approved on motion by Regent Houchin.

The low bid was below the projected cost for the project. Dr. Dennis and the architect have recommended the acceptance of this low base bid plus alternates two and seven as submitted by Blount-Barfell-Dennehy, Inc. for a total contract of \$3,007,200. This acceptance must be subject to final approval by the Public Health Service.

President Cross recommended acceptance, subject to approval of the Public Health Service, of the bid proposal submitted by Blount-Barfell-Dennehy, Inc. for the base bid plus alternates two and seven, and that upon notification by the Public Health Service of approval of the bid, the President of the Regents be authorized to execute a contract for this construction.

Approved on motion by Regent Huffman.

President Cross reported the Physical Plant Department at the Medical Center prepared plans and specifications for a prefabricated metal warehouse and requested the Central Purchasing Division of the State Board of Public Affairs to secure bids for site preparation, furnishing, and erecting a 40' by 60' metal warehouse. President Cross reported the death of Dr. Harold E. Affsprung, Professor of Chemistry, on August 5, 1967.

In accordance with his letter to the Regents dated August 17, President Cross recommended the appointment of Ambassador Robert Campbell Strong as a Professor of History and Political Science for the regular session, 1967-1968.

President Cross said the former Ambassador to Iraq is coming to the University as a Department of State Senior Fellow in a program which is administered for the Department by the Foreign Service Institute.

During a ten-month period Mr. Strong will have an opportunity to inform persons on the OU campus and in the State of Oklahoma about the Department and the Foreign Service. At the same time he will become acquainted with elements of the American public important to his future assignments as a representative of the United States abroad.

The University is thus receiving, at Department of State expense, an added member of the faculty who is a professional diplomat with many years of experience in international relations. He will provide information to supplement the theories presented in the classrooms.

Ambassador Strong will develop his program in cooperation with the University administration. It is anticipated that he will conduct classes, seminars and colloquia on an occasional basis, cooperating with the established professors for the courses. He also is expected to fill speaking engagements before a variety of groups in Oklahoms.

A career diplomat, Ambassador Strong was born September 29, 1915, in Chicago, Illinois. He attended Beloit College in Beloit, Wisconsin, where he was elected to membership in Phi Beta Kappa and received a Bachelor of Arts degree magna cum laude in 1938. Beloit conferred an honorary Doctor of Laws degree on him last June.

After graduation from Beloit, Ambassador Strong did graduate work at the University of Wisconsin in Madison until he entered the Foreign Service. His Foreign Service assignments have included Frankfurt, Prague, Durban, Lourenco Marques, Sofia, Canton, Chunking, Taipei, Damascus and Iraq.

Ambassador Strong also has held the following positions within the Department of State in Washington: assigned to the Naval War College as Department of State representative; special assistant to the director, Office of Chinese Affairs; member, Policy Planning Staff of the Department; assigned to the Army War College, and director of the Office of Near Eastern Affairs.

He received the Department's Superior Service Award in 1959 and the National Civil Service League Career Service Award in 1965. He is classified as Foreign Service Officer Class 1.

When Ambassador Strong was named to participate in the Senior Fellow Program, he selected the University of Oklahoma. In the four years of the program, the Department of State has sent 27 Fellows to 29 campuses in 24 states and the District of Columbia. Of the 27, seven have been or are Ambassadors.

Ambassador Strong, who had been Ambassador to Iraq since 1963, returned to the United States in June when diplomatic relations were severed by Iraq.

President Cross recommended that the Regents formally approve the appointment of Ambassador Robert C. Strong as Professor of History and Political Science for the regular session 1967-68.

President Cross presented for the information of the Regents the following committee report on the Recreation--Physical Education Building which he received from Dean Jodie C. Smith on July 31, 1967:

On September 29, 1966, Dr. McCarter named a Planning Committee for a Recreation and Physical Education Building. Student members were added upon recommendation of the Student Senate President. Dr. McCarter's appointment communication indicated that committee reports should be directed to you. This is such a report.

The Planning Committee has identified for the project architects a list of proposed facilities to be included. The architects have given an estimated building cost (\$5,236,000) which does not include land cost, equipment, architect fees, parking or site improvements. Obviously, this estimated cost must be reduced by Committee reconsideration of the proposed facilities. This process is underway, but it appears likely the total project cost (to include an estimated operational cost) will approximate five million dollars (\$5,000,000). It is assumed that that portion of the academic operational costs consisting of the expense of the Department of Physical Education will continue to be supported by the College of Arts & Sciences.

It is neither realistic nor equitable to finance this project solely by student fees. To do so would necessitate a fee of \$9.71 per student per semester for a five million dollar program. This cost is based on a student enrollment of 15,000. However, the Committee is still firmly committed to the belief this Recrestion & Physical Education Building must become a reality. Accordingly, we propose the following actions to help solve the financing problem:

By action of the Council on Planning and Development, with your approval, place the proposed Recreation & Physical Education Building on the list of projects to be funded under the next state building bond issue. We assume the citizens of the state will approve another bond program.

The use of this building as an instructional facility by an academic discipline justifies its inclusion on a high priority list. However, an even more important factor, in my opinion, would be a positive indication to our student body that the University is firmly committed financially to the project. We need the students to know we are.

Such action would also permit the filing of an application for federal funds under Titles I and II of the Higher Education Facilities Act of 1963. These matching funds, along with the amount provided under the next state building bond issue would reduce substantially the amount to be funded by a student fee.

Additionally, we should not abandon our search for an individual or individuals who could and would make a substantial gift(s) toward the building.

If we could announce early in the 1967 fall semester that the Recreation and Physical Education Building would receive funds made available by the next state bond issue, we could, I believe, then develop a proposal which would permit this needed facility to be constructed in stages. In fact, the architects' plans would need to be developed this way.

In summery, fund the building by:

- (1) Bond Funds, State Election
- (2) Matching Funds, Federal
- (3) Student Fees

and if we should get fortunate

(4) Individual Gifts

No doubt, the best way would be to construct the project at one time. The reasons are obvious. However, the Committee sees no practical way to accomplish this end. Accordingly, the Committee recommends construction in stages and funding by the methods identified in this communication.

There was no action required on this report.

By letter dated August 18 the Regents accepted the cafeteria and Tower No. 1 of the new housing project as complete and authorized final payment to the contractor for the two buildings.

Since August 18 the contractor has finished the refrigeration plant and Tower No. 2 and the University moved into the facility in order to prepare it for student occupancy. Students are now using the entire facility.

Because of the timing and the urgency for moving into the facility by September 1, there are a few minor items that need adjustment before the entire amount due the contractor can be paid. The architect and the Director of the Physical Plant have recommended that the Regents accept the project as complete, but that the University withhold \$25,000 until the final adjustments are made.

President Cross recommended that the Regents confirm the August 18 action by mail in accepting Tower No. 1 and the cafeteria as complete and that the Regents now accept Tower No. 2 and the refrigeration plant as complete except that \$25,000 be retained until the final adjustments are completed.

Approved on motion by Regent Little.

When bids were received for the construction of the new Social Science Center, it was necessary to use practically all of the funds available in order to accept the low bid. At that time the architects suggested certain changes in order to free a small amount of money for possible change orders.

The Department of Housing and Urban Development has now approved the changes which result in a net reduction of \$13,676 to the total construction contract. The following changes are included:

#### ITEM 1.

Frames on all recessed fluorescent lighting fixtures are changed from extruded aluminum to painted steel and Holophane control lens shown for all lighting fixtures are changed to 100% acrylic K-12 pattern.

This change will not affect the quality or performance of the lighting fixtures.

## ITEM 2.

Furnish and install extra heavy cast iron soil pipe and fittings for all roof drainage piping in lieu of standard weight galvanized steel pipe with black cast iron drainage fittings. Cast iron pipe to be joined with neoprene fittings.

This change will make erection of piping more simple, especially in horizontal runs.

## ITEM 3.

Delete brick bond courses in Building "A" and use Dur-O-Wall ties in lieu thereof. Delete false bond courses in stair and elevator tower of Building "B".

This change was requested by the architect to provide harmony in exterior appearance of the brickwork.

Change Display Case specified to one of similar design and equal quality to be manufactured by York Metal Fabricators, Oklahoma City, Oklahoma.

Reinstate Alternate No. 10, Dimmers for incandescent lights, at price stated in the Alternate Proposal.

Reinstate Alternate No. 11, Sound System, at price stated in the Alternate Proposal.

Sound system is required for operation of the large classrooms.

President Cross recommended that the Regents authorize the President of the Board to sign Change Order No. 1 for the Social Science Center to provide for a net reduction in cost of \$13,676.00 as explained above.

Approved on motion by Regent Sparks.

President Cross reported the estimated delivery time on the purchase of refrigeration equipment for the Power Plant expansion project is 14 months. This fact was reported to the Federal Programs Officer in the

office of the Oklahoma State Regents for Higher Education who in turn requested special approval from the U. S. Office of Education in order that the equipment could be ordered at the earliest practical date. The Office of Education approved the request.

Invitations to bid on the equipment were circulated and bids were received on August 24 for furnishing two 3,000 ton refrigeration units for the Power Plant. The following bids were received:

President Cross recommended that the low base bid from Carrier Air Conditioning Company be accepted for a total cost of \$343,343.

President Cross reported that bids will be received on September 22 for the construction of a parking lot to hold 1,465 cars to serve the new Towers which have just been completed. The plans and specifications for the new parking lot were prepared by the architects, Black, West and Wozencraft, as a part of the site improvements for the project.

Since construction of the lot should be started as quickly as possible and since there appears to be no real reason to delay the consideration of the bids until the next regular meeting of the Board, President Cross recommended that the Regents authorize the President of the Board to award the parking lot construction contract to the lowest and best bidder at the earliest possible date after the September 22 bid letting.

Approved on motion by Regent Houchin.

Regent Davidson said that if there is anything unusual about the bids received on this project the matter will be referred to the entire Board for consideration by telephone.

President Cross reported the contractor has completed the construction of the boathouse at the Biological Station. The architect has recommended that the project be accepted as complete and final payment to the contractor be authorized.

The contractor has also finished the construction of the new living facility at the Biological Station, and the architect has recommended that this project be accepted and the final payment to the contractor be authorized.

President Cross recommended that the Regents accept as complete the construction of the boathouse and the construction of the new living facility for the Biological Station and that final payments to the contractors be authorized.

Approved on motion by Regent Houchin.

President Cross reported the contractor has completed the addition to Gould Hall for the use of the Geological Survey except for a few mechanical items that require additional testing. The University Architectural Committee has recommended that the project be accepted as complete except that \$3,000 be withheld until the mechanical testing is completed.

President Cross recommended that the Regents accept as complete the addition to Gould Hall but that \$3,000 be retained from the final payment to the contractor until the mechanical items have been tested satisfactorily.

Approved on motion by Regent Little.

President Cross reported the Multi-Purpose Training Center of the VISTA Training Program of the Extension Division has requested that Professional Administrative and Training Consultants, Inc. be retained to furnish the psychological assessment and consultant services in connection with the VISTA IV Program under the contract with the Office of Economic Opportunity. The contract is estimated to cost \$2,100.

Since the President of Professional Administrative and Training Consultants, Inc. (Maurice K. President Cross recommended that the contract be awarded to Moore-Cottrell Subscription Agencies, Inc.

Approved on motion by Regent Houchin.

President Cross reported that one of the items of equipment in connection with establishing a laboratory for Psleomagnetism was the purchase of a Spinner Magnetometer with a digital readout and provisions for digital printout. The equipment is a one source item available only through the supplier, Princeton Applied Research Corporation, Princeton, New Jersey. The representative of the corporation is Noskes Engineering, Irving, Texas.

In making plans for the laboratory, Dr. Robert DuBois, found that if the item could be ordered immediately, delivery could be made prior to the beginning of school. If the order was delayed, the equipment would not be available until approximately the end of the first semester.

Since the item was available from only one source and since shipment could be made immediately, Vice President Brown contacted the President of the Board of Regents and Mr. Davidson authorized the Purchasing Office to issue the purchase order to complete the purchase of the item. The specifications for the item are as follows:

1 - Model SM-1D-Spinner Magnetometer with digital readout and provisions for digital printout

President Cross recommended that the Regents confirm the purchase of the Spinner Magnetometer at a total cost of \$10,050.00 from the Princeton Applied Research Corporation as explained above. An Affidavit certifying to the fact that this is a one source item was included in the agenda.

Approved on motion by Regent Little.

President Cross reported that bids have been received through Central Purchasing for 32,500 gallons of gasoline to be delivered to University storage tanks as requested in quantities of 5,000 to 5,500 gallons.

Bids received by Central Purchasing were:

Grimwood Oil Co., Norman, net \$.1902 per gallon \$6,181.50

Continents 1 Oil Co., Oklshoms City,

net \$.2035 per gallon \$6,613.75

Skelly Oil Co., Kansas City,

Missouri, net \$.2095 per gallon \$6,808.75

President Cross recommended that the contract be awarded to the low bidder, Grimwood Oil Co. at a cost of \$.1902 per gallon.

Approved on motion by Regent Houchin.

President Cross reported the Purchasing Office requested bids on a one-year contract for the lease of musical instruments for the School of Music. The contract also contained a provision for an option to renew for four additional years. While trying to obtain bids it was determined that C. G. Conn Limited is apparently the only manufacturer operating a lease-purchase arrangement in this area.

Sharp & Nichols Music Company, Inc., was the only firm to bid on the instruments desired. Sharp & Nichols bid on the rental of some of the instruments acting as agent for Conn Limited and bid on the remainder in the name of Sharp & Nichols. The bid information furnished by Sharp & Nichols was included in the agenda for this meeting.

The offer made is to furnish all instruments listed at a rental cost of \$9,233.26 per year. Should the School of Music decide to purchase these instruments at any time during the original contract or any extension of the contract, the total cost would be \$46,166.30. This amount is the same as the rent for five years. Any rent paid would apply toward the price of the instruments. If these instruments are rented for a period of five years at \$9,233.26 per year, they become the property of the University of Oklahoma.

If the options are exercised, the rent per instrument for a five year period is a discount of approximately 22% from the list prices shown.

President Cross recommended that the bids of Sharp & Nichols Music Company and C. G. Conn Limited be accepted and the President of the Regents authorized to sign the necessary contract.

Approved on motion by Regent Houchin.

President Cross said that representatives of Swearingen Research Park have been negotiating with the General Services Administration for the construction of a building to house the National Severe Storms Laboratory. The laboratory has occupied a frame building in the Swearingen Research Park since 1962. The General Services Administration is now interested in negotiating a long-term lease to provide permanent facilities for the laboratory. The total cost of the facility will be approximately \$600,000 and will be paid entirely from the long-term lease.

President Cross recommended that the Regents appoint an architect to prepare the plans and specifications for the new facility and that the appointment be on a contingency basis subject to approval of a long-term lease by the General Services Administration.

Approved on motion by Regent Huffman.

Regent Davidson reported the committee on the selection of architects had met this morning and recommended the appointment of Otha Wolf, architect from Oklahoma City, for this project.

On motion by Regent Huffman it was voted to employ Mr. Wolf on a contingency basis to prepare the plans and specifications for the construction of a building on the North Campus to house the National Severe Storms Laboratory.

Several months ago the Regents approved the appointment of McCune and McCune, Tulsa, for the preparation of plans for remodeling Richards Hall and for an addition to the Building with funds from the recent state bond issue. After the architects had done a great deal of work in preparing plans for submission to the State Regents and to the Office of Education for matching funds, the University found it necessary to reduce the scope of this project in order to provide sufficient funds for completion of the Physical Science Center and the Social Science Building. It is planned that the addition to Richards Hall will be the first priority from the next bond issue.

Since remodeling is the only project anticipated in the near future, McCune and McCune have requested a fee of 10% for this part of the project.

It was voted unanimously to add this item to the agends for this meeting for consideration.

Since the fee requested is in line with the usual charge for remodeling projects, Mr. Davidson said the Regents' architectural committee recommends a contract be executed with McCune and McCune for remodeling Richards Hall at a fee of 10% when funds are available.

The recommendation was approved on motion by Regent Sparks,
