MINUTES OF A REGULAR MEETING BOARD OF REGENTS OF THE UNIVERSITY OF OKLAHOMA THURSDAY, FEBRUARY 14, 1957 - 10:00 A.M.

The February meeting of the Board of Regents of the University of Oklahoma was held in the office of the President of the University at 10:00 a.m. on Thursday, February 14, 1957.

The following were present: Regent Foster, President, presiding; Regents Little, McBride, Benedum, Savage, Morgan. ABSENT: Regent Grisso.

The minutes of the meeting held on January 17, 1957, were approved.

President Cross reported that Regent Dave Morgan had again sent a check for \$1,000.00 to be used for scholarships in special cases; that checks in like amounts had been sent for several years. The Regents expressed appreciation to Mr. Morgan for his generous contributions.

President Cross stated there has been a problem in securing competent help in the President's house on a permanent basis; that they have located a woman with ten years experience who has expressed an interest in the position, but that she prefers institutional instead of personal employment by the President. She feels institutional employment would provide some advantages, such as hospitalization. He suggested the salary could be on the University payroll, and deduct the amount of such salary from the expense allowance for the President's house.

Moved by Regent Benedum, and voted, that the University provide domestic help for the President's house, to be selected by the President, and to be placed on the University payroll and the amount of salary deducted from the expense allowance provided for the President.

President Cross read a letter from Gomer Jones, under date of February 11, as follows: "As per our conversation of February 5th concerning the opportunity the Champlin Oil Company has afforded me to endorse their products.

There is a substantial remuneration connected with this offer. Inassuch as it would only take approximately one and a half days to film the endorsement, there would be no time-consuming factor involved. I would like very much for you to discuss this matter with the Board of Regents and would appreciate your letting me know their decision at your earliest convenience."

It was voted to approve Mr. Jones' request for permission to do a TV program for the Champlin Oil Company.

President Cross made a progress report on the matter of public relations which has been discussed at several meetings in the past. He stated the over-all question, including local transportation, has been studied, and in his opinion the weakest part is in our relations in Washington. He stated it would be desirable to have someone in Washington about monthly. Dr. Sliepcevich, Associate Dean of the College of Engineering, and R. L. Biesele, Associate Professor of Electrical Engineering are in Washington, D. C. now contacting various foundations concerning the Computer Laboratory; that Mr. Biesele is on leave of absence from his teaching and working on the matter.

Some consideration has also been given to the matter of local transportation and that it is planned to buy a station wagon in the near future.

President Cross stated he had made arrangements to invite representatives of the press, those who have been active in connection with fund raising for the Journalism Building, as guests at luncheon, following which there will be the ground-breaking ceremony at the location of the building on the south oval.

He also called attention to the Grantland Rice Award Ceremony in Holmberg Hall Auditorium at 4:30 p.m. and expressed the hope that the Regents would attend.

President Cross discussed the preliminary plans and a model of the new Women's Dormitory.

Regent Savage moved, and it was voted to approve the preliminary plans for this dormitory.

Bids were received on 610 reams of Warren's Book Paper for the University Press. Identical bids of \$7,310.60, six weeks delivery, f.o.b. Norman, less 2% - 30 days, were received from the Tulsa Paper Company and the Western Newspaper Union. These two companies are the only two dealers in this paper in the state. Following the policy of alternating purchases, President Cross recommended that the contract for this order be awarded to the Western Newspaper Union, Oklahoma City.

Approved on motion by Regent Little.

Bids were considered on furnishing stainless steel cafeteria and kitchen equipment for Wilson Center. Six bids were received. President

Cross recommended that the contract be awarded to the low bidder, Allied Sales Engineering Company for equipment to be manufactured by Howard Vinson Manufacturing Co., and with acceptance of alternates and adjustment of base bid as follows:

Moved by Regent Morgan, and voted, to award the contract as recommended.

Regent McBride brought up the matter of fraternity housing. He stated some of the organizations are having financial difficulties and that some of this might have been avoided if the University had exercised some supervision. He stated further in some places the institution provides housing and rents to the fraternities, and he mentioned Northwestern as an example. President Cross stated Tennessee has such a plan.

It was agreed that an investigation be made and bring a report to the Regents at the next meeting. The legal aspects of such a plan should be looked into.

President Cross reported that the following recommendation for the improvement of academic standards had been received from the University College Council:

ACADEMIC PROBATION

Whenever as a result of a semester's work a student fails to maintain an overall average of "C," he will be placed on academic probation. He may remove his probationary status as soon as he has at the end of a subsequent semester raised his overall average to "C." Under no circumstances, however, will he be given more than two semesters to remove his probationary status. During his probationary period only the grades in courses taken in residence and applicable for credit toward his degree will count toward the removal of the probation. If at the end of the probationary period he has not raised his overall average to "C," under the conditions specified above, he will not be permitted to apply for enrollment for at least twelve months. At the end of twelve months, he may apply for reinstatement.

A student may use two summer sessions to raise his overall average. These summer sessions will not count against the number of semesters of probation a student is allowed.

Students on probation will be permitted to enroll only after all students in good standing have been enrolled.

These regulations apply to and govern the admission of transfer students, including former students returning to the University.

He said this recommendation would receive study and consideration by the faculties of degree recommending colleges. The Regents expressed general approval of the proposed regulation.

President Cross reported the following deaths:

Dr. M. L. Wardell, David Ross Boyd Professor of History. Dr. Wardell served as a member of the faculty from 1925 to the time of his death on Tuesday, February 5. Dr. Wardell's outstanding service as a teacher was recognized by the Regents in 1946 through appointment as David Ross Boyd Professor of History. Very few members of the faculty have served the University as effectively as did Dr. Wardell, and his passing is a great loss to the institution and the state.

Dr. William M. Taylor, Professor Emeritus of Pediatrics. Dr. Taylor served as a member of the faculty of the School of Medicine from 1911 to 1938, when he was given the title of Professor Emeritus of Pediatrics upon his retirement from active service. Dr. Taylor died January 3, 1957.

Dr. Coyne Campbell, Professor of Psychiatry and Neurology. Dr. Campbell served as a member of the faculty of the School of Medicine from 1933 to the time of his death, January 22, 1957.

Theodore K. Davis, Teaching Assistant in Industrial Education. Mr. Davis served as a member of the faculty in the College of Engineering from July 1, 1924 to July 1, 1950, and has been on a retirement status since that time. Mr. Davis died on Sunday, January 13, 1957.

It was voted that the President of the Regents write letters of sympathy to the families.

Item No. 11 with reference to extension of utility lines from the Journalism Building to the site of the Jones Chapel at an estimated cost of \$6,500.00 was withdrawn by President Cross in view of the fact that Mr. Jones has agreed to pay \$5,000.00 of the cost.

President Cross reported when the Library Addition and the Journalism Building are occupied, the peak electrical load on the University Power Plant will increase to a level requiring regular operation of two turbines.

This will require additional cooling tower capacity. The most feasible way to provide this is to replace the tower at the old power plant. This tower, installed in 1927, is beyond economical repair. The concrete basin can be put into good condition at low cost, and a new tower installed over it.

He recommended that the Regents authorize calling for bids on furnishing and installing a new cooling tower on the concrete basin at the old power plant, and that \$20,000 of unobligated funds in the 1955-57 Modernization and Repair Program be set aside for this project.

Approved on motion by Regent Savage.

President Cross called attention to the Regents' policy on season football tickets adopted last year (see p. 5515). Following is a copy of a letter from Kenneth Farris, Business Manager of Athletics, in which he calls attention to ticket priorities for lettermen.

"January 28, 1957

"Dear Dr. Cross:

"Please find attached the names of all season ticket holders who in 1956 purchased ten or more season tickets.

"Our ticket office encountered a great number of disgruntled patrons during the 1956 season, which of course, we expected in the light of our entire ticket policy being changed. My ticket staff and I now feel that this is all behind us and the new policy will work quite smoothly in the future.

"We are quite pleased with the Courtesy Card arrangement, the policy covering the distribution of Texas tickets, the longevity plan concerning improvement, as well as the Notre Dame distribution plan approved by the Board of Regents last October.

"I can think of only one change in the new ticket policy which had to do with football lettermen. Since the policy adopted last March states that no preference shall be shown to any group or to the members of any group in improving seat locations, other than on the basis of longevity, we find that this imposes a hardship on our graduating football lettermen. It means that they must start from scratch in the end-zone.

"Since it is these boys that have enabled us to attain our national ranking, prestige and success, we are requesting permission to give them preferential treatment on the east side of the stadium. It is not our intention to place them on the 50 yard line at the beginning, but to give them a helping hand somewhere between the 10 and 35 yard lines. This request pertains to football lettermen only.

"Please allow me to state at this time that I would be opposed to any further season ticket reductions. We have everyone pretty well satisfied and have been able to explain to them in a courteous manner the reasons for the new ticket policy and even though it has been somewhat trying and difficult in a number of cases, we have all of our customers pretty well satisfied.

President Cross recommended that football lettermen be given priorities as requested by Kenneth Parris, and it was voted to approve the recommendation.

Also, the names of individuals and firms with the number of tickets authorized under the Regents' policy are included (see next.page).

The following statement and recommendation with reference to stadium bonds was presented:

Stadium Refunding Bonds with face value of \$55,000 mature March 1, 1957.

The required \$105,000 Stadium fee revenue will be sufficient to retire the \$55,000 maturing bonds, pay interest due, and redeem \$35,000 of bonds ahead of maturity. Terms of the bonds make it mandatory to call bonds ahead of maturity with the surplus from the \$105,000 fee revenue.

These retirements March 1 will reduce the indebtedness on the Stadium to \$509,000. If payments on the indebtedness are limited to annual maturities and the mandatory redemptions with fee revenue, the final payment will be made September 1, 1961.

RECOMMENDATION:

That in addition to the mandatory bond call described above, \$30,080 of the Athletic Department surplus be used to call bonds prior to maturity March 1, and that the following resolution be adopted:

RESOLUTION

Whereas, prior to March 1, 1957, there will be in the principal and interest fund of the Regents of the University of Oklahoma Stadium Refunding Bonds of 1951 an amount sufficient to meet the interest and principal payments due on that date, plus sufficient cash to redeem \$35,000 face value bonds prior to maturity and pay the call premium thereon; and

Whereas, there also will be in the said principal and interest fund sufficient cash to redeem optionally \$30,000 in bonds; and

Whereas, under terms of the proceedings authorizing the bonds, such redemptions prior to maturity must be made in inverse order of the serial numbers of the bonds;

Be it resolved by the Board of Regents of the University of Oklahoma that the 39 bonds of the 1966 maturity numbered 666 to 704 inclusive be called for redemption prior to maturity as of March 1, 1957, at par and accrued interest and a call premium of \$20 per bond; and that 26 bonds of the 1965 maturity numbered 640 to 665 inclusive be called for redemption prior to maturity as of March 1, 1957, at par and accrued interest, without call premium; all as provided in the proceedings authorizing the issuance of the bonds; and provided further that the Trust Department of The First National Bank and Trust Company of Oklahoma City, Trustee for this bond issue, be instructed to redeem the said bonds and give the Controller of the University evidence of such redemption and cancellation.

Moved by Regent Morgan, and voted, to adopt the resolution.

President Cross reported funds are available in the Athletic Department budget to purchase additional bleacher units for the south end of the Stadium. This will bring total seating capacity of the Stadium to 61,731. Since the additional units must fit the structural system of the present bleachers, the order can be placed with only one company.

President Cross recommended that the Board of Regents authorize purchase of Waco Model 2600 steel bleacher units with accessories, to seat 1,800 persons at 18" per seat, from Sani-Mist, Southwest, Dallas, Texas, at a total price of \$12,260.78.

It was voted, on motion by Regent Benedum, that the applicants recommended, including alternates, for the 1957 freshman class of the School of Medicine, be approved.

President Cross called attention to the fact that football coaches' contracts begin on January 1, except Gomer Jones who is on tenure, and that any salary changes or appointments become effective as of that date.

The hour for luncheon (12:00 noon) having arrived it was agreed to postpone consideration of the matter at hand until the afternoon session, and the meeting was adjourned to meet for luncheon with representatives of the Press as guests, to be followed by ground-breaking ceremonies for the Journalism Building at 1:30 p.m.

The meeting was resumed at 2:25 p.m. in the President's office.

There was further discussion on the question of salaries for football coaches. President Cross stated he had had a conference with Athletic

Director Wilkinson. Mr. Wilkinson stated he would like to increase the salaries of assistant coaches but that he would not want to have such salaries out of line with those of members of the faculty. He did recommend, by letter, that adjustments in salaries for the year beginning January 1, 1957 be made as follows:

> Gomer T. Jones, Associate Professor of Physical Education, Assistant Football Coach, Assistant Director of Athletics, \$9,500.00. (\$2,000.00 expense allowance authorized beginning 7/1/54)

Sam Lyle, Assistant Football Coach, \$7,700.00

Eddie Crowder, Assistant Football Coach, \$6,800.00

Ted Youngling, Assistant Football Coach, \$6,060.00

President Cross recommended approval of the salaries as submitted by Mr. Wilkinson.

Moved by Regent Little, and voted, to approve salaries as shown.

In the absence of Regent Grisso, the Secretary reported receipt of a recommendation by mail from Mr. Grisso, concurred in by Mr. Felix Simmons, Chairman of the Will Rogers Memorial Scholarship Investment Advisory Committee, on the following:

The Will Rogers Memorial Scholarship Fund has been sent a warrant for 250 rights for the purchase of additional shares of Socony Mobil Oil Company common stock at \$45.50 a share. Ten rights are required for the purchase of each share, and we are entitled to 25 shares. As of February 6 the rights were selling on the market at 25/64ths.

Also, a warrant for 228 rights for the purchase of 4%% convertible debentures due 1987, Phillips Petroleum Company, have been received. Twenty eight rights are required for the purchase of a \$100.00 bond. On the basis of the attached warrant, we may purchase 12 \$100.00 bonds at a total cost of \$1,200.00 not including additional cost of 12 rights which we will need to complete the twelfth bond. As of February 8 the rights were selling on the market at 13/32's each.

It was voted to authorize purchases as recommended by mail by Regent Grisso.

Regent Grisso wrote under date of February 12, 1957 concerning investment of Crippled Children's Hospital Funds as follows: "Some days ago you asked for advice on a Regents' controlled fund as follows:

Crippled Childrens' Hospital Funds

I referred this to the Liberty National Bank. In their opinion all of the available cash should be invested in common stocks. Reviewing the other assets, I agree with this conclusion.

The suggestions of the Bank are expressed by Mr. Louis F. Danforth, Jr. and appear on the photostat of his letter which we are enclosing.

My own ideas are as follows:

1. Bucyrus-Erie at market for one-half of funds available.

2. Ohio Oil for one-half of the funds available.
