MINUTES OF A SPECIAL MEETING BOARD OF REGENTS OF THE UNIVERSITY OF OKLAHOMA THURSDAY, JUNE 19, 1975

A special meeting of the Board of Regents of the University of Oklahoma was held in Dining Room 1 of the Oklahoma Memorial Union on the Norman Campus on Thursday, June 19, 1975, beginning at 2:45 p.m.

The following were present: Regent Walter Neustadt, Jr., President of the Board, presiding; Regents Mack M. Braly, Bob G. Mitchell, M.D., Richard Bell, and Dee A. Replogle, Jr.

Absent: Regents Thomas R. Brett and K. D. Bailey

The following were also present: President Paul F. Sharp, Provost Hunsberger, Vice Presidents Dean, Morris, Nordby, and White; Executive Assistant to the President Joseph C. Ray; Mr. R. Boyd Gunning, University Trust Officer; and Mrs. Barbara H. James, Executive Secretary of the Board of Regents.

1975-76 Norman Campus Budget

Regent Neustadt said the purpose of this special meeting was to consider the budgets for the University for the fiscal year 1975-76. Each of the Regents had been provided prior to the meeting with a copy of the Norman Campus budget as well as a list of the academic promotions for the Norman Campus, a copy of which is appended as a part of these minutes. Attention was also called to the following additional title changes which are or should be a part of the budget:

Don Burkhead, from Manager, Computing Services, to Manager, Computer Utility.

Lonnie Moore, from Auditor III to Associate Internal Auditor.

David Walters, from Project Manager, Architectural and Engineering Services, to Management Systems and Project Administrator, Office of the Vice President for Administration and Finance.

William R. Rutherford, from Assistant to the Vice President for University Relations to Coordinator, Internal Communications.

Robert Maxwell, from Program Development Specialist to Program Manager, Special Programs in Career Development.

Richard Little, from Program Development Specialist to Project Director, Special Programs in Career Development.

Don S. Hale, from Conference Specialist to Program Development Specialist, Health Care Facilities.

Joe Rieger, from Instructor to Assistant Professor of Pharmacy.

Mary Jane Rutherford, from Administrative Secretary to the President to Secretary to the President, transferred from B Budget to A Budget, Managerial Classification.

President Sharp called attention to the following expense allowances which are included in the 1975-76 budget salaries for the individuals indicated:

Regent Braly moved approval of the 1975-76 Norman Campus budget. After a brief discussion pertaining to the desirability next year of the Regents having additional time to review the budget prior to action being taken, the motion was approved.

1975-76 Health Sciences Center Budget

The attached list of promotions for members of the faculty on the Health Sciences Center Campus, both salaried and clinical, was presented and approved on motion by Regent Replogle.

President Sharp reported the printed budget for the Health Sciences Center has not yet been prepared but the SRA forms which must be submitted to the State Regents for approval and allotment purposes were presented to the Regents. President Sharp said the printed Health Sciences Center budget is in the process of preparation and should be ready for the next meeting.

President Sharp recommended approval of the SRA forms for the Health Sciences Center. Approved on motion by Regent Replogle. Regent Braly abstained.

1975-76 Oklahoma Memorial Union Budget

In accordance with the terms of the lease agreement between the Regents and the Board of Trustees of the Oklahoma Memorial Union, the proposed budget for the Union for 1975-76 had been submitted to the Regents prior to the meeting.

President Sharp recommended that the Regents approve the budget for the Oklahoma Memorial Union for 1975-76 as presented. Approved on motion by Regent Replogle.

June 19, 1975

Concessions - The Lloyd Noble Center

At the June 12 meeting action was postponed on a three-year lease with Underwood's Bar-B-Q to operate the concessions for The Lloyd Noble Center in order for the administration to give the matter additional consideration and to look into a number of questions raised by the Regents. Mr.Don Hotz, Manager of The Lloyd Noble Center, presented the following report:

"With regard to the request made by the University Board of Regents for additional information pertaining to the concession operations at The Lloyd Noble Center, I am submitting for your review and consideration the following:

- Cash flow for employment of personnel and products for concession operation. (See attached). It should be pointed out that in addition to the \$25,000 annual guarantee submitted by Underwood's, an additional \$5,000 annual payment will be made to the University to offset the cost of time required by Lloyd Noble Center personnel to monitor and control this concession contract. This \$5,000 payment is separate of, and in addition to, the \$25,000 guarantee and/or 30% of gross sales commitment. It should also be pointed out that the first three years of an arena operation such as The Lloyd Noble Center, are considered to be the most critical and generally recognized as the time period required to establish a full booking schedule. Consequently, the request made by the Regents to establish whether or not Underwood's would be willing to accept a year's contract, with the University purchasing their equipment at an amortized cost at the end of a year period, was rejected by Underwood's. - While I continue to feel that we could operate our own concessions within The Lloyd Noble Center, I am also cognizant of the fact that the availability of additional funds for the purchase of all types of equipment for this facility is limited.

With limited funds available, I feel it is necessary that we establish priorities on the use of these funds. The priority items for equipment and/or modification to The Lloyd Noble Center would include such things as the purchase of follow spotlights, staging, portable chairs, protective covering for basketball court, equipment for cleaning and maintenance of the facility, etc.

In addition to the purchase of equipment, we will be looking for additional funds to make both major and minor modifications to the facility such as additional rest rooms, additional concession stands, and additional spotlight and camera locations.

"With this thought in mind, I would recommend that consideration be given to awarding this concession contract to Underwood's, allowing us to take advantage of their purchasing and installation of equipment and establishment of concession operations, thus freeing any additional funds available for the purchase of equipment necessary for the operation of this facility."

"Dear Mr. Hotz:

"As per your inquiry pertaining to my company's position on the lease purchase of concession equipment proposed for the Lloyd Noble Center, I have checked this request with my staff and it is concluded that any time periods less than those indicated in our proposal would not be feasible in that we feel that the original three year contract would be the minimum amount required to amortize the cost of our equipment.

We are certainly looking forward to working with you and the University of Oklahoma on this fine project.

I would also point out that it is necessary that we start immediately to purchase and install equipment in order that we might be ready by August 31st. Should I be of any further assistance to you, please do not hesitate to contact me.

Regent Mitchell asked Mr. Hotz if the University could come up with the funds to purchase the equipment would he be able to get set up and in operation for the first scheduled events. Mr. Hotz replied that time is getting short but he believes that he could do it. Regent Mitchell then asked Vice President Nordby if he would be able to scrape up the funds for this purchase if the Regents did not approve the lease.

Vice President Morris said it is the opinion of the administration that as soon as the arena is open, in order to get it operational as it should be, there will be a continuing demand for funds for a number of items. He said if they developed a priority list and put in \$40,000 for the concessions equipment, it would be pretty far down the list of priorities. It was Dr. Morris' opinion that in view of the shortage of funds and this kind of priority for the concession equipment that the best thing would be to approve the lease proposal and allow Underwood's to handle the operation for the first three years.

In response to Dr. Mitchell's question, Dr. Nordby said he probably could scrape up \$40,000 if necessary but it would have to come from another auxiliary that might need the capital and this might jeopardize the expansion or continuing viability of that auxiliary.

In response to a question, Mr. Hotz reported that if the lease is awarded to Underwood's and it is not renewed by the University at the end of the three-year period that the University will have the right to purchase the equipment at the amortized cost.

The proposal of Underwood's Bar-B-Q of Oklahoma City included agreement to operate the concessions in accordance with the specifications prepared by the Director of The Lloyd Noble Center, as well as the following:

- 1. Term of the contract three years with a three-year renewal option resting with the University.
- 2. A guarantee of an annual payment to the University of \$25,000 or 30% of gross receipts from the sale of concession items, whichever is greater.
- 3. Installation of approximately \$65,000 in concession equipment to include portable concession stands.

President Sharp recommended acceptance of the proposal submitted by Underwood's Bar-B-Q. Approved on motion by Regent Replogle. Regent Mitchell asked that he be recorded as voting NO.

Scholar-Leadership Enrichment Program

President Sharp recommended that Dr. Samuel A. Kirkpatrick, Professor of Political Science and Director of the Bureau of Government Research, be given the additional title of Director, Scholar-Leadership Enrichment Program, effective July 1, 1975.

President Sharp explained this new program, which was made possible this year through the leadership of Governor Boren. He said \$150,000 has been allocated to the University by the State Regents for this program for 1975-76. President Sharp said the budget for this program has not yet been prepared but will be presented to the Regents at the next meeting. President Sharp then introduced Dr. Kirkpatrick. He said a press conference would follow the Regents' meeting so the media would have the opportunity to ask questions and to get acquainted with Dr. Kirkpatrick.

The additional title for Dr. Kirkpatrick was unanimously approved on motion by Regent Mitchell.

Sub-Contract with Radian Corporation

The University submitted a proposal to the Environmental Protection Agency to conduct a "Technology Assessment of Western Energy Resource Development". This proposal was a joint proposal with the Radian Corporation of

Austin, Texas. The total amount of the proposal was \$1,299,993 with Radian's share in the form of a sub-contract to be \$649,947.

The University has been negotiating with the Environmental Protection Agency and fully expects to be awarded a contract for this work to begin July 1, 1975.

President Sharp recommended approval by the Regents to enter into a sub-contract with Radian Corporation when the contract from the Environmental Protection Agency is awarded. The sub-contract will not exceed the amount provided by EPA for this purpose.

Approved on motion by Regent Braly.

There being no further business the meeting adjourned at 3:15 p.m.
