

MINUTES OF A REGULAR MEETING  
BOARD OF REGENTS OF THE UNIVERSITY OF OKLAHOMA  
THURSDAY, JUNE 9, 1960 - 10:00 A.M.

The regular June meeting of the Board of Regents of the University of Oklahoma was held in the office of the President of the University, Norman, on Thursday, June 9, 1960, at 10:00 a.m.

The following were present: Regent Benedum, President, presiding; Regents Savage, Northcutt, Rothbaum, Grisso.

ABSENT: Regent Morgan.

The minutes of the meeting held on Tuesday, May 10, were approved.

President Cross reported the University's request to schedule a football game with the University of Hawaii in Hawaii in 1961 had been denied by the Faculty Representatives of the Big Eight Conference. Regent Benedum inquired if there is any possibility for reconsideration of this action. President Cross stated he would contact each institution president and inquire about this possibility.

Regent Northcutt moved and it was voted that a committee be appointed to study the advantages and disadvantages and problems involved in withdrawing from the Big Eight Conference. The Chair appointed Regents Northcutt, Savage, and Rothbaum.

President Cross read a telegram from J. & W. Seligman & Co. recommending an exchange of \$52,000 in government bonds due November 1961, to 3-3/4 Treasury Notes due May 15, 1964. After a discussion the Regents voted to take no action on the matter.

Regent Northcutt stated the State Regents for Higher Education held a meeting in Durant on May 23 and asked him to be present. They were especially interested in information concerning the Biological Station at Lake Texoma.

President Cross read a letter from Mr. Dean A. McGee, and a telegram he had sent in connection with a recent article appearing in Time Magazine relative to "The Great Plan" of Oklahoma City University, calling attention to mis-statements made and credited to him.

President Cross was asked to write to Mr. McGee thanking him for his letter and the telegram sent.

The Board expressed appreciation to Mr. Rothbaum and Mr. Savage for the fine work they did in setting up the meeting and forum luncheon held in Tulsa on May 10 in connection with OU Day in Tulsa.

Regent Benedum read a letter from Mrs. Betty Tankersley, of Norman, asking the Regents to adopt a no car rule. President Cross stated he had a letter from Dr. John Lamb, also concerning a no car rule. After a discussion on the financial problems of enforcing a no car rule, the Regents agreed no action be taken.

Regent Grisso discussed the functions of the Will Rogers Advisory Committee. Following this discussion, Regent Savage moved, and it was voted, that no action be taken at this time.

Regent Grisso stated Anderson-Prichard had expressed an interest in leasing the 20 acres owned by the University as a part of the Oliver Wildlife tract. Due to various complex situations previously discussed (see minutes p. 6539, May 10, 1960) it was agreed that no action on executing leases be taken at this time. Regent Grisso was asked to investigate concerning the possibility of an offset well.

Regent Benedum presented the following letter from Fred Wright and John Dean, two of the young men who appeared at the Regents' meeting at Tulsa on the matter of the separate graduation exercises for the College of Law:

"May 15, 1960

"Dear Mr. Benedum:

"On behalf of the Student Bar Association and the Class of 1960, College of Law, University of Oklahoma, we extend our sincere thanks and appreciation for allowing us to appear before you and for your consideration of the petitions of our student body.

"It has made us quite proud and truly respectful to know that the Board of Regents will take their time and effort to consider student proposals with such sincerity and concern. It has further substantiated our confidence in the merits of student participation and though we were unsuccessful, we know that our time was not spent in vain.

"Again, we compliment our administration and extend our many thanks for your courtesy, interest and consideration.

At the May meeting in Tulsa the Regents asked for a report on acceptances in the 1960 freshman class of the School of Medicine. Dr. Taylor reports that in practically all cases the students who have been accepted must make satisfactory progress during the current semester and consequently their acceptances are tentative. So far, of the 104 accepted, only one has withdrawn, and that was a nonresident.

Dr. Taylor will have a report on acceptances by the July meeting, with assurance of admission for those who meet all requirements at the end of the second semester, and by September all students, including those who were required to take summer work.

President Cross stated the Pure Oil Company has sent to the University the abstract on Tracts B and C which they had prepared in connection with the leases on the North Campus. In sending this abstract they wrote as follows: "This abstract was made at our expense and we wish to present it to the University of Oklahoma with the compliments of The Pure Oil Company."

In another letter the Company wrote as follows: "We wish also to commend and express our gratitude to your Mr. Stockwell. The excellent cooperation and competent consideration he has displayed in preparation of the leases and working out the many details which we encountered have been most helpful."

The Regents expressed appreciation for this generous contribution to the University.

President Cross reported that the State Regents for Higher Education approved the recommendation for approval of degree programs as follows:

Master of Nuclear Engineering (see p. 6547) to replace the degree of Master of Engineering Physics (Nuclear Option).

Master of Preventive Medicine and Public Health through the Department of Preventive Medicine and Public Health in the School of Medicine (see p.6547).

President Cross stated the School of Geology recommends an increase in the subsistence charge for students in the Lake Murray field course (Ardmore) from \$90 to \$100. This includes transportation of students in their field work. He concurred in this recommendation.

On motion by Regent Savage it was voted to approve the recommendation. Regent Grisso asked that he be recorded as voting NO.

Regent Grisso asked that departments be requested to anticipate fees in advance and that one recommendation combining fee changes be brought before the Regents once a year. President Cross stated an effort would be made accordingly.

President Cross reported for the past three years the Regents have authorized waiving military drill and/or physical education for a selected number of men in the University Band on an experimental basis.

The University Band Committee now recommends as follows:

"To extend indefinitely the policy permitting a maximum of 60 Freshman boys and 60 Sophomore boys to substitute University Band for basic Military, Air or Naval Science, and Physical Education since the program has been operating successfully for the past three years."

President Cross concurred in this recommendation. Approved on motion by Regent Savage.

On June 14, 1950 the Regents authorized listing the Department of Aviation as a part of the College of Business Administration (p. 3541). Conditions at the present time are such that there is no relationship between the program of the Department of Aviation and the work of the College of Business Administration.

President Cross recommended that the action taken on June 14, 1950 be rescinded, and that the Department of Aviation be listed as a separate department in the same way as the three military science departments under the heading "Departments not in Colleges."

Approved on motion by Regent Savage.

President Cross stated that for the past two years, the terms of the Invitation for Bids on delayed television rights for regular season football games have been as follows:

(1) Exclusive delayed television rights shall be limited to the State of Oklahoma.

(2) Bid shall consist of a cash amount to be paid as a flat fee, plus agreement to pay the University Athletic Department an amount equal to one-half of the one hour published TV rate for the time period used in each station carrying the delayed television program. The flat fee shall be paid in full not later than September 1, and the additional payments not later than December 1.

(3) Bidder must agree to make a complete film of each game at no cost to the University, using a two camera crew, each such program to run at least 30 minutes, and to give the complete film to the University Athletic Department after each such delayed telecast.

(4) Bidder must agree to use as commentators only persons approved by the University Athletic Department.

(5) Bidder must agree to submit to the University Athletic Department Business Manager the name of every sponsor or advertiser for approval or disapproval.

(6) The University agrees to designate a television station selected by the successful bidder as the University's official station authorized to make films for delayed telecast, to facilitate arrangements for filming games away from Norman, and in all possible cases arrange a reciprocal agreement with the other colleges where games away are played for use of film facilities by successful bidder or his representative.

(7) Bidder agrees to pay \$100 for use of film facilities at each of the Big Eight Conference institutions other than the University of Oklahoma where 1960 games will be played, in accordance with conference regulations governing such fees.

(8) Delayed telecast cannot be scheduled until the day after the game was played.

(9) Regular games of the 1960 season are as follows:

The Business Manager of Athletics and the University Business Manager recommend that Invitations for Bids for delayed television rights for 1960 be advertised on the same basis as the invitations during the two previous years. President Cross concurred in the above recommendation.

Approved on motion by Regent Savage. The Regents asked that Invitations for Bids be sent to various television stations in Oklahoma and to advertising agencies.

President Cross reported bids were taken on a field cover of aluminum/black neoprene for the football field on both 10 oz. per square yard and 8 oz. per square yard cover material in order to better judge the price as well as need.

After discussion with representatives of the Athletic Department, it was decided that the 8 oz. would make a more desirable cover and would be just as durable.

The Business Manager of the Athletic Department, the Director of Purchasing, and the University Business Manager recommend that the bid be awarded to Southern Athletic Company at a total price of \$10,488.00. This price not only includes delivery but also a five-year guarantee on the cover, an annual inspection and the cost of a man who will teach our employees how to handle the cover.

President Cross recommended that the bid be awarded to Southern Athletic Company at a total price of \$10,488.00. Approved on motion by Regent Savage.

President Cross reported bids were received for new wrestling mats for the wrestling practice room and a new mat for intercollegiate wrestling, net, FOB Norman, as follows:

The Business Manager of the Athletic Department, the Director of Purchasing, and the University Business Manager recommended that the low bid of \$8,033.59 of Resilite Sports Products, Ames, Iowa, be accepted. President Cross concurred in this recommendation.

Approved on motion by Regent Savage.

Dr. Carl Riggs reported that he now has fourteen extra applications for family dwelling units for the summer months at the University of Oklahoma Biological Station. The fourteen applications are in excess of the facilities now available. With the completion of the new building, Dr. Riggs will be able to house eight of the fourteen families.

The Trustee of the University of Oklahoma Dormitory System Bonds of 1957 has approved the sale of six of the single pre-fab units to the Biological Station at a price of \$250 each. Dr. Riggs estimates that the units can be moved to the Biological Station and installed for an additional \$100 each. The purchase would be made from the Biological Station Commissary Account.

The Director of the University Housing believes that the six single pre-fab units will not be needed during the school year 1960-61. The Director of Housing and the University Business Manager recommended the Regents authorize the sale of the six units to the University of Oklahoma Biological Station at the rate of \$250 each and that the Biological Station be responsible for moving the units to the Station facility.

President Cross concurred in the above recommendation. Approved on motion by Regent Northcutt.

President Cross reported the following bids have been received on 32 compact kitchen units for the Housing Department to replace 32 of the units now in Niemann Apartments:

President Cross recommended that this bid be awarded to the low bidder, Murray R. Womble Company, Oklahoma City. Approved on motion by Regent Rothbaum.

Approved on motion by Regent Grisso.

Regent Savage moved that the service scholarship in Special Education for Joe Henry Ford, \$200 per month, June and July, 1960, from the Will Rogers Memorial Scholarship Fund be approved. Motion carried. Regent Grisso asked that he be recorded as voting NO.

On motion by Regent Savage, action was deferred on the following recommendation concerning service scholarships:

Following is a statement from the Chairman of the Will Rogers Committee with reference to the establishment of additional SERVICE SCHOLARSHIPS effective September 1, 1960:

"On April 21, 1960, the Will Rogers Committee met to consider the status of the Fund. A considerable surplus has accumulated in recent years. Should we recommend to the Regents that it be invested, or are there ways it could be spent to fulfill the intent of the trust agreement? We believe the money can be spent to good advantage.

"Should we recommend that eligibility standards for handicapped students be liberalized to include those with minor disabilities? This possibility we rejected. The present policy definitely assures that only severely handicapped students receive scholarships.

"Should the amounts of the scholarships be liberalized? This suggestion was rejected by the Oklahoma Division of Vocational Rehabilitation. The Will Rogers Fund matches money with the Division, the Division has students in other colleges, and must make its grants uniform. The Division renders services to the students in investigating their needs and in counseling that the University could not provide without spending substantial sums.

"Therefore, no changes are recommended in the program for handicapped students. The Committee believes that the anticipated increases in enrolment during the years immediately ahead will bring many more handicapped students to our campus.

"Pending the anticipated increase in enrolment of handicapped students, the Committee recommends temporary changes in the other part of the program, namely, service scholarships to educate persons to perform professional services to help the handicapped. We recommend that:

- "1. A service scholarship be established for a first year student in the graduate Social Work program;
- "2. That one additional service scholarship be made available to each of the three departments now receiving them -- Special Education, Speech and Hearing, and Clinical Psychology;
- "3. That the four service scholarships recommended be considered temporary, that they should not be awarded until it is first determined that available funds will take care of scholarships for handicapped students and the three permanent service scholarships.

"Severe shortages continue to exist in all those disciplines concerned with rehabilitation. Many handicapped persons cannot be rehabilitated unless

personnel for these disciplines can be trained.

It was agreed by the Regents that the regular July meeting be postponed from July 6 to Wednesday, July 13 at 9 a.m. in the President's Office.

President Cross recommended the following changes for administration of the Speech and Hearing Clinic and of the graduate program in Speech Sciences:

1. That, upon the recommendation made by the Dean of the Graduate College on March 11, the graduate degree program in the Speech Sciences be shifted to the Medical Center, except that courses required in the undergraduate certification program and certain advanced courses, for reasons of convenience, continue to be taught and administered at Norman;
2. That the name of the Speech and Hearing Clinic be changed to the Speech and Hearing Division of the Medical Center;
3. That the Speech and Hearing Division of the Medical Center, in the operation of both its instructional program and its clinical program, be considered an integral part of the Medical Center, its Director to be administratively responsible to the Director of the Medical Center, with the understanding that responsibility for the program of graduate instruction shall flow through the Associate Dean of the Graduate College in charge of the Medical Science Division to the Dean of the Graduate College (this means that Speech and Hearing is part of the Medical Center but not necessarily part of the School of Medicine, and that the Director of Speech and Hearing is responsible to the Director of the Medical Center in such matters as finance, personnel, and maintenance);
4. That the Speech and Hearing Division of the Medical Center no longer have any formal administrative relationship to the Department of Speech or the College of Arts and Sciences;
5. That the present staff of the Speech and Hearing Clinic be considered the staff of the Speech and Hearing Division of the Medical Center, with the express understanding that Professor Shank and Professor Ritzman be offered joint appointment in the Department of Speech and in the Speech and Hearing Division of the Medical Center, with recommending power concerning rank, salary, and the like for Professor Ritzman and Professor Shank to

remain with the Department of Speech and the three deans concerned on the Norman campus;

6. That the budget of the Speech and Hearing Division of the Medical Center and the institutional funds necessary to support it for the year 1960-61 be transferred from the budget of the College of Arts and Sciences and of the University of Oklahoma, Norman Campus, to the Medical Center and to the control of the Director of the Medical Center and of the Business Administrator of the Medical Center;

7. That financial support of the Speech and Hearing Division of the Medical Center from institutional funds beginning July 1, 1961, be made the responsibility of the Medical Center; that the Director of the Medical Center be authorized by the University Regents and the State Regents to include in his biennial requests for state funds an amount adequate for the support of the Speech and Hearing Division of the Medical Center from this source; and that he also be authorized to aid in the preparation of requests for funds to national, state, and municipal agencies and other appropriate external sources;

8. That questions of rank, tenure, duties, and departmental affiliation for the staff of the Speech and Hearing Division of the Medical Center be settled by the Director of the Medical Center in keeping with policies prevailing in the Medical Center;

9. That in the Spring Semester of 1963 a reassessment of the position of the Speech and Hearing Division of the Medical Center and of the effect of this reorganization upon faculty, students, and clinical operation be made by the Director of the Medical Center, the Dean of the Graduate College, and the Dean of the College of Arts and Sciences, upon instigation of the Director of the Medical Center and with the aid of such other administrative officers and faculty members as they may deem necessary to consult.

Approved on motion by Regent Northcutt.

President Cross recommended that School for the Deaf fees be changed from \$30 per month to \$90 per month, and that Therapy fees in the Speech and Hearing Clinic be changed from \$4 per hour to \$6 per hour.

The recommended fees have been used as a basis for negotiating with the Crippled Children's Commission (State Department of Public Welfare) for payment by the Commission for Clinic services during the coming year and are satisfactory to the Director. The recommended fees are more nearly comparable than present rates to the scale of fees in private enterprises of this type in Central Oklahoma. The proposed fees have also been used in estimating the 1960-61 income of the Clinic.

Approved on motion by Regent Savage. Regent Grisso voted NO.

President Cross reported eleven bids were received on the construction of the addition to the Speech and Hearing Clinic. Several of the bids were within the funds available.

The Architect and the Business Administrator of the Medical Center have recommended that the low bid of E. V. Cox Construction Company be accepted to include the Base proposal plus Alternates 1, 2, and 3 at a total cost of \$172,936. A tabulation of the bids is in the Agenda for this meeting.

President Cross concurred in the above recommendation. Approved on motion by Regent Savage.

President Cross stated Dr. Stephen Scatori, Professor of Modern Languages, will have reached the retirement age of seventy prior to July 1, 1960. He has been on a leave of absence because of illness since September 1, 1957 and was first employed by the University in September 1920. He is not a member of the Oklahoma Teachers' Retirement System and he will, therefore, receive no supplemental retirement benefits from the University.

President Cross recommended that Dr. Stephen Scatori be given the title Professor Emeritus effective July 1, 1960. Approved.
