MINUTES OF A REGULAR MEETING BOARD OF REGENTS OF THE UNIVERSITY OF OKLAHOMA THURSDAY, SEPTEMBER 15, 1960 - 10:00 A.M.

The regular September meeting of the Board of Regents of the University of Oklahoma was held in the office of the President of the University, Norman, at 10:00 a.m. on Thursday, September 15, 1960.

The following were present: Regent Benedum, President, presiding; Regents Savage, Morgan, Northcutt, Rothbaum, and Grisso.

ABSENT: None.

The minutes of the July 13, 1960, meeting were approved with the last paragraph (p. 6634) being corrected to: "Regent Rothbaum moved and it was voted that one meeting each year be held in Tulsa."

The minutes of the special meeting held on July 26, 1960 were approved.

President Cross recommended that the Regents adopt a policy to the effect that University airplanes may not be used for trips unrelated to University welfare. On motion by Regent Savage the recommendation was approved.

President Cross recommended the appointment of Charles M. Bridges as Acting Director of the Oklahoma Science Service in addition to his duties as Assistant Professor of Education; his salary to be increased from \$6,516 to \$7,176 for 12 months, effective October 1, 1960. Approved on motion by Regent Savage.

President Cross reported on his attendance at a meeting of the International Association of Universities held in Mexico City, September 5-12. There were 300 delegates from 69 countries from all parts of the world. Much time was devoted to a discussion on the responsibility of the university to public services. Also to a discussion on the intricate problem of a balance between the humanities and sciences; and the problem of physical plant expansion and faculties. Much value was gained through the intermingling of representatives. The University of Mexico provided interpreters and the hospitality was superb.

Mr. Benedum stated the annual meeting of the Association of Governing Boards will be held at the University of Washington, Seattle, October 19-22. Regent Savage moved Regents Northcutt, Rothbaum, and Grisso, or as many of these as can attend, be the official representatives of the University Board of Regents. Approved.

Regent Savage, reporting for the Investment Committee, called attention to the recommendation of J. & W. Seligman & Co., Investment Advisory Service, in which they recommend selling 65 shares of General Motors stock in the Will Rogers Fund and 100 shares in the Sallie B. Clark Fund, and with the proceeds purchase other securities.

Regent Savage moved, and it was voted not to sell the General Motors stocks at this time. Regent Savage reported as follows on investments:

Recommended that the cash available from July 15, 1960 U. S. Treasury Bills, Will Rogers Fund, be reinvested in the most favorable, short-term (not to exceed two years) Government securities.

Reported the U. S. Treasury Notes, in the amount of \$22,000.00, maturing August 15, 1960, had been reinvested in Government securities by the Liberty National Bank, on behalf of the Sallie B. Clark Loan Fund. The cash on hand, in the amount of \$8,439.95 as reported by the Controller, is to be retained for loan fund purposes.

Recommended that the cash available from U. S. Treasury Certificates, maturing July 15, 1960, be reinvested in the most favorable, short-term (not to exceed two years) Government securities, on behalf of the Crippled Children's Hospital Fund.

Recommended that the cash on hand in the LaVerne Noyes Scholarship Fund, realized through U. S. Treasury Bills with maturities July 15, 1960, be invested in Montgomery Ward Credit 4 7/8's 1980 as recommended by the Advisory Service.

Recommended that the \$174.28 cash on hand in the Charles B. Taylor Lectureship Fund be invested as recommended by Vice President Brown as follows:

11 shares in George Putnam Fund 1 share of Raton & Howard Balanced Fund

The recommendations of the Investment Committee as presented by Regent Savage were approved.

There was a discussion concerning the income from oil and gas leases (Noble Auxiliary Flying Field and North Campus). The Controller reported previous investments representing 90% of the income had been made in Government securities. He reported also that \$28,102.75 is on hand at this time.

It was voted to invest the balance on hand as shown above in Government securities.

President Cross reported the State Regents for Higher Education have requested an estimate of capital improvement needs that are anticipated

for the University of Oklahoma over the ten-year period 1960-1970. The University's Council on Planning and Development has studied this matter for some time and has submitted recommendations on presently visualized needs for the Norman Campus for the next ten years.

The following constitutes a summary statement of these needs for the period 1960-1970, as recommended by the Council:

Approved on motion by Regent Morgan.

President Cross recommended confirmation of the telephone vote on the purchase of carpet for Holmberg Hall from A. F. Williams Furniture Co., Oklahoma City, in the amount of \$6,449.13, made on Monday, August 22. It was reported at that time that bids were sent to six potential bidders but only the following were received:

Approved on motion by Regent Grisso.

President Cross also requested confirmation of the telephone approval on an increase in the enrollment fee in the University School, grades 1-12 and the kindergarten of \$10.00 per semester on each enrollment. This establishes a fee of \$25.00 per semester for grades 1-12 and \$35.00 per semester in the kindergarten.

This increase is necessary because the Norman Board of Education has advised that reimbursement will be made for ten teachers instead of eleven, for which the school has qualified in the past two years. Also, additional courses are to be offered.

Approved on motion by Regent Savage.

Pursuant to the request of the Regents, the matter of our Commencement Exercises was referred to the Deans and also the Commencement Committee. The question of separate graduation exercises for the various colleges was discussed at a meeting of the Deans on May 18.

The consensus was that a fragmented Commencement would be undesirable. They consider it most important to emphasize that the degree is granted by the University and not by one of the colleges and to have it conferred by the President and not by one of the Deans. They came to the conclusion that, instead of moving further in the direction of separate exercises, the University should require the School of Medicine to rejoin the single Commencement ceremonies.

The Deans also made the suggestion that the form of Commencement be revised so that the Bachelor of Laws degrees would be conferred separately from the other Bachelor's degrees. The Dean of the College of Law was of the opinion that such an arrangement might tend to satisfy the desire of the Law seniors for separate recognition. This plan was adopted and used at the June Commencement, but the abridgement of the ceremonies because of weather conditions probably detracted from the emphasis that was intended for the Law graduates.

The Commencement Committee has not yet made a recommendation on this matter.

The Commencement Committee has recommended, however, that in the spring of 1961 graduation ceremonies be held on the Sunday two weeks before the end of final examinations, and that the University Band, the glee club, and other appropriate organizations be asked to participate. This recommendation has been referred to the University Senate so that faculty opinion of it may be obtained. The Senate is expected to report on this matter during the fall semester. If this plan of early Commencement is adopted, and if the pageantry and impressiveness of the exercises can thus be enhanced, the desire of the Law and Medicine seniors for separate Commencements may be diminished.

No action.

At the March meeting the Regents approved the request that Wright and Selby, Architects, prepare preliminary plans and specifications for remodeling the press box at the stadium. Wright and Selby have estimated that the desired remodeling would cost approximately \$50,000.00.

President Cross reported the University Architect, Wright and Selby, and the Director of Athletics believe that the desired additional facilities can be constructed more economically under the stadium. As a result, the project for remodeling the press box has been dropped. No action.

President Cross reported Mr. Pedrick of the State Board of Affairs and officials of Central Purchasing Agency will visit with the Regents concerning the University purchasing more through Central Purchasing at the October or November meeting. Dr. Cross stated the University is buying through Central Purchasing now whenever purchases can be made more favorably.

President Cross reported the requisition for 4,800 linear feet of eight inch schedule 4 seamless pipe for a line to the Continuing Education Center was sent to Central Purchasing Agency and the bids were taken by that agency.

President Cross recommended that the contract be awarded to the low bidder, Eldon C. Thomas, Oklahoma City, at their bid of \$13,200.00, fob Norman. Approved on motion by Regent Northcutt.

President Cross reported bids have been received on 21 expansion joints to be used in the line to the Continuing Education Center. They are as follows:

These bids were taken by Central Purchasing. The University Director of Purchasing reports a check of the bids shows that the joints bid by the low bidder do not meet specifications.

On motion by Regent Savage, the Regents voted to approve President Cross' recommendation that this bid be awarded to Zallea Brothers, the second low bidder, at a price of \$6,900.00, fob Norman, net 30 days. The Regents asked that the Central Purchasing Agency be advised to buy from second bidder.

Bids have been received on 4,950 feet of pipe insulation, and canvas to cover this insulation, for the line to the Continuing Education Center, and they are as follows:

This bid was circulated by the Central Purchasing Agency and the University Director of Purchasing reports the low bid does not meet specifications.

President Cross recommended that this bid be awarded to the company submitting the low bid for insulation that meets specifications, which is Insulation Service, Tulsa, Oklahoma, at a total of \$14,652.00.

On motion by Regent Savage, it was voted to approve the above recommendation and that Central Purchasing be advised to purchase from the second bidder.

President Cross reported the Purchasing Office attempted to obtain bids on the list of magazine subscriptions for the Library and various departments. In years past we have received bids from three or four companies but this year only one bid was received, this from F. W. Faxon Company, Boston, Massachusetts, which has consistently been the low bidder.

President Cross recommended that the award be made to the F. W. Faxon Company, at a total of \$10,050.00. Approved on motion by Regent Savage.

Following is a statement prepared by Ben Stockwell, Legal Advisor to the President's Office, on the matter of withholding the Gross Production Tax:

It has now been established to the satisfaction of Anderson-Prichard that the University is not obligated to pay the gross production tax on any royalty proceeds received from production on the oil in the Noble Auxiliary

Air Field. This would include the 1/8th royalty interest and the 1/8th overriding royalty interest. Anderson-Prichard is now paying the royalty and overriding royalty due us without deduction of the gross production tax.

However, as you will recall, it appeared that Anderson-Prichard through its purchaser of the bulk oil, the Rock Island Oil and Refining Company, was deducting the gross production tax from the production payment. This amounts to 5% of the total production payment or at the most a tax deduction, so far as the University is concerned, in the approximate amount of \$3,300.

I previously indicated it was my opinion Anderson-Prichard should be advised that we contend the production payment due the University should be tax-free, not because of any immunity of the State of Oklahoma or the University of Oklahoma, but by virtue of the terms of the oil and gas lease.

As a result of my conference with Mr. Benedum on this matter some weeks ago, he advised me that once I determined the tax was in fact being withheld, to take no further action regarding collection until the Regents had an opportunity to discuss it.

I am of the opinion that time has arrived. I recommend the Regents extend authority to take such action as necessary to insure the payment of the production payment without tax deduction. I would envision commencing this effort first by a letter to Anderson-Prichard advising them of our position and legal authority therefore. If they do not then voluntarily concur and remit the funds due, the next step would be a suit against Anderson-Prichard to require and compel performance of the lease as written, and for an accounting, and in this manner, obtain a judicial interpretation of the provision of the lease in question.

I do not believe the urgency is sufficient to warrant a special meeting of the Regents on this matter but would earnestly suggest this being included on the agenda of the next regular or special meeting of the Regents. While we may delay ϵ reasonable amount of time before taking action, any lengthy delay may prejudice our right to raise this point in the future.

CONCLUSION: The University's production interest in the Noble Auxiliary Field Oil and Gas lease is being paid subject to the gross production tax. In my opinion, this is improper and should be contested if necessary. In light of Mr. Benedum's conference with me, I am taking no further action until the Regents have had an opportunity to discuss this matter and await your direction in that regard.

After discussion, Regent Rothbaum moved Mr. Grisso explore the matter with Anderson-Prichard and report to the Regents before any action is taken. Approved.

President Cross stated a final inspection has been held on the construction of the new dormitory at the Biological Station. There were a few items that needed adjustment. President Cross recommended that the Regents authorize final acceptance of the dormitory as soon as the contractor makes the adjustments to the satisfaction of the University Architect, Director of the Physical Plant, and the Business Manager; and that final payment be authorized upon receipt of the certificates required by the construction contract.

Approved on motion by Regent Savage.

At the May meeting the Regents approved a recommendation to replace the kitchen units at the Niemann Apartments during a three-year period. Thirty-two units have now been installed. They are completely satisfactory and add a great deal to the utility of the apartments.

Adequate funds are now available in the Operating Account to purchase units for the remaining 64 apartments.

The Director of Housing, the Business Manager and the Vice President for Business and Finance have recommended that since adequate funds are now available and since the new units are so satisfactory, the 64 remaining units be purchased now instead of the three year period as approved in May. President Cross concurred in this recommendation.

On motion by Regent Savage, the Regents unanimously approved the above recommendation.

President Cross reported the Director of the State Agency for Surplus Property requires authorization by the University Regents for the purchase of surplus property. He recommended that the Regents adopt the following resolutions:

RESOLUTION

The Board of Regents of the University of Oklahoma hereby resolves that D. R. Kimrey or his agent is authorized to sign all instruments and to enter into such negotiations as may be necessary in the acquisition of federal surplus property from the Oklahoma State Agency for Surplus Property.

The Board of Regents of the University of Oklahoma Medical Center hereby resolves that Raymond D. Crews or his agent is authorized to sign all

instruments and to enter into such negotiations as may be necessary in the acquisition of federal surplus property from the Oklahoma State Agency for Surplus Property.

On motion by Regent Savage, it was unanimously voted to approve the Resolutions.

DEGREE OF BACHELOR OF LIBERAL STUDIES (B.L.S.):

After some three years of study a committee of the faculty, in consultation with the majority of the faculty and administration, have evolved and recommended a program of semi-independent study for adults leading to a degree.

The proposed degree is designed not as a professional degree nor as a specialized technical degree. It is aimed at a broad liberal education focusing the great liberal arts tradition upon twentieth-century man through the three channels of the humanities (including the fine arts), the social sciences, and the natural sciences.

The degree and the methods of administering it are adapted to the needs of adults who were unable to achieve a university degree in their youth or who, having established themselves in a profession or a vocational specialty, now feel the need of deepening their knowledge and perception of the liberal arts.

Since the degree is designed for adults, it is to be administered through a combination of independent study (chiefly through the reading of prescribed books), intensified on-campus seminars usually in the summer to permit use of vacation periods, and comprehensive examinations.

Being fully aware that a degree for adults may be academically suspect, the faculty committee have taken particular care to set the degree requirements by extraordinarily high standards. President Cross stated that in his opinion the degree that they have recommended is one in which the University may take great pride not only as a new service to the people of Oklahoma but as a pioneering innovation in American education.

President Cross recommended the approval of this new degree for adults, to be known as the degree of Bachelor of Liberal Studies.

Approved on motion by Regent Northcutt.

If the degree of Bachelor of Liberal Studies is approved by the State Regents for Higher Education, there must be a collegiate unit to administer it, but it cannot be suitably located in one of the present component colleges of the University. Thus it becomes necessary to establish a college structure for adults who enroll for the new degree.

President Cross recommended, therefore:

- 1. That such a college be established with the title College of Continuing Education;
- 2. That the College be established in conjunction with the Extension Division, and that the Dean of Extension be also the Dean of the College of Continuing Education;
- 3. That the faculty of the College be composed of members drawn from the General Faculty of the University;
- 4. That the faculty of the College have the same control over curriculum, academic standards, and procedures as do the faculties of the other academic units of the University.

Approved on motion by Regent Northcutt.

President Cross recommended C. B. Wilkinson, Director of Athletics, be allowed to complete arrangements for the University to meet the University of Oregon in football here in Norman on September 17, 1966. Approved.

President Cross recommended the following for scholarships from the Will Rogers Memorial Scholarship Fund for the school year 1960-61:

Approved on motion by Regent Morgan. Regent Grisso asked that he be recorded as voting NO.

The Secretary reported the Will Rogers Committee has under consideration the names of 4 or 5 additional handicapped students who have been approved by Vocational Rehabilitation. On motion by Regent Savage scholarships were approved for these additional students if and when approved by the Will Rogers Committee. Mr. Grisso asked that he be recorded as voting NO.

As requested at a previous meeting of the Regents the final list of acceptances to the freshman class in the School of Medicine for the fall semester, 1960, was included in the agenda. This showed the changes that had been made since the original list was submitted. No action.

President Cross reported that on July 23, 1960, because of an unusual rain, the new addition to the Medical Center in Oklahoma City, which houses the Radiology Laboratory as well as other facilities, was literally flooded because of inadequate storm sewers. As a result of the low elevation and the torrential rain, sewage backed up into the building, covering the basement floor, and water was collected around the building to a height of 25 inches.

This problem was considered and we thought satisfactorily provided for when the building was designed. However, the design was obviously inadequate. As such, at the President's request, Mr. Stockwell, Legal Advisor to the President's Office, conferred with the architects, Mr. Herbert O'Neil, the Physical Plant Manager at the Medical Center, the Business Manager at the Medical Center, the University Architect, and John Kuhlman in an effort to achieve an immediate solution to this problem. Although no actual damage of any consequence resulted from this particular flood, electric lines and other conduits were completely submerged, and considerable damage to property as well as possible injury to person could have resulted.

As a result of these conferences, a solution, both to the sewage-backup problem and the surface-water overflow, was worked out generally as follows:

Alterations of pump facilities on the sewage lines and ancillary construction thereto which will cost approximately \$500.00. This can be done by our own personnel and should be commenced immediately. At this point, it has not yet been decided who will bear the cost, but that can be determined after the problem is corrected.

Construction and installation of new storm sewer lines extending southward from the building in question to provide an additional outlet for the surface water. This will cost approximately \$10,000. We have been successful in obtaining assistance from the City of Oklahoma City in this matter, and if we will give them the necessary easement for their sewer lines, they will undertake the necessary construction. Copy of the plans have been approved by Herbert O'Neil, Dean Everett of the Medical Center, John Kuhlman, and the University Architect's Office, and the form of the easement has been approved by Mr. Stockwell.

Before the City Council of the City of Oklahoma City will authorize this work, it is necessary that they have an easement from the Regents of the University of Oklahoma. President Cross stated he feels this solution is a very satisfactory one and recommended that the following easement be approved:

President Cross stated it is desirable that a general agreement be entered into between the University of Oklahoma and the Research Institute for the purpose of delineating the various responsibilities, duties, rights, and privileges of each, and their respective staff members.

The agreement in its present form has been approved by Ben Stock-well, Dr. Brown, Dr. Swearingen, Mr. Giezentanner, Dr. McCarter, representing the University, and Mr. Verne Kennedy, Executive Director of the Research Institute, and Leo Whinery, Attorney for the Research Institute.

It is anticipated that with this basic agreement, it will only be necessary from time to time to specifically lease certain buildings to the Institute and refer in general to this instrument.

President Cross recommended approval of this instrument.

On motion by Regent Savage, it was unanimously voted to authorize the President of the Regents to sign the Basic Agreement between the University and the Research Institute on behalf of the Board of Regents.

President Cross recommended that the President of the Board of Regents be authorized to execute a lease, on behalf of the Regents, to the University of Oklahoma Research Institute, on Building 901, Rooms 141 and 143, having a total gross area of 1152 square feet, located on the North Campus. The lease would permit the Research Institute to sublease the space to the Oil Recovery Corporation, New York.

Approved on motion by Regent Savage.

Regent Northcutt moved the following resolution be adopted and a copy be sent to Walter Byers, Executive Secretary of the National Collegiate Athletic Association, and to the President of the University of Texas:

RESOLUTION

WHEREAS, the University of Oklahoma was placed on indefinite probation by the National Collegiate Athletic Association on January 6, 1960, and,

WHEREAS, one effect of this order of probation, without commenting on justification or lack thereof, is to prevent the live televising of the 1960 Texas-Oklahoma football contest, scheduled to be held in Dallas, Texas, on October 8, 1960, and further,

WHEREAS, this will result in the loss of substantial revenue and income to the University of Texas, and the University of Oklahoma is willing to waive all monetary income to be derived from the live televising of said game, and,

WHEREAS, said order is to the detriment of the athletic spectator inasmuch as all tickets to this contest have already been sold. By virtue of this order, hundreds of thousands of Texans and other citizens in the United States will be thereby deprived of an opportunity to see this athletic contest, although these spectators are in no way involved in the matters which occasioned the action of the National Collegiate Athletic Association.

NOW THEREFORE BE IT RESOLVED that the President of the University of Oklahoma, directly or through his duly designated faculty representatives to the National Collegiate Athletic Association, be and the same is hereby authorized and requested by the Board of Regents of the University of Oklahoma to request the National Collegiate Athletic Association to permit live televising of the 1960 Texas-Oklahoma game, in order that the University of Texas will not be deprived of their otherwise legitimately anticipated revenue therefrom, through no act of their own, and further, so that the citizens of the Southwest be not prevented from observing an athletic contest which has truly risen to the status of an annual football classic.
