MINUTES OF A REGULAR MEETING THE UNIVERSITY OF OKLAHOMA BOARD OF REGENTS APRIL 8, 1982

A regular meeting of the Board of Regents of The University of Oklahoma was held in Dining Room 5 of the Oklahoma Memorial Union on the Norman Campus of the University on Thursday, April 8, 1982 beginning at 9:15 a.m.

Notice of the time, date, and place of this meeting was submitted to the Secretary of State as required by Enrolled House Bill 1416 (1977 Oklahoma Legislature).

HEALTH SCIENCES CENTER AUDITOR FOR 1981-82

Touche Ross & Co. has submitted the following proposal to audit the accounts and express an opinion on the financial statements of The University of Oklahoma Health Sciences Center for the year ended June 30, 1982:

"The purpose of our engagement is to examine the Health Sciences Center's financial statements for the year ended June 30, 1982, and evaluate the fairness of presentation of the statements in conformity with generally accepted accounting principles applied on a basis consistent with that of the preceding year.

"Our examination will be conducted in accordance with generally accepted auditing standards which will include a review of the system of internal control and tests of transactions to the extent we believe necessary. Accordingly, it will not include a detailed audit of transactions to the extent which would be required if intended to disclose defalcations or other irregularities, although their discovery may result.

"We direct your attention to the fact that management has the responsibility for the proper recording of transactions in the books of account, for the safeguarding of assets, and for the substantial accuracy of the financial statements. Such statements are the representations of management.

"The objective of our examination is the expression of an opinion on the Health Sciences Center's financial statements. Our ability to express that opinion and the wording of our opinion will, of course, be dependent on the facts and circumstances at the date of our report. If our opinion will be other than unqualified, the reasons therefore will be fully disclosed.

"In addition, we will prepare as a normal part of our examination a letter of recommendations including comments on deficiencies we have observed in internal controls and possible ways to improve the efficiency of your

operations, It is also our practice to discuss our comments on such matters with the appropriate level of management.

"We are, of course, available to assist you in other areas that might arise.

"The timing of our examination will be scheduled for performance and completion as follows:

"Assistance to be supplied by your accounting personnel and the internal audit department will be similar to the assistance provided in the previous years engagement. We have discussed the planned assistance with Mr. Warren Elkins of the internal audit department and Messers. Gary Smith and Mark Lemons of Health Sciences Center.

"Our fees are based on the amount of time required at various levels of responsibility, plus actual out-of-pocket expenses (travel, typing, telephone, etc.), payable upon presentation of our invoices. Total fees for this engagement will be \$30,300."

This proposal has been reviewed by Mr. John P. Eckert, Director of Internal Auditing, and Mr. Gary L. Smith, Vice Provost for Administration and Finance. Both concur in the continuation of Touche Ross & Co. as outside auditors for the Health Sciences Center Campus.

- 2. Replacement of a second elevator

- 4. Renovation and modernization of the auditorium

The total cost of this project, including construction, professional fees, and construction contingency, is \$2,198,800. \$2,098,800 in State Bond funds has been allocated by the State Regents for Higher Education. An additional \$100,000 will be needed from Section 13/New College funds for the auditorium renovations.

The development of the plans and specifications is being monitored and will be reviewed by the University staff and the President.

NORMAN CAMPUS AUDITOR FOR 1981-82

Price Waterhouse has submitted a proposal to audit the accounts and express an opinion on the financial statements of the Norman Campus of the University for the year ended June 30, 1982 as follows:

"Our services will constitute an audit of the financial statements of The University of Oklahoma Norman Campus (the "University") in accordance with generally accepted auditing standards to enable us to express an opinion on the financial statements for the year ended June 30, 1982.

"In order to render our report, we will be responsible for making an examination in accordance with generally accepted auditing standards which includes such tests of the accounting records and other supporting evidence and such observation and review of the system of internal accounting control as we consider necessary. This examination, however, will not include a detailed audit of transactions, such as would normally be required to disclose defalcations or other irregularities. The responsibilities and functions of the independent auditor in his usual examination of financial statements are explained and his objectives are described in the Statement on Auditing Standards No. 16 and Section 110 of Statement No. 1 of the American Institute of Certified Public Accountants. We would be happy to furnish you with copies of these statements and discuss their content with you if you should so desire.

"As mentioned above, during the course of our examination we will review the University's system of internal accounting controls and will submit our report thereon setting forth our recommendations for strengthening internal controls and improving administrative efficiency.

"Our fees for these services are based on the fee estimate discussed in our original proposal of March 31, 1978, plus the effect of inflation on our billing rates. Accordingly, our fee estimate for the fiscal year ended June 30, 1982 is \$27,500 plus out-of-pocket expenses of \$2,750."

This proposal has been reviewed by Mr. John P. Eckert, Director of Internal Auditing, and by Vice President Arthur J. Elbert. Both concur in the continuation of Price Waterhouse as the auditor for the Norman Campus.

BURTON HALL JC-80 CONTROL SYSTEM

The renovation of Burton Hall includes new heating and cooling systems. The installation of a mechanical control system will permit the control of the heating and cooling systems by the Physical Plant JC-80 control system. This control system will permit the utilization of energy conservation procedures. A sole source bid for installation of the control system has been received.

Review of the bid of \$41,703 presented by Johnson Controls, Incorporated by members of the University staff identified a need for a night setback system not included in the original bid information. Subsequent analysis of the cost of the additional work by Johnson Controls indicated that an additional cost of \$559 was involved.

Therefore, a summary of the bid plus the change is as follows:

Funds are available for this control system within the existing renovation budget.

President Banowsky recommended that the combined bid of \$42,262 be awarded to Johnson Controls, Incorporated for installation of a mechanical control system needed for the Burton Hall Renovation project.

Regent White moved approval of the recommendation. The following voted yes on the motion: Regents Engleman, White, Little, McCurdy, and Imel. The Chair declared the motion unanimously approved.

APPOINTMENT OF ENGINEER - CAMPUS LIGHTING PROGRAM AND AS ON-CALL ELECTRICAL ENGINEERING CONSULTANTS

A preliminary study of campus lighting problems and critical needs has been completed. Based on information obtained during a visual survey of the campus and reports received from a number of student groups, the University Police Department, and the Physical Plant Department the major problem areas have been identified.

The sum of \$175,000 of Section 13/New College Funds has been allocated to implement the first phase of a campus security lighting improvements program. An additional sum of \$90,000 is available in the budget of the Imhoff Road project for street and parking lot lighting.

It also is anticipated that the firm selected for this project will serve for a one-year period as an on-call electrical engineering consultant. There will be an option to renew the on-call arrangement for one additional year. The on-call service will be limited by a letter contract stipulating the terms of the agreement including estimated project cost, time schedule, scope of the project, and compensation for the firm's services. The letter contract for on-call service will limit to \$25,000 or less the fee for each project.

Interviews were conducted on April 5, 1982 to examine the qualifications of five engineering firms that had indicated an interest in providing the professional design services required for the campus lighting program. These

interviews and the preliminary review process were conducted in accord with the provisions of the State law and policies of the Board of Regents. The following qualifications of each firm were considered:

- 1. Professional reputation
- 2. Experience with this type of project
- 3. Available professional staff
- 4. Scope of service 3 offered
- 5. Amount of work in progress
- 6. Other University projects completed
- 7. Financial standing and stability
- 8. Size of firm
- 9. Amount of State work completed
- 10. Location of firm

The interview group obtained information from the consultants, the files of the State Board of Public Affairs and other sources. Basic information and a summary of a preliminary review of the qualifications of the engineering firms was distributed to the Regents as follows:
