Considerations for harvest aid products in cotton intercropped or in rotation with small grains.		
Cotton Harvest Aid Product	Use Considerations/Restrictions	Plantback Interval
Aim (Carfentrazone-ethyl)	Winter wheat: 0.5 – 1 oz per acre prior to boot Other small grains: 0.5 – 1 oz per acre prior to jointing Cotton: up to 1.6 oz per acre in a single application and max in-season rate of 3.2 oz per acre allowed as harvest aid	Small grains: 1 day
ETX (Pyraflufen-ethyl)	Wheat or triticale: up to 1.25 oz per acre prior to emergence; up to 0.6 oz per acre prior to flag leaf Cotton: up to 1.7 oz per acre in a single application and max in season rate of 3.4 oz per acre allowed as harvest aid	Wheat or triticale: 0 days Other cereals: 1 day
<b>Sharpen</b> (Saflufenacil)	Small grains: $1.0 - 2.0$ oz per acre preplant or preemergence Cotton: up to 1 oz recommended as a single application and max in season rate of 2 oz per acre allowed as harvest aid	Small grains: 0 days (up to 4 oz)
Ethephon (including 6 lb./gallon, 3 lb./gallon and ethephon + cyclanilide products; Super Boll, Boll'd, Boll Buster, Ethephon 6, Flash, Finish 6 Pro, etc.)	If small grains are planted earlier than 30 days after application, or intercropped with cotton, may only be used for cover and cannot be harvested for food or feed	Small grains: 30 days
Thidiazuron + Diuron (including Ginstar, Cutout, Adios, Redi-Pik, etc.)	If intercropped with cotton may only be used for cover cannot be harvested for food or feed	Small grains: 1 month
Folex (Tribufos)	Do not graze treated fields; do not use on crops harvested for food or forage	Small grains: 0 days
<b>Paraquat</b> (including 2 lb. a.i./gallon Gramoxone and 3 lb. a.i./gallon Parazone, Firestorm, etc.)	<b>Barley or wheat:</b> 2 – 4 pints (2 lb. a.i./gallon) or 1.3 – 2.7 pints (3 lb. a.i./gallon) at preplant or preemergence <b>Cotton:</b> maximum 2 pints of 2 lb. a.i. per gallon <b>or</b> 21 oz of 3 lb. a.i. per gallon may be used as a cotton harvest aid	Small grains: 0 days



## Oklahoma Boll Weevil Eradication Organization Update: Quarantine of Cotton Harvesting Equipment Coming From Certain Areas of Texas

Cotton harvesting equipment entering Oklahoma from two eradication areas in Texas has to be certified as boll weevil free prior to movement into our state. Please contact the Texas Boll Weevil Eradication Foundation (TBWEF) at least 48 hours in advance of equipment departure from these two areas. This will allow TBWEF to inspect the equipment. A USDA-APHIS phytosanitary certificate is issued and is required before equipment can be transported from these areas. These ONLY include the Lower Rio Grande Valley Eradication Zone (blue area on the map below) or the East Texas Maintenance Area (brown area on the map below). This is critical to meet USDA-APHIS requirements and prevent the re-infestation of boll weevils into eradicated areas. It is illegal to move non-certified cotton harvesting equipment from these areas into the state of Oklahoma.
