CAMERON UNIVERSITY

He also discussed the upcoming 10-year reaccreditation visit the University will host in March 2021 and the expectations the accrediting group will have of the Regents.

ROGERS STATE UNIVERSITY

Following the Cameron University portion of the retreat, President Rice apprised the Board of the current state of Rogers State University and plans for the future, including budget planning and enrollments and a recent financial aid audit at the University. Due to budget constraints and the current COVID-19 problems, furloughs of one day per month were set to begin for all full-time employees beginning August 1.
