TULSA MEDICAL POPULATION REACHES 322

Thirty-Three New Doctors Enter Practice In Tulsa County During 1954. General Practice and Surgery Attract Greatest Numbers of Newcomers.

Tulsa's medical population continued to take a sharp upswing as 33 medical doctors entered practice here in 1954. The number was seven more than for 1953 and represented a new annual record. During the past 24 months newcomers to the Tulsa profession have totalled 47.

Of the 33 additions in 1954, five had formerly been in practice in Tulsa and returned after a tour of active duty with the United States Armed Forces. The remainder were completely new to Tulsa. Of this group only three had been in private practice elsewhere. Most had just completed internships, residencies, or military service.

In a breakdown by specialties the 1954 newcomers are grouped as follows: general surgery, 6; pediatrics, 2; obstetrics and gynecology, 4; internal medicine, 2; anesthesiology, 2; general practice, 8; ophthalmology, 1; radiology, 1; orthopedic surgery, 3; pathology, 1; neurosurgery, 1; and otolaryngology, 1.

For the 24 months period from January 1, 1953 to December 31, 1954, the specialty grouping is as follows: general surgery, 9; pediatrics, 3; obstetrics and gynecology, 6; internal medicine, 7; anesthesiology, 3; general practice, 12; ophthalmology, 1; radiology 2,; orthopedic surgery, 5; pathology, 1; neurosurgery, 2; otolaryngology, 1; industrial medicine and miscellaneous, 5.

As an offset to influx of new doctors, three doctors moved to new locations in 1954, three were called to military duty (but will presumably return to Tulsa in two to three years), and one passed away. (Three others, all retired, also died in 1954).

The year previous, 1953, saw two physicians leave Tulsa for other locations, four called to military service, and three deaths.

Membership in the Tulsa County Medical Society at the end of 1954 stood at a record of 322 members. Of this number, 285 were in active full-time practice, 28 were retired or semi-retired, and nine were in military service. The Society also carries six others on its rolls who are away on postgraduate medical training programs; at least half of these men are expected to return to practice in Tulsa. It is anticipated that all of the nine military members will resume practice here after their discharge.

The growth in membership of the Tulsa County Medical Society is reflected in a study of membership records of the past fifteen years. In 1940, the Society had 204 active members, two in military service, and five retired; in 1945 at the height of World War II, there were 161 in active practice, 50 in military service, and eight retired. By 1950 the medical population had grown to 259 active members, five in military service, and fourteen retired.

The total membership figures for these years were: 1940, 211; 1945, 219; 1950, 278; and 1954, 322.

February is the month in which we celebrate the birthdays of two great Americans-George Washington and Abraham Lincoln. In bringing to mind their contribution to our country, we cannot help but feel poorly inadequate for our own small effort in making America the finest nation on earth. What is more serious to contemplate is the utter lack of concern which many of us have for our responsibilities as participants in our community life and civic progress. Doctors, unfortunately, have been prone to remain away from this obligation, not so much from a lack of citizenship perhaps as from an inherent single-mindedness which limits their interest to things medical. I believe doctors must make a conscious effort to overcome this failing. The respect which has long been accorded the medical profession demands not only our participation but our leadership in community affairs. Aside from the paramount responsibility to do our part, doctors will profit by improved public relations, a more specialized supervision of medico-civic affairs, and a greater awareness of the practical workings of community progress.

A good place to begin, in my opinion, is our Tulsa Chamber of Commerce. While most doctors are members, a sizeable number are not. The payment of the annual membership fee is but a beginning to this activity. Actual participation in the Chamber's affairs, through its many committees and advisory groups, would be welcomed by the Chamber's officials. Attendance at the weekly luncheons each Thursday should be encouraged; few are the doctors who are seen at these events. The Tulsa Chamber of Commerce has been largely responsible for the progress of this City; what is good for Tulsa is good for Tulsa doctors. I hope that each member of the Tulsa County Medical Society will give the Chamber his active and interested support. It is a good investment of time and money, payable in dividends of good living.



PROMINENT GENETICIST TO SPEAK HERE FEBRUARY 14TH

Dr. Laurence H. Snyder, Dean of the Graduate School of the University of Oklahoma, Norman, Oklahoma, will be guest speaker for the Tulsa County Medical Society on Monday, February 14, 1955, at 8:00 P.M. His subject will be "Medicine and Genetics—With Special Reference to Transfusion Reactions."

The meeting will again be at the Auditorium of the Blue Cross-Blue Shield Building, 1215 South Boulder, Tulsa. Telephone service is available by calling 5-9149.

Dr. Snyder is repeating a widely acclaimed lecture presented before the regional meeting of the American College of Physicians in Oklahoma City last October. Tulsa doctors who heard the lecture described it as fascinating in its medical and genetic aspects, and numerous requests were received by the Program Committee to arrange for its repetition in Tulsa.

A student of human genetics for over 31 years, Dr. Snyder is the author of four books and more than 100 articles on various phases of human heredity. He was instrumental in developing the modern statistical methods for the study of human inheritance, and he has done extensive research work in the inheritance and racial distribution of the blood

groups, human anomalies and diseases, and the linkings of the human genes.

Dr. Snyder is a graduate of Rutgers University, Class of 1922, and holds a Master's and Sc.D. degree from Harvard University, and an honorary Sc.D. from Rutgers. For many years he was Chairman of the Department of Zoology and Entomology at Ohio State University. Since 1947 he has been associated with the University of Oklahoma as Dean of the Graduate School. He was formerly special advisor to the Surgeon General of the United States Army and the Surgeon General of the United States Public Health Service. Dr. Snyder was President of the Genetics Society of America in 1948, President of the American Society of Human Genetics in 1950, and a past officer and member of numerous similar organizations. He is presently National President of Phi Sigma and a member of the Board of Directors of the American Association for the Advancement of Science.

Dr. Snyder developed the first course in medical genetics to be required in a medical school in the United States while at Ohio State University and has inaugurated similar courses in other medical schools. He has lectured widely all over the world and has surveyed many graduate schools in foreign countries and in the United States at the request of those institutions. He has given nineteen endowed lectures in this country, Alaska, and Puerto Rico. More recently, Dr. Snyder has been a member of the Council of the Oak Ridge Institute of Nuclear Studies and Chairman of its Committee on Medical Problems.

"Dr. Snyder has a splendid lecture of unusual interest," said Dr. Frank J. Nelson, President of the Tulsa Medical Society, "and I hope that every member of the Society will avail himself of the opportunity to hear it."







TUMOR CLINIC FINDS 200 NEW CANCER CASES IN YEAR

Slightly more than 200 new cases of cancer were discovered by the St. John's Tumor Clinic of Tulsa in 1954, a report issued late in December by Dr. Ralph A. McGill, Medical Director, indicates.

The report, covering the first eleven months of the year, reflects the continued progress of the outpatient department for indigent cancer patients of Northeast Oklahoma. Patients were accepted in 1954 from 24 Oklahoma counties, all referred by private physicians or county health officers.

Since its opening on March 2, 1948, nearly seven years ago, the Tumor Clinic accepted 2,267 patients up to November 30, 1954. A total of 12,224 patient visits were recorded in the same period.

The first eleven months of 1954 saw 352 new patients accepted and a total of 2,457 patient visits seen. The patients were cared for by the Clinic's volunteer staff of eighty specialists and general practitioners.

One hundred eighty four old and new patients were hospitalized at St. John's Hospital for further diagnosis and treatment. They spent a total of 1,960 pa-

tient days in the Hospital.

Patients or their families paid for 765 of these days at charity rate, while 180 were on a complete charity basis. The Oklahoma Crippled Children's Commission paid for 120 days, and health insurance covered 196. The remainder were financed by charity funds paid by the various counties.


The report noted that St. John's Hospital contributed \$16,775 in x-ray therapy for 183 patients, as well as \$6,039 for diagnostic x-rays. The Hospital also contributed several thousand dollars worth of charity hospitalization for cer-

tain patients.

The Clinic is financed largely by annual grants from the Oklahoma Division of the American Cancer Society. The staff includes Miss Helen Hawkins, social worker, and Mrs. Hope Hauskins, secretary. Nursing personnel is provided as needed by St. John's Hospital, which also contributes the physical quarters and use of x-ray equipment and other materials.

EDITORIAL

An unfortunate action taken by the Tulsa City Commission last month removed the administration of the City's meat inspection program from the Tulsa City-County Health Department. In creating a separate office to handle this important public health function, the Mayor and the City Commissioners have not only saddled the taxpayers with the burden of additional expense but have established a dangerous precedent. On the basis of this action, it is not unreasonable to think that the milk inspection program could next be removed, then the examination of food handlers, the restaurant inspection, food market inspection, and The net result could be an uncoordinated group of autonomous units without proper supervision or control.

Other than the fact that certain influential interests apparently wanted the meat inspection program away from the City-County Health Department, there appears to be no justification for the precipitate action of the Commission. The reasons for it remaining within the jurisdiction of the Department are several, all of the considered merit. These rea-

sons are:

1. The meat inspection program is properly a public health function and should be under the administration of persons qualified by education and experience in public health. This will give greater assurance that no infectious disease is transmitted to man through the dissemination and use of meat.

2. Proper safeguards under the most effective operation of the program will be attained if the program is under a supervisory board rather than one person. This will insure that the intent of the ordinance will be carried out in the

most effective manner.

3. The continued administration of the meat inspection program by the Tulsa City-County Health Department would be the most economical, inasmuch as the present Department facilities, personnel and equipment would be used.

Our Tulsa City-County Health Depart-

ment has come to be recognized in recent years as one of the most efficient and progressive in the United States. We fail to understand why the Department, with its competent and experienced personnel, should be ruled out of one of its most important functions. We fail to understand why a public health function should be vested in a separate agency lacking supervisory board control.

Rather than increasing public confidence in local meat, the unfortunate action of the Mayor and City Commission will undoubtedly lead many Tulsans to restrict their meat purchases to those inspected by United States federal meat inspectors. While a political victory has been gained, a practical defeat has been experienced.





MIAMI PEDIATRICIAN SET FOR ANNUAL MEETING PROGRAM

Dr. Robert B. Lawson, Chairman of the Department of Pediatrics at the University of Miami School of Medicine, Miami, Florida, is the newest addition to the panel of visiting distinguished speakers for the 62nd Annual Meeting of the Oklahoma State Medical Association in Tulsa, May 9-11, 1955.

Dr. Walter E. Brown, Chairman of the Scientific Works Committee, said the addition of Dr. Lawson completed the scientific program for the 1955 convention. A total of 28 papers will be presented in the three-day session by ten visiting guest speakers and by members of the Oklahoma State Medical Association. Tulsans appearing on the program include Dr. H. J. Rubin, Dr. Sol Wilner, and Dr. Robert M. Shepard, Jr.

One of America's best known pediatricians, Dr. Lawson was formerly Chairman of the Department of Pediatrics at Bowman-Gray College of Medicine, Winston-Salem, North Caroline. Earlier this year he was engaged to head and develop the Department of Pediatrics at the new University of Miami School of Medicine, which plans to take its first class in 1955-56. Dr. Lawson was recently the subject of a lengthy study by Time Magazine and is widely known for his pediatric research and writings.

Dr. James G. Hughes of Memphis, Tennessee, previously announced as the speaker in Pediatrics, has had to relinquish the invitation due to an assignment for the United States government which will take him out of the country for the Spring months.

Exhibits are planned by several Tulsa physicians and organizations, as well as by other groups and individuals over the State.

The Tulsa County Red Cross Blood Center observed its sixth anniversary on January 12, 1955, as a joint project of the Tulsa County Chapter of the American Red Cross and the Tulsa County Medical Society. Since its opening in 1949 more than 55,000 pints of whole blood have been given without charge to patients of Tulsa County hospitals.

On the first day of operation of the Center, ten donors appeared to give blood, of which eight did not meet the medical qualifications. Today, the Center averages forty acceptable donors daily. The output of blood has risen from 6,000 pints in 1949 to 12,098 pints in 1954. The estimated need for 1955 is 13,500 pints.

Mr. Dale T. Bartlett, Director of the Tulsa County Chapter of the American Red Cross, paid tribute to the Center and its value to the community. "We have no way of knowing in exact figures, but doubtless many lives have been saved through the blood program," he said. "While no price can be placed on the value of the blood provided by the Center, it is estimated that Tulsa County patients have been saved well over a million dollars in the six years the blood program has been in operation."

The Tulsa Center is one of 20 operating throughout the United States in cooperation with local medical societies, providing blood on a "free of charge" basis. In addition, the Red Cross operates 45 regional center programs throughout the United States.


