THE DOCTOR AND THE BRICKLAYER

A Comparison of Incomes

Cadillacs and caviar—that seems to be the standard of living a big segment of the American Public believes the medical

profession enjoys today.

Well, let's face it. An average doctor does enjoy more financial security to-day than he did in the dismal days before World War II. And so does everyone else—laborer, professional man, proprietor alike.



But whoever thinks today's doctor is eating unfairly high on the hog should take a look at the facts. Just for comparison, let's examine the earnings of a typical doctor and a representative bricklayer for a period of twenty years.

The United States Department of Commerce reported the net average income of a medical doctor in 1951 was \$12,518.00. To be generous, let's set the 1955 figure 20 per cent *above* this average (which it isn't!). The bricklayers' income can be based upon figures for a moderately sized city where the prevailing scale is slightly lower than the na-

tional average.

A bricklayer must be an apprentice for two years in most areas; the scale is \$2.10 an hour or \$84 a week. For his first two years of apprenticeship he earns a total of \$8,736. Now he becomes a journeyman; his pay is \$3.50 an hour, \$140 for a 40-hour week. In the next eight years he earns \$58,240. His total income for his first ten professional years is \$66,976. Bear in mind that doesn't include any of the lucrative overtime pay (time and a half or double time).

Now, let's take a look at a typical med-

ical doctor's first ten years. For eight years he attends college and medical school. His total income from his profession—zero. Next comes a year's internship; pay scales vary but seldom exceed \$2,500 a year. Another year goes into a residency, again at not more than \$2,500. The doctor's income for his first ten dedicated years is the munificent sum of \$5,000.

Now, the doctor is on what the public believes to be the gravy train. He is ready to start repaying the money he borrowed to finance his medical education—a sum which may range as high as \$30,000. That is, unless he's tapped for a minimum of two years military duty or another one to four years of residency training. He's also ready to borrow some more money for office furniture, professional equipment, paying the salaries of the office personnel, and his own expenses of living through the first lean years.



However, let's say he begins practice in a typical prosperous community at the end of his first year of residency. He can expect average earnings estimated today at \$15,000 a year for the next ten years.

At the end of twenty years the brick-layer has earned \$139,776—not including overtime—while the M.D. has earned \$155,000. For this sum the doctor will work not forty hours a week but an average of 56 hours a week according to the Bureau of Medical Economic Research of the American Medical Association. If a bricklayer worked a 56-hour week, he would earn \$140 for the first 40 hours, \$42.00 at time and a half for

the next eight hours, and \$56 or double time for the next eight hours, or \$238 a week. His annual pay would be \$12,376, a fraction less than the doctor's for the same number of hours of work.

But let's not forget the \$30,000 cash outlay for a medical education. Assuming the doctor does earn an average \$2,500 a year more than the bricklayer (for the 56-hour week), almost fifteen years are required to amortize that indebtedness. Upon reaching the age of 45, say, the doctor will have paid for his medical education and will have earned to that point approximately the same income as the bricklayer.

Up to the time the doctor is 60 years old, he may expect to earn, on the average, \$2,500 more per year than the bricklayer. After age 60, the doctor's practice usually declines and average earnings drop. After age 65, they drop sharply in most instances. The union bricklayer, in contrast, continues to earn the union scale until his retirement.

Of course, there are many individual exceptions, particularly in the case of highly trained specialists or general practitioners in rural areas. But, as pointed out in the Medical Economics survey, the top specialist group in income (proctologists) average only \$21,000 a year. Most such specialists now require an additional three to five years in postgraduate specialty training; again, at best, such fellowships or residencies produce a top income of \$2,500 annually.

Then, it could be mentioned that while the doctor may earn more in his shorter period of professional life, the income tax bite is higher, thus reducing takehome pay. He begins his life insurance program in most instances at age 32 to 35 and pays the higher premium; Mr. Bricklayer starts his program at 21 and takes advantage of the lower premiums. There's the loss of income on savings, too.

The purpose of this comparison is not

to stir up an argument over a bricklayer's pay. He is a skilled and respected artisan in a job that is often hazardous. From his hands have come mute but mighty monuments. Whatever he earns, let's concede he is entitled to it.

And the doctor—well, let's just say that he owes his community no apology for the monetary rewards of dedicating his life to its service.





DR. GEORGE T. HARRELL TO SPEAK HERE SEPTEMBER 12

Dr. George T. Harrell, Jr., Dean of the University of Florida School of Medicine, Gainesville, Florida, will be the visiting distinguished guest speaker for the Tulsa County Medical Society on Monday, September 12, 1955, at 8:00 P.M. His subject will be "Myxedema: A Frequently Overlooked Condition".

The meeting will be in the Auditorium of the Blue Cross-Blue Shield Building, 1215 South Boulder, Tulsa. Telephone service is available by calling LUther 5-9141. All medical doctors are

invited to attend.

Dr. Harrell is a graduate of Duke University Medical School, Class of 1936. He served his internship and a four-year residency in Internal Medicine at Duke Hospital. In 1939 he was appointed to faculty of Duke University Medical School, and two years later was named Assistant Professor of Medicine at Bowman Gray School of Medicine, Wake Forest College, Winston-Salem, North Carolina. Dr. Harrell rose to the position of Professor and Director of the Department of Internal Medicine at Bowman Gray. In 1952 he retired as head of the Department to do research in medicine. In 1954 he was appointed to his present position as Dean and Professor of Medicine at the University of Florida School of Medicine.

The September guest speaker is a diplomate of the American Board of Internal Medicine, member of the American Society For Clinical Investigation, fellow of the American College of Physicians, fellow of the Royal Society of Tropical Medicine, and member of the American Association for Advancement of Science, Society of Experimental Biology and Medicine, the American Society of Tropical Medicine, Phi Beta Kappa, and Alpha Omega Alpha. In 1953 he served as President of the Southern Society for Clinical Research, and has also been an officer of the North Carolina Heart Association and the Southern Medical Association. At present he is Chairman of the Medical Advisory Committee of the Oak Ridge Institute of Nuclear Studies, Oak Ridge, Tennessee.

Dr. Harrell is a former member of the editorial boards of the Journal of Clinical Investigation and the North Carolina Medical Journal, and at present he is an

editor of Medicine.

His research interests include the study of alterations of fluid balance during infections by radioisotope techniques, antibiotic therapy with penicillin, aureomycin, and streptomycin, application of radioisotope techniques to the study of physiological changes in myxedema, and other metabolic problems. Special assignments on tropical medicine took him to Hondouras in 1943 and more recently he has taken special training in isotopes at Oak Ridge and at the Brookhaven National Laboratory. His research has been financed by over a dozen grants from national organizations, private industry, and private individuals. Five of his scientific exhibits have been featured by the American Medical Association and the Southern Medical Association. Major speaking engagements have taken him to the Universities of Oxford, Padua, Naples, Leiden, Brussels, Leige, and London, and to numerous universities, army medical centers and state and national medical societies over the nation.

Dr. Edward L. Moore, Chairman of the Program Committee, has announced

PRESIDENT'S PAGE

During the past month the people of Tulsa have been overwhelmed almost to the point of hysteria by the importance of immunization against poliomyelitis. There has also been much concern that the percentage of pre-school children vaccinated against smallpox is very low as determined by the recent survey of the Tulsa Council of Social Agencies and Tulsa County Medical Society. One feels that in the enthusiasm for the former, it should not be forgotten that there are still sporadic cases of smallpox, diphtheria, and whooping cough. The high incidence of injury on the highways, in industry, on farms and elsewhere emphasizes the importance of tetanus toxoid. It seems to me that while people are "immunzation conscious" as a result of the polio publicity it would be a very opportune time to wage a campaign urging prophylaxis against those other diseases which in all probability, especially in the case of tetanus, constitute a greater hazard than polio.

To this end I have appointed a special committee of the Tulsa County Medical Society to formulate plans for a concentrated public campaign to secure inoculation of pre-school children. The details of this program will be announced shortly and the project is one requiring the complete cooperation of every member of the medical profession. Your Board of Trustees believes that this campaign is clearly indicated in the interests of individual and general good health. It is designed solely as a public health and public relations measure with the intent of improving our deplorable low rate of vaccination and inoculation among pre-school children. As the project advances, your suggestions and assistance will be sought. I know that each of you will cooperate in the same fine spirit which has marked all of the Society's past projects.

BLUE CROSS-BLUE SHIELD SETS ANNUAL ENROLLMENT

The third annual Oklahoma Blue Cross and Blue Shield individual enrollment for residents of Tulsa County has been scheduled for September 1-14, 1955.

During that period any person under the age of 65 as of November 1, 1955, may purchase Blue Cross and Blue Shield hospital and surgical and obstetrical care benefits. New enrollees will be placed on a bill-direct basis with statements for premiums rendered quarterly. Those who are employed where there are existing groups of ten or more will be added to the group. In both instances protection will become effective November 1, 1955.

The enrollment has been endorsed by the Tulsa County Medical Society and is being sponsored by the Tulsa County Blue Cross member hospitals.

Members of the Tulsa County Medical Society are requested to cooperate in making the enrollment a success by enclosing literature with their statements, by displaying posters in their offices, and by offering information about Blue Cross and Blue Shield to their patients.

The enrollment is designed to meet the public demand for Blue Cross and Blue Shield protection for the self-employed, retired persons, farmers, and all other persons not eligible to enroll through an employee group.

The enrollment is conducted only once each year. Those who enroll in both Blue Cross and Blue Shield may also add extended benefits to their present protection.

Improved medical and hospital care

benefits will be offered this year. The new Blue Shield membership agreement for individuals includes the addition of a medical care benefit. That is a payment of \$3.00 per day for doctors' inhospital visits on non-surgical cases, beginning the fourth day for a total of 30 days.

A total of 90 days hospital care each contract year is being offered in the new Blue Cross membership agreement for individuals. This is an increase of 60 more days of hospital care.



The Tulsa County mortality rate among mothers in childbirth is ten times lower than the Oklahoma average, due largely to an adequate blood supply, officials of the Tulsa County Red Cross Blood Center recently reported. The Oklahoma rate is seven deaths per 10,000 births, but in Tulsa the rate is .7 per 10,000 births. The ready availability of whole blood of all types is believed to have materially contributed to the low local rate.
