A WOMEN'S CENTER IN OKLAHOMA CITY?

A VICTORY FOR SILKWOOD

The Karen Silkwood story was finally brought to a victorious conclusion on January 12, when the Supreme Court held the Kerr-McGee Corporation liable for a \$10 million punitive damage award. The Company had been charged with the plutonium contamination of Silkwood, a laboratory analyist and union official at a Kerr-McGee plutonium processing plant in Crescent, Oklahoma.

Silkwood was killed in an auto crash November 13, 1974, on her way to meet a reporter and union official with documentation of safety violations and quality control abuses. The National Organization for Women, the Oil, Chemical and Atomic Workers' Union (the union Silkwood worked for), and her family pressed for a federal investigation into her death. The premature termination of this investigation and its limited scope prompted a meeting between NOW and the Justice Department on August 26, 1975, demanding a reopening of the investigation. The Silkwood advocates also formed the Karen Silkwood Fund under the direction of Sara Nelson, who also served as the head of NOW's Labor Committee. The persistence of Nelson, Danny Sheehan, NOW member and attorney in the case, and pressure from NOW kept the case alive.

In November, 1976, Silkwood's parents filed a lawsuit against Kerr-McGee on behalf of her three children. In 1979, an Oklahoma federal jury found the company negligent and awarded Silkwood's estate \$10.5 million in actual and punitive damages. A federal appeals court set aside the \$10 million punitive damage award in the 1981 decision, but the Supreme Court reinstated the award by its January action.

The chapter will be one of about 100 already organized internationally as a part of Mothers Without Custody, headquartered in Greenbelt, Maryland. Local organizer of the group, Phyllis Morrison, has scheduled a meeting for 6:00 p.m., April 3, 1984 at the Women's Resource Center, 226 East Gray St., in Norman. LESBIANS SUBJECT OF RESEARCH

Lesbians over the age of 60 is the subject of research by Dr. Monika Kehoe, San Francisco State University. Dr. Kehoe, through her anonymous survey, hopes to answer some of these questions: "Who are the "old" women of the Lesbian community?"; "What are the life experiences, the strengths and the needs of a group of Lesbians 60 plus?"; "What similarities and differences exist in this seemingly invisible group?"

RAPISTS IN PAKISTAN ARE GOING TO HAVE AN easier time getting around the law if that country's government has its way. The Wall Street Journal reports Pakistan officials are contemplating a change in evidence laws that would make a woman's testimony worth only half that of a man. It's not as though Pakistan's court system is all that tough on suspected rapists even without the rule change. As the law now stands, if a woman seeks the maximum penalty of stoning, the accused rapist must have been seen in the so-called "act of penetration" by no less than four witnesses. The four witnesses must all be adults and all be Moslems. They must also all be men. (Her Say)

THE QUOTE OF THE WEEK COMES FROM AL Goldstein, publisher of that classily named magazine, Screw. Talking to another publication, New Scientist, about predictions that robot spouses will one day be available, Goldstein said: "My fantasy is to phase the wife out of the picture. Goldstein added that his own wife has taken that possibility in stride, explaining: "She knows she's on the way out, like the buffalo." But then with a husband like Goldstein, who would complain about being replaced? (Her Say)

A FORMER NUN WHO WORKED WITH PROSTITUTES in Haiti has died from Acquired Immune Deficiency Syndrome. The un-named AIDS victim, who was Canadian, had worked for more than 20 years in Haiti. She reportedly had no history of promiscuity, blood transfusions or drug abuse. Physicians who treated the woman at Toronto General Hospital, reportedly believe her case strengthens the argument that North American AIDS cases are somehow linked to Haiti. (Her Say)

Abbott, Sidney, and Barbara Love: SAPPHO WAS A RIGHT-ON WOMAN: A Liberated View of Lesbianism (Stein & Day), 1978 (1972), 256 pp., \$1.95 pb. An important piece of gay-movement literature from the 70's, written by two lesbians. The book focuses on what it means to be lesbian and how lesbian pride can be achieved.

Adler, Margot: DRAWING DOWN THE MOON: Witches, Druids, Goddess-Worshippers, and other Pagans in America Today (Beacon), 1979, 455 pp., \$8.95 pb. A fascinating and honest look at the religious experiences, beliefs, and life-styles of the people who call themselves neopagans.

Brown, Rita Mae: RUBYFRUIT JUNGLE (Daughters), 1973, \$4.00 pb; (Bantam), 1977, \$3.50 pb. Modern classic about brash, tomboy Molly Bolt growing up poor in the South and making it against fantastic odds as a lesbian and student in New York City. A dyke Horatio Alger story. The most popular lesbian novel we've ever carried.

Brown, Rita Mae: SIX OF ONE (Bantam), 1979, \$3.50 pb. Funny like Rubyfruit Jungle, the story travels back and forth in time between 1909 and 1980, through three generations of women in the town of Runnymeade, Pa.

Brown, Rita Mae: SOUTHERN DISCOM-FORT (Harper & Row), 1982, 256 pp., \$13.50 cl., (Bantam), 1983, 256 pp., \$3.95 pb. A heterosexual, historical novel set in the South. The characters range from prostitutes who work the train station, to a prominent Black family, to one of the wealthy, controlling families of the town. Structurally, the novel is probably better than her previous work, and the characters are lively and full of spunk as only Brown can create them. A good read. (Will be available in paperback, May, 1983, from Bantam).

Brown, Rita Mae: SUDDEN DEATH (Bantam), 1983, 241 pp., \$13.95 cl. Rita Mae's new lesbian fiction set behind the scenes of the women's tennis circuit. An important book, in that it discusses the dangers of living a closeted existence. How living a lie hurts everyone who is involved. Many excellent one-liners, but the people are much less likable than in her previous novels.

Bryant, Dorothy: A DAY IN SAN FRAN-CISCO (Ata Books), 1982, 144 pp., \$6.00 pb. Carla Lontana, a middle-aged women's studies professor has a son who is gay. She is disturbed by contemporary gays' frivolity and promiscuity and by her son's inability to make commitments.

Budapest, Z: THE HOLY BOOK OF WOMEN'S MYSTERIES, Part I (Susan B. Anthony Coven #1), 1979, 136 pp., \$7.35 pb. This book describes wimmin's rituals, practiced by the Susan B. Anthony Coven #1. It also describes spellcasting, Tarot divination, and a herstory and philosophy of wimmin's religion.

Budapest, Z.: THE HOLY BOOK OF WOMEN'S MYSTERIES, Part II (Suan B. Anthony Coven #1), 1980, 223 pp., \$8.95 pb. A cooperation between Z. and her mother, Masika, includes 57 chapters on women's mysteries, Dianic Genesis, Laws of the Craft, rituals, and more.

Cliff, Michelle: CLAIMING AN IDENTITY THEY TAUGHT ME TO DESPISE (Persephone), 1980, 66 pp., \$4.00 pb. An incredible personal voyage through divisions of race, relationships, and sexuality. A courageous blend of herstory and poetry.

Daly, Mary: BEYOND GOD THE FATHER: Toward a Philosophy of Women's Liberation (Beacon), 1973, 225 pp., \$5.95 pb. Goes beyond other key works of the movement to describe possible ways a radical feminist can exist in the patriarchal world.





Gearhart, Sally: THE WANDERGROUND (Persephone), 1979, \$6.00 pb. A best-selling fantasy of the future. Written in connected short segments, it tells how and why the women leave contemporary society for the Wanderground. A very important work.

Lifshin, Lyn, ed.: ARIADNE'S THREAD: A Collection of Contemporary Women's Journals (Harper & Row), 1982, 288 pp., \$17.95 cl, \$6.95 pb. Diaries and journals of both well-known and lesser-known contemporary writers. Includes Marge Piercy, Judy Chicago, Ntozake Shange, and others.



McAllister, Pam, ed.: REWEAVING THE WEB OF LIFE: Feminism and Nonviolence (New Society), 1982, 448 pp., \$19.95 cl., \$8.95 pb. Anthology with more than 50 contributors. Includes women's history, women against militarism, self-defense, civil rights, interviews, songs, poems, short stories, and bibliography.



Rich, Adrienne: OF WOMAN BORN: Motherhood as Experience (Bantam), 1977, \$3.95 pb.; (Norton), 1976, \$12.95 cl. Mothering, a subject that lacks resource material, is written about from the author's personal experience. She discusses both the potential of the motherhood relationships and the institution.

Rich, Adrienne: ON LIES, SECRETS AND SILENCE: Selected Prose, 1966-1978 (Norton), 1980 (1979), 310 pp., \$3.95 pb, \$15.95 cl. An excellent selection of essays and introductions, some previously published. Includes the essay Women and Honor: Some Notes on Lying; also discusses women's studies, motherhood, and a wide variety of feminist/lesbian topics. An important book.

Walker, Alice: THE COLOR PURPLE (Harcourt Brace Jovanovich), (1982), 245 pp., \$11.95 cl.; (Pocket), 1983, \$5.95 pb. Pulitzer prize-winning lesbian fiction set in the Black South of the 1920's. Walker creates a new language here—a beautiful book!
