The University Senate met in regular session with Vice-Chairman J. F. Bender in the chair. (President Cross came in a few minutes late and took over to continue with the meeting.)

The Journal of the Senate for the previous meeting was approved.

H. V. Thornton, Chairman of the Committee on Committees, presented a report recommending that all of the old members on the standing committees of the University Senate who are still members of the Senate be re-appointed to those committees, and that only vacancies be filled. - (I) Committee on Committees: A. O. Weese--elected by the Senate at the previous meeting.
