## DISTRIBUTION OF UNIVERSITY SENATE MEMBERSHIP

## Explanatory Comment

The Charter of the University Senate, as approved by the Regents of the University in 1947, provides in part as follows:

The Faculty of each college and degree granting school of the University shall be entitled to representation in the Senate proportionately on the basis of a quota to be determined by the general faculty every third year beginning in 1947. However, each college and independent degree granting school shall elect at least one member to the Senate. Any member of that faculty is eligible for election as such representative if he meets the eligibility requirements prescribed hereafter. The general faculty shall elect the remaining members of the Senate.

In the regular meeting of the University Senate on September 28, 1953, Dr. Moorhead moved that consideration of the proportional distribution of membership in the University Senate for the three-year period, September 1, 1954 to September I, 1957, be referred to the appropriate committee of the Senate. The motion was approved and Dr. Pray, as Chairman of the Senate, referred the matter to the Committee on University Orqanization, Budeet, and Publications.

Report of the Committee on University Organization, Budget, and Publications
The Committee on University Organization, Budget, and Publications recommends that membership in the University Senate for the next three years (1954-57) be allocated in the followine manner:
