SOCIAL SECURITY


Explanatory Comment

This special session of the University Senate was called by the Chairman at the suggestion of the Committee on Faculty Personnel, for the purpose of considering problems connected with the social security program which may soon be available to University personnel.

Senate Action

The Chairman of the Senate called upon Professor Farrar to present a report of the Committee on Faculty Personnel.

Professor Farrar stated that the Committee on Faculty Personnel had met with repersentatives of the social security program and had arranged for a panel of four persons to discuss social security with the Senate at this special session. The four persons present to discuss the problem were: Russell Daiker and Wayne Schooley, representing the social security program, and Roscoe Cate and Dud Giezentanner, representing the President's Office.



Social Security -- continued

Professor Farrar moved that the report of the Committee on Faculty Personnel be approved by the University Senate as follows:

Because of the universal and far reaching effects and because of the potential benefits available in the form of the survivors and retirement benefits, this Committee recommends that the University Senate go on record as favoring the social security program and take immediate steps to make social security available to all eligible employees.

The motion by Professor Farrar was seconded.

Mr. Daiker made a general statement concerning social security and how participation in the program might be arranged for the University staff in case it is decided that such participation is desirable. Vice President Cate answered certain questions concerning the implications of participation in both the present retirement plan and social security.

Following the discussion, a vote was taken on the motion by Professor Farrar and it was approved by the Senate.

Professor Farrar offered a second motion that the University Senate recommend that an early meeting of the General Faculty be called for the purpose of apprising the General Faculty concerning the social security program. The motion was seconded and passed.

Dr. Pray moved that the Committee on Faculty Personnel assume whatever leadership might be necessary in presenting the problem of social security to the General Faculty. His motion was seconded and approved by the Senate.

ADJOURNMENT

The special session of the University Senate adjourned at 5:00 P. M. The next regular meeting will be Monday, January 31, 1955, at 4:10 P. M.
