UNIVERSITY CALENDAR

Dr. Ewing, Chairman of the Committee on Academic Standards, reported that his Committee is meeting weekly to consider matters relative to the University Calendar. A report will be rendered at the regular session of the Senate on March 26, 1956.

NOMINATIONS FOR UNIVERSITY COMMITTEES

Professor Fraser, Chairman of the Committee on Committees, reported that his group is now concerned with the development of lists of nominees for the various University committees appointed each year. A report will be given at the March meeting and the Senate will vote on the nominees to be submitted to the President when it convenes in April.

Professor Fraser pointed up the problem in developing lists of names for 1h different committees. Approximately 150 members of the University faculty must be involved in the committee nominations. Following a brief discussion of whether so many committees are needed, Dr. Crook moved that the Senate request the University Self-Study Committee to arrange to have an evaluation made of the various University committees in an attempt to determine whether they are all essential and working effectively. His motion was seconded and passed by the Senate.
