## PARKING AND TRAFFIC ON CAMPUS

#### Explanatory Comment

On September 30, 1957, Dr. Raines raised for consideration by the Senate certain problems connected with the parking of automobiles on campus. Following his general comments, he made a motion that the Committee on Student and Public Relations be charged with the responsibility for making a study of the entire matter of parking regulations as put into effect with the beginning of the first semester, 1957-58. This matter was referred to the Committee on Student and Public Relations.

## Report of Committee on Student and Public Relations

February 14, 1958

The members of the committee have carefully read the report by the Institute of Community Development and the Office of the University Architect entitled A RECOM-MENDED AUTOMOBILE TRAFFIC AND PARKING POLICY AND PLAN FOR THE UNIVERSITY OF OKLA-HOMA. This report was made according to the suggestions included in the report of 1957 of this Senate Committee.

Although this report does not include some of the recommendations made in 1957 by the committee, we feel that it has considerable merit and that those individuals involved in making it are to be commended for its quality and scope. We recommend it be put into effect on a trial basis (30 to 60 days) as soon as it is feasible to do so, except for III-B-3, which reads, "Build a new metered parking lot for students east of the fieldhouse and meter the student portion of the Gould Hall lot."

The recommendation made last year by this committee that is not included in the report - the recommendation that this committee feels is of equal importance with traffic routing, and was therefore listed first in our recommendations of last year is as follows:

"That no student should drive an automobile on campus from 7:30 A.M. to 5:00 P.M. Monday through Friday and from 7:30 A.M. to 12:30 P.M. on Saturday."

The stipulation that this recommendation should not apply "until new peripheral parking space is provided" was added. One of the two proposed peripheral lots has been completed and is in use; the other is to be just east of the fieldhouse on the northwest corner of Brooks and Jenkins streets. To this committee this seems to be a poor site for a student parking lot. It is not really peripheral, and will therefore bring additional traffic into the suggested traffic routing for the campus; it is not sufficiently large, and it is a site that will undoubtedly be needed later for additional building.

We reiterate our recommendation that students not be allowed to drive on the campus during daytime class hours and urge that it be put into effect as soon as a second peripheral lot is completed. We do not agree with the frequently expressed idea that the University cannot legislate when and where students can drive on the campus.

This committee also questioned the recent increase in faculty parking fees from \$2.50 to \$5.00. Mr. Spradling, the Controller, explained that the cost of building and maintaining faculty parking lots and entrys had steadily increased, and the increase in rates was necessary to pay for the lots. He said that a survey of other similar institutions indicated that even with the increase our parking fee is lower than most universities of comparable size.

Two additional parking problems have been brought to the attention of this committee - night parking near the Union and near Holmberg Hall when there is an activity there. We therefore recommend that the Council on Planning and Development consider these problems, if they are not already doing so, and include the question of the feasibility of night parking along the west side of Asp Street from Boyd to Brooks. We also urge that they carefully consider another site for the peripheral student parking lot other than the one proposed east of the fieldhouse.
