RE-EVALUATION OF PHYSICAL EDUCATION WITH REFERENCE TO ITS COMPULSORY
NATURE AND CONSIDERATION OF A NON-COMPULSORY ROTC PROGRAM FOR

Explanatory Comment

The problems involved in the current programs of compulsory ROTC and Physical Education have been under consideration for a number of months by a committee from the University Senate. Recommendations from the Senate have been submitted to President Cross.

Senate Action

At the meeting of the University Senate on November 24, President Cross made an informal statement of his views relative to the ROTC and Physical Education programs in the University. His comments were not intended to encourage action on the part of the University Senate and no action resulted.

POLICIES GOVERNING THE FORMULATION OF THE UNIVERSITY
OF OKLAHOMA CALENDAR

Explanatory Comment

The Committee on Academic Standards of the University Senate has for some time been considering revision of the current policies governing the formulation of the University calendar. At the meeting on November 24, Dr. Brixey, Chairman of the Committee on Academic Standards, distributed copies of a working draft of recommended policies to govern the formulation of the calendar.

Senate Action

Following explanation of several items in the working draft of recommended policies, informal discussion and questions from the floor, comments from Dean Fellows and Dean Livezey, Dr. Brixey moved that a special meeting of the University Senate be held at 4:10 p.m., Monday, December 8, 1958, to consider and come to a conclusion regarding calendar revision. His motion was seconded and passed unanimously.

ADJOURNMENT
