### SENATE RECOMMENDATIONS APPROVED

## EFFECTIVE DATES FOR POLICY RECOMMENDATIONS



#### Memorandum from Vice President McCarter

November 3, 1960

I suggest that every policy recommendation made to the President ought to include the effective date of the policy. Most effective dates for new policy or policy change should be keyed to the University calendar and set at term-beginnings. Unless an effective date is named, we tend to consider the new policy effective as of the date of the President's approval and this sometimes leads to confusion.

#### Senate Action

Following a brief discussion of this matter, Dr. Fite moved that in the future each senate committee include with its recommendations the date at which the recommendations should go into effect. His motion was seconded and passed.

EQUIPMENT RENTAL AND DEPARTMENTAL SERVICES



Report of the Committee on University Organization, Budget, and Publications

November 11, 1960

Reference is made to the report of the Committee on page 5 of the agenda for the Senate meeting on May 30, 1960. That report was returned to the Committee with a request for recommendations of a more positive nature. After further deliberation, the Committee drew up the following:

### Recommendations

1. That typewriter rental and photographic services be continued under the present management.

# Equipment Rental and Departmental Services -- continued

- 2. That audio and visual instructional aids be supplied by the Educational Materials Services to teachers requesting such aids, and that the supplying agency be allotted a budget to cover the cost of this service. (Comment: This would mean returning to the former practice with regard to supplying audio-visual materials. Under the present plan of allocating funds to these materials.)
- 3. That the University Book Exchange grant a 15 per cent discount to all University employees on all purchases at the Exchange.
- 4. That individual budgetary units be not only allowed but encouraged to make the most economical arrangements in renting or purchasing typewriters and any Recommendation 1. It appears that a department should be allowed to exercise its own judgment as to the time of amortization for a given machine, and that a department should be allowed to negotiate with any vendor relative to purchase or service contracts.)
- That the University Book Exchange augment intellectual stimulation among the University community by enlarging its offering to include (in addition to regular textbooks and supplies) a wider range of serious hard-back scholarly books.

#### Senate Action

Dr. Springer presented the foregoing report relative to equipment rental and departmental services and commented relative to each of the five items. # RULES CONCERNING THE HANDLING OF CASES OF CHEATING imes

## Report of the Committee on Student and Public Relations

November 15, 1960

On November 15 the Committee on Student and Public Relations met to consider the question referred to it by the Senate.

The question, raised by Professor T. A. Shadid, concerned an addition to the faculty rules covering cheating, page 33 of the 1958 Faculty Handbook.

## Rules Concerning the Handling of Cases of Cheating -- continued

After some discussion of wording, the committee passed a motion to add a third item after the two items listed as (1) and (2) which follow the phrase "within the following limits". The new item will read:

(3) A student who by any dishonest set other than those covered by (1) and (2) above seeks to obtain an unmerited grade for himself or another person, may be suspended from the University for the remainder of the semester in which the set took place, or for the following semester.
