#### ASSOCIATION OF GRADUATE ASSISTANTS

### Explanatory Comment

Certain major concerns of the Association of Graduate Assistants have been studied by the University Senate. On February 28, 1966, recommendations were approved and subsequently submitted to President Cross. On March 14, 1966, President Cross indicated that at that time he could neither approve or disapprove those particular recommendations.

## Senate Action

#### Report from the Senate Committee on Academic Standards

April 8, 1966

The following material constitutes a report from the Senate Committee on Academic Standards.

After appropriate consultation with the faculties of the various colleges and the Committee itself, we wish to make recommendations regarding the University policy on "I" grades.

Any student receiving an "I" grade must remove the "I" or re-enroll in the course within two regular semesters after he returns to the University of Oklahoma campus. The foregoing time limitation concerning the removal of "Incompletes" does not apply to graduate research and graduate problems courses. If the student graduates within the established time allowed for the removal of an "Incomplete", the "I" grade will remain unchanged.

#### Senate Action

Dr. Eek presented the foregoing report and moved that it be accepted by the University Senate. His motion was seconded.

Considerable discussion followed in which the primary concern was clarification of the meaning of certain specific points in the recommendations. Dr. Love then made a substitute motion that the matter be referred back to the Senate Committee on Academic Standards for further study, clarification, and re-statement. His motion was seconded and passed.


### Senate Action
