REMARKS BY KYLE HARPER, SENIOR VICE PRESIDENT AND PROVOST

Prof. Hirschfeld introduced Kyle Harper, the Senior Vice President and Provost. Prof. Harper expressed his appreciation of being invited to speak at the first meeting of the Faculty Senate about the directions and priorities of the Provost's Office. His presentation was broken into three segments: 'OU Outlook', 'Being OUrbest', and 'On the horizon: priorities and focus'.

He stated that the OU is a gateway of opportunity—a comprehensive, public university combining excellence and accessibility. He reiterated the President's view that OU is a family—a campus where people from different walks of life come together and care about each other. By preparing students for citizenship and for life in a global society, we build character and civility. Our faculty members are competitive and utilize collaboration, boldness, and creativity, to excel and give Oklahoma a university of which to be proud.

Provost Harper stated that tuition and fees are now a dominant force in higher education, however, ours are low for a Carnegie R1 university. He sees the rate of tuition growth overall slowing. In response, universities are increasing their enrollment, which leads to competitive pressures on institutions. Thus, OU's brand, value, and identity are important.

Our undergraduate population has become 'bigger and better'. Our Fall 2015 Cohort consists of 4,200 freshmen, of which 285 are National Merit Scholars. Their average ACT is 26.4 and GPA is 3.62. It is also the most diverse cohort in OU's history. OU had 13,000 applicants of which 9,000 were admitted and 4,200 enrolled. There have been major changes in Admissions and Recruitment in terms of organization including a recent union of Admissions with Recruiting, the transition to completely holistic admissions, and recruitment strategy.

Provost Harper has been Provost since March 2015. His key team consists of:

Areas where the Provost's office has put significant emphasis are retention, graduate education, and community engagement. Provost Harper noted that 86.1% of last year's freshmen returned, but our goal is to approach 90-92%. In order to better support freshmen, the Provost's office is requiring all faculty who teach 1000-level classes to participate in providing mid-semester grades; these grades are now due at the end of week 8 of the semester instead of week 6.

Provost Harper said that Stewart Berkinshaw was hired last year to provide more insight, organization, and discipline into our budgeting process. For example, we have \$60 million in cash/carry forward. Provost Harper prefers timely and accurate information: one-page income/expense. He noted the recent change to a Presidential Hiring Authorization, which provides a single annual cycle, in line with the R1 norm. It features an early, simple authorization that flows from the Department through the Dean and Provost to the President. The departments and deans both play a critical role in this process. He noted that we had almost \$20 million in unexpended endowments and scholarships in non-interest bearing accounts.

Graduate Education is very important to the Provost. OU is in the process of evaluating our competitiveness, funding model, opportunities, and recruiting/marketing. The Provost noted that several faculty members told him that our research programs are as good as the graduate students that we can get to come here.

On the horizon are the renovation of the lower level 2 of Bizzell Library, the creation of residential colleges, the IRB review, the management of space and classrooms, and changes to the OU Portal (oZone).

The Provost asked the faculty to consider 'What Kind of University Can We Be?' He proposes that OU aspire to be a university whose students succeed at such rates that people ask "how do they do it?", a university that leads a state on the move and connects to the community in a special way because it represents the people's university, a university known for its top-tier faculty who are making an impact in their fields and on the world, a university known for its broad variety of top 5/25/50 programs, and an elite but affordable public university that embodies the American ideal of opportunity for everyone. He stated that OU can only get there because of our faculty, because of their time, talent, and effort and working together.

Prof. Emily Johnson asked if there has been consideration of limiting the number of hours that students may take during the summer session. She is concerned that over-enrollment is not in the best interests of the students. Provost Harper shares her view that there should be limits on enrollment hours, but is still in the process of gathering data on the summer enrollments. He does not want to unnecessarily limit student enrollments, especially if their courses are spread out over the entire summer session. Provost Harper said he would follow up with Prof. Johnson on this issue.

Prof. Fiedler asked if there is a way to alter the pricing structure to allow students to pursue the learning style and mode of delivery that works best for them. Provost Harper said that there is no discussion about changing our pricing structure. The flat rate 15-hour tuition charge is seen as the best option for our students. Our curriculum is designed for students to take at least 15 hours per semester and thus graduate in four years. He did note that pricing is a very complicated issue. He also stated that there is constant activity around determining the best way to help our students learn. We are investing in assessment of learning outcomes and want to provide faculty with multiple ways to meet their students' needs.

Prof. Bembien said that he has continued concerns that the current graduate student tuition waiver does not include fees, which can be quite large. He would like the University to waive graduate student fees

in addition to their tuition. Provost Harper stated that a fee waiver is not a financial option in the near term. For historical reasons, OU does have an uncommon structure of tuition and fees. An inadvertent effect had been high fees assessed on graduate students. He agreed that our tuition and fee structure does affect our ability to recruit graduate students.

Prof. Irvine asked about the review of the IRB process, as she sees a lot of variance in the current process. Provost Harper stated that IRB review has become a more important issue recently as he hears more faculty concerns about it. Our procedures may be more robust than the procedures at other peer institutions and this is complicated by our sharing the IRB with the Health Sciences Center. So, it may be advantageous to separate those processes.

Prof. Hirschfeld thanked the Provost for speaking at today's meeting.

SENATE CHAIR'S REPORT, by Prof. Tassie Hirschfeld

"Dean's Council Report from the May 6, July 1, September 2 meetings. Issues discussed included diversity initiatives, the combination of recruiting and admissions into one office, and the Galileo exhibit and renovations to library 5th floor special collections. We have invited VP Shumate to speak at the October Faculty Senate meeting to speak more on diversity initiatives.

"The 2015-16 Faculty Senate Executive Committee met for the first time on Monday, August 31. The following items of business were completed:


- Senator Jon Foreman was elected to serve as the official Parliamentarian for the upcoming academic year.
- Discussion of short and long term issues affecting faculty productivity, welfare, and morale and the Faculty Senate committees that address these issues.
- Update on new University initiatives from Provost Kyle Harper.

"Planned new and continuing Executive Committee work for 2015-16 includes:


- Supporting campus diversity initiatives as they become more formalized through the Vice President's office.

- Information and updates from Human Resources on any proposed changes to benefits for the upcoming year. Les Hoven will speak at our October meeting in preparation for open enrollment."
