The Faculty Senate is sad to report the death of retired faculty member Edward Blick (Geological and Petroleum Engineering) on April 9, 2020.

SENATE CHAIR'S REPORT, by Prof. Joshua Nelson

The Senate Chair's Report was distributed to all regular faculty members prior to this meeting along with the meeting agenda; it is attached. Prof. Nelson asked if there were questions or comments about any of the items in the report. There were none.

REMARKS BY VICE PROVOST FOR INSTRUCTION AND STUDENT SUCCESS MARK MORVANT

Prof. Nelson introduced Vice Provost for Instruction and Student Success Mark Morvant. Prof. Morvant referred faculty to the recent announcement about in-person fall classes from President Harroz. Prof. Morvant said that there are several teams making plans for how to come back to campus in a safe way. Those teams are addressing testing, contact tracing, and PPE availability, facilities, student life, housing and residential life, and research.

Prof. Morvant added that they are striving to make the campus safe for in-person instruction but also be resilient for what may come up that is unexpected in the fall semester. They are taking action to maximize chances of a safe, healthy return to in-person instruction. They will be expanding some online offerings and flexibility, decreasing the density of students within classrooms and in the buildings, promoting behaviors and protections to decrease the chance of transmission, and encouraging instructors to develop their courses with flexibility to pivot to remote learning if needed.

Core elements of the planning has been relocating classes to larger classrooms to allow greater social distancing, expanding time between classes to allow for greater social distancing in the halls and walkways, moving some large enrollment courses online, and create in-person and blended sections of normally large enrollment courses, specifically first year courses to allow students to have an in person experience. They will be promoting flexible course design that can pivot from in-person to online if needed, which will include providing faculty development training to assist in the development of courses He closed his presentation by saying that these are the main concepts that we're looking at, but that nothing has been decided and there are no decisions other than that we are planning for an in-

person experience and making that experience as safe as possible, but they are still working through all the details. Prof. Morvant opened the floor to questions from the senators.

Prof. Teodoriu asked Prof. Morvant to define what 'large enrollment' means in terms of class size. Prof. Morvant said that depends on the discipline, but certainly those that have several hundred students. He added that even in those classes, OU wants students to have some type of in-person experience and that we may split or create additional sections for some of those historically large classes.

Prof. Ashby asked that at-risk faculty be given the option of teaching online for the fall. Prof. Moore-Russo also asked for the same option for faculty members that care for elderly parents. Prof. Morvant said that would be considered on a case-by-case basis. Provost Harper said that these are all important questions and the safety of faculty, staff, and students is paramount. He added that they are working to create the right processes in the fall to reduce risk.

Prof. Raymond asked what would happen if there is a COVID-19 outbreak on campus which renders many faculty members in a department unable to continue teaching. Prof. Morvant said they are discussing the accommodations that would need to be made in that case and this is one reason they are encouraging flexibility in course design. Prof. Faison asked for more detail about what the Provost's office envisions for blended courses. Prof. Morvant said that perhaps some content could be moved to an asynchronous content and then faculty would meet with half the students on a Tuesday and half on a Thursday.

Prof. Burge asks if there has been consideration of block class scheduling. Prof. Morvant said that initially they did look at an 8-8 or 4-4-4 semester. However, both options are difficult to put together schedule-wise and require faculty to rearrange their course content. Prof. Morvant said they are looking at courses they could block that are all-freshman courses as they have not yet started enrolling, and multiple options are still being considered.

Prof. Heyck said that social network analyses suggest that eliminating or moving larger courses online will make little to no differences as everyone on campus is connected via three social steps anyway. Prof. Morvant said that they are watching the data and projections regarding transmission rates as well as putting in more social distancing and more PPE.

Prof. Nelson summarized several questions regarding coordination of the various planning groups and who will be making the decisions about social distancing protocols and testing. Prof. Morvant emphasized that they are following the lead of our public health and infectious disease professionals and that there is considerable communication between the planning groups. Recommendations are being sent to both Provost Harper and Sean Burrage as many of these decisions will be made by the President. Provost Harper concurred and conceded that there are supply chain issues with both PPE and testing.

In response to a question from Prof. Randall about whether faculty would be expected to teach a greater number of smaller class sections, Prof. Morvant said that there is no expectation that faculty will have to increase their teaching load. Prof. Randall asked whether classrooms would be upgraded to include web cameras, microphones, and whiteboard capturing technology. Prof. Morvant said that we currently have only a few classrooms with webcam and video capture ability. His recommendation in the short-term is for faculty to bring laptops to campus so that they can continue to Zoom with students that are not physically present.

Prof. Raymond asks if professional programs that have required field placements for certification will be given guidance on what to do if the university is open, but the sites of field placements are not, as this

might significantly impact seniors in some programs. Prof. Morvant said that they will be working closely with these programs to see what the opportunities are and how we can utilize them.

Prof. Shahada asked if faculty members who would rather teach their courses online because of health concerns, even if their classes are relatively small, be required to teach in person classes. Prof. Morvant replied that the Provost's office would be setting up guidelines for faculty with health risks. They will do everything within their power to make accommodations so that those individuals that are at high risk are not putting themselves at risk. He added that Prof. Irvine in the Provost's office is working on these guidelines in consultation with the deans. She is also looking at what our peer institutions are doing. Prof. Nelson thanked Prof. Morvant for addressing the Faculty Senate.

COMMITTEE ON COMMITTEES NOMINATIONS FOR VACANCIES ON UNIVERSITY AND CAMPUS COUNCILS/COMMITTEES/BOARDS AND FACULTY SENATE STANDING COMMITTEES

The Senate approved the Committee on Committees' nominations for end-of-the-year vacancies on university and campus councils/committees/boards and Faculty Senate standing committees (attached). PROPOSED REVISION TO THE BY-LAWS TO ALLOW ELECTRONIC VOTING

Prof. Nelson directed the senators' attention to the proposed changes to the Faculty Senate By-laws to allow electronic voting. He said that in response to the discussion at our last meeting and ongoing conversations with the executive committee, we have revised the proposal to respond to most of the concerns. There was a minor change to the wording of a couple of sentences and the attached revision was approved.

RECOGNITION OF OUTGOING SENATORS AND EXECUTIVE COMMITTEE MEMBERS

Prof. Nelson thanked the outgoing senators for their contributions. They will receive certificates of appreciation for their service. The following outgoing senators were recognized for completing full three-year terms (2017-20): Michael Ashby, Amy Bradshaw, Stephanie Burge, Natalie Ellis, Liorah Golomb, Dave Hambright, Hunter Heyck, Feng Lai, Robert Lifset, Claude Miller, Anthony Natale, Duane Stock, and Chris Weaver. Certificates will also be sent to the outgoing members of the Senate Executive Committee.

RESOLUTION OF APPRECIATION TO PROF. JOSHUA NELSON, OUTGOING SENATE CHAIR

Prof. Nelson congratulated Prof. Bradshaw on her transition to Chair of the Faculty Senate for 2020-21. Prof. Bradshaw introduced a resolution of appreciation for Prof. Nelson, which was approved by applause.

WHEREAS Professor Joshua Nelson has provided smooth and steady leadership in a time of changes and disruption, including a(nother) presidential transition, the emergence of OU Global, the development of a university-wide strategic plan, incidents of racist language use by faculty, a threeday student-led sit-in and hunger strike at Evans Hall to protest racism on campus, and the COVID-19 global pandemic;

WHEREAS Professor Joshua Nelson has demonstrated awareness of and concern for the needs of faculty, staff, students, and administrators, and has worked cooperatively with and on behalf of each of these constituencies;

WHEREAS Professor Joshua Nelson has demonstrated commitment to and advocacy of diversity, equity, and inclusion through measurable actions, practices, and outcomes;

WHEREAS Professor Joshua Nelson has demonstrated commitment to the ideals, responsibilities, and beneficial outcomes of shared governance;

WHEREAS Professor Joshua Nelson has positively represented the Norman campus faculty in his engagement with the OU Board of Regents;

WHEREAS Professor Joshua Nelson has conducted meetings of the Faculty Senate in a manner that balances broad consideration of issues with a remarkable tendency to adjourn on schedule;

Prof. Natale would like the Faculty Senate to allow for the most flexibility for faculty members. Prof. Heyck raised the possibility of summer Faculty Senate meetings via Zoom as needed. Prof. Nelson noted that there is value to meeting in-person.

SENATE CHAIR'S REPORT, by Prof. Joshua Nelson May 4, 2020

Between April 9 and 14, several members of the Faculty Senate Executive Committee attended the public forums and individual interviews with two candidates for the dean of the Honors College. We communicated our impressions to Senior Vice Provost Jill Irvine, who is chairing the search committee, and asked that she pass them on to Provost Kyle Harper and Interim President Joe Harroz. At the Provost's chairs and directors meeting on April 13, we learned about various options being discussed for the fall instruction plan, about which we'll learn more at the May Senate meeting, although plans are not yet solidified ahead of late-spring internal deadlines related to enrollment. Decisions are being informed by the president's taskforces that have heavy representation from OUHSC representatives. One piece of the plan that has not changed in planning for fall instruction is that faculty should be considering how to again migrate their courses to an online format if isolation measures continue or are reinstated. Barring unforeseen developments, sabbatical applications approved at the provost level are moving forward.

On April 14, Vice Provost Mark Morvant and I discussed the fall plan, and he outlined various options and parameters (for course scheduling and re-enrollment, e.g.) for block scheduling, online seat capacity, hybrid deliveries, and online delivery. He expressed his belief that the institution would be well served in the long run by avoiding major hits to graduate education.

On April 16, the Faculty Advisory Council for the state regents met and learned more about online learning initiatives and needs around accessibility and proctoring. I asked about flexibility for capstone projects and new online programs and was assured that the regents would carefully consider current circumstances should exceptions be required.

The Large Faculty Senate Executive Committee (which includes our representatives on university councils and chairs of the Senate's standing committees) met on April 20. Their full reports will be delivered in the near future. A few items of note: The Athletics Council is looking into increased mental health resources. The Continuing Education Council is exploring more opportunities for cross-campus collaboration. The IT Council continues to monitor needs under the one-computer per faculty member policy and university responses to the COVID crisis (which are not unrelated). The Research Council is concerned that funding is getting tighter but is enthusiastic about restructuring efforts that would provide increased distribution among humanities disciplines and more productive seed funding in STEM fields. The Research Council has also made concerted efforts to provide more feedback on proposals that were not funded. The Faculty Compensation Committee is carefully monitoring a review of the tier structure for health insurance and urges closer conversation with the Employee Benefits Committee. The Academic Programs Council reports the new structure for graduate program review, with APC concerns channeled through the provost's office, is working well. The FSEC suggested the Faculty Senate consider recommending a modification to the Graduate Council's membership structure to include a nominee from the Senate.

The taskforce on which I serve that is looking at how the new Diversity, Equity, and Inclusion course might relate to general education requirements met several times over the month and will soon provide a list of favored options to the task force working on the course's content and structure.

Vice Provost Morvant and I discussed concerns I have heard from faculty about the possibility that recorded Zoom sessions from courses might be used in efforts to exploit faculty in the service of political

causes. He plans to contact Associate Provost Chris Walker to discuss ways that faculty might address such issues, perhaps with language that could be included in syllabi to explicate the importance of curricular context and mutual trust that faculty rely upon in their teaching. Vice Provost Morvant also detailed some of the restrictions attached to student funding from the CARES Act. Although there are complications, funding can be used by students for technology needs (personal computers and internet expenses, e.g.) if requested. He encouraged faculty to share this information with their students.

Senior Associate Vice President Randy Hewes reached out to the FSEC for a nominee to a committee in the Vice President for Research and Partnerships office that is preparing plans for reopening the campus for research purposes. Prof. Liz Karr was the top nominee, and she generously agreed to serve.

Provost Harper and I talked on April 24, and he provided an update on the search for the dean of the libraries (ongoing) and first-year enrollment trends (down from last year, but in line with the year before that). I encouraged the provost to stay in conversation with the FSEC on several pressing matters, including the plan for fall instruction, the DEI course development, and budget planning.

At the FSEC meeting on April 27, we discussed ways that communication between the Faculty Compensation Committee and the Employee Benefits Council might be facilitated, perhaps through an amendment to the bylaws in the coming year. Revisions to the proposed amendment to the bylaws concerning remote meetings were proposed. Provost Harper and Vice Provost Morvant provided us with a draft of the fall instruction plan that we discussed at length, and we will provide formal feedback ahead of Vice Provost Morvant's presentation to the Senate this month and will endeavor to stay in contact as plans are refined and formalized. Our conversation with Interim President Harroz on April 29 reiterated several points made in the FSEC meeting, punctuated by our refrain that the FSEC and faculty voices more broadly should register in discussions that touch on matters of great concern to facultyincluding the return to campus (informed by the plans being developed in several different areas), fall instruction, budgeting, insurance tiers, and the DEI course—and we offered our existing structure of committees as an excellent one to work within. Interim President Harroz welcomed our input, especially in light of an overview of the budget picture that prepares for declines in tuition and fees up to \$50 million, in state appropriations around \$13 million, and unknown millions in athletics and giving. Some fee waivers are in place, and tuition discounting and housing strategies are being considered. Measures to address physical safety are underway, including virus testing and tracing and air filtration systems. Our agenda also touched on ongoing needs to fill the ombudsperson position, to institute administrator and office effectiveness evaluations (IP Harroz verified that these will begin for the former this year), to communicate plans for reopening campus for research, and to provide technological needs for faculty (adequate computers and pedagogical tools).

Lori Granec from Human Resources contacted the FSEC to solicit a nominee to a search committee charged with filling the position of Institutional Equity and Title IX officer. Nominations will come through the Faculty Senate's Committee on Committees to the FSEC.

With my final chair's report now in your hands, I'm going to go whittle my gavel into a ploughshare. Or maybe a gavel-shaped pencil would respond better to the raw source material. My sincere thanks to all of my colleagues who have offered support, encouragement, and countless hours of labor throughout the year, especially the FSEC members, Stacey Bedgood, Sam Quick, and all the senators. I know you'll do the same for our new chair Amy Bradshaw, and the many faculty who will join her in serving on the Executive Committee.

Addition to the Faculty Senate Bylaws under Section D. Procedures

Approved by the Faculty Senate at the May 4, 2020 meeting

In light of the inability of the Faculty Senate to meet in person due to a pandemic that has occasioned the legal preclusion of in-person gatherings of more than ten people, the Faculty Senate Executive Committee offers the following language (additions in red and bold) to the bylaws of the Faculty Senate, in accordance with the motion passed at the April 2020 meeting. Current Faculty Senate bylaws do not allow for electronic voting, yet we nevertheless propose to vote electronically on this motion given our current circumstances, our desire to carry on the work of the body, and our uncertainty over when in-person meetings will be allowed to continue. Should this motion carry, once the Faculty Senate can gather in-person, we encourage the body to revisit the actions taken, perhaps with a motion to ratify or revise.

D. PROCEDURES:

- 1. Voting shall be *viva voce* or by show of hands, but five members may require a roll call vote upon any proposition.
- 2. The presiding officer shall have a vote only in case of a tie.
- 3. The agenda of each meeting shall be prepared and distributed in advance by the Agenda Committee, which shall consist of the Chair, the Chair-Elect, and the Secretary. Any matter submitted by a member to the Secretary shall be placed upon the agenda of the next regular meeting.
- 4. In the event that the absence from campus of a significant number of members of the Senate makes holding an in-person meeting impracticable, the Faculty Senate may meet via an electronic system enabling synchronous voice and/or video communication with supplementary recording capabilities. Reasons for holding synchronous, remote meeting might include, but are not limited to, the closure of campus due to a health emergency. Such synchronous, remote meeting may conduct all the normal business of an in-person meeting and is subject to the same procedural rules, including establishing a quorum, with such minor technical adaptations as are necessary to conduct business electronically. Votes on routine motions may be held during synchronous, remote meetings. Special care should be taken to ensure votes are accurately registered, such as through using recorded "chat" or other text-based features, or a motion for a roll-call vote. For votes normally done anonymously by paper ballot, such as elections of officers, an online voting or survey service such as Qualtrics may replace paper ballots, subject to the condition that all voting members of the Faculty Senate have access to the appropriate platform(s), that vote outcomes are recorded, and that adequate time for voting is allowed. For votes conducted with such a service, the Faculty Senate Executive Committee will determine and announce a voting period, which should generally allow two business days for responses. Votes may be reviewed and verified by the Faculty Senate administrative coordinator. If less than a majority of the Senate submits a vote, the motion will be tabled due to lack of quorum. A summary of the motion and results of the vote will be recorded and reported in the Journal of the Faculty Senate. Electronic discussion contributions are subject to open records requests.
- 5. In the event that urgent, time-sensitive matters requiring action on the part of the full Faculty Senate arise (i.e., situations that preclude the customary month separating discussion and voting), as determined by a two-thirds majority of the Faculty Senate Executive Committee, the Faculty Senate Executive Committee may offer a motion to the Faculty Senate to be discussed electronically, such as in a virtual, synchronous meeting that should be announced in accordance with open meetings laws. The motion may be voted on during such a meeting in accordance with the bylaws and established procedures. For motions to be adopted before the customary month separating discussion and voting, they must be passed by a two-thirds majority of the Faculty Senate.
