With a letter from the Commissioner of Indian Affairs, a schedule of Indian depredation claims examined prior to January 1, 1887, with the determination of the Departments thereon.

SIR: In compliance with the provisions of an act entitled "An act making appropriations for the current and contingent expenses of the Indian Department, and for fulfilling treaty stipulations with various Indian tribes, for the year ending June 30, 1887, and for other purposes" (United States Statutes of 1886, pamphlet copy, page 44), I have the honor to transmit herewith a list of depredation claims in favor of citi-

zens and against Indians holding treaty relations with the United States, whose examinations in pursuance of said act were completed by the 1st instant. Said list gives the numbers of the claims, name and post-office address of each claimant, character of the property stolen or destroyed, Indians charged with the depredation, when committed, when filed, amount claimed, amount allowed, date of action, and the "date and clause of the treaty creating the obligation for payment," and also what funds, now existing "by reason of treaty or other obligation, out of which the same should be paid."

Each claim herewith is accompanied by the record of the original testimony, former action had, post-office address of the witnesses, together with a letter embodying my "opinions and conclusions upon all material facts, and all the evidence and papers pertaining thereto."
